

75 lac voters are with disabilities in Bangladesh. For free and fair 9th National Parliamentary election, the citizens with disabilities demand:

- To introduce separate queue and groundfloor voting arrangements in the voting centers
- Arrange for permanent or temporary ramps in the polling centers
- Visually-challenged voters choose his/her own helper, or "tactile ballot" be introduced
- Incorporation of education, health and employment of the people with disabilities in the election manifestos of the political parties
- Raise awareness to create disabilityfriendly-voting environment by the public media.
- Every political party should nominate at least two candidates with disabilities from each division for a total number of 12 MPs in Parliament.

Let us be respectful towards the demands of the people with disabilities in order to ensure a free and fair election and to consolidate democracy in the country.

The theme of this year's observance of the International Day of Disabled Persons, "E-accessibility", reminds us of the need to make the Internet available to everyone. Access to information and communication technologies creates opportunities for all people, perhaps none more so than persons with disabilities. And as the development of the Internet and these technologies takes their needs more fully into account, the barriers of

prejudice, infrastructure and inaccessible formats need no longer stand in the way of participation.

This is a welcome change. As information and communications technologies spread across the world, drawing in more and more users every day, most websites remained inaccessible to the millions of people who have difficulty manipulating a mouse, or who are visually impaired and need a "screen reader" or large fonts to read the page. Slowly, governments and the private sector have been recognizing the economic and social benefits of making websites fully accessible, and have been putting place changes involving software and hardware alike.

The Convention on the Rights of Persons with Disabilities, which is expected to be approved by the General Assembly later this month, can give additional impetus to this trend. States that choose to become party to the Convention will thereby commit themselves to taking steps to provide "information intended for the general public to persons with disabilities in accessible formats and technologies appropriate to different kinds of disabilities in a timely manner and without additional cost". The Convention urges private businesses and mass media to do the same with their services.

On this International Day, let us pledge again to do our utmost to achieve the vision of an inclusive, people-centred, development-oriented information society. And let us redouble our efforts to ensure that persons with disabilities can exercise their human rights and play their full part in the economic, social and political lives of their societies

Disability Scenario in Bangladesh Amongst 14 millions disabled people around 50% are

- hardcore poor 1.5 million people are severely disabled -have no
- working ability and living in worst condition,
- 96% children with disabilities do not have access to primary education
- 72% parents face difficulties enrolling their children in education institutions Education of disabled children is under Ministry of
- Social Welfare, not under Ministry of Education
- Of 3.4 million eligible disabled children, only 1700 are currently enrolled in special needs schools
- Crude mortality rate is double among disabled children, it was 14% in rural areas in 2001
- Disabled people do not have access to Microcredit!!

The theme of the International Disability Day 2006 is 'e-accessibility.' The world becomes a global village due to the wide uses of internet and satellite channels. However, most of the persons with disabilities are deprived of these opportunities. The declaration for ensuring computer facilities for every child by 2010 has no value to the challenged people while their access to the basic rights like education and health services are a daily struggle. Nevertheless, we should make concerted efforts to improve services for computer training and to develop accessible software and hardware for the challenged people.

Experience of Election Observation:

Umme Kulsum Ranjana, Chairperson, National Council of Challenged Women

During the observation of the last national parliament elections it was noticed that the people with disabilities are ignored. The wheel-chair users and other disabled citizens including crutch users did not get priority in exercising their franchise and faced difficulties. Attempts were made by certain influential candidates to coerce some voters with money to vote in their favour.

The visually-impaired people were prevented from entering the centers and they were told not to cast their votes and ask their acquaintances to vote for them. In some isolated cases even the helpers of the visually-impaired people were not allowed to vote and the presiding officers themselves cast the votes on their behalf.

The 9th General Election is going to be held soon. So our demand to the government, political parties and others concerned is that the issues of the people with disabilities are taken into account and ensure their participation in the election process, which will strengthen democracy.



How much of the hopes and aspirations of the people of disabilities have been achieved?

10% population of the country should enjoy economic, social, cultural, civil & political rights. The Disability Welfare Act 2001 should be amended to promote and protect their rights. Disability is included in the Poverty Reduction Strategy Paper (PRSP). What is now essentially required is to allocate

resources in the budget to implement the action plan of PRSP. People with disabilities do not have access to the Bangladesh Civil Services. The government declared 1% quota for them in the BCS, which is indeed a praiseworthy step. This generated a great deal of enthusiasm among the people with disabilities all over the country. It is still uncertain when this quota will actually be implemented.
