for SELECTION OF SPONSOR TO DEVELOP A 1-2 MW SOLAR PANEL ASSEMBLING PLANT IN BANGLADESH

- Infrastructure Development Company Limited (IDCOL) intends to select a sponsor through a competitive bidding process to develop a 1-2 MW solar panel assembling plant in Bangladesh with the objective of lowering price and ensuring uninterrupted supply of solar panels to its partner organizations. IDCOL has already financed 90,000 solar home systems in the remote rural areas of Bangladesh and has the target of financing 200,000 SHS by 2010 through its fourteen partner organizations. Currently, about 3,500 systems are being installed each month under IDCOL's solar program.
- Interested participants must have previous experience in solar business, preferably in Bangladesh. The participants must also be able to enter into long-term purchase contract for supply of solar cells, procure equipment and arrange necessary training to develop manpower. - IDCOL will provide (a) capital subsidy; and (b) concessional loan (10 year tenor with 6% annual interest rate) up to 40% of the project cost. In addition, IDCOL will assist in availing necessary licenses/approvals from different government entities to develop and operate the project. The project will also be eligible for existing government incentives.
- Sponsor will be selected using a two envelope evaluation process as follows:  
(a) Envelope I - Technical proposal, including technical capability and qualifications; and  
(b) Envelope II - Financial proposal, including: (i) Project cost; (ii) Amount of capital subsidy required; and (iii) Indicative selling price per watt-peak.
