Iajuddin now wants Zakaria to stay in EC after finalising package proposal

President and Chief Adviser (CA) to the caretaker government lajuddin Ahmed suddenly appears opposed to the sending of Election Commissioner SM Zakaria on leave as proposed by the advisory council to reconstitute the Election man can do nothing to the election process," an adviser last night quoted the president as saying at the advisers' meeting on Wednesday

The adviser was talking to The Daily Star in return for anonymity. The president's stance has irked Awami League (AL) and its allies who had earlier decided to move

towards the polls on the advisers' assurance that the commission would soon be reconstituted.

The AL-led 14-party combine yesterday renewed its call for the interim government to keep Zakaria inactive till the election is over while the BNP-led four-party alliance stood firm in favour of the controversial election commissioner.

A delegation of the four-party

alliance yesterday met a fourmember panel of advisers at the state guesthouse Padma and said they will not accept any move to send Zakaria on leave, meeting sources said.

"We will have no objection if the president appoints a new election commissioner and make him the acting chief election commissioner

The Election Commission (EC) starts correcting the mistakes in the updated voter list today through door-to-door visit by its staffs to detect the fake and duplicate names in the list, allocating eight days for the task as per the EC's latest decision.

Amidst widespread allegations that the updated voter list contains over one crore 'excess' voters, the EC on Tuesday decided to correct the mistakes by sending its staffs for door to door visit in only three days -- December 8 to 10.

As per the latest decision, the field level staffs will visit door to door till December 15. Earlier, it took 22 days to complete the field

EC announces fresh polls schedule

The Election Commission (EC) yesterday rescheduled the upcoming ninth parliamentary elections, setting January 23 as the polling day instead of January 21, to ensure participation of all political parties in the next elections.

The dates for different stages of the election--submission of nomination papers, their scrutiny and withdrawal of candidature--have also been rescheduled in the new

The EC announcement of the new schedule--after 10 days of its surreptitious and hasty declaration of January 21 as the election datecame following a series of negotiations between the council of advis-

ers to the caretaker government and political parties.

The [polls] schedule was refixed so that all political parties can participate in the election," EC Secretary Abdur Rashid Sarkar said at a news briefing after announcing the new schedule finalised at an EC

meeting yesterday afternoon. "The election was rescheduled on the basis of a consensus among

the political parties," he said. Acting Chief Election Commissioner (CEC) Justice Mahfuzur Rahman, however, declined to make any comment on

Sit-in ends in polls mood



Move on to revive controversial bid

Official from president's office makes secret trip to power ministry

Going out of its way, President lajuddin Ahmed 's office has taken an initiative for reviving the controversial unsolicited bid for the Meghnaghat 450 megawatt phase-3 power project.

Sources said an official from the president's office earlier this week visited the power ministry and collected the power project's documents prepared by the immediate past alliance government for approval by the cabinet's purchase

The official from the president's office asked officials concerned of the power ministry to keep his visit a secret. The president's office is reviewing how to get this project approved during the caretaker government's tenure.

Though there has been tremendous pressure from the 'alternative centre of power' of the immediate

past BNP-led alliance government and a big real estate developer cum leading tissue paper manufacturing company, the government could not award contract for the Meghnaghat-3 power project in the last two years. The unsolicited proposal for this project', given by inexperienced and unknown US-Irish joint venture Cadogan-Manning Group (CMG), violates many rules and regulations and

Judges to resume work Sunday

The Supreme Court (SC) judges yesterday decided to resume court proceedings from Sunday ending their unprecedented work absten-

The judges started work abstention from last Tuesday demanding apologies from the SC lawyers and punishment of vandals responsible for the vandalism at the SC premises on November 30 that was triggered by a stay order by the chiefjustice.
