



The Awami League-led 14-party combine did not accept the new appointments while the BNP-led four-party alliance welcomed the newadvisers.

The council of advisers to the caretaker government will sit today to discuss whether to resume negotiations with the two major political alliances to break the political deadlock.

Three of the new advisers expressed optimism about holding free and fair elections on time through the resolution of the present political crisis.

Adviser Ruhul Alam told reporters, "The only challenge now before the nation is to hold the next parliamentary election on time in a free and fair manner. I am confident we will be able to face the challenge.

No salary for MA Aziz

The office of the Controller General of Accounts (CGA) has refused to pay Chief Election Commissioner (CEC) MA Aziz his last month's salary as the EC Secretariat could not justify his going on a 'threemonth paid leave'

Justice Aziz who was appointed the poll chief on May 23 last year has drawn salary as the CEC only for the month of October. Before that, he had been drawing salary and enjoying privileges as a judge of the Appellate Division of the Supreme Court, officials in the CGA office said.

As laid out in the financial rules, he has been the CEC for one and a half months [counting from October] and accordingly, has earned so far 11 days' leave, they

Many from minorities missing on voter roll

They may not be included due to form shortage

Several thousand members of the minority communities in Dinajpur town who were not included in the updated voter list may not be enrolled this time also due to acute shortage of voter registration

Besides, the names of many under aged students of a madrasa

in the capital's Mohammadpur area, registered as voters earlier, were not deleted from the list till vesterday while correction of it ends on Friday.

Filed level Election Commission (EC) staffs continue to show negligence to list people who were not enrolled earlier. Severe shortage of voter registration forms is one of the main reasons for this.

These anomalies were detected during spot visits by a team of The Daily Star correspondents in the capital and different parts of the country yesterday.

They also feel if AL goes to election under the government led by lajuddin then the four resigned advisers' statement that the current situation is not conducive to holding a fair election, will be rendered unsubstantiated.

Following the resignations of the four erstwhile advisers to the CG and appointments of four new ones, the CG has now turned into a 'complete' partisan government, said the leaders of the majority group expressing their firm determination not to take part in the next election under a government led by the current chief adviser.

"The chief adviser is the main

atmosphere for a free and fair election. Without his resignation from the post no fair election can be held in the country," said Abdul Jalil, general secretary of AL, at a news briefing in its Dhanmondi office in the capital following a presidiummeeting of the party.

"It is not possible to take part in the election under lajuddin Ahmed as he has made the caretaker government, Election Commission and the administration partisan to BNP-Jamaat alliance and has been working to implement their agenda," AL Presidium Member Amir Hossain Amu told The Daily

Amu also said the election will be held in the country if the president resigns from the post of the CA and appoint a non-partisan person in accordance with the constitu-




