Admission Test Results

On the basis of results of Admission Test held on 01-12-2006 Friday, the undermentioned registration number holder students (male/female) have been considered eligible for provisional admission to 1st year BDS Course at Dhaka Dental College/Chittagong & Rajshahi Medical College Dental Units. They have been selected for admission on the basis of merit & choice of college. At the same time waiting list of 200 (two hundred) merit basis General 5 (five) freedom fighters' reserved seats & 5 (five) tribals reserved seats is also published.

Prior to admission, the Local Admission Committee constituted by the Principal of respective colleges shall verify the original copy of certificates & documents submitted with the application. The students (male/female) getting opportunity must deposit all their original documents & attested photograph with the college authority at the time of admission. Medical Board constituted by the Principal of respective college shall conduct the medical examination. After execution of the said rules & regulations, the qualified candidates will be admitted provisionally. In case any wrong information of any student (male/female) is detected later, then his/her admission will be cancelled and punitive action shall be taken.

Candidates selected for admission are instructed to contact the Principal of respective college for admission. In case any student (male/female) after admission happens to be unwilling to study at the college admitted to, the student and his/her legal guardian may take back the original certificate/marksheet on written application to cancel his/her admission. 28-12-2006 Thursday has been fixed as the last date for admission.

Students (male/female) participating in Admission Test may know the test result in detail from the office of the Principal of the college where he/she appeared at the test. No information on result can be known from the Directorate of Health. May apply for verification of own examination result by depositing Bank Draft for Tk 500 (five hundred) only (non-refundable) in favour of Director, Medical Education, Directorate of Health, Mohakhali, Dhaka within 15 (fifteen) days of publication of results. The applicant shall be informed after verification of his/her answer script by the verification committee. The decision of the Admission Test Committee of the Directorate of Health shall be treated as final in this regard.

Such students (male/female) as interested for migration should properly fill in the sample form supplied by college and deposit at the office of the Principal by 28-12-2006. The admitted students (male/female) have no opportunity of transfer or migration to any other college other than auto migration.

1st year BDS class shall start after completion of migration process for minimum 2 (two) times. The date of starting class shall be informed to the Dental/Medical College authority. The students (male/female) should contact the Principal in this regard.

The Admission Committee of the Directorate of Health reserves the right of any amendment & addition to the admission test results.
