

# Notice for Tax Deduction at Source from House Rent

It is notified for information of all concerned that there is provision for deducting/collecting tax at source under a number of heads in the existing Income Tax Act. Deducting Tax at source from house rent is a main head. Any govt, semi-govt or autonomous organisation, statutory corporation & its units, all companies including private companies, medical college, dental college, engineering college & university and NGOs registered with NGO Bureau are treated as deducting authority in matters of deducting tax at source from house rent. Rules of Income Tax Act in this regard are such that in case the amount of house rent is above Tk 15,000/= (fifteen thousand), the rental paying authority should deduct tax at the undermentioned rate from the rental amount and deposit in Govt exchequer under prescribed code of Income Tax (in case of company 1-1141-000-0101 and in case of individual & others 1-1141-000-0111) and send a monthly return on the same to the tax authority.

Rate of deducting tax at source Rate of deducting tax Amount of rental If the amount of monthly rental is not above Tk 15,000/= Zero If the amount of monthly rental is above Tk 15,000/= but not above Tk 35,000/= If the amount of monthly rental is above Tk 35,000/=

If, besides the agreement executed for the original house, there executed separate agreement for furniture fixture, fittings or land attached to the building, the amount stated in the separate agreement shall also be treated as included in house rent and as such the tax should be deducted at source from the total

In the interest of national revenue all the deducting authorities (except company/firm under jurisdiction of large tax paying unit) are specially requested to deduct/collect tax at source under appropriate head as

well as all other heads as per rules and deposit in govt exchequer in favour of Tax Commissioner, Tax Zone-2, Dhaka and send a return on that to Tax Commissioner, Tax Zone-2, Dhaka. It may be noted that failing to deduct Income Tax at source as per existing Income Tax Act & rules and deposit in govt exchequer in due course, the responsible person of the deducting establishment shall be treated as defaulting tax payer in accordance with Rule 57 of Income Tax Ordinance, 1984 and legal

action shall be taken against him to realise the undeducted tax. Moreover, he shall be bound to deposit additional amount at the rate 2% per month for the unrealised period. Besides, there exists such provision under Rule 30 (AA) of Income Tax Ordinance 1984, that if any business firm (in appropriate case) fails to deposit tax in govt exchequer deducting it from the paid amount, then the respective paid amount shall not be treated as deductable expenditure at the time of deciding business income of the firm.
