Security Council to okay Iran sanctions

The Security Council was expected to approve yesterday a slightly amended European draft resolution mandating nuclear-related UN sanctions against Iran, diplomats

French Ambassador to the United Nations Jean-Marc de La Sabliere told reporters the 15nation Security Council had decided to meet at 11:00 am (1600 GMT) Saturday to vote on the draft put forward by European sponsors. 'We will take action tomorrow at

11:00 am," confirmed Friday Qatar's UN envoy Nasser Abdelaziz al-Nasser, who chairs the council this month.

He added the vote would follow last-minute consultations among council members.

A Western diplomat close to the talks, who spoke on condition of anonymity, said the latest draft

would be endorsed overwhelmingly and possibly unanimously.

China's UN Ambassador Wang Guangya told reporters that he planned to consult with his government before the vote. The vote will take place exactly

"I would file a libel suit against her [Hasina] if she fails to bring enough evidence to prove me guilty within the next three days, "Abbas

Laden's 'close aide' killed in airstrike

US-led forces have killed a close associate of Osama bin Laden in an airstrike in southern Afghanistan in a major blow to the deadly Taliban-led insurgency, a military statement said vesterday. Mullah Akhtar Mohammad

Osmani's vehicle was struck in Helmand province near the Pakistan border after coalition forces received credible information about his hideout, the statement said. "Mullah Akhtar Mohammad

Osmani, a senior member of the Taliban's inner circle, was killed on December 19 in Helmand province," coalition forces spokesman Colonel Tom Collins said.

"Osmani was in the top ring of the Taliban leadership and he was also a close associate of Osama bin Laden and Gulbuddin Hekmatvar," he said. "His death is a major achieve-

Hekmatyar a wanted terrorist for helping lead remnants of the ousted Taliban regime in a deadly insurgency against foreign troops in Afghanistan that are working to stabilise the warravaged nation.

A key Taliban commander in charge of large sections of Afghanistan, Osmani was killed instantly in his vehicle in a deserted area of the province, along with two unidentified associates, the statement added

One Afghan intelligence source said he was the commander of Taliban forces in southern Afghanistan. Speaking on condition of anonymity, the source said he was part of a 12-member leadership council of Taliban and ranked number four in the ousted militia

force. Collins did not rank Osmani in the Taliban leadership but said he was their chief of military operations in the provinces of Uruzgan, Nimroz, Kandahar, Farah, Herat and Helmand.
