# 100 hurt as hartal paralyses Rangpur over Ershad's fate

STAR REPORT

Fierce clashes between police and activists of Awami League-led grand alliance marked the dawn-todusk hartal called by the alliance in Rangpur and Lalmonirhat districts yesterday while the hartal in Kurigram, Gaibandha and Nilphamari districts passed off almost peacefully. Half-day hartal was also

observed at Sylhet-3 and Habiganj-3 constituencies. At least 100 people including

police, activists and leaders of the grand alliance and journalists were injured in a series of clashes at different places in Rangpur town during the hartal hours, reports our Rangpur correspondent.

The grand alliance called the hartal yesterday to protest the cancellation of nomination papers of Jatiya Party (JP) chief HM Ershad.

Police along with armed police from Joypurhat and BDR led by Magistrate Iqbal Hossain Moniruzzaman and Israil brought

**Ershad files** appeal with EC today

Nomination Rejection

Jatiya Party (JP) Chairman HM Ershad will file appeal with the Election Commission (EC) today challenging the validity of the returning officers' (RO) decisions rejecting his nomination papers for five constituencies.

"We will file appeal with the Election Commission tomorrow. Our lawyers are preparing for the legal battle," JP Secretary General Ruhul Amin Hawlader told The Daily Star vesterday

Nine candidates, whose nomination papers were rejected on different grounds, filed appeal with the EC yesterday, the first day of filing appeal against the RO's

The ROs on Wednesday rejected 264 nomination papers due to loan defaults and other disqualifying factors.

As per the election laws, a candidate can appeal against rejection of his or her nomination papers within three days. On receiving the appeals, the EC will start disposing those from December 31.

## 12 EU election observers arrive Sunday

Twelve European Union long-term election observers (LTOs) will arrive in Dhaka on Sunday for the parliamentary elections scheduled to take place on January 22.

They will join the EU election observation mission's (EOM's) core team of ten election experts, who arrived in Bangladesh on December 17. The mission is being led by Alexander Graf Lambsdorff, a member of the European Parliament from Germany, said a press release.

After extensive briefing by the core team in Dhaka on January 1, a team of two observers will be deployed in Barisal. Chittagong. Khulna. Raishahi and Svlhet divisions each on January 2. One team will remain in Dhaka.

## Grand alliance to decide today if it would contest

#### Hasina to talk to the press

The Awami League (AL) led grand alliance will announce today its decision whether to participate in the next parliamentary elections under the circumstances when the caretaker government is allegedly using the administration and law enforcement agencies against the alliance.

AL President Sheikh Hasina will announce the alliance's crucial decision at a joint press conference in the presence of top alliance leaders, said AL General Secretary Abdul Jalil at a press briefing at the Dhanmondi AL office yesterday.

"President and Chief Adviser lajuddin Ahmed with directions

from the BNP-Jamaat alliance is leading the current situation towards a direction that will force us to take any rigid stance," Jalil, also 14-party coordinator, said.

Chairman HM Ershad, Liberal Democratic Party President AQM Badruddoza Chowdhury, and other key leaders of the grand alliance will be present at Hasina's press briefina The AL top leaders yesterday

Sources said Jatiya Party

discussed the latest political development with Hasina at her Sudha Sadan residence. They will sit today morning to finalise the strategy to be declared.

Following declaration of Ershad's all five nomination papers

invalid, the top leaders of the AL-led grand alliance began backtracking from their decision to contest the January 22 polls.

Jalil said Ershad's nominations were cancelled without showing any proper grounds and following rules and regulations.

Sources said almost all top leaders of the alliance are sure that the caretaker government and the administration will work for the BNP-Jamaat alliance.

Talking to The Daily Star, many AL candidates alleged that the field level administration is not cooperating with them.

## Toxic transformer oil used for frying food

Presence of poisonous oil used in electrical transformers as coolant was found in deep fried food items sold in roadside shops in the capital.

Traces of toxic polychlorinated biphenyl (PCB) were also found in blood samples of some people, tested under an ongoing project of the Department of Environment (DoE). It has been assumed that unscrupulous businessmen have been engaged in mixing the coolant with edible oil for a long time.

However, tests of edible oil to find out traces of PCB are yet to be

A study conducted by experts of DoE under the project recently

found presence of the poisonous chemical in cooked and packed food items. A draft report of the study titled

'survey and research on DDT and PCB in food items' mentioned that presence of PCB was found in piaiu. jilapi, puri, and potato chops sold in road side cafés and in packed chanachur sold in stores. PCB has hazardous effects on

humans, the experts said. Different symptoms of the effect include nausea, eye and respiratory tract irritation, dehydration, weight loss, cvanosis, and altered function of the neuromuscular system, liver, kidneys and pancreas, the experts

PCB can remain in fat cells of a human body up to 120 years with the possibility of altering the DNA structure of an affected person and traces of it can also be transferred to

offspring, according to the experts.

The experts confirmed that the lone source of PCB in the country is a kind of industrial oil which is used in electric transformers and capacitors as a cooling agent.

An organised group of unscrupulous edible oil traders have been buying used transformer oil and mixing it with edible oil, a field investigation revealed.

The main sources of used transformer oil are the storage of Dhaka

## Politics rule attorney general's office

The Attorney General's Office (AGO) goes into overdrive, speeding up or slowing down some court orders for the Election Commission (EC) to capitalise on the dubious moves that curiously suit the purpose of the BNP-led alliance.

Of late, judgement copies are either being sent overnight from the court or being delayed by weeks apparently to upset the execution process. Observers credit the erratic pace of the AGO to its office bearers, most of whom are directly involved with the BNP and Jamaat politics.

The Japanese boat purchase graft case against HM Ershad and the stay order by Supreme Court freeing the election candidate from the obligation to disclose personal

details to the EC are the two most recent controversial instances.

The AGO was also found all too hyperactive on November 30 when it put three writ petitions to rest that challenged Professor lajuddin to become the caretaker government chief. "I haven't seen such an active role of the AG office in my whole legal stint," remarked a very senior lawyer after that unprecedented incident.

In contrast, the court order rejecting the appeal of top seven JMB leaders against their death sentence (upheld by the HC) could not find its way to the jail authorities even one month into the ruling.
