AL's alliance to go for blockade Jan 7-8

Threatens indefinite siege of Bangabhaban over publication of 'proper' voter list, resignation of Iajuddin as chief adviser

Awami League (AL)-led grand electoral alliance yesterday announced back-to-back countrywide blockades on January 7 and 8 demanding publication of a 'properly' corrected and updated voter list, and resignation of Chief

Adviser (CA) lajuddin Ahmed.

Speaking at a packed news conference yesterday, AL President Sheikh Hasina warned, if the demands are not met, the president's official residence, Bangabhaban, will be blockaded indefinitely.

"If the demands are not met even after the countrywide blockades, Bangabhaban will be blockaded indefinitely," Hasina said at the grand alliance news conference

flanked by Jatiya Party (JP) Chairman HM Ershad, Liberal Democratic Party (LDP) President AQM Badrudozza Chowdhury, and top leaders of AL-led 14-party

Asked if AL will boycott the election if their demands are not met even after the countrywide blockades, Hasina said, "We don't want to run away from the battlefield. We want to stay there and fight till our demands are met."

The AL chief accused the president and CA of not being interested in creating a congenial atmosphere for a free and fair election. "Every time we peel off one layer of his conspiracy another layer appears." Replying to a query whether the

Dense fog bedevils home rush for Eid

Ferry service at Paturia, flights at ZIA remain suspended for hours

Dense fog in the early hours yesterday disrupted road and river communications across the country and forced suspension of flight operations at the Zia International Airport (ZIA) for hours, causing immense sufferings for the homebound passengers ahead of the Eid-ul-Azha.

Thousands of passengers had to wait from Thursday last night until 11:00am, as there were long queues

of vehicles at Paturia and Daulatdia ferry terminals. Chilly weather on the riverbank added to their suffer-

"My family left for Magura early in the morning but reached there at 5:00pm. As they had to wait for several hours to get the ferry at Paturia, the four-hour journey took 10 hours and the kids had to suffer much," said a resident of Lalmatia in the capital yesterday.

No flights left Zia International Airport for nine hours until

11:00am yesterday and the authorities had to reschedule 22 international flights due to poor visibility. flight enquiry sources said. As the sun remained invisible until 11:00am in most of the places, motor vehicles had to move with their fog lights on especially in the

northern region and riverside

Ershad appeals to confront rejection

EC not accepting bank appeals to cancel defaulters' nomination


A total of 70 aspirants including Jatiya Party (JP) Chairman HM Ershad, whose nomination papers had been rejected by returning officers (RO), yesterday filed appeals with the Election Commission (EC), challenging the validity of the ROs' decision.

The number of appealing candidates whose nomination papers

were rejected on different grounds now reached 79 in two days of the three-day process for filing appeals against the ROs' decision

Meanwhile, the EC is not receiving bank appeals to cancel nominations of loan-defaulting candidates, whose nominations have been accepted by the ROs although it had accepted 22 such appeals ahead of the last parliamentary election.

IMB LEADERS' APPEAL AGAINST DEATH SENTENCE

Court's rejection order fails to reach jail in a month

Prison authorities to fix execution date only after receiving the paper

Even after a month of the Supreme Court (SC) judgment on the Jhalakathi judges murder case that confirmed death sentences of six Jama'atul Mujahideen Bangladesh (JMB) leaders, its copy has not yet reached the prisons where the six convicts have been kept.

While the people of broad walks of the society are eagerly waiting to see the execution of the verdict for IMB's killing of a number of innocent people including judges in the name of religion, it is still uncertain when the jail authorities will get the court order.

The prisons authorities said they cannot fix the date for execution of the six JMB convicts until

they receive the court order. "The court order will initiate our necessary activities," Inspector General (Prisons) Brig Gen Zakir Hasan told The Daily Star on Tuesday.

It now completely depends on the chief justice and other judges of the Appellate Division that passed the order.

The SC on November 28 rejected the six JMB men's petitions seeking permission to appeal against a High Court (HC) judgment upholding the sentences for killing two judges in a suicide bomb attack in Jhalakathi on November 14.

The six convicts are JMB chief Abdur Rahman, top kingpin Siddiqul Islam alias Bangla Bhai, three other Majlish-e-Shura members Ataur Rahman Sunny, Abdul Awal and Khaled Saifullah, and suicide bomber Iftekhar al Mamun.

Asadul Islam alias Arif, another militant convicted by the trial court, has been on the run.

The Appellate Division only pronounces the order while passing a judgment. It takes time later for drafting the text of the judgment, examining the draft by the Appellate Division members several times, and making necessary corrections.

After finalising the draft, all the members sign it and send it to the section concerned for providing the prisons with its certified copy.

Muslims pray for AL man killed, peace at Arafat

More than 2 million elated Muslim pilgrims crowded onto holy Mount Arafat near Makkah yesterday, praying for Muslims around the world and hoping for a safe hajj.

Muslims believe Allah is more likely to answer their prayers if they are made within the sacred zone on the mountain plain, the site of Prophet Mohammad's last sermon 1,400 years ago.

Wearing simple white robes to symbolise equality and selflessness, many trekked at dawn to the rocky outcrop, known as Jebel al-Rahma (Mount Mercy).

"Whenever I stand on Jebel al-Rahma I feel reborn," said Ruquia Manouzi, a Moroccan woman.

Mohamado Thiam, a telecoms engineer from Senegal, said pilgrims are praying for Muslims in hotspots around the world. 'I'm very happy, look how our

nation is expanding," he said. "But

we have to pray for our brethren in

Iraq, in Palestine, in Sudan. There are people dying there."

In one of the world's biggest displays of mass religious devotion, pilgrims spend five days following a route around the mountains of the ancient city of

The gruelling ritual is a duty for every able-bodied Muslim who can afford to make the trip.

With such large crowds, Saudi Arabia deploys more than 50,000 security men to try to avoid deadly stampedes, as well as attacks by Islamists opposed to the U.S.-allied Saudi royals.

Security fears are heightened this year because of concerns over ongoing sectarian strife between Sunni and Shia Muslims around the region.

A record 1.65 million pilgrims have come from abroad, a 6 percent rise on the last hajj. Several hundred thousand people inside SEE PAGE 15 COL 2

All papers ready for rapid execution

Iraqi officials have completed all paperwork necessary to execute Saddam Hussein and could hang him as early as today, but may wait

until later in the week, said an aide to the prime minister.

"All documents relating to the implementation of the execution are compiled and ready," Sami al-Askari, a member of Iraq's main Shiite parliamentary bloc and a political consultant to Prime Minister Nuri al-Maliki, said

"Saddam has only a very short time ahead of the implementation of the execution. The execution will be either before dawn on Saturday, or immediately after the Eid holiday," Askari told AFP. Eid al-Azha will begin at the

weekend and last until Wednesday night, and Iraqi officials have already said that it would be unlikely that an execution be carried out during a religious holiday. Meanwhile, an Iraqi judge
