Library set up by a woman brings the world to former enclave dwellers in Dashiarchhara

Two book shelves, two tables and a couple of chairs in a tiny tin hut may not strike a city dweller as much of a library.

Yet, Golam Maola Alor Dishari Library is fostering enthusiasm among the book lovers in Dashiarchhara, a former Indian enclave in Kurigram's Phulbari upazila.

It was established in September 2015 in West Ajwatary village of Dashiarchhara following the exchange of 162 enclaves between Bangladesh and India in August of the same year.

Growing up in the locality, library founder Momotaj Mohal Baby was well-aware of the deprivation of citizenship rights of the enclave dwellers and felt the need to do something for them, especially for the women.

"Between 2000 and 2015, I worked as a teacher at a Brac pre-primary school which had a Kishori Club. Girls could come play, sing, and read books, lent by different people. The reading section, however, stopped when a fee was attached to the service," Momotaj said, recounting how she came up with the idea of opening a library.

Later, some of the club members told Momotaj that they missed reading books for free.

"Around 2009, I started collecting old books, and loaned those out to people for free for several days on condition of return," she reminisced, adding that she had begun with 50 books.

HC rule for counsellors, psychologists at schools UNB, Dhaka

The High Court yesterday issued a rule asking the government to explain as to why directives should not be given to recruit counsellors and clinical psychologists in educational institutions across the country.

The HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman issued the rule following a petition.

Advocate Farhad Uddin Ahmed Bhuiya, who filed the petition, stood for himself while deputy attorney general Advocate Amit Talukdar represented the state.

On November 24 last year, Farhad Uddin Ahmed Bhuiya filed the writ with the High Court seeking recruitment of clinical psychologists in all educational institutions.

RECRUITMENT IN MALAYSIA Won't send workers unless cost is cut Says expatriates' welfare minister

The government doesn't want to send Bangladeshi workers to Malaysia before a low-cost and transparent system of recruitment comes into place, Expatriates' Welfare and Overseas Employment Minister Imran Ahmad said yesterday.

"If I allow high charges for recruitment [of Bangladeshi workers abroad], I will betray my constituents," he told a press conference at the ministry yesterday.

The biggest challenge facing overseas job sector is the high recruitment cost. In 2016 and 2018, Bangladeshi workers were charged up to Tk 4 lakh for jobs in Malaysia, he said at the event organised by Reporters for Bangladeshi Migrants. Malaysia suspended recruitment of Bangladeshi workers in September 2018, alleging that a cartel of 10 Bangladeshi recruiting agents patronised by several influential politicians of previous Malaysian government was charging exorbitant sums of money from migrant workers.

'Drug dealer' killed in 'gunfight'

An alleged drug peddler was killed in a "gunfight" with police in Teknaf upazila of Cox's Bazar early yesterday.

The dead was Samuda Begum, 40, a resident of Satghoria Para area in Teknaf, said police.

On information that some drug peddlers had gathered in Laboner Math area in Whykong union, a Teknaf police team conducted a drive there around 4:00am.

Sensing their presence, the criminals at the spot opened fire on the team forcing them to retaliate, said Pradip Kumar Das, officer-in-charge of Teknaf Police Station.

After the gunfight, police found the bullet-hit body of Samuda lying on the ground.

She was taken to the upazila health complex and was later moved to Cox's Bazar Medical College Hospital where on duty doctors declared her dead on arrival, said the OC. SEE PAGE 11 COL 1

Half a billion animals reportedly killed; Aus\$25m raised to help firefighters Agencies

Vickii Lett has been a volunteer wildlife carer in New South Wales (NSW) for 32 years. While she says her work can sometimes be heartbreaking, this year she has witnessed Australia's wildlife being wiped out on an unprecedented scale by fires that continue to rage across the country.

"The scope of these fires is something we've never experienced before," said Lett, whose work with the Australian wildlife rescue group, WIRES, often involves searching for survivors amid the ashes.

"It's heartbreaking to see those injured animals. Many of them have to be destroyed, others, maybe you see the shell of a body but it's basically just a shape in the ash."

Since country-wide fires first flared up unseasonably early in September, hundreds of homes have been lost, more than five million hectares (12.4 million acres) of bush and farmland have been scorched, and at least 24 people have been killed.

Ecologists from the University of Sydney estimate almost half a billion mammals, birds and reptiles have died since the fires began.

As another heatwave sweeps across the country, the fires are showing no sign of abating and experts fear there may not be enough habitat or numbers left for some species to recover.
