# **BRTC** to start probe soon

Purchase of 'Faulty' Buses, Trucks

The authorities will finally start investigating the purchase of "faulty" buses and trucks from Indian manufacturers for the Bangladesh Road Transport Corporation.

The BRTC has formed a probe committee last month, almost three months after the Road Transport and Bridges Minister Obaidul Quader directed the officials concerned to launch an investigation.

"We will start the investigation very soon and complete it within the shortest possible time," BRTC Chairman Ehsan-E-Elahi told The Daily Star on Sunday.

Buet has yet to send the name of its representative in the probe committee, he said. "We will start investigating within one week after getting the name."

Duration of the probe would be fixed once the committee members held their first meeting, he added.

The government brought 600 buses and 500 trucks from different Indian makers with Tk 559 crore in multiple phases last year. The funds were lent by the Indian government. The vehicles have already arrived in Bangladesh. Farid Uddin Ahmed was the chairman of BRTC at that time.

After the vehicles arrived, especially the buses, it was reported in the media that some of the non-AC buses had leaky roofs and several double-decker ones were not what their spec sheets mentioned.

On September 16, Quader at a programme at the BRTC head office said, "There must have been experts among those involved in bringing the buses [from India]. They [Indian companies] supplied us vehicles full of defects.

"I am directing the [BRTC] chairman to launch a proper investigation to find out whether anyone [from our officials] accepted the defects willingly or they had been

Quader, also general secretary of the Awami League, had also mentioned that those who supplied the vehicles had taken the responsibility and promised to fix

In last October, the Road Transport and Highways Division

(RTHD) directed the BRTC to launch the investigation and asked BRTC chairman to form the probe committee with representatives from

Led by Ehsan-E-Elahi, committee will have representatives from the RTHD, Bangladesh Road Transport Authority (BRTA) and mechanical engineering department

But the nation was worried as well. Because the man who had led the nation to freedom was still detained in the Pakistani jail.

Bangabandhu Sheikh Mujibur Rahman, the undisputed leader of independence of Bangladesh, had been put in solitary confinement for nine and a half months. Soon after December 16, he was moved from the jail to a more remote place.

On December 24, he was brought by a helicopter to the compound of a police academy at Shihala, not far from Rawalpindi of Pakistan.

Soon after his arrival, Zulfikar Ali Bhutto, the president of Pakistan, came to meet him. Bangabandhu asked him if he had also been placed in detention.

In reply, Bhutto told him that he had become the president of Pakistan. "How have you become president

when I got twice as many seats in the National Assembly?" asked Bangabandhu, laughingly.

Embarrassed, Bhutto responded that Bangabandhu could become president if he desired.

"No, I do not desire it, but I desire to go to Bangladesh as soon as possible," replied the father of the nation.

Bhutto then told him that he would make necessary arrangements but needed a few days. Bangabandhu told him that he had gathered, from the conversation between the lawyers who had attended his trial some months earlier, that Dr Kamal Hossain

was also held in custody awaiting trial. On Bangabandhu's request, Dr Kamal was also brought to Shihala.

According to a secret telegram sent from US Embassy in Pakistan to Secretary of State, the USA, on January 3, 1972, Bhutto shared with the US ambassador in Pakistan his conversation with Bangabandhu.

"Mujib had been virtually cut off from all outside sources of information while he (Mujib) assumed that a war of some major proportion had gone on, and that "perhaps a part of East Pakistan had been occupied by India," he had no idea of the magnitude of the "tragic defeat" which Pakistan had suffered," said the telegram.

It added that, "...Mujib seemed "almost stunned" by the changed circumstances in which he found himself, and appeared highly despondent to learn that Indian troops occupied all of the East. Bhutto also noted that during his conversation the Sheikh, referring to Indian occupation

The next few days were spent in pursing the request for arrangements to go to Bangladesh. It was clear that since over 90,000 Pakistani military personnel were prisoners of war in Bangladesh, this would ensure Bangabandhu's safety and early

Bangabandhu and Dr Kamal were told that they would be flown to London within the next few days; the night of 7 January was specifically

They were also informed that Bhutto would like to host a dinner for them at the President's Guest House before they leave.

Bhutto arrived and, after initial greetings, he requested Bangabandhu to maintain links with Pakistan.

"After what has happened, and the blood spilt which could have been avoided had you listened to us. Instead you unleashed a brutal armed assault. I cannot see how any relation with Pakistan is possible other than as between two sovereign states, Bangabandhu replied.

After Bhutto kept pressing him to consider his appeal, Bangabandhu said he would give him a reply after returning to Bangladesh.

Then Bhutto came up with an unexpected suggestion: that the departure be delayed till the following morning when the Shah of Iran was due and would like to meet Bangabandhu.

Bangabandhu turned to Bhutto and said that he should ensure permission for their flight to leave that night; insisting that he did not wish to meet the Shah, and that they should be transported back to jail immediately if their departure could not take place after dinner as scheduled.

Realising the annoyance caused, Bhutto said that a plane would be instructed to be flown over from Karachi to ensure their departure after

Bangabandhu and Dr Kamal Hossain were driven to the airport. Bangabandhu was escorted by Bhutto up to the plane. They were briefed that no announcement would be made about the plane journey until they were an hour away from London.

As they approached London, a message would be sent to the British authorities to say that Bangabandhu was due to land at London's Heathrow airport around seven in the morning.

## DU erupts in protest

She was raped and tortured there, some of her friends said, quoting her. regaining consciousness around 10:00pm, she somehow went to her friend's home and her friends

then took her to the DMCH. DU Proctor AKM Golam Rabbani visited her at the hospital early yesterday while Vice Chancellor Prof Akhtaruzzaman later in the morning. Talking to reporters, the VC said the university authorities would do everything necessary so that the victim gets justice.

Later in the day, DU students as well as members of different socio-cultural organisations came to the streets on the campus. They demanded that the government bring the rapist(s) to book immediately.

Many took to social media to express their anger at the lack of women safety in the country.

Rights body Ain O Salish Kendra condemned the rape incident and demanded legal steps against those involved. In a statement, the ASK said,

"Increasing violence against women has become one of the major concerns in our lives. "It is undoubtedly a weakness of the state that it cannot ensure the

environment conducive to women's safe movement." The rape took place days after the ASK said the number of rape incidents

in Bangladesh doubled last year from the previous one. A total of 1,413 women were either gang-raped or subjected to rape last

year. Of them, 76 were killed after rape and 10 others died by suicide, the rights body said in its annual report released on December 31. THE SCENE

Police identified the crime scene based on the victim's statement.

The place is several yards off the pavement of the busy Airport Road. It is about 150 yards north to the Kurmitola General Hospital's gate and 30 yards south to the gate of a golf club

The scene is outside the boundary net of the club and surrounded by bushes, several officials told this correspondent at the spot.

A guard stationed at the club told our correspondents that many people use the pavement during the daytime, but the number of the pedestrians go down at night.

Asked, he said he was not on duty when the incident took place. **EVIDENCE** 

Kazi Shahan Hoque, officer-in-charge of Cantonment Police Station, told this newspaper that they visited the scene around midnight Sunday, after being informed by the victim.

Finding some pieces of evidence, they informed the CID's crime unit, which collected them yesterday morning.

The evidence, included a gabardine pants, a piece of undergarment, a pen, a notebook, a key ring, two inhalers, wrist watch, and some medicines (for common cold-related disease), CID Inspector Aminul Islam told this

"We have already sent those to lab for tests," he said.

Chakraborty, commissioner (Gulshan Division) of the Dhaka Metropolitan Police, said apart from police personnel, members of other agencies were also working to find the culprit(s) and solve the case.

OC Shahan said the victim's statement suggest that she was raped by a single person.

Talking to this correspondent early today, he said they were yet to identify any suspect and that they collected the footage of the CCTVs installed in the area for investigation.



He said they found injury marks on her throat and it suggested someone tried to strangle her.

Two Rohingya men, suspected of being drug peddlers, were killed in a "gunfight" with members of Border Guard Bangladesh in Cox's Bazar early The dead are Mohamamd Ismail,

28, and Helal Uddin, 20, inhabitants of block-22 in Ukhiya Rohingya Refugee Haider Azad Ahmed, commanding officer of 34th BGB

## Ban single-use plastics findings of the National Geographic

soil fertility, agricultural production, human health and safety were violations of citizens' constitutional rights to life, health and environment. According to the DoE, Bangladesh

generates around 3,000 tonnes of plastic waste every day, the petition

A joint study carried out by the DoE and Waste Concern has found that 36 percent of plastic waste was formally recycled while 39 percent was dumped in landfills and the remaining 25 percent leaked into the environment, eventually flowing to the Bay of Bengal through the rivers.

According to the 2018 research

Channel, an American television channel, 300 different types of plastic goods end up in the Bay of Bengal via the Padma river.

The National Geographic study covered an area of 2,575 square kilometres from the Padma to the Bay of Bengal to reach this alarming conclusion, the rights organisations said in the writ petition, adding that in 2018 the United Nations Environment Programme (UNEP) had reported the dumping of 73,000 tonnes of plastic waste into the Bay of Bengal through the Padma, Jamuna and Meghna Rivers.

In the petition, they stated that according to a 2015 study by the tripled to 17.24 kg in 2017.

Waste Concern, a total of 821,250 tonnes of plastic waste were generated annually in urban hubs of Bangladesh, while some 207,685 tonnes were dumped in marine environments every year.

According to this study, 95 percent of the solid plastic waste generated in Dhaka comprise poly-packed including throwaways, bottles, polythene bags and sachets of fast food and non-food consumer goods such as toiletries, food items nd toothpastes.

The study also revealed that per capita annual consumption of plastic products in Dhaka was 5.56 kg in 2005, which has more than
