

# Government land grabbed

Habiganj Krishak League leader built illegal structures on 13 acres khas land

A local leader of Bangladesh Krishak League allegedly grabbed 13 acres of government land at Kachuarabda village in Habiganj's Baniachong upazila.

On Thursday, Assistant Commissioner (Land) Matiur Rahman Khan visited the spot and asked Habiganj Krishak League President Humayun Kabir Reza to remove his all illegal structures on the land within three days but the latter is yet to remove any structures.

The assistant commissioner (AC) took the step after one Jyotirmay Das, on behalf of local landless families in the village, filed a written complaint to the land minister on November 27.

Habiganj district administration leased out 13 acres of government land to local landless people in the area in 1988.

In 2010, a fierce clash took place between the landless people and the men of Kabir, also the former chairman of local union parishad, over grabbing of the land.

"Since then, the Krishak League leader continued threatening us to leave the land," said Jyotirmay Das, adding that Kabir built several illegal structures on the land.

Contacted, the Krishak League leader said "An orphanage and a madrasa were built on the land in public interest. I did not occupy any government land."

Upazila Nirbahi Officer (UNO) Mamun Khandaker said without genuine leaseholders, no one can build any structures on government land.

There is no scope of transferring the leased land to someone else, said the UNO.

The AC (land) said the government did not lease out the land to the Krishak League leader.

They will soon conduct an eviction drive to demolish the illegal structures on the government land, said AC Matiur Rahman.

## Trader fined for illegal sand lifting from Titas

A mobile court on Monday fined a trader for lifting sand illegally from the Titas river near Sheikh Hasina Titas Setu (bridge) at Charlohania village in Banchharampur upazila of the district.

Executive Magistrate Nasir Uddin Sarowar, also the upazila nirbahi officer (UNO), led the court.

Nasir Uddin said sand trader Saidul Islam was fined Tk 80,000.

Being informed that Saidul was lifting sand from the river the mobile court raided the bridge area and fined him, said the UNO.

On January 5, the High Court (HC) ordered the government to stop sand extraction from the Titas river near Sheikh Hasina Titas Setu in 48 hours in order to protect the eye-pleasant bridge and flow of the river.

Issuing a suomoto (voluntary) rule, the court asked the authorities concerned of the government to submit a report before it after complying with the directive in a month.

The HC came up with the order and rule following a report published on The Daily Star on December 25 last year under a headline "Illegal sand trade poses threat to Titas bridge".

# Human remains stolen from 22 graves in Mirzapur

After the discovery of theft of human remains from 42 graves in two graveyards in Dinajpur last week, 22 human remains were found to have been stolen from a graveyard in Mirzapur.

The 22 graves in Mirzapur, inside a century-old graveyard at Shabhulla village of Fatepur union, might have been dug out for skeletons between Tuesday night and early morning yesterday, said locals.

Humayun Talukder, president of the graveyard committee and also

former chairman of Fatepur Union Parishad, said affected relatives of the deceased as well as villagers were outraged by the discovery.

A few months back, thieves made off with several human remains from the same graveyard, he said, adding that the thieves might have taken advantage of lack of security lighting inside the graveyard and sharp fall in people's movement in the area due to extreme cold.

Saiful Islam, a ward member of the union parishad, said they petitioned the local Rural Electrification Bard office in 2018 for electric poles in the

graveyard area, but to no avail.

Mirzapur Police Station Officer-in-Charge Saidur Rahman said they received a complaint of the theft and already launched an investigation.

Human remains were also stolen from another graveyard in neighbouring village of Baniara in the same upazila several months ago.

Human skeletons are high in demand among medical students for their anatomy courses and organised gangs of criminals often steal human remains from graves for making a quick buck from the sale of skeletons.

## Youth found murdered

A hotel worker was found murdered in Panchbibi upazila of Joypurhat district yesterday.

The deceased was identified as Zihad Hossain, 35, son of Moznua Mia of Fiskarhat village in the upazila. He worked at Abdul Kalam Azad's hotel at Chanpara village.

Monsur Rahman, officer-in-charge (OC) of Panchbibi Police Station in Joypurhat, said Zihad went out of home to go to his workplace on Tuesday and since then he remained missing.

On information, police recovered the body from a potato field in the area yesterday morning, said the OC, adding that the body was sent to Joypurhat Modern Hospital for autopsy.

Criminals might have strangled the hotel worker, said the police official.

A murder case was filed, he said.
