### DNCC All candidates' info still not on EC site

It has been 14 days since councillor aspirants for the two Dhaka city corporations filed their affidavits and income statements, but the returning office of Dhaka North City Corporation (DNCC) polls is depriving voters of information about most councillor candidates.

Let alone information about affidavits and income statements, even names of councillor contenders have not been posted online, contradicting electoral code.

"There are posters of only the AL-backed incumbent councillor in my area. To know about other candidates, I visited the EC website but found nothing," said Azizur Rahman, a resident of ward-26 of DNCC.

Till 8:30pm last night, DNCC's returning office published affidavits and income statements of general councillor candidates in only 19 of 54 wards.

It also failed to disclose information of reserved seat candidates completely. Information of only seven out of 18 reserved seats were published till yesterday evening.

However, affidavits and other information of mayoral candidates of both city corporations have been published on the site.

According to the city corporation election operations manual, a massive publicity on affidavits should be carried out by the returning officer, so that voters can analyse information and choose the right candidate.

It has also directed the returning officer to publish affidavits and income statements of contenders on the Election Commission Secretariat website.

Mayor and councillor candidates submitted their affidavits, tax return files and income statements along with their nomination papers to the returning officers by December 31 last year.

The returning officers scrutinised the nomination papers on January 2. Two days later, the returning office of Dhaka South City Corporation (DSCC) polls published the information on the website. A couple of days later, they however removed the information and again made it public on the website on January 12 On the contrary, their counterpart -- the office of DNCC -- published information of only a few councillor candidates on January 12. On Monday, Sushashoner Jonno Nagorik (Shujan) wrote a letter to the secretary of Election Commission, to publish information of income and tax return of all candidates at the earliest.

# AL lawmakers continue to flout polls rules

Awami League lawmakers continue to violate electoral code of conduct by taking part in campaign and election-related activities for the party mayor candidates of Dhaka city corporation polls.

Yesterday, AL lawmaker Sadek Khan joined a street meeting in Agargaon area, seeking vote for party-nominated Dhaka North City Cooperation mayor candidate Atiqul Islam.

Atiqul was scheduled to be at "Shatadaal Complex" playground in the area, but he did not show up till noon. Meanwhile, Sadek Khan participated in

the campaign there. When journalists asked the MP why he joined the campaign violating polls

code, he replied, "I merely came to see the campaign. I won't participate in any activity." He left the place soon after the inquiries from

Asked, DNCC Returning Officer Abul Kashem said

if MPs participate in the electoral campaign, asking votes for the mayor or councillor candidates then it is of course a violation.

"However, I need to look into the matter whether he [Sadek Khan] participated in the campaign," he added. Though Atiqul was not available for comments, his

media coordinator Saifuddin Emon said, "He [Sadek Khan] just came to see the campaign as the area falls under his constituency. He did not seek votes."

On Saturday, Sadek Khan and another AL MP Aslamul Haque joined campaign for the same mayor candidate.

Awami League lawmakers are participating in the campaign and other electoral process, when the ruling party and Election Commission are at loggerheads over MPs participation

in the campaigns and election-related activities for Dhaka city polls -- slated for January 30. It began after AL on January 3 formed two committees



## A struggle for water

Patients, attendees suffer due to interrupted supply at Nat'l Institute of Cardiovascular Disease MOUDUD AHMMED SUJAN

As soon as the clock hits six in the morning, Salma jumps into action. She hurries towards the bathroom either to take a shower or save some water in a container.

But there's completion. Most of the time the 35-year-old has to wait for a long time before she can use the facility, since many others form a queue there, as running water has become sort of a precious commodity at the wards of staterun National Institute of Cardiovascular Disease (NICVD).

Salma has been staying at Ward-1 of the 414-bed specialised hospital with a patient for the last six months. The situation has been the same for as long as I have been here. From dawn to noon, there's no water at the washrooms. We do get some afterwards, that too at intervals," she told this correspondent recently.

"As soon as the supply starts, all of us stand in a queue to begin our day. Even patients have to wait in line. Water should be a basic amenity at a hospital but it's not the case here," she added.

Due to the crisis, patients and their attendees continue to suffer at the hospital. This interrupted water supply has also resulted in making the washrooms unhygienic.

But their sufferings do not just end there. There is also no source of drinking water at the wards.

"I have to spend around Tk 200 daily to buy water --SEE PAGE 4 COL 2

### DEMAND TO DEFER CITY POLLS DU students issue 18-hour ultimatum



Agitating students blockaded Shahbagh intersection yesterday for nearly two hours till 6:30pm yesterday.

Agitating students of Dhaka University yesterday blockaded Shahbagh intersection for nearly two hours, demanding deferment of Dhaka north and south city corporation polls, as it coincides with Saraswati Puja.

The protesters also issued an 18-hour ultimatum to meet their demand, and threatened to lay siege to the Election Commission office otherwise.

"We will besiege the election commission if they do not change the date of the polls within our given time frame," Utpal Biswash, vice president of Jagannath Hall union told The Daily Star.

Terming the decision contradictory to the constitution, he also demanded resignation of the officials concerned. Earlier, around 500 students of the university staged

a sit-in, blocking the capital's Shahbagh intersection at around 5pm.

Vehicular movement on the roads connecting to the



Dilip Kumar Sarker, central coordinator of Shujan, said there were no instances of such delay in publishing candidates' information in previous elections. "It's a kind of negligence of officials concerned," he said.

## Enamul, Rupon on four-day remand

A Dhaka court yesterday placed two alleged ringleaders of illegal casino business in the capital on four-day remand each, in connection with two separate money laundering cases.

Enamul Haque Enu, vice-president of Awami League Gendaria thana unit, was remanded in a case filed with Gendaria Police Station on September 25 last year, while Rupon Bhuiyan, joint general secretary of the same AL unit, was placed on remand in the case filed with Sutrapur Police Station on September 26.

The court also granted a three-day police remand to Sheikh Sunny Mostafa, an aide of the duo, in the laundering case filed with Gendaria Police Station.

Dhaka Metropolitan Magistrate Rajesh Chowdhury passed the order after Inspector Mehedi Maksud of Criminal Investigation Department (CID) of police produced the trio before the court with a 10-day remand prayer for each in the cases.

The CID on Monday arrested the trio from a flat in Dhaka's South Keraniganj, where Enamul and Rupon took shelter after failing to flee the country with forged passports

Enamul and Rupon, who allegedly ran a casino illegally in the capital's Motijheel, went into hiding after law enforcers launched a crackdown on illegal casinos, bars, and spas in September last year.

Wanderers Club, of which Enamul was the director, was raided by Rapid Action Battalion on September 18, the first day of the crackdown.

The two brothers have 22 houses and plots in the capital, five cars, and Tk 19.11 crore in 91 bank accounts frozen by the Bangladesh Bank, according to case dockets and police.

To operate the casinos, Enamul and Rupon hired several Nepalese nationals, law enforcers said, adding that the SEE PAGE 4 COL 1


