Russian govt resigns as Putin calls for reforms

Russia's government resigned in a shock announcement yesterday after President Vladimir Putin proposed a shake-up of the constitution. The announcement by

Putin's longtime ally Dmitry Medvedev came after the president used his annual state of the nation address to call for a nationwide vote on a package of constitutional

The resignation raises deep questions about the long-term shape of Russia's political system and the future of Putin, who is due to step down at the end of his fourth Kremlin term in 2024.

A few hours after the Russian leader's address, Medvedev and Putin appeared alongside each other on national television to say the government was stepping down.

Medvedev said the constitutional proposals would make significant changes to the country's balance of power and so "the government in its current form has resigned".

"We should provide the president of our country with the possibility to take all the necessary measures" to carry out the changes, Medvedev said. "All further decisions will be taken by the president."

Putin thanked Medvedev -- who also

for four years from 2008 expressing "satisfaction with the results that have been achieved.

The changes Putin proposed would transfer vesterdav more authority to parliament, including the power to choose

the prime minister and senior cabinet members, instead of the president as under the current system.

Other changes would see the role of regional governors enhanced and residency requirements tightened for presidential candidates.

"Today in our society there is a clear demand for change," Putin said in his address. "People want development, they are striving to move forward in their careers, in their education, in becoming prosperous."

The package of reforms would be put to a national vote, he said, without specifying when.

"We will be able to build a strong prosperous Russia only on the basis of respect for public opinion," the 67-yearold leader said.

Speculation has swirled about changes to Russia's political system that would allow Putin to stay on after 2024.

Some have suggested he could remain as a prime minister with increased powers or in a powerful behind-the-scenes role

caused adverse impacts on fishermen's livelihood," Hasina said.

greenhouse gas emission, she said.

Responding to another question

from AL MP Anwar Hossain Khan, Hasina said there are 40 transponders in Bangabandhu Satellite, and \$1 million to \$1.25 million could be earned a year from each transponder as per the present market rate.

Answering a query from AL MP AKM Rahmatullah, the PM said Bangabandhu's birth centenary celebrations would make it possible to share the life and work of the Father of the Nation in the international arena.

She mentioned that the Unesco is celebrating Bangabandhu's birth

"They [Unesco] did not make the decision considering Bangabandhu a political leader, rather they considered him a symbol of realising people's rights," Hasina said.

The PM added that she was very much fortunate that in 2020 the AL is in power and for this, the party got the chance to celebrate her father's birth

POLLS DATE COINCIDES WITH

Members of the Hindu community said the observance of Saraswati Puja will start at 9:10am on January 29 and continue till 11:00am on January 30 as per Loknath Panjika, a traditional annual Bangla calendar that the Hindus follow.

Saraswati Puja is observed at almost all educational institutions where worshippers gather to offer prayers. But things may be different this time in the capital as polling centres will be set up at different schools, colleges and

It will be difficult for worshippers to go to the educational institutions to observe the Puja as section 144 of the Criminal Procedure Code will be imposed in and around the polling centres, said Rana.

Several top officials at the EC Secretariat told this newspaper that they could set aside one or two rooms in each of the educational institutions on the polling day for the Hindus to

They also mentioned that the EC

may defer the polls date if it faces mounting pressure from all sides.

Members of the Hindu community were stunned by the EC announcement on December 22 that the election would be held on January 30.

They said many members of the community boycotted last year's Rangpur-3 by-polls as it was held on October 5, the second day of Durga

"Earlier, we had urged the EC to reschedule the Rangpur-3 by-polls but the commission did not pay heed to our demands," Rana said.

"We suspect that a vested quarter is trying to curb the constitutional rights of the minorities. It seems that the EC is unable to understand the issue of religious sensitivity.'

Rafiqul, however, said they fixed the election date keeping in mind that the Saraswati Puja, according to the government calendar, falls on January

"We also took the SSC exams schedule into consideration."

When an empty container arrives in the country, the shipping agent concerned submits a detailed list (called BL) to general bond section of the customs. An entry is also made into the server of

Empty containers do not require bill of entry, but customs officials can find out where a container is by searching their server and the BL.

Fakhrul However, commissioner of Chattogram Customs House, said they do not know the number of empty containers brought in or sent back with export goods, as import documents such as bill of entry or letter of credit are not required for empty containers.

He said while shipping agents must pay duty if any container is destroyed or sold, no money has ever been paid to customs for this. Yet, at various container selling shops

and workshops in Chattogram, this correspondent found at least 57 empty containers with tracking numbers. The tracking numbers of seven

containers was cross-checked by this correspondent with data on Chattogram port's server Container Terminal Management Service (CTMS).

CTMS showed that the containers entered Bangladesh between August 21, 2018, and June 24, 2019, and were shown to be at the port's yard. One of the containers (with tracking

number FCIU3138251) was found at the Ajmir Marine Enterprise's workshop in the port city's Nayabazar area. According to the CTMS and customs server, it was brought in by HR Shipping

Omar Faruk, secretary of Chattogram port, told The Daily Star that the port's server was not updated regularly. He said they would enquire how

the server was still showing wrong information on containers that were taken out of the port so long ago. "We will verify the information," he added.

About container FCIU3138251, Rakibul Islam, managing director of HR Shipping Lines, told The Daily Star, "This container might have been taken outside the port or the (inland container) depot but we do not know

He said sometimes a container can be destroyed, or sold at auction, when it arrives at its last destination after its expiry. However, that too must be done upon customs authority's permission and paying duty.

"Till date, we have not sold or destroyed any container," he claimed. Last year, an investigation into at

least 6,000 import consignments, some of which went missing and remained undelivered, revealed that shipping agents and owners of inland container depots were not following the customs' rules regarding containers.

The probe is still on and officials could not say how many containers were actually missing. Joint Commissioner of Customs

Shariful Hasan, who led the investigation, told The Daily Star that the general bond section of Customs House is not monitoring the containers and government is losing revenue due to lack of supervision.

Nitish Kumar Biswas, assistant commissioner of general bond section, and Swapan Kumar Bepari, revenue officer of the Customs House, told The Daily Star that they do not know anything about the 1999 order of the Customs House.

Swapan said most of the shipping

agents and private depot owners submit a list of containers transported from the port to the depots. But no verification is done to ensure if containers leaving the port actually ends up at the inland container depots.

The president of Bangladesh Inland Container Depots Association Nurul Qayuum Khan said depot owners were liable to pay compensation for any missing containers.

He said, "Till date, no shipping agents have ever complained about any missing containers. "We all know that empty containers

are taken outside the depot illegally and sold in the market but I do not know how this happens." He suspects that some of the 18

private depot owners as well as shipping agents could be involved.

Ahsanul Haque president of the Bangladesh Shipping Agent Association, maintains that empty containers are not being imported for sale. "Some quarters may be selling those

illegally," he said

Regarding the customs policy about selling containers, he opined that many people might not know about the order because it was old and that customs should reissue a circular to create awareness.

BOOMING BUSINESS

Jasim Uddin, proprietor of Ajmir Marine Enterprise, however, told The Daily Star that he buys all his containers from shipping agents.

"I do not know the law about empty containers. We buy empty containers from different shipping agents, who sell the containers unsuitable for carrying cargo with permission from the principal company (the main owner of the containers)," he said.

Usman Goni, who owns three container workshops in the capital's Farmgate, Kamalapur and Chattogram's Sadarghat area, asserted that the empty container trade could not be illegal since the money is transacted through banking channels. He claimed that the shipping

agents and the principal owners of the containers make contracts to bring these boxes to Bangladesh for resale. Seeking anonymity, a managing

director of a shipping agent company, admitted to selling containers to meet unaccounted shipping expenses. The MD said many shipping agents

and owners of private inland container depots were compelled to sell containers in the market, knowing that such sales were illegal, as shipping agents often have to bribe to get clearance for ships. Besides, they also have to bear the

cost of storing the containers at the port yard or inland container depots when importers do not take delivery of their consignments, the MD said.

Info minister meets Modi

Bangladesh Information Minister Hasan Mahmud was among the ministerial-level delegates from 12 countries who called on Indian Prime Minister Narendra Modi at his residence yesterday on the sidelines of the Raisina Dialogue.

Mahmud was invited with the others to meet Modi as a special gesture by India even though he was neither a speaker nor an attendee at the two-day Dialogue, a key event of the Indian External Affairs Ministry, which ended yesterday.

Mahmud, who was in Delhi for a meeting with Indian Information and Broadcasting Minister Prakash Javdekar, deferred his travel to Hyderabad to meet the Indian PM, diplomatic sources said.

Neither Bangladesh Foreign Minister AK Abdul Momen nor his deputy Shahriar Alam participated in the Raisina Dialogue though both were invited.

Mahmud later flew to Hyderabad where he would visit the Ramoji Film City to get some idea of it as Bangladesh is building Bangabandhu Film City in Gazipur and India has promised assistance on this score.

Among others who met Modi with Mahmud were Foreign Ministers of Iran, the Maldives, Latvia, Uzbekistan, Hungary, Czech Republic, Estonia, South Africa, Denmark, the Secretary General of the Commonwealth and the Secretary General of the Shanghai Cooperation Organisation.
