

Fresh cracks in JP leadership

Raushan appoints 16 to central posts, GM Quader snubs it

Rift between Jatiya Party Chairman GM Quader and the party's chief patron Raushan Ershad became evident yesterday again, after Raushan "appointed" 16 JP leaders including her son Saad Ershad to different toplevel posts of the party.

In a press release sent to the media, Raushan -- also leader of the opposition in the parliament -- said she appointed Saad and MA Sattar as the party's co-chairmen.

She also included 11 others -including Maj (retd) Khaled Akhter, Delowar Hossain, Raushan Ara Mannan and Mahjabeen Morshed -- in the JP presidium body, and gave Amanat Hossain and Md Yahiya the JP vice chairman posts.

Claiming that it was as per the power bestowed on her in the party's

Uddin Buiyan and Rejaul Karim as the party's joint secretary generals.

Immediately after Raushan's press release, Delowar Jalali, deputy press secretary of JP chairman GM Quader, in a counter release called upon all to ignore the one Raushan had sent. Urging media not to publish

"confusing news", Delowar said Raushan has no jurisdiction, according to the party charter, to appoint any leaders to any party post. He also said it is the party chairman

who has the authority to do so. GM Quader, younger brother of Ershad, did not respond to requests for comments over phone, despite

several attempts. The Daily Star also could not reach Raushan for her comments.

According to JP insiders, Raushan

A JP leader who Raushan included in the presidium body last night told this correspondent that he was not aware of his post

"Through media, I came to know

that I was made the JP presidium member," said the leader, a close relative of late founding chairman of the party HM Ershad. "Raushan madam's latest move is

a clear indication that rivalry between her and GM Quader has become open, which will definitely harm the party," he also said.

Party insiders said a section of JP leaders are backing Raushan to pit her against Quader to make Raushan the party's chairperson and tighten their grip in the party.

Cops foil students' EC march, Shahbagh blockaded yet again

DEMAND TO DEFER CITY POLLS

After failing to march towards the Election Commission (EC) office, a group of Dhaka University students yesterday blockaded the Shahbagh intersection for the second consecutive day, demanding deferment of Dhaka north and south city corporation elections scheduled for January 30 -- as it coincides with Saraswati Puja.

Holding placards, they gathered in front of the Raju Memorial Sculpture on DU campus around 11am, shouted slogans and held a brief rally there.

While speaking at the rally, spokesperson of the protest Utpal Biswas condemned the remarks made by Election Commission Senior Secretary Md Alamgir about holding polls on the day of puja.

Expressing solidarity, Assistant General Secretary of Dhaka University Central Students' Association Saddam Hussain threatened the authorities concerned to resist the polls if it is held on the day of Saraswati puja.

Later, agitating students began a march towards the Election Commission office in Agargaon, before they were stopped by police at Shahbagh. Students then blocked Shahbagh intersection at 1:50pm

and kept it blocked till 3pm to press home their demand. The agitators announced to stage sit-in in front of Raju Memorial Sculpture today and urged students of all the

educational institutes of Dhaka to hold protest programmes. On Wednesday, students had given an 18-hour ultimatum to the authorities concerned and threatened to

Withdraw comments endorsing crossfire at once'

Rights activists urge lawmakers

Rights activists yesterday expressed deep concern and frustration over parliament members' demands of killing rapists "in crossfires".

They said such remarks from the legislature will hinder establishment of rule of law in the country. It will also encourage a culture of impunity and increase the number of extrajudicial killings.

also demanded They parliamentarians withdraw 'injudicious" comments immediately.

Several senior lawmakers, from both the treasury and opposition benches, at Jatiya Sangsad on Tuesday said law enforcement agencies should "kill rapists in crossfires" to stop rape incidents, which have alarmingly increased in recent times.

Yesterday, in a press statement, Human

Rights Forum Bangladesh (HRFB) said the forum and its members were "stunned and outraged" after hearing such comments at the parliament, the highest legislature of

"When lawmakers ask to defy laws themselves, it will definitely impact the country's human rights situation and establishment of justice," said HRFB, a platform of rights activists.

Terming crossfires brutal and inhuman, the forum said law enforcement agencies have already developed a tendency of breaking laws and misusing their power by carrying out crossfires.

"The state visibly expressed its lack of confidence on its own judiciary [by favouring crossfire], which has put the efforts of establishing justice in danger," it added.

Tabith, Ishraque code violations

BNP's mayor candidate for Dhaka North City Corporation Tabith Awal yesterday complained that polls code is being violated incessantly but the Election Commission is not doing anything about it even after complaints were lodged in this regard.

"The Election Commission is encouraging people to break the electoral code of DHAKA CIT conduct," he alleged while campaigning in Badda.

Tabith said they submitted a written complaint to the EC on Monday in this regard but the EC is yet to cooperate. "The violation [of electoral code] is getting out of their [the EC] control," he told journalists.

complain of polls Info Commission must assert mandate: activists

The Information Commission has to play a pivotal role in upholding the true spirit of Right to Information (RTI) Act -- not only for people's empowerment but also for enhancing the government's image, noted RTI advocates said at a seminar in the capital yesterday.

"The Information Commission must assert its legal mandate to make public information accessible," said Md Abdul Halim, a Supreme Court advocate and RTI activist.

Halim pointed out to the chief information commissioner, present at the seminar, that neither the Supreme Court nor any lower court and tribunal across the country has a designated officer to facilitate disclosure of much-needed public information to justice seekers. Research Initiatives Bangladesh (RIB) organised the seminar on the

findings of a 15-month project titled "Advancing Accountability and Transparency through the RTI" at Cirdap auditorium. It was funded by National Endowment for Democracy. Project Coordinator Ruhi Naz in a presentation said a total of 4,700

RTI applications were filed under the project in view of government's commitment to Sustainable Development Goals and achievement of its seventh five-year national development plan, and created 70 RTI activists. Of the total applications, 58 percent received full and partial responses with information from various public offices, while 34 percent received no

response with eight percent are still pending, she said. Of the non-responded applications, 437 were forwarded to the appellate authorities and 57 to Information Commission as complaints, she added.
