Abrar Murder Decision on charge

A Dhaka court will decide on January 21 whether to accept the charges against 25 accused in connection with the killing of Buet student Abrar Fahad in October last year.

Judge KM Emrul Kayesh of Metropolitan Sessions Judge's Court set the date.

On January 13, the case was shifted to the court from Additional Chief Metropolitan Magistrate's Court.

Meanwhile, Morshed Amartya Islam, an accused in the case, surrendered before the court on Sunday. With him, 22 accused are now in jail.

On December 3, a Dhaka court ordered to confiscate property of four fugitives. The other fugitives are Morsheduzzaman Jishan, Mustafa Rafid and Ehtashamul Rabbi Tanim, all students of Buet.

On January 5, court asked police to publish ads in newspapers asking them to appear before it.

On November 18, it accepted charge sheet against the 25 accused and issued arrest warrant for the four.

Labour Migration

Zero-cost recruitment deal soon: Malaysia

Kuala Lumpur and Dhaka are close to finalising the zerocost recruitment agreement that will facilitate the hiring of Bangladeshis into the Southeast Asian country soon.

"I'm sending the Malaysia-Bangladesh Joint Working Group to Dhaka, Bangladesh, soon to iron out the remaining issues on the zero-cost recruitment agreement, said Malaysian Human Resources Minister M Kulasegaran.

"Almost all matters have been settled and we have come very close to finalising it," he was quoted by Malaysian newspaper the Malaysian Reserve yesterday.

"The Bangladeshi government has said they won't be sending workers without due compliance and there must be due compliance to the necessary provision, just like what we reached with Nepal," he added.

Malaysia, which is home to some eight lakh Bangladeshis, suspended labour recruitment from Bangladesh in September 2018 following allegations that a syndicate of 10 Bangladeshi agents -- with support from Malaysia -- controlled labour recruitment between 2016 and 2018, when recruitment cost went up to Tk 4 lakh.

Malaysia's previous government had insisted on a selection of the 10 Bangladeshi agents in the recruitment job, but the Mahathir-led government suspended it.

Last year, Malaysia signed a labour deal with Nepal, stipulating that workers will not have to pay any Employers are responsible for the recruitment service

charges, two-way airfare, visa fees, health check-up, security screening and levy charges.

Officials of Bangladesh and Malaysia met several times last year, but are yet to sign a new deal, though Malaysia

suffers from labour shortage in its industries.

Four top officials of Biman get bail

A Dhaka court yesterday granted ad-interim bail to four top incumbent and former officials of Biman Bangladesh Airlines, after they surrendered in a case filed over scam in recruiting 30 pilot cadets.

Judge KM Emrul Kayesh of Senior Special Judge's Court of Dhaka passed the order after the accused surrendered before the court and sought bail in the case.

The accused are former managing director Abul Munim Mosaddique Ahmed, flight operation director Capt Farhat Hasan Jamil, incumbent principal of Bangladesh Airlines Training Centre Partha Kumar Pandit, and manager (recruitment) Fakhrul Hossain Chowdhury.

On November 25 last year, ACC Assistant Director Saiful Islam filed the case with the ACC integrated district office against the four over the scam. The accused officials gave 30 cadet pilots "grace marks" and then manipulated viva exams to give them jobs, according to the case FIR.

Even before the tests, the then Biman authorities relaxed the minimum educational qualification and age limits to allow underqualified candidates to apply, it said, adding that one of the recruits is the nephew of Abul Munim Mosaddique Ahmed, who was forced to quit the state

Road accidents kill 8 ARMS CASE

At least eight people were killed and seven injured in road accidents across the country in the last two days, our correspondents and news agencies report.

In Rangpur, three people were killed and two injured after a collision between an ambulance and bus at Bachurbanda area of Taraganj upazila around 7am yesterday. The deceased are ambulance driver Rubel (30), and its passengers Biplob (20) and Shathi Akhtar (25), said police.
Biplob and Shathi died on the spot after the ambulance

collided with a bus of Dipjol Paribahan around 7am.

On information, police rushed the injured to Rangpur Medical College Hospital where Rubel was declared dead. Police seized the bus but its driver and helper fled.

In Jhenidah, at least two people were killed on the spot, including a minor, in separate road crashes yesterday. The deceased are Roni Ahmad (10), son of Bahazzel

Hossain; and Kamal Hossain (31). Rony was a fourth-grader of Govt Ghighati Primary School, and Kamal was a human-haulier driver.

In the district's Kaliganj upazila, Rony was playing near Kaliganj-Kotchandpur road. At one point, while he was crossing the road, a speeding microbus ran him over. In Moheshpur upazila, Kamal was driving a human

haulier. When he reached near Bazrapur village, a truck collided with his vehicle. In Mymensingh, bus helper Abul Hossain (40) was killed and five bus passengers were injured after it collided

with a truck at Kazir Shimla area of Trishal upazila around

7:30am yesterday. Quoting locals, police said the bus hit a truck from behind, injuring six people initially. They were rushed to Mymensingh Medical College

Hospital where doctors declared Abul dead. Police sent his body to the hospital's morgue for autopsy. Police seized both vehicles but their drivers fled. A case was lodged.

In Habiganj, Shajahan Mia (55), was killed after a speeding truck hit his motorbike at Kalimnagar area of Shaistaganj upazila on Tuesday evening, said police.

He was the general secretary of Habiganj Zila Truck-Tank-Lorry Workers Union. Locals rushed him to a hospital, where doctors referred

him to a hospital in Dhaka for better treatment. Shahjahan died around 1am on his way to Dhaka, they added.

In Pabna Sadar upazila, van driver Ebadot Ali (70) was killed on the spot after a collision between a truck and van at Naldah area on Tuesday noon, said police.

Police seized the truck and a case was filed in this connection.

Charges against Khalid Bhuiyan accepted

A Dhaka court yesterday took cognizance of charges against expelled Jubo League leader Khalid Mahmud Bhuiyan in connection with an arms case.

Judge KM Emrul Kayesh the Metropolitan Sessions Judge's Court of Dhaka accepted the charges against Khalid, now in jail, in his presence.

He also fixed February 12 for hearing on charge framing against Khalid.

On November 19 last year, Rab Assistant Superintendent of Police Belayet Hossain, also the case's investigation officer, submitted the charge sheet before the Chief Metropolitan Magistrate's Court of Dhaka.

Rab arrested Khalid, organising secretary of Jubo League's Dhaka south unit and also the president of Youngmen's Football Club, from his Gulshan residence on September 18, 2019 in the wake of the crackdown at a "casino" in the football club. Rab also seized arms, bullets and yaba pills from his residence.

League Iubo September 20 last year expelled Khalid. Later, four cases were filed against him -- three with Gulshan Police Station and one with Motijheel Police Station.

BCC dismantles illegal structure

Barishal City Corporation (BCC) yesterday demolished part of a building constructed encroaching a road in the city's Chawk

Bazar area. Imtiaz Mahmud Jewel, executive magistrate of BCC, led the eviction drive in the afternoon. He said the building was constructed on around eight-decimal land of the city corporation and the road connecting Port and Chawk Bazar areas. It was situated within a few yards of Nagar

Bhaban, he added. Jewel said during construction of the building last year, locals objected the move and BCC also issued a notice to the owner for encroaching pubic property.

"As the owner did not pay heed to the notice, we conducted the drive and knocked down the illegal portion of the structure," said Kazi Moazzem Hossain, administrative officer of BCC.

Owner of the building could not be contacted despite repeated attempts.

Rabab Fatima elected president of Unicef **Executive Board**

Ambassador Rabab Fatima, Bangladesh's Permanent Representative (PR) to the United Nations, has unanimously been elected president of the Unicef Executive Board at elections held on Tuesday at UN Headquarters Serving alongside her as vice presidents will be the PRs of Lithuania

and Morocco, and deputy PRs of Brazil and Switzerland, according to a message from the Bangladesh Permanent Mission at the UN. With this election, Bangladesh will be able to contribute further to

the UN's work, this time in providing strategic guidance to its agency specialising in children's causes. In her acceptance speech, the ambassador thanked board members

and assured Unicef that the new board will work hard to bring new ideas that can ensure the wellbeing of children and fight for their rights. Unicef Executive Director Henrietta H Fore welcomed the new president and said the agency looks forward to benefiting from her experience and wisdom.

Fore expressed optimism that Fatima would spearhead the bureau's guidance to the work of Unicef.

TEACHER RECRUITMENT HC stays results of

669 qualified

The High Court yesterday stayed the results of 669 qualified candidates from Nilphamari and Barguna districts in the government primary school teacher recruitment examinations for six months on charges of violation of relevant rules.

The court also issued a rule asking authorities concerned to explain in four weeks why the results published on December 24 last year should not be declared illegal.

The bench of Justice Sheikh Hassan Arif and Justice Md Mahmud Hassan Talukder came up with the order and rule following a writ petition filed challenging the results.

The process for recruitment of 266 candidates from Nilphamari and 403 candidates from Barguna -- who qualified in the examinations -- will remain halted for six months following the HC order, said Advocate Rezaul Karim, a lawyer for the petitioners.

He said as per Section 7 of the primary teacher recruitment rules 2013, 60 percent of such teachers will be appointed from female candidates, 20 percent from "posshya" (dependent) quota and 20 percent from male candidates. But the conditions were not followed, he said. He said 21 female

candidates, who qualified in the preliminary and written tests but their results were not published, collectively filed the petition on January 14
