Broken bridge lies unrepaired for 3yrs

Thousands of villagers are suffering a lot as a 150-foot-long bridge on Sutabaria canal in Patuakhali's Dashmina upazila has remained unused since a portion of the bridge collapsed over three years ago.

Especially school goers and critical patients are the worst sufferers as they have to cross the canal on a dinghy amid risk of

Locals said in 2016, a 25-foot-long portion of the bridge in Jamir Mridha Bazar area collapsed as a sand-laden cargo hit it. A girl was killed and five others were injured in the accident.

Since then the bridge has remained unused, causing immense sufferings to thousands of commuters, they said.

A source at Local Government Engineering Department (LGED) in Dashmina upazila said in 2014-15 fiscal year, the bridge was built at a cost of Tk 10 lakh to ease communication of nearby 11 villages with the upazila headquarters.

The villages include Mordana, Goromali, Jafrabad, Kharija, Betagi, Rambollov, Chingoria, Dabari, Chandrabaj and Tafalbaria in the upazila.

Md Hiron Ahmed, acting headmaster of Kharija Betagi High School, said a Patuakhali-bound sand-laden cargo from Galachipa upazila hit one of the pillars of the bridge while crossing the canal on December 14 in 2016. At the time, a portion

Since then students and local people have to cross the canal on dinghy amid risk of accident, Hiron said, adding that due to this, students' attendance in different schools of the area has thin.

There are 320 students at Kharija Betagi High School and 213 at Kharija Betagi Government Primary School in the bazar

Faria Sultana, health care service provider of a community clinic in the area, said a good number of patients visited the clinic before the bridge collapsed but now the number of patients has decreased.

Jahanagir Melkar, a trader of the bazar, said they have to face various problems to bring their goods to the markets of the upazila headquarters since the bridge became unfit to use about three years ago.

Despite repeated pleas, the authorities concerned are yet to take any steps to repair the bridge, said Md Mohibul Alam, chairman of Betagi Sankipuyr Union Md Nasir Uddin Pahloan, vice chairman

Upazila LGED Engineer Md Jahangir Alam said they have already written to the higher authorities for funds to repair the bridge but to no respond vet.

Carpeting of newly renovated road damaged

Locals allege low quality work of the LGED road in Lalmonirhat

The carpeting of newly renovated five-kilometre Mohiskhocha-Burirhat road in Lalmonirhat's Aditmari upazila is getting damaged as the work under Local Government Engineering Department (LGED) was done allegedly without doing sufficient strengthening work.

Meanwhile, the contractor has already received 95 percent of the bill although the road is yet to be handed over to the authorities concerned, said official sources of the LGED in Lalmonirhat.

Locals said the carpeting of the road has already got detached at places as the contractor did the work without maintaining the standard. Stipulated strengthening with Water Bound

Macadam (WBM) was not done while renovating the road, said a few stakeholders. As per schedule, the road was to be renovated

with three-inch thickness of WBM and 40-milimetre thickness of carpeting, LGED officials said. Contractor Abdul Hakim got the Tk 2.65 crore

work order from LGED and the construction work started in January last year. "I gave the work to sub-contractor Daud Ali and

he has done renovation of the road with the proper monitoring of the LGED engineer. If there is any fault in the work, Daud is responsible," Hakim

Asked about the matter, Daud Ali declined to talk with journalists about the renovation work of Mohishkhocha-Burirhat road.

He suggested that the LGED engineer concerned can say details about the matter.

Aditmari upazila LGED engineer Aminur Rahman remained silent when asked why the road was competed without stipulated WBM work.

Teesta char farmers see hope in spices

Cultivation of turmeric, ginger and other spices, alongside other primary crops, are gaining popularity in the Teesta river chars of Sundarganj upazila.

Farmers said they have been growing spices alongside conventional crops as market prices of spices are higher than that of the conventional ones.

Among the spices, cultivation of turmeric and ginger has been more profitable as their prices continued to rise considerably since onion prices hit a record high across the country last year, they also said.

In order to take advantage of the higher prices, farmers in Ramjibon, Bamondanga, Sarbanando and Tarapur unions are growing turmeric and ginger on more than twice as much land that they used in the previous years.

According to the Department of Agricultural Extension, 35 to 40 maunds of turmeric and 25 to 30 maunds of ginger can be harvested from one bigha of land

While visiting Bhabanipur village in Ramjibon this season, he also said

union, farmer Ashraf Ali said he had been growing turmeric on two bighas of land for the last five years and made Tk 1.40 lakh each year from the sale of unripe turmeric. But this year, encouraged by the higher prices, he cultivated turmeric on three bighas of land.

"This season, price of unripe turmeric reached Tk 80 per kilogram at retail markets. So, I'm hoping to make nearly Tk 2.50 lakh from its sale," he added.

Rafiqul Mia, a vegetable vendor at Ramjibon market, said spices like turmeric and ginger used to be cultivated on unused land around dwellings of framers. But now that prices of those have increased significantly at the markets, the spices are being grown on croplands too.

Sundarganj Upazila Agriculture Officer Syed Reza-e-Mahmud said in comparison with years before, cultivation of turmeric and ginger doubled in the upazila this year.

Turmeric has been cultivated on 60 hectares of land and ginger on 50 hectares
