develop balu mohals near bridges, the letter added. If necessary, measures to evict brick kilns erected in

these locations should be undertaken, the letter also said. The ministry also asked to ensure proper drainage of rain water so that trapped water cannot cause damage to bridges, culverts and roads.

There are 4,404 bridges and 14,814 culverts in RHD's 22,096-kilometre road network across the country, according to the 2018-19 annual report of the RHD.

#### WHY IS SAND LIFTING A SERIOUS ISSUE?

Shishir Kanti Routh, additional chief engineer of RHD, said when a bridge is constructed, it blocks the natural flow of a river, which is why scouring -- weakening of the soil underneath the piers -- takes place.

This is why a hydro-morphological study is conducted during the design stages of a bridge to keep scouring at a minimum and protect piers.

However, sand lifting near bridges increases the probability of deeper scouring and, in turn, increases the vulnerability of bridges.

Asked how the RHD takes steps against sand lifting,, Shishir said RHD officials monitor it and inform local administration

Contacted, RHD Chief Engineer Ashraful Alam said in many cases, local RHD officials are unable to do carry out this task due to pressure from influential quarters.

"However, these ministry directives will embolden them (local officials). We will now seek more help from the administration and police. We are going to intensify our effort with the new directives," Shishir Kanti Routh said.

#### THE BALU MOHAL SITUATION

There are 707 balu mohals across the country. Of them, 126 are in Dhaka, 200 in Chattogram, 75 in Rajshahi, 94 in Sylhet, 65 in Rangpur, 57 each in Khulna and Barishal and 33 in Mymensingh division, according to land ministry.

DC offices lease out these balu mohals to interested parties. However, many people lift sand from undesignated places too, some of these places too close to bridges.

Shishir Kanti Routh said the local administration, in many cases, gives lease of balu mohal near bridges without understanding its risk. "So, they [local administration] should take consent from us [local RHD officials] before issuing a lease," he told The Daily Star.

He said issues in a single bridge due to sand lifting can collapse a road network consisting of 50 to 100 bridges.

hearing arguments from counsels of the writ petitioner and Tabith Awal.

Tabith's lawyer Barrister Rokanuddin Mahmud told The Daily Star that there is no legal bar for his client to continue contesting as a mayoral candidate in the upcoming DNCC election following the HC order.

AHM Shamsuddin Choudhury Manik, a former judge of the Appellate Division of the Supreme Court, who filed the writ petition, told The Daily Star that he will move an appeal before the Appellate Division challenging the HC order, and seeking cancellation of Tabith Awal's candidacy.

Justice Shamsuddin submitted the petition to the HC on January 26 for its directive on the EC to probe the allegation against Tabith Awal of concealing information about in his wealth in Singapore in his affidavit submitted to the EC, and to cancel his candidature if the allegation is found true.

During yesterday's hearing, petitioner's lawyer Qumrul Haque Siddique told the court that Tabith Awal and two others have a private company named NFM Energy Singapore Ltd in Singapore, but Tabith Awal did not mention it in his affidavit,

which is a violation of the rules and laws

Advocate Qumrul requested the HC to order the EC to inquire the allegation against Tabith and to submit the inquiry report before this court.

Meanwhile, Rokanuddin Mahmud opposed the writ petition saying the documents submitted by the writ petitioner are not original, as those where downloaded through a computer.

He requested the HC not to entertain the writ petition, as the schedule for the DNCC election has already been declared and there are only four days left before the

Barrister Rokanuddin cited article 125(c) of the constitution that says, "A court shall not pass any order or direction, ad interim or otherwise, in relation to an election for which schedule has been announced, unless the Election Commission has been given reasonable notice and an opportunity

The lawyer also said the writ petitioner has no locus standi (right or capacity to bring an action or to appear in a court) to move such a petition, as he (Justice Shamsuddin) is not contesting the upcoming DNCC election.

the circular on its website to recruit manpower. It apparently disheartened many BCL leaders, who

wanted the jobs for themselves, said teachers, wishing anonymity. The teachers also alleged that BCL leaders had been pressurising the authorities for the last couple of months to publish the circular, even though they do not meet many criteria to apply for those.

After seeing the circular, BCL activists went on a rampage in the evening. They broke window panes of buildings, held demonstrations and early yesterday foiled the orientation programme, said witnesses.

They also locked the administration building and brought out multiple processions under two factions.

Both factions, however, said they were protesting on behalf of general students. One faction said the groups were rallying to realise their 13- and 11-point demands. The demands include immediate solution to shortage of classrooms and laboratory facilities, reducing various fees, increasing transportation facilities and dorms for students and removing officials with BNP-Jamaat connection.

The both factions also threatened to go for tougher protests if their demands are not met.

Teachers, however, said BCL activists were using the demands as a "shield", and are creating chaos on the campus to put pressure on the authorities to republish the

Contacted, Rony and Pallab Hossain, leaders of the factions, said they have no interest in the job circular and were staging demonstrations for the betterment of the university and students.

When asked if they were protesting for students' welfare then why they foiled the orientation event, both denied their involvement.

Confirming the day's incidents, Registrar Prof Fazlul Haque said a tense situation was prevailing on the campus following BCL demonstrations. "We had no other option but to cancel the orientation to avoid any untoward incident," he added.

He said they will not hold a joint event for the new students. "Rather, all departments will arrange individual orientation programmes as early as possible and students will be notified beforehand through our website," said the registrar. He, however, did not want to say anything regarding the job circular.

Regarding BCL demands, he said the university authorities will hold a meeting in this regard soon. Despite repeated attempts, Vice Chancellor Prof Dr M Abul Kashem could not be contacted for comments.

changing... if we have proper team and equipment, it will help our investigation," said the CT official.

Polash Kanti Nath, additional deputy commissioner of CT unit, said, "A proposal for Cyber Lab has been sent to the ministry and the US embassy representatives informed us that the ministry has given a green signal." The next course of action will be taken as per the project plan, he added.

According to police, there are two cyber labs -- one in Criminal Investigation Department (CID) and other in Counter Terrorism and Transnational Crime (CTTU) unit of Dhaka Metropolitan Police (DMP).

CID has a Digital Forensic Lab, which was installed in 2012 and officially inaugurated in 2017 while CTTU's lab was set up on October 15, 2019.

Korean International Cooperation Agency funded the CID's lab under Enhancing Cybercrime Investigation Capability of Bangladesh Police (2013-2016) while ATA funded the CTTU's lab under Standard Operational Procedure (SOP) system.
