The other reasons include malfunction of railway engines, breaking of rail lines, disruption of telephone systems, derailment, disruption of rail movement

The minister said this in reply to a query from Workers Party MP Lutfun Nesa Khan.

The minister said the government has taken various initiatives so that railway staff can carry out their responsibilities more consciously.

"Besides, actions are being taken against staffers who were responsible for the train accidents," the minister also said.

"Guided by the ideology of the Father of the Nation and constitutional pledge, Bangladesh is committed to uplifting human rights of every citizen in providing a better life, food, shelter, security, employment, education, free mobility, and rights to enjoy their inalienable rights," he said.

Momen said the government has prioritised human rights, especially by creating opportunities for all, irrespective of race, ethnicity, color, religion, caste or/and background.

eight months to finish the initial project, with a budget of just around Tk 25,000. "Robotics is an expensive hobby, but Robin was made with minimal costs, which proves that making such robots is quite affordable for everyone," he said.

Making Robin was not only affordable but accessible as well. Shuvo managed to acquire all the hardware from local shops in Dhaka and Barishal, and the biggest market of all - online.

But Robin isn't all talk and no action;

it has several useful features. "Robin is a

self-learning robot that can learn by itself," Shuvo explained. The robot uses machinelearning algorithms to process information. One notable feature relies on a sensor installed inside Robin that can detect signs

of fire and send location information to the nearest fire service office via Google Maps. But that's not all. Robin is also a treasure trove of information. It can interact with children to teach them the basics of multiple subjects and can provide valuable insights to

farmers on how to care for their crops. "I'm working to improve Robin even further. The robot doesn't have eyesight at the moment and moves using its wheels.

But in future, it will be able to walk and see everyone," Shuvo hoped.

For Shuvo, this fascination with science and technology goes way back. "I have been immersed in these subjects from an early age, and I used to daydream about new technologies and scientific breakthroughs,

And he was rewarded for this very fascination in many instances of his life. For his multiple accolades, Shuvo received an award from Dr Dipu Moni on July 5 last year and another at the National Children's Prize held in 2018. He was also honoured with an award from Science and Technology Affairs Minister Yeafesh Osman at The National Science and Technology Fair on June 26, 2018.
