Eight killed, three injured in road accidents

Four die in M'singh alone

Eight people were killed and three injured in road accidents in four districts during the last two days, according to reports from our correspondents.

In Mymensingh, a bus and a batteryrun auto-rickshaw collided head-on in Gouripur upazila yesterday, leaving four people dead and two injured.

Police said the auto-rickshaw was going to the upazila headquarters while the bus to Kishoreganj from Mymensingh. The accident took place on Mymensingh-Kishoreganj road at Char Sreerampur

The deceased were identified as Rabeya Khatun (75), Shahara Banu (62), Lal Mia (50) and Rafiqul Islam (55).

The four were from Gouripur's Bangnamari Ujan Kashirchar. They were travelling to the upazila headquarters in the auto-rickshaw

Of the victims, Rabeya died on the spot and the other three succumbed to their injuries at Mymensingh Medical College Hospital, said Gouripur Police Station Officer-in-Charge Md Borhan Uddin

The injured -- Jomila Khatun (63) and Sweety Akter (11) -- were undergoing treatment at the hospital, said the OC.

Police seized the bus but its driver managed to flee the scene.

In Fairdpur, a schoolboy was killed as a truck ran him over while he was crossing a road at Bastola in Madhukhali upazila around noon yesterday.

The victim -- Siam Sheikh (7), son of Jinnat Sheikh from Madhukhali's Shreepur · was a local primary school student, said

Siam was initially rushed to Madhukhali Upazila Health Complex from where he was referred to Faridpur Medical College Hospital. He died on the way to the hospital, police added.

In Gopalgani, a motorbike rider and a pedestrian were killed and another was injured as the motorcycle hit the walker at

Debgram in Sadar upazila on Tuesday. The deceased were identified as Rajib Sheikh (22), son of Tipu Sheikh from Vennabari; and Jinnat Mollah (65) from

Debgram in the upazila. The accident happened while Rajib was riding the motorcycle and Jinnat was crossing a road, said Tanvir Ahamad, subinspector of Sadar Police Station.

The injured -- Abdur Rahman who was Rajib's pillion passenger -- was undergoing treatment at Gopalganj General Hospital.

In Jashore, two people were killed in separate road accidents yesterday.

In one incident, Sahabur Mia (45) was killed as two pickups collided in Natunhat, said Kotwali Police Station OC Sheikh Tasmim Alam.

In another incident, a bicyclist named Mohiuddin Mollah (50) died after a pickup hit him on Bahadurpur road in Sadar upazila on the same day, said the officer-

Journos must evolve to keep | Pay no heed to up with changes: speakers

Online course on media law, digital safety launched

In the age of social media, the risks that affect journalists also affect citizens, speakers said at the launch of an online course on media law, media ethics and digital rights at hotel Amari Dhaka yesterday, a press release said.

UK-based rights body Article 19 and German media development organisation DW Akademie launched the platform as part of a project funded by Germany's Federal Ministry for Economic Cooperation and Development (BMZ).

"In the age of social media, the difference between journalists and nonjournalists have become blurred. Police can arrest me for posting a status update on Facebook," said Faruq Faisel, regional director Bangladesh and South Asia for Article 19, at the programme.

Referring to the recently-passed Digital Security Act, he said along with journalists, rights activists and bloggers must also be

aware of digital rights and laws.

Dr Asif Nazrul, one of the designers of the course, said, "Journalism has become difficult. We have seen attacks on the judiciary, and misuse of information technology [in recent times]. We were fully aware of this when designing the course. We designed it with the aim of promoting safe, smart and responsible journalism."

ROAD CONSTRUCTION PROJECT

question paper leak rumours: Dipu Moni Tk 10.38cr for damaging hills

The Department of Environment (DoE) yesterday fined Chattogram Development Authority (CDA) Tk 10.38 crore on charges of damaging environment and binding capacity of hills in a road construction

The fine was slapped following a hearing at DoE headquarters, said Abdullah Al Mamun, deputy director of DoE (enforcement).

CDA, a government organisation under the public works ministry, did not comply with its own plan submitted to the DoE to cut hills, said the official. They put the whole project area at risk of landslide, he said.

AKM Rafique Ahammed, director general of DoE in Chattogram, told The Daily Star that he along with a team visited the Bayezid Bostami area, where CDA was constructing a road titled "Link Road from Dhaka Trunk Road to Bayezid Bostami Road including loop road at the periphery

To implement the project, they cut hills indiscriminately exposing the area to landslide during the upcoming monsoon, According to the plan, "The CDA was

granted to cut 2.5 lakh cubic metres of hills but they cut 10.3 lakh cubic metres, which is unprecedented," he added. CDA cut hills in 90 degree angle, whereas

it was asked to follow a 26 degree angle at best, said the official. Earlier in 2016, the CDA started the road

construction project without any clearance from DoE. At that time, DoE fined it Tk 10 akh, said DG Rafique Ahammed.

Later, the development agency submitted its plan to the DoE, he said.

The latest fine came as the CDA defied the plan, he added.

This correspondent tried to reach Rajib Das, project director of the road construction project. But his phone was found switched off despite multiple attempts.

Appoint 117 doctors | Constituency-Based Development to prisons now: HC

The High Court yesterday directed authorities concerned of the government to immediately appoint doctors to fill the 117 vacant posts in prisons across the country.

The court also ordered the director general of Directorate of Health Services (DGHS) to submit a report before it within a month after complying with the order. The bench of Justice FRM Nazmul

Ahasan and Justice KM Kamrul Kader gave the order while hearing a writ petition filed by Supreme Court lawyer Md JR Khan Robin on February 19 last year, seeking its order to allow recruitment of doctors. Deputy Attorney General Abdullah Al

Mahmud Bashar submitted two reports

prepared by the DG of DGHS and office of inspector general (IG) of prisons, showing that there are 117 posts of doctors vacant in 68 prisons across the country. In response to an HC query, DAG Bashar

said the government had issued show cause notices to 16 doctors who did not join the posts despite directives to do so. Five doctors gave satisfactory answers

to the notice, and departmental cases were filed against the other 11, as their replies were not satisfactory, he told the court.

Approval of fresh project involving Tk 20cr underway

LGRD Minister Tazul Islam yesterday told parliament that a new project is underway for approval allocating Tk 20 crore in each constituency to conduct development works as per the recommendations of local lawmakers in their areas.

Replying to a query from Jatiya Party MP Nazma Akther of reserved seat, the minister said, "It is under process to approve a new project over important rural infrastructure development on priority basis -- keeping allocation of Tk 20 crore at each electoral constituency. In a scripted answer, the LGRD minister said the development activities

will be implemented as per the recommendations of local lawmakers. "Allocations on the basis of constituencies will be provided following project approval," he said.

Tazul İslam said a project -- "Important rural infrastructure development

on priority basis" at Tk 20 crore for every constituency -- is currently going on, which will expire this year. Responding to a query from BNP lawmaker Rumeen Farhana, the LGRD minister said the government has no immediate plans to establish

city government in Dhaka and other big cities. In reply to another query from Mouazzam Hossain Ratan from Sunamganj-1, Tazul said the government has prepared a list of 2,502 hawkers so that movement of vehicles and people are not obstructed by them. The minister, in his written reply, however, did not give details in this regard.

He said the government has introduced six holiday markets on SEE PAGE 4 COL 4

Ex-DIG prisons Bazlur denied bail in graft case

The High Court yesterday denied bail to suspended department of prisons Deputy Inspector General (DIG) Bazlur Rashid in connection with a corruption case. The case was filed over amassing Tk 3.08 crore beyond the known source of his income.

The court also directed the Anti-Corruption Commission (ACC) to finish probe into the charge within six months.

The bench of Justice Md Nazrul Islam Talukder and Justice KM Hafizul Alam passed the order after rejecting a petition filed by Bazlur Rashid seeking bail in the case. Deputy Attorney General AKM Amin Uddin Manik said Bazlur cannot get released from jail following the HC order.

The HC bench observed his alleged transactions to be similar to a "white colour crime", ACC's lawyer Khurshid Alam Khan told The Daily Star.

This correspondent tried to contact

Bazlur's lawyer Advocate Abdul Matin Khasru for comments, but his cellphone was found switched off. The ACC arrested Bazlur Rashid in the

case -- filed with ACC's Integrated District Office -- and showed him arrested in the case on October 20 last year.

The following day, the home ministry suspended him from service.

According to the case statement, Bazlur signed a contract with a real estate company in 2018 to buy a flat in the capital's Siddeshwari Road area at Tk 3.09

Through April 20, 2018 to June 7, 2018 Bazlur paid Tk 3.08 crore in cash and cheque, but during ACC officials' interrogation, he could not show any legal source of the money.

According to his bio, Bazlur joined the service as a jail super in 1993. He was promoted to DIG prisons in 2013 and transferred to Dhaka in 2016.
