Recovered railway land under illegal occupiers in two months

Hardly two months after recovery from illegal occupiers, a large area of Bangladesh Railway's (BR) land near Sreemangal station in Moulvibazar is again under the grabbers' possession.

The BR authorities on November 27 last year recovered 2.75 acres of land after removing 300 shops made by illegal occupiers in the area.

BR's Estate Officer Nazrul Islam, accompanied by Sreemangal Upazila Nirbahi Officer (UNO) Nazrul Islam and Assistant Commissioner (Land) Md Mahmudur Rahman, led the operation.

the former occupiers became active anonymity. again and about 2.50 acres of land has been re-occupied by now.

Visiting the spot a couple of days ago, this correspondent found that shops with signboards marking various items, including furniture, soft drinks, cigarettes, mobile recharge devices, and railway. even construction materials, are filling up the railway land.

"I built a shop at my previously occupied place as others are doing so. If I did not take the possession, it would have been occupied by some others. If the railway authorities conduct drive again, we will move But only a few days after the drive, away," said an occupant seeking to the present market value.

Earlier, BR's attempts to recover the land on several occasions failed.

Rupashpur Mouza, adjoining the east side of Bhanugach Road in Sreemangal Station area, comprises 287 decimals of land owned by the

Several years ago, some local influential people occupied 135 decimals of the land in the name of "Muktijoddha Sangsad Krishi and Nursery project".

Besides, over a hundred traders illegally built shops on the rest 152 decimals of land, worth about Tk 65 crore according

Contacted, Aslam Mia, one of the alleged occupiers under the banner of the said nursery, said, "I don't know about the matter. Some people want to tarnish my image."

The government is being deprived of huge revenue due to the illegal occupation of the railway land.

The BR authorities in 1981 allocated 182 plots of the land in Sreemangal to lessees through tender.

But the authorities could not hand over the possession of the plots to the people concerned as complexities arose due to filing of a series of cases by several occupants who prepared fake documents in collusion with a jurisdiction.

the cases and issued a rule in favour of Bangladesh Railway, but the illegal occupiers continued to stay.

railway authorities launched a drive to remove illegal set-ups including the nursery but the occupiers, holding a banner inscribed with pictures of Bangabandhu and names of freedom fighters, foiled the drive, said the stakeholders.

Sreemangal UNO Nazrul Islam said it is the responsibility of the railway authorities to free the land under their

"When they conducted the drive Later the High Court dismissed all to free the land two months ago, we administrative officials served as magistrates. Now the place is being occupied again. We will inform On October 16 in 2016, the the railway officials and extend cooperation if they want to evict the illegal occupiers again," he said.

Railway Division's Estate Officer Nazrul Islam said, "Two months ago, we recovered the land from people who had kept it under illegal occupation for long. As attempts are being made to re-occupy the land, I have informed my higher authorities and they have decided to file a case against the perpetrators."

RAPE OF 3 SCHOOLGIRLS Another arrestee confesses crime

OUR CORRESPONDENT, Tangail

Another arrestee gave statement to the court in Tangail yesterday admitting his involvement with Sunday's rape of three schoolgirls in Ghatail upazila.

Police produced the arrestee, Mohammad Russel, 22, son of Shukur Mahmud of Sandhanpur Modhyapara village in the upazila, to the court in the afternoon, said Tanvir Ahmed, court inspector in Tangail.

Senior Judicial Magistrate Farzana Hasanat recorded his confessional statement under Section 164, he added.

Earlier on Tuesday, police produced three other accused of the case -- Yusuf Ali, Babul alias Sabuj and Sujon -- to the court.

Yusuf, 30, and Babul, 35, of Satkua village, gave confessional statements to Senior Judicial Magistrates Sumon Kumar Karmokar and Ariful Islam respectively under Section 164, admitting their involvement with the incident.

On the same day, Senor Judicial Magistrates Nawrin Mahbub and Farzana Hasanat in Tangail recorded statements of four girls including the three rape victims, the court inspector added.

The four girls, Class IX students of a school in Ghatail, along with two boys went to Jharka in the upazila by a three-wheeler on Sunday noon.

A group of locals confined them in Satkua area and drove away the two boys after beating them.

Later, three of the group raped three girls while one girl could escape as she seemed known to one of the criminals.

Informed by the guardians, a police team recued the girls and took them to Ghatail Police Station the same night.

Father of one of the victim girls filed a case with the police station against seven unnamed people under Women and Children Repression Prevention Act on Monday and police arrested four people in connection with the incident the same day.
