The main objective of the technical agent (Consulting Firm) services is to support IMED in examining completeness of data, results verification of specific DLIs as per verification protocols and preparing reports on actual results achieved and providing constructive feedbacks to the IMED.

The Implementation Monitoring & Evaluation Division (IMED) now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. - General experience of the Firm(s);
- Experience in similar projects of compatible size, complexity and technical specialty in the required area;
- Financial soundness of the firm; and
- Staffing and logistics of the firm.

Consultants are requested to submit the following supporting documents in support of the above-mentioned criteria:

- Registration paper of the firm(s);
- JV agreement/letter of intent (if applicable);
- Firm's brochure;
- Audited financial reports for last three years;
- service experience record (including nature, total cost, total input in terms of man month, employer, location of service etc.). Key Experts will not be evaluated at the shortlisting stage.
