Students suffer for want of permanent campus

Nilphamari Medical College, that was established two years ago, is yet to get its permanent campus to run the academic and administrative activities.

The medical college is now running its activities on three-storey extension building of Nilphamari Diabetic Association beside Nilphamari-Domar road at Palashbari village in Sadar upazila as the construction work of the permanent infrastructure at the college is still under process.

"The authorities have given us to use the building without rent," said Dr Md Rabiul Islam Shah, principal of the college.

A total of 50 students from the national merit list got admitted to the medical college for second time in January this year but the college is yet to get its permanent campus, he said.

At the end of 2018, the prime minister had given final recommendation to set up five new medical colleges in Nilphamari, Chandpur, Naogaon, Netrakona and Magura. After the announcement, the health ministry

started functioning of Nilphamari Medical College by admitting 50 students. The first batch of students is now promoted to second year.

Initially, the government appointed 12 teachers, including the principal, and a few officials besides allocating some furniture, practical instruments, projector and 800 books for library, said the accountant of the medical college.

Primarily, the medical college started its academic activities on the ground floor of the 250-bed Sadar Hospital in the district town, said principal Rabiul Islam, adding, that later

Nilphamari Diabetic Association, a local voluntary organisation, gave them to use its three-storey extension building without rent.

The second floor of the building is being used as a male students' hostel while local guest house of Danish-Bangladesh Leprosy Mission as girls' hostel, he said.

"At initial stage, the authorities of Palashbari Degree College and Palashbari Girls' School also provided us benches and tables to run classes," said the principal.

Mujibul Huque Chowdhury Shahin, secretary of Nilphamari Diabetic Association, said "We have allowed Nilphamari Medical College to use our extension building free of cost until its new infrastructure is constructed."

Civil Surgeon Ranjit Kumar Barman said when the first batch of students will be promoted to third year in 2021, the students will be given opportunity to attend practical classes in 250-bed modernised hospital.

Second-year student Md Imran Hossain said "We are suffering for want of a wellequipped laboratory but we are very happy to see our teachers' sincere effort."

Commissioner Rahman Chowdhury said process is on to acquire 30 acres land near the present temporary campus to construct permanent infrastructure.

Director General of the Directorate General of Health Services Dr Abul Kalam Azad said health directorate in collaboration with respective departments will soon submit a development project proposal to the Executive Committee of the National Economic Council (Ecnec) for approval.

Aminur's cost-effective 'mobile' duck farm pays off

Aminur Rahman of Gachhpara Kamrangaon village in Tangail's Delduar upazila has found a more profitable way of duck rearing, which requires him to shift the birds to a different place twice or thrice a year, depending on availability of water in waterbodies.

He started the farm with a thousand ducks around a year ago at a waterbody near his fatherin-law's house at Shikderbari village in the upazila.

"When the waterbody dried up after a couple of months, I shifted the ducks to a beel (waterbody) near my village home at Kamrangaon in Fazilhati union. A few days ago, I shifted those to the Dhaleswari river at adjacent Elasin union," he said.

About a decade ago, Aminur, then engaged in wheat business, started buying a duck almost every day. The number of the birds later rose to 165 and Aminur realized that duck rearing would be a profitable business.

However, he closed his business and went to Saudi Arabia with a job. He returned after a couple of years as the income there was not

He later went to Singapore and worked there for a few years.

Over a year ago, Aminur returned to the country with a plan to start duck farming on a

He bought 1000 Jinding and Khaki Campbell varieties of duck chicks for Tk 35,000 and started rearing those at Shikderbari. Beside the waterbody, he made a makeshift structure, where he stayed and kept feed and vaccines for the

"Within four months, the ducks started giving eggs. I get 300 to 350 eggs from my ducks every day and sell it for at least Tk 1000 per hundred to local wholesalers," he said. "I have got around Tk 5 lakh by selling eggs

in the last five months while I had to spend Tk 2 lakh during the period for running the trade," he said. "As my ducks eat natural foods from

waterbodies, I don't have to spend much for buying other feed, usually made with wheat dust, chaff and paddy, for them," he said, adding that the price of his 1000 ducks is Tk

Aminur's wife Bipul Begum said she helps her husband in rearing the ducks. "I have received training on duck rearing for 38 days in two phases from the livestock department. I can provide primary treatment to the ducks of the farm," she said.

"Now our family is running better than when my husband lived abroad for earning," she

It will be easier for people, especially unemployed youths to engage in profitable duck farming if the livestock department provides them necessary training and arrange free vaccinations for ducks, Aminur said.

Appreciating Aminur's 'mobile' duck farm, Dr Mohammad Ali, a veterinary surgeon of livestock department in Delduar upazila, said, "The department provides vaccinations, treatment facilities and suggestions for duck farms at the rate fixed by the government."

Five held for raping girl on stranded vessel

their plan and the three gang-raped the woman, the inspector said.

The victim filed a case against the four yesterday morning.

Building roads

Shisalanga uses high-density polyethylene (HDPE), a thick plastic typically used for milk bottles. A local recycling plant turns it into pellets, which are heated to 190 degrees Celsius until they dissolve and are mixed with additives. They replace six percent of the asphalt's bitumen binder, so of the nation's dumps. every ton of asphalt contains roughly 118 to 128 bottles.

Shisalanga says fewer toxic emissions are produced than during traditional processes and says its compound is more durable and water resistant than conventional asphalt, withstanding temperatures as high as 70 degrees Celsius (158F) and as low as 22 below zero (-7.6F).

The cost is similar to existing methods, but Shisalanga believes there will be a financial saving as its roads are expected to last longer than the national average of 20

"The results are spectacular," says general manager Deane Koekemoer. "The performance is phenomenal.

Unlike in Europe, for example, where recyclable plastic is often collected directly from homes, in South Africa,

70 percent is sourced from landfill. The plastic will only be taken from landfill if there is somewhere for it to go -- such as into roads. Shisalanga says that by turning bottles into roads it is creating a new market for waste plastic, allowing its recycling plant partner to take more out

Kit Ducasse, control technician at the KZN Department of Transport -- which commissioned the plastic repaving -- is "impressed" with the road and has now commissioned a highway on-ramp in addition to the first road. "It's working so well," he says. "Time will tell, but what I've seen is great news.

Shisalanga has applied to the South Africa National Roads Agency (SANRAL) to lay 200 tons of plastic tarmac on the country's main N3 highway between Durban and Johannesburg and is awaiting approval for the project.

If it meets the agency's requirements, the technology could be rolled out across the nation. Since SANRAL's standards are so high, Shisalanga hopes it would then be able to meet the strictest regulations across the world.

Their eldest daughter, Sadia, an 8th grader, said she and her father spoke on the morning of the fateful day.

Sadia said continuing her studies will now be

difficult due to poverty. Kulaura Upazila Nirbahi Officer ATM Farhad Chowdhury said the administration will extend its support to the families.
