SC expresses disappointment at non-implementation of 2003 HC directives over arbitrary arrests on suspicion, torture on remand

The Supreme Court yesterday expressed disappointment that the 2003 High Court verdict directing police to refrain from making arbitrary arrests on suspicion and torturing people on remand has not been executed in 17 years.

"What is the point of delivering verdicts if the directives are not followed?" the Appellate Division of the apex court asked

The SC was hearing a review petition filed by the government against its 2016 judgement that upheld the 2003 HC verdict against the arbitrary exercise of power

The top court yesterday said people could be arrested under section 54 of the CrPC and it might happen to anyone's family members. And then the person may never return.

"Will the state take its responsibility?" it asked, saying that incidents of disappearance were alarming. At one stage of the proceeding Attorney General Mahbubey Alam sought adjournment of the hearing. The

In recent memory, Pahela Falgun, the first day of spring according to the Bangla calendar, has fallen on February 13... or has it? Turns out, it was merely our

dependence on the Gregorian calendar that led to this day always being celebrated on a fixed date. If we look at the Bangla calendar, Pahela Falgun has actually fallen on February 14 for the past two years, and in the years from 2013 to 2016.

Rajib Kumar Saha, an officer at Bangla Academy's lexicography and encyclopaedia department, explained how there was always a discrepancy between the two

Deadliest day of Two more coronavirus crisis

Hubei alone reports 242 more deaths, 14,840 new cases; spike attributed to change in counting method

China's official death toll from the new coronavirus spiked dramatically yesterday after authorities changed their counting methods, fuelling concern the epidemic is far worse than being reported.

As the figures soared in China, a troubling new front opened abroad as neighbouring Vietnam placed 10,000 people under quarantine after six COVID-19 cases were discovered in a cluster of villages -- the first such lockdown

Japan also saw its first death of an infected person yesterday-- a woman in her 80s, according to the country's health minister -- making it the third outside mainland China after the Philippines and Hong Kong,

The two Bangladeshis found infected yesterday are aged 30 and 37 and all four are linked to a work site in Seletar Aerospace Heights.

One of the Bangladeshis confirmed to be infected yesterday fell ill on February 7.

Hasina tells Ansar-VDP members

calendars. "Previously, each month from Baishakh to Bhadra had 31 days, while Ashwin to Chaitra had 30 days. On leap years, Falgun had 31 days.

"There has been a lot of confusion regarding which calendar to follow for which occasion. It was always easier for everyone to follow a fixed date under the Gregorian system, but that often led to forsaking the accurate Bangla date," said Rajib.

"For example, Ekushey would sometimes fall on Falgun 9, and sometimes on the previous date. The same would happen for Pahela Baishakh, with the day sometimes falling on April 14, and often on the next day," he added.

In order to settle the matter once and for all, Bangla Academy and the Ministry of Cultural Affairs introduced a revised Bangla calendar for the country last year, in which Baishakh to Ashwin consists of 31 days, while the next six months, except Falgun, have 30 days. Falgun will only have 30 days on leap years.

This revision locks the Bangla dates for days that are historically significant. February 21, March 26, and December Chaitra 12, and Poush 1, which were the original Bangla dates in 1952 and for the Bangla New Year, Rabindra

Nafisa's sentiments were echoed by multiple others, who feel that February 14 has already been branded as Valentine's Day, a western celebration for love -- whereas Pahela Falgun has an entirely different theme of welcoming spring in vibrant colours.

An affinity for flowers is one of the few things in common between the two celebrations. "Sales during the offseason are around Tk 10,000 per day,

The 37-year-old was identified as a close contact of the two previously identified Bangladeshis, who worked at the Seletar Aerospaces Heights

Both were being kept in isolation cooms at the National Centre for Infectious Diseases.

The Institute of Epidemiology, Disease Control and Research (IEDCR) in Dhaka said the condition of the two previously infected Bangladeshis in Singapore was stable.

A total of 58 people have been diagnosed with coronavirus, including eight new cases reported in the country, the Ministry of Health in Singapore said.

Meanwhile, the 312 Bangladeshis, who returned from the Chinese city of Wuhan and had been quarantined in the Ashkona Hajj Camp, would be going home tomorrow, Health Minister Zahid Maleque said zesterday.

"All the returnees from China are in the last stage of their quarantine period. They would be able to leave the camp on Saturday following health check-ups," the minister said.

On February 1, 312 Bangladeshis, who had been stranded in Wuhan -- the epicentre of the coronavirus outbreak, were flown back to the country in a chartered flight arranged by the government and were kept quarantined in the camp.

Atter landing at Hazrat Shahjalal International Airport, eight of the returnees were sent to hospitals as they had fever.

Later, all of them were tested coronavirus negative by the IEDCR.

Three returnees, quarantined at the camp, were also hospitalised due to high body temperature. They were also cleared by the IEDCR.

The health minister yesterday urged people not to panic.

"Nobody inside the country has been infected so far. Medical admission [of any Chinese returnee] does not necessarily mean coronavirus infection. We should not say it's a coronavirus infection until it is proven through a test. Otherwise, it creates panic.

Yesterday, police detained five people from different areas in the capital for allegedly spreading rumours about the coronavirus outbreak.

Najmul Islam, additional deputy commissioner of DMP's cyber security and crime division, said the detainees, using their Facebook accounts and different online portals, were spreading rumours that the virus had spread in Bangladesh.

They were taken into custody for nterrogation, he added.

The virus has so far claimed 1,370 lives and infected 60,329 people, mostly in China.

She added, "Establishing a taskforce and building emergency hospitals to address the crisis is timely and praiseworthy."

'Amend University Ordinance of 1973'

BNP lawmaker demands at House to enforce uniform admission tests STAFF CORRESPONDENT

BNP lawmaker Harunur Rashid yesterday in parliament demanded that the government amends the University Ordinance 1973 to "force" four leading public universities to follow the uniform admission tests from this year.

Speaking on a point of order, the opposition MP also urged Speaker Shirin Sharmin Chaudhury, who was presiding over the sitting at that time, to issue a ruling so that the government can introduce the uniform university admission tests from this year removing all barriers.

Vice chancellors of 28 universities sat in a meeting on Tuesday. It's a matter of concern that some VCs of major universities, including Dhaka University and Buet, are talking about the 1973 ordinance and showing their unwillingness to accept the uniform admission test," he said, referring to media reports.

As per the ordinance, authorities of universities can make decision about their academic activities on their own.

According to media reports, Dhaka University, Bangladesh University of Engineering and Technology (Buet), Jahangirnagar University and Chittagong are SEE PAGE 4 COL 1

'Don't deport Rohingyas'

Global coalition urges Saudi Arabia

Free Rohingya Coalition, a global platform of Rohingyas worldwide, has urged Saudi Arabia not to deport any Rohingyas until the genocide against Myanmar is over.

"Once the case is settled and peace prevails in Rakhing state of Myanmar, they will go back to their country of origin. At this moment, we urge Saudi authorities not to deport any Rohingyas -- either from the detention camps or outside in the Kingdom to Bangladesh," said Free Rohingya Coalition Co-founder Nay San Lwin.

The urge comes as a Saudi delegation is in talks with Bangladesh authorities over the deportation of the Rohingyas from Saudi Arabia.

"This is a sensitive issue. We don't want deportation for the sake of deportation. There are issues of security. We are talking about it," said Mahir Abdul Rahman Gassim, Saudi Arabia's Deputy Minister for International Affairs of the Ministry of Labor and Social Development.

He said this at a joint press briefing at the Economic Relations Division (ERD) in the

capital vesterday, after a two-day meeting of the Joint Commission of Bangladesh and Saudi Arabia.

The meeting discussed a range of issues including Saudi investments in Bangladesh and the welfare and protection of Bangladeshi migrants in Saudi Arabia.

ERD Secretary Monowar Ahmed said the Rohingya issue was raised at the discussion. "We took note of it. A few ministries

are involved in the issue. We will discuss and then decide on the matter," he told journalists, but did not mention the number of Rohingyas Saudi Arabia wants to deport.

According to media reports, Saudi Arabia wants to deport some 42,000 Rohingyas, who are carrying Bangladeshi passports.

Nay San Lwin said there are some 3 lakh Rohingyas living in Saudi Arabia. Around 1,600 of them were in detention camps in Jeddah. Of them, a few dozen were deported to Bangladesh last year.

"The Roingyas living in Saudi Arabia are a source of livelihoods for their families back either in Bangladesh or Myanmar. SEE PAGE 4 COL 3 MIGRANT WORKERS IN LEBANON

470 to return home this week

Some 470 Bangladeshi migrant workers are set to return home this week from crisis-hit Lebanon, following applications for repatriation under a special programme announced by authorities. Many of them are desperate to return home, said officials and migrant workers living in the Arab country.

The returning migrant workers, including some physically ailing and more than 200 women -- will be the second batch of workers to be repatriated willingly since the programme was announced in September last year.

Six Air Arabia Airline flights will carry the workers to Dhaka between February 15 and 23, said an official at the Bangladesh embassy in Beirut.

The first batch, comprising about 582 workers returned home in December last year, the official said.

Amid an economic meltdown, around 1.6 lakh Bangladeshi migrant workers are passing days in uncertainty in Lebanon, as many of them have either lost their jobs or remained unpaid over the last few months.

Of them, some 30,000 are undocumented, according to media reports.

Abdullah Al Mamun, first secretary at the labour welfare wing of the Bangladesh Mission in Beirut, said they have received about 3,683 applications in two phases since the special programme was announced.

Of those, 2,383 applications were received in September and about 1,300 more in February this year, he told this newspaper by phone.

Mamun, also head of chancery at the Beirut Mission, said they are expecting to receive about 1,200 more applications in the second phase which will bring the number of workers to be repatriated under the programme to nearly 5,000.

Those who applied are now illegal residents [in Lebanon]," he added.

He said they are looking for a suitable place outside the embassy to run activities under the programme, as the embassy premises is not large enough to handle the rush of the workers.

Limit trans-fat use to 2pc in all foods Consumer rights activists urge govt

Consumer rights activists at a discussion yesterday urged the government to limit the use of trans fat in all foods to maximum of two percent, and maintain the standard strictly as the substance is injurious for health.

They also detailed a nine-point demand, including ban on hydrogenated oil -- the major sources of trans fat, and formulation of a policy in this regard.

Industrially-produced trans-fatty acid, also known as trans fat, causes severe health risks -- such as increasing risks of cardiovascular disease and cancer. However, several foods in the country contain an excessive amount of the fat and there is no policy to control it, they said.

Consumers Association of Bangladesh (CAB), National Heart Foundation of Bangladesh (NHFB) and Progotir Jonno Gyan (PROGGA), in association with Global Health Advocacy Incubator (GHAI), organised the discussion on the health risks of trans fat at Cirdap auditorium in the capital.

Speaking as chief guest, Industries Minister Nurul Majid Mahmud Humayun said the government is working on regulating the use of trans fats and planning to formulate a policy in this regard.





unwilling to adopt the uniform admission system.

MP Harun said the public universities are not being run fully following the 1973 ordinance, while most universities have no student union.

"But the university authorities talk about the ordinance when it comes to student admission and teachers' appointment. That's why I think this ordinance should be amended to make it time-befitting," he said.

Harun said the lakhs of students and their guardians have to go through serious sufferings during admission tests at different universities. "So, uniform admission test must be introduced from this year."

Earlier on January 23, the UGC announced that it would go for uniform admission test for the 2020-2021 academic

Bangladesh Bishwabidyalaya Parishad, an association of vice chancellors of public universities, decided at a meeting on Tuesday that all public universities would have a uniform admission test this year. However, VCs of DU, Buet, and JU did not attend the meeting.

For higher education, public universities remain students' top choice. But the number of seats is much smaller than the number of students seeking admission.

There are 39 public universities, which enroll some 65,000 students every year through separate admission tests. Last year, some 9.88 lakh students passed the HSC and its equivalent examinations under the 10 education boards.

He also assured the government will try to execute the ninepoint demand within a short time, as it is in the interest of public health.

"In order to regulate trans fat, we will also reform and update age-old acts if necessary," he added.


CAB President Ghulam Rahman said World Health Organisation (WHO), considering public health issues, recommended all countries to achieve the target of limiting trans fat use at two percent by 2023.

"Bangladesh government needs to give more focus on the topic, and collaborate with NGOs and consumer rights activists to meet the target," he said.

NHFB Founder and President Prof Brig (retd) Abdul Malik said trans fat in foods must be eliminated in order to reduce the prevalence of non-communicable diseases -such as stroke, heart diseases and cancers -- in the country.

Deporting them means the fate of their families in Bangladesh or Rakhine will only worse," he told The Daily Star by phone from Germany.

There are over a million Rohingygas in Bangladesh, including about 7.5 lakh who fled a brutal military crackdown against them since August 2017. Thousands were killed, women raped and their houses burnt to ashes.

The Gambia, on behalf of the Organization of Islamic Conference, filed a genocide case with the International Court of Justice -- the UN's highest court -- against Myanmar in December last year. The court ordered in January this year to stop genocidal acts in Myanmar's Rakhine State.

Nay San Lwin said Rohingyas are the victims of genocide and that the Saudi government should not do anything that can worsen the state of the Rohingyas.

Gowainghat, Jaintiapur and Kanaighat upazilas.

Traders dig the earth around 200-250 feet deep, and cut river banks and hillocks, which is posing serious environmental threats to the region.

Eight rights activists from renowned organisations pressed a joint statement on January 22, in which they urged the local administration to take adequate steps to put an end to all this.

A taskforce led by the upazila administration of Companiganj is carrying out regular drives at different illegal extraction areas. The taskforce, consisting of members of Department of Environment, Border Guard Bangladesh (BGB), police and other agencies, are destroying stone extraction machines, locally known as "boma machine", shallow machines and

other equipment. In recent drives, they also blocked the road to Shah Arefin Tila, filled several pits with water and seized equipment worth crores of taka.

Suman Acharjee, upazila nirbahi officer of Companiganj, said, "After taking charge three months ago, I started strict regular drives to stop illegal extraction. Over the time, the frequency of stone extraction is reducing, and we will continue our drives

until it stops completely.' Locals and activists, however, are not too optimistic.

Abdul Karim Kim -- general secretary of Bangladesh Paribesh Andolon's (Bapa) Sylhet chapter -- said, "There is no sign of illegal stone extraction ending, which is gradually destroying the environment at large. Amid some drives of the taskforce, stone traders are continuing their operation, even at night, when workers are more at risk of death.'

"A strong initiative by the government is the only way to stop illegal stone extraction in Sylhet", he said.

Meanwhile, stone traders along with transport workers are regularly protesting at Companiganj's Bholaganj and Gowainghat's Jaflong, demanding authorities not interfere in their business.

Islam, Emdadul commissioner of Sylhet, said, "Necessary steps to stop illegal stone extraction are being taken. Police should promptly arrest those who are responsible for the illegal activities and workers' deaths.'

"The protest of transport and stone workers is completely baseless. We have asked them not to go on strikes or any protest," he said.

When asked about the probe body's list, the DC said, "We always raise the issue at our coordination meetings and urge all responsible authorities to work together to put an end to this by following the probe report's recommendations."

It is worth noting that authorities on

numerous occasions in the past have made promises, given excuses, and assured of stricter action.

In 2017, at least 32 people were killed while extracting stones. DoE had said they were dealing with a huge backlog of cases waiting to be heard at court. The then DC of Sylhet, Md Rahat Anwar, had said stricter action would be taken.

Last year, when the death toll had reached 50, DoE officials and the current DC said they were trying their best, stressing social and political initiatives to end the practice.

It is worth questioning why people are still getting crushed under the earth. Why is this illegal trade so persistent?

Abdul Karim Kim said, "Illegal stone extraction is a business worth hundreds of crores, and many who are responsible for stopping the activities are receiving money for not taking action. The beneficiary list includes local administration, law enforcement agencies, local council representatives to those even higher up the ladder."

'Lawyers and judges, who deliberately help stone extractors in court, also get some money in return," he said.

In reply, DC Emdadul said if authorities receive any specific accusations against influential individuals, they will take action. But officials can do nothing if vague allegations are put forth.

As far as the drives are concerned, Shah Shaheda Akhter, regional coordinator of Bela in Sylhet, said, "It's like The Tom and Jerry Show. Minutes after they conduct a drive, stone extractors resume their operation soon after. As far as we understand, the upazila administration doesn't have the ability to stop this anyway."

"The stand of police in these areas is questionable, and DoE doesn't seem too interested. If all agencies responsible remain silent, who will stop all this?" she said. "The situation will remain the same unless the government intervenes."

And when it comes to specific accusations, seeking anonymity, some residents of Companiganj claim that the upazila chairperson Shamim Ahmed is the key person behind this industry. Shamim, however, denied any involvement.

"I don't own any stone pit anywhere. Those who allege my involvement are basically my political opponents and their allegations are false," he said.

Recently, authorities seem to have ramped up their action against this illegal trade.

The HC on Monday gave a verdict which prohibited all forms of stone extraction at Shah Arefin Tila. Authorities conducted a drive at the site and ousted workers who were residing there unauthorised.

But the reality is still bleak. To regulate stone extraction, "The Mines and Minerals Rules 2012" was gazetted but to this day, all sections under the rules are being violated at all stone extraction sites.

Lebanon's mismanaged economy has been stagnant for nearly a decade. The crisis has deepened in recent months with an acute dollar shortage leading banks to restrict foreign currency withdrawals in the heavily "dollarised economy", reports Al Jazeera.

Scores of businesses have closed down and thousands of employees have been laid off or had their working hours and wages slashed. Meanwhile, prices of everyday goods have gone up, according to media reports. Last year, the World Bank estimated that

up to half of Lebanon's population could fall into poverty, up from 30 percent in 2018. "Unemployment, especially among youth, is already high and could further rise sharply," it cautioned. Lebanon is also reeling from a political

crisis. Thousands have been taking to the streets for over three months demanding a productive economy, an end to corruption and the ouster of sectarian leaders who have ruled the country since its civil war ended in 1990. Rana Ahmed, a migrant worker from

Brahmanbaria's Nabinagar upazila, applied under the special programme at the beginning of this month and have been

waiting for his repatriation.

Rana said he used to earn about US\$ 700 per month as a welder at a workshop in the city of Nahr Ibrahim. He lost that job in October last year after the workshop was shut down. Now Rana, who needs to support his

daily basis. This way he can work five days a month at best. Rana said. "It's difficult to meet my own expenses with the current income. How can I send

16 held for online gambling in Ctg

Police busted a gambling syndicate at the city's Riazuddin Bazar Pakhir Goli area and arrested 16 gamblers including three "ringleaders" -- on charge of online gambling yesterday morning.

Among the arrestees, Mithu, Rubel, and Shipu are ringleaders of the syndicate, police claimed, adding that they ran betting worth almost Tk 1 crore every month and gave out loans to gamblers. The deals were done in US dollars as they took place on an international gambling website.

Tipped off, a team of Kotwali police raided an eatery at Riazuddin Bazar's Pakhir Goli in the dead of the night and arrested them while they were gambling on their mobile devices, said Shah Md Abdur Rauf, additional deputy commissioner (ADC), Chattogram Metropolitan

"The accused are of different professions. They spend around Tk 5,000 to 10,000 every day on 'bet365.com', an international gambling site. After winning in digital dollars, they cash out in Bangladeshi currency," said the

The drive was led by Sajal Das, SI of Kotwali Police Station. The SI told The Daily Star, "Under the guise of an eatery business, the syndicate ran the betting ring for a long time. The ring pauperised many young people and their families through illegal gambling.

"They maintained contact through imo, WhatsApp and other communication apps," said the SI.

ADC Rauf said a case was lodged with Kotwali Police Sation under the Digital Security Act in this connection, as the gambling was done through digital devises.

The Bela report stated that the authorities were hiding the actual death toll to avoid consequences.

On January 20, stone worker Liton Miah (22) died at Shah Arefin Tila area of Companiganj upazila. Police on January 23 arrested Aiyub Ali, an illegal stone trader who was operating at the pit where Liton

A probe body of the district administration published a report in February 2017, mentioning names of 47 stone traders responsible for illegal extraction and deaths of workers. Aiyub's name was on top of that list.

It took three years and another person dying to put Aiyub in jail. If that was not discouraging enough, almost all the listed people are currently roaming free and recommendations of the probe body remain unfollowed.


Supreme Court lawyer Sayedul Hague Suman, popularly known "Barrister Suman", has resigned from his post as prosecutor of the International Tribunal.

'All busfires' now contained: report

AFP, Sydney

All the blazes in Australia's hard-hit state of New South Wales have been brought under control, firefighters said yesterday, signalling the end of a "black summer" that claimed 33 lives nationwide.

But heavy rains that helped extinguish the blazes that have raged along the east coast since September are causing flash floods in parts of the state, posing new problems for

"Not all fires are out, there's still some fire activity in the far south of the state but all fires are contained so we can really focus on helping people rebuild," the state's fire service deputy commissioner Rob Rogers said on Twitter.

"It is very good news," a Rural Fire Service spokesman

Bushfires scorched more than 10 million hectares in the country's east and south, killing at least 33 people and an estimated one billion animals, while destroying more than 2,500 homes. The fires were exacerbated by prolonged drought and worsened by climate change in the country's hottest and driest year on record.

Days of recent rainfall have extinguished the largest fires and brought those that remain under control. Attention has now turned to tackling flash flooding expected in the coming days following the heaviest rains in 30 years.

On Thursday dams near Sydney overflowed after days of torrential rain. The Nepean dam was just a third full less than a week ago, but on Thursday video footage showing water cascading over the dam wall. Hundreds of people have been rescued from floodwaters in recent days.

UK PM tightens grip on govt

Finance minister Javid resigns after row; Labour calls reshuffle "chaos"

British finance minister Sajid Javid resigned yesterday, a surprise move that underlined Prime Minister Boris Johnson's desire to tighten his grip on government in a long-planned reshuffle by jettisoning a minister who refused to toe the line.

Johnson, who wanted to minimise any disruption from the cabinet reshuffle, quickly appointed Javid's deputy Rishi Sunak, an ultra-loyal supporter of the prime minister who has often been put in front of the cameras to sell government policy.

The prime minister's team had carefully choreographed the reshuffle, presenting it as an opportunity to foster new talent, particularly among women, while also rewarding loyal supporters to deliver his vision for Britain beyond Brexit.

But the finance minister's resignation which some commentators said might have been sought by Johnson's team - due to a dispute over Javid's advisers added to the picture that the prime minister will not tolerate dissent in his government.

Chancellor of the Exchequer (finance minister)," a source close to Javid said.

The source said Johnson had told Javid he would have to sack his advisers and replace them with advisers from the prime minister's Downing Street office. The Chancellor said no self-respecting minister would accept those terms."

Smith, who had been in charge of parliamentary discipline for Johnson's predecessor, Theresa May, was the first minister to lose his job in the reshuffle. He was joined by business minister Andrea Leadsom and environment minister Theresa Villiers.

Ultra-loyal Alok Sharma, former minister for international development, was appointed as the new minister for business and also the head of the COP26 climate change summit in Scotland in November, due to be attended by world leaders.

Opposition politicians said the reshuffle was a mess. "This is a historical record. A government in chaos within weeks of an election," said John Sterling rose on the expectation of McDonnell, finance spokesman for the investors that Sunak's appointment main opposition Labour Party.

TRUMP'S STONE INTERFERENCE

Republicans unmoved as Democrats demand probe

Republicans in Congress on Wednesday brushed aside calls to investigate possible political interference at the US Justice Department after the agency asked for a lighter prison term for President Donald Trump's longtime

The Justice Department's decision to back off its sentencing recommendation of seven to nine years for the Republican operative sent shock waves through Washington and prompted all four prosecutors to quit the case and one to quit the agency.

"There should be an investigation," said House of Representatives Speaker Nancy Pelosi, the top Democrat in Congress. Other Democrats accused Trump of purging the US government of perceived enemies following his acquittal on impeachment charges last week.

They said they would question Attorney General William Barr about the matter when he testifies before Congress on March 31.

"You have taken steps that raise grave questions about your leadership of the Department of Justice," Democratic members of the House Judiciary Committee wrote to Barr in a letter.

Republican lawmakers, who nearly all voted to acquit Trump of impeachment charges, offered muted criticism of the president but shrugged off suggestions they should investigate whether his political concerns were influencing law enforcement.

After the Justice Department decision, Trump on Wednesday praised Barr, his appointee to the law enforcement job, for "taking charge of a case that was totally out of control and perhaps should not have even been

China appoints hardliner to Hong Kong office

China yesterday appointed a senior official known for a hardline crackdown on Christians to head its main policy-making body for Hong Kong, following months of pro-democracy protests in the semi-autonomous city. The reshuffle comes after months of political unrest -- the starkest challenge to Beijing since the former British colony was returned to Chinese rule in 1997. Senior Beijing official Xia Baolong, currently secretary-general at the national committee of China's top political advisory body, was promoted to director of the Hong Kong and Macau Affairs Office of the State Council. His predecessor Zhang Xiaoming was demoted to deputy in charge of daily operations. Xia, 67, was Communist Party secretary of eastern Zhejiang province for five years from 2012. Xia also served as Xi's deputy between 2003 and 2007 while the now-president was Zhejiang party secretary.

Senate moves ahead to curb Trump's war powers

The US Senate advanced legislation on Wednesday intended to limit President Donald Trump's ability to wage war against Iran, paving the way for a final vote as eight Republicans joined Democrats in supporting the war powers resolution. The resolution would require Trump to remove U.S. troops engaged in hostilities against Iran unless Congress declares war or passes a specific authorization for the use of military force. The vote was 51-45 on a motion to proceed to a final vote, expected on Wednesday or on Thursday. Republican opponents, including Trump, said passage would send the wrong message to Tehran. The US Constitution gives Congress, not the president, the power to declare war. Despite bipartisan backing, the resolution is unlikely to garner enough support from members of Trump's party to overcome a veto if it

Big Ben tower more badly damaged than thought



Britain's Big Ben tower at the Houses of Parliament was more badly damaged by German bombs during World War Two than originally thought, experts said yesterday, as the bill for its restoration rose by nearly 20 million pounds (\$25 million). The 177-yearold tower has been swathed in scaffolding for the past three years as craftsmen refurbish its stonework and famous 12-tonne clock. Although the tower survived Nazi bombing, its roof and dials were damaged in a May 1941 air raid which destroyed the main House of Commons chamber. The latest refurbishment of the structure, during which its 13-tonne Big Ben bell has been largely silenced, is expected to be finished next year.

US foreign policy 'amoral'

AFP, Washington

The former US ambassador who was a key figure in President Donald Trump's impeachment trial criticized US foreign policy on Wednesday as "amoral" and based on threats.

Marie Yovanovitch, who Trump abruptly recalled last May from her post as US ambassador to Ukraine, spoke at Washington's Georgetown University where she received a prize from the school's Institute for the Study of Diplomacy.

"Right now, the State Department is in trouble," she said. "Senior leaders lack policy vision, moral clarity and leadership skills."

"To be blunt, an amoral, 'keep-em-guessin' foreign policy that substitutes threats, fear and confusion for trust cannot work over



the long haul," Yovanovitch

Trump last year disparaged Yovanovitch in a telephone call with Ukrainian President Volodymyr Zelensky which was the center of his impeachment for abuse of power.

The House of Representatives impeached him for pressuring Ukraine to announce investigations, including into his political opponent Joe Biden.

In October Yovanovitch testified to Congress that she was recalled due to "unfounded and false claims by people with clearly questionable motives.

The 33-year diplomatic veteran said she was subjected to a smear campaign orchestrated in part by Trump's personal lawyer Rudy Giuliani.

Republican lawmakers on Wednesday proposed legislation setting a goal for the United States to plant a trillion trees by 2050 to fight global warming, a plan intended to address climate change by sucking carbon out of the air instead of by cutting emissions.

The proposed legislation reflects an acknowledgement

some in the Republican Party of rising voter demand for action on climate change, even as it seeks to preserve the economic benefits of a historic drilling boom that has made the United

States the world's biggest oil and gas producer. Republican President Donald Trump, who has repeatedly cast doubt on the science of climate change, had expressed support for the idea of a massive treeplanting campaign during a speech at the World Economic Forum in Davos, Switzerland, last month.

Libya rivals ignore UN ceasefire call

Rival forces clashed in the Libyan capital yesterday, witnesses and pro-Government of National Accord (GNA) forces said, a day after a UN Security Council resolution called for a "lasting ceasefire".

Flights were again suspended at Mitiga, Tripoli's sole functioning airport, following rocket fire, as fighting broke out between forces loyal to the UN-recognised GNA and fighters of strongman Khalifa Haftar in the capital's south. Witnesses heard explosions in the largely agricultural

area of Machrou al-Hadhba about 30 kilometres (18

miles) south of the Tripoli city centre. Rockets also struck residential neighbourhoods, killing one woman and wounding four other civilians, according to a spokesman for the health ministry, Amin al-Hachimi. Meanwhile, Haftar's forces yesterday said they won't allow United Nations to use the only functioning airport in the capital Tripoli.

The UN earlier warned flight restrictions by commander Khalifa Haftar's forces known as the Libya National Army (LNA) were hampering humanitarian and mediation efforts in the oil-producing country embroiled in a conflict between loose alliances from western and eastern Libya since 2014.

The UN Security Council adopted on Wednesday a resolution calling for a "lasting ceasefire" in the conflict-hit country, a first since Haftar launched his offensive to seize Tripoli in April.

More than 1,000 people have died in the clashes between Haftar and the GNA, while another 140,000 have been displaced, according to the UN.

WHO extends **Ebola emergency**

The UN health agency on Wednesday said it was extending its global emergency designation for the Ebola outbreak in the Democratic Republic of Congo but said the sharp decline in cases was "extremely positive". The recent outbreak was first identified in August 2018 and has since killed more than 2,300 people in eastern DR Congo. The WHO, however, said it was downgrading the national and regional risk of the disease from very high to high, while it kept the global risk at low.

Somalia's journalists under fire: Amnesty

Journalists in troubled Somalia are "under siege", facing bombings, beatings, attacks and arrests, rights group Amnesty International said vesterday. The East African nation has long been seen as one of the riskiest places to work as a journalist. Journalists face threats on all fronts, from attacks by Somalia's al-Oaeda-allied Al-Shabaab fighters, to the internationally backed authorities. At least eight journalists have been killed since 2017, and at least eight more fled the country, the report said.

Australia extends ban on visitors from China

Australia yesterday announced a ban on travellers from China would extend for at least a week beyond Saturday's planned deadline, as the death toll from the coronavirus soared. Prime Minister Scott Morrison said the government would maintain "entry restriction on foreign nationals who have recently been in mainland China" for further week "to protect Australians from the risk of coronavirus".

The United States has secured a seven-day reduction in violence in talks to help seek a negotiated settlement in Afghanistan, Pentagon chief Mark Esper said yesterday.

The announcement came as Nato defence ministers met in Brussels and a day after Afghan President Ashraf Ghani reported "notable progress" in negotiations with the Islamist insurgents.

"The United States and the Taliban have negotiated a proposal for a seven-day reduction in violence," Esper told reporters, dubbing his meetings with Nato colleagues "productive."

"We've said all along that the best, if not the only, solution in Afghanistan is a political agreement. Progress has been made on that front and we'll have more to report on that soon, I hope."

Esper did not say when the partial truce would begin, but on Wednesday a Taliban official told AFP that the group would begin a "reduction of violence" starting from today. "It is our view that seven days for now is sufficient but in

all things our approach to this process will be conditions based, I will say it again, conditions based," Esper said. "So it will be a continual evaluative process as we move

forward, if we go forward.' Washington and the insurgents have been locked in gruelling talks that have stretched over more than a year, seeking an end to what has already become America's longest war.

US announces 7-day India SC tells parties to justify rise in 'criminal candidates'

Says 'winnability' can't justify such malpractices

Political parties must upload on their websites details of criminal cases against poll candidates and the reasons for selecting them, the Indian Supreme Court said yesterday, flagging an "alarming rise in the criminalisation of politics" in the last four national elections.

The Supreme Court said it would be mandatory for parties to upload the details of their candidates' criminal history on their websites, on social media and in newspapers within 48 hours of selection. "Political parties will have to specify reasons for selecting candidates having pending criminal cases against them on their website," said the court.

Parties must submit the same details to the Election Commission within 72 hours, the court

"The reason to select candidates should be based on merit and not winnability. Winnability can't be the only justification," the top court directed.

Election Commission was unable to implement the directive, it would be considered contempt of court, the judges said.

The verdict comes on contempt petitions filed by lawyer Ashwini Kumar Upadhyay and others. In September 2018, a five-judge constitution bench

had asked the central government to immediately enact laws to ban those involved in serious crimes from contesting elections and

becoming party officials. BJP leader and lawyer Ashwini Upadhyay had filed a contempt petition against the central government and the Election Commission, alleging that no serious efforts were made to stop the criminalization of politics despite the court order.

The court had earlier even ordered that candidates publish their criminal details in the newspaper thrice after filing their nomination. The petitioner had alleged that the Election Commission had not attempted to implement this order effectively.



The US cruise ship Westerdam is finally given permission to dock in Cambodia, having been turned away from several Asian ports over concerns that a passenger could be infected. This ship is to dock early Friday in Sihanoukville and passengers will be transferred directly to the airport to fly to Phnom Penh and onward.



MAJOR MOBILE FAIR SCRAPPED

The world's top mobile telephone trade fair, the annual World Mobile Congress, is cancelled after fears stemming from the coronavirus spark an exodus of industry heavyweights. The event had been planned to run in Barcelona from February 24 to 27. The organising GSMA mobile trade association says "the global concern regarding the coronavirus outbreak, travel concern and other circumstances, make it impossible" for it to go ahead.

OIL MARKET HIT

The International Energy Agency warns that global oil demand will suffer its first quarterly drop in a decade as the COVID-19 virus lashes the economy in China and its impact ripples throughout the world. Trump says he does't mind if Manila cuts military pact

REUTERS, Washington US President Donald Trump said on

Wednesday he did not mind Philippines President Rodrigo Duterte's decision to end a decades-old military agreement with the United States, a position at odds with that of his defense secretary who viewed the move with dismay. Duterte on Tuesday announced

termination of the two-decade-old Visiting Forces Agreement (VFA). U.S. Defense Secretary Mark Esper called the decision "unfortunate" as Washington and its allies press China to abide by "international rules" in Asia. The US embassy in Manila called it "a

serious step with significant implications." Duterte's decision, sparked by the revocation of a US visa held by a former police chief who led Duterte's bloody war on drugs, takes legal effect in 180 days and US officials have expressed hope it can be reversed or delayed.

"I don't really mind if they would like to do that, it will save a lot of money," Trump told reporters at the White House when asked about Duterte's move and

whether anything could be done to get him to reconsider. "My views are different from others," he added.

Trump has frequently expressed a desire to bring US military forces home from decades-long deployments abroad and has strong-armed some allies into paying more for the right to U.S. defense.

Trump said the United States had helped the Philippines defeat Islamic State militants. He said he had "a very good" relationship with Duterte and added: "we'll see what happens."

Duterte's decision could complicate US military interests in the broader Asia-Pacific region as China's ambitions rise. Some Filipino senators quickly sought to block the move, arguing Duterte had no right to unilaterally scrap international pacts the country's senate had ratified.

The VFA is important to the overall US-Philippines alliance and sets out rules for U.S. soldiers operating in the Philippines, a former US territory. Washington has the relationship "ironclad," despite Duterte's complaints that include allegations of U.S hypocrisy and ill

Another wall goes up for Trump

India builds wall in Ahmedabad to shield view of slums

US President Donald Trump will be shielded from the sight of slums by a newly built wall when he visits the city of Ahmedabad during a visit to India this month. A senior government said the wall was being built for

security reasons, not to conceal the slum district. But the contractor building it told Reuters the

government "did not want the slum to be seen" when Trump passes by on the ride in from Ahmedabad's airport.

"I've been ordered to build a wall as soon as possible, over 150 masons are working roundthe-clock to finish the project," the contractor said, speaking on condition of anonymity.

cleanliness" drive. Whatever the reason, the 400-meter-long and sevenfeet-high wall will prevent the US leader from getting a glimpse of a slum district that houses an estimated 800

violence in myanmar's rakhine state 20 children injured as school hit by mortar

Around 20 children were injured yesterday when mortar fire hit a primary school in the northern fringes of Myanmar's Rakhine state, an area where the military is locked in battle with Arakan Army (AA) rebels.

The attack happened in Buthidaung township, one of several areas in lockdown, and it is not clear who was responsible. Scores of civilians have been killed, hundreds injured and some 100,000 displaced since January last year when both sides stepped up operations. The AA claims to be fighting for more

autonomy for ethnic Rakhine Buddhists. Teacher Thar Aye Maung from Khamwe village told AFP by phone how his school was hit yesterday morning, injuring 21 pupils.
"One girl is badly hurt. Most of the others

have injuries to their hands and legs.' He said all the wounded children were ethnic Khami, a Buddhist minority in a

state with a complex patchwork of different groups living alongside the Rakhine.

Maungdaw district chief Soe Aung confirmed the incident, but said 19 children had been wounded.

There was "no reason" to believe the mortar had been fired by the military, said Western command spokesman Colonel Win Zaw Oo, adding the army sometimes loses weapons and ammunition to the rebels.

"(The AA) fires at villages with our shells and then misleadingly claims the military

The armed rebel group could not be reached for comment.

The AA has ratcheted up operations in recent months with a series of brazen kidnappings, bombings and raids against the military and local officials.

The army has hit back hard, deploying thousands of soldiers to the area.

Buthidaung is one of nine townships to suffer a government-imposed internet blackout, restrictions decried by rights groups in a statement yesterday.

KASHMIR, CAA **US** senators

express concerns NDTV ONLINE

Ahead of US President Donald Trump's India visit later this month, four top US senators have written to US Secretary of State Mike Pompeo, expressing concern about the internet curbs in Kashmir more than six months after Jammu and Kashmir's special status was scrapped under Article 370, as well the preventive detentions of

political leaders. In their letter, the senators also express concern over the Citizenship (Amendment) Act or CAA that triggered protests across the country.

The letter by the senators, two Democrats and two Republicans, says that the Indian government "continues to block most internet in the region... India has now imposed the longest ever internet shutdown by a democracy, disrupting access medical care, business and education for 7 million

people". "Hundreds of Kashmiris remain in 'preventive detention' including key political figures," the letter to Mike Pompeo states. The senators said "these actions have severe consequences".

Among the four senators who wrote the letter is Lindsey Graham who is very close to Trump.

"The Indian government has taken other troubling steps that threaten the rights of certain religious minorities and the secular character of the state. This includes the passage of the controversial Citizenship Amendment Act," senators sav.

The US senators also want an assessment of the "number of individuals at risk of statelessness, denial of nationality pursuant to an NRC (National Register of Citizens)".

Broccoli farming sees success in Moulvibazar haor

A sharecropper becomes the pioneer in growing the nutritious foreign vegetable in the area

MINTU DESHWARA, Moulvibazar

It was hard for any ordinary farmer to see the prospect of an uncommon vegetable in haor region where cultivation of any crops other than paddy is somewhat unlikely.

Malind Biswas, However, sharecropper of Panisail village under Barlekha upazila in Moulvibazar has gained success in broccoli cultivation, growing the foreign vegetable for the first time in the area.

The dark green nutritious vegetable resembles popular local vegetable cauliflower. The arable lands around Malind's village submerges round the year except the dry season when farmers mostly cultivate Boro paddy there.

"I was almost broke after losing my 37,000. There are some 1000 broccoli in

paddy in last Boro season too but I could hardly see any hope of profit by cultivating the usual crop," Malind said.

"Then, I heard about the broccoli and decided to cultivate it. I collected 2200 seeds of the vegetable with the help of the upazila agriculture office and planted the seeds in late October last year. The seedlings were then planted on 15 decimals of leased land.

"I faced problems due to lack of experience in broccoli cultivation but Upazila Agricultural Officer Debal Sarkar and Sub-assistant Agriculture Officer Subinoy Chandra Das helped me with their suggetsions.

"I have already sold 1200 broccoli at Tk

paddy during floods in 2017. I cultivated my field for sale," he said, adding that he second half of October. Later the seedlings is planning to increase broccoli cultivation are planted. Flowering takes place within in the next season.

He spent around Tk 15,000 for the cultivation.

"When I started cultivating the foreign vegetable, people laughed at me. But I took the risk and gained success. Now locals honour me as a pioneer. Many of them have shown interest in broccoli cultivation," Malind said.

Upazila Agriculture Officer Debal Sarkar said they have taken initiative to encourage farmers to grow broccoli as the soil and climate of the haor area is

"Malinda Biswas is cultivating broccoli using locally produced organic fertilizers. Seeds of the vegetable are sown in the 80 to 90 days," he added.

Dr Md Sharaf Uddin, chairman of agro forestry and environmental science department of Sylhet Agricultural University, said, "Broccoli is rich in vitamin K, vitamin C, folic acid, potassium and fibre, which are extremely beneficial for health. It contains sulfurorphine, an ingredient helpful for prevention of cancer.

The low calorie vegetable is also useful for keeping the heart healthy, he added.

The nutritious vegetable is likely to be an economically viable crop in the haor area, said Dr Nurul Haque, health and family planning officer of Kulaura Upazila TC TO 18 SCHOOL STUDENTS

Occupiers thwart eviction drive again

In face of obstruction by illegal occupants, an eviction drive to remove illegal structures from railway land in Saidpur municipality was suspended on Tuesday.

It was scheduled to conduct the eviction drive on February 8, but the date was shifted to Tuesday in face of agitation.

Earlier, a strong team, led by Divisional Estate Officer in West Zone (WZ) of Bangladesh Railway (BR) Md Nuruzzaman, made a list of 119 illegal occupiers in Haldar para and railway bazar area of the municipality and started eviction drive around 11:00am on Tuesday.

Before the drive, a notice was served to the occupants 15 days ago and an announcement through loud speakers was made to move to their desired places.

According to railway estate office in west zone, 447 acres of BR land and around 2,200 abandoned rail quarters in Saidpur municipality are under the occupation of influential locals.

On Tuesday morning, when the eviction team accompanied by a large number of police and Rapid Action Battalion (Rab) personnel and railway security staffers went to Halder para area where occupants constructed buildings to use it as residence and business centre, the occupiers and their men encircled them, said the divisional estate officer.

At that time, the officer who was enjoying magistracy power sentenced one Nadim, 28, to seven days' imprisonment for creating obstruction to the drive.

Without demolition of any illegal structure, the team left the area and came to local railway market and faced obstruction by the occupants. The occupiers then sprayed pepper powder on the team.

One of the accused, spice trader Hasinur Rahman, who sprayed pepper powder fled the scene when police went to arrest him. The eviction team later seized several maunds of onion, garlic, ginger and turmeric from Hasinur's shop and sold them in auction at Tk 12,000.

At the time, Ershad Alam Pappu, councilor of ward no 11 in the municipality, came to the scene and repeatedly asked the officer to go to the municipality office and made cellphone call to somewhere to influence the team but the latter refused.

At one stage, the officer suspended the eviction drive around 1:30pm.

On contact, councilor Pappu refused to pressurize the officer and said, "I just requested him to give the victims some days so that they can take preparation to shift."

Railway Divisional Estate Officer Md Nuruzzaman said, "The illegal occupants have been given 15 days to move to their desired places. Otherwise, we will start drive after the deadline."

Air pollution is a national crisis

And the authorities should act accordingly

CCORDING to a report that is the first to assess the global cost of air pollution, in 2018 air pollution cost the world an estimated USD 2.9 trillion. The World Health Organization (WHO) already approximates that globally air pollution accounts for 29 percent of all deaths and disease from lung cancer, 17 percent from acute lower respiratory infection, and a quarter from stroke and heart disease.

Bad air quality is one index where Dhaka consistently tops the global chart—and more recently, it has cemented its place at the very top. A World Bank report previously estimated that Bangladesh loses about USD 6.5 billion every year due to pollution and environmental degradation in urban areas. However, given that the study is a few years old, and that air pollution has gotten significantly worse over the past years, the cost can safely be assumed to be higher now.

The environment, forest and climate change minister said that brick kilns are responsible for more than half the air pollution in the capital, followed by smog from a staggering number of unfit vehicles plying the city streets. But then again, we all know this. Different health and environmental groups have repeatedly highlighted this problem. And the media has time and again covered this issue. It is the authorities who have not done their part to address it. Given that the major causes of air pollution are well known and a number of clear-cut solutions have already been suggested to the government, the fact that the government has not responded timely is shameful, particularly because air pollution is responsible for the deaths and health problems of countless people including children.

The minister has also said that the authorities are looking into the matter. But what the authorities must realise is that people's lives and health are at stake here, which is why they must stop dithering about and act quickly.

Save students from drugs



Don't take voters' apathy lightly

I NDIFFERENCE and apathy are even worse than hatred. And when those are directed to a system rather than an individual, it is dangerous and ominous, even more so when its significance is either not

comprehended or disregarded wilfully. Thus, amidst the constant barrage of hyperbole springing from some officebearers of the ruling party on the causes of the very low turnout in the recently held election in Dhaka city corporations, a sensible explanation was offered by the party's secretary general. He ascribed the reason for the voters shunning the polling centres to public apathy. It was not surprising to the careful observers the scant presence of voters attending the dry-run practice of EVMs a couple of days before the polls betrayed a lack of enthusiasm among them. It was an indicator of things to come.

However, in the midst of the political theatrics, the only redeeming feature was the EVM, which, despite all its demerits, prevented inflation in the voter turnout figure by the EC, something we witnessed done after the 2014 elections. But nothing is foolproof if the system is operated, and the environment hogged, by only one side. Eyewitness accounts—and there were many in the media—narrated the manner in which the EVMs were used to cast the votes as per the suggestions of those who controlled the system.

It was surprising to hear all kinds of narratives to justify the indifference of the voters of the metropolis, less than 30 percent of whom turned out to choose who they wanted to be the ones holding the important posts of mayors and councillors. It was equally astounding to see the two winning mayoral candidates taking a self-gratifying pleasure in their victory without realising the serious consequences of people's indifference to democracy and democratic institutions in the country. It should be a matter of concern for anyone seeking public office to find himself or herself a winner in a supposedly democratic contest where the vast majority of the stakeholders preferred to remain absent.

Reportedly, the polling booths were not left to the voters alone, as there were other people extraneous to the system present there. While it is not the intention to dwell on the inviolability of the EVM—incidentally, most countries who had introduced the machine in the system have done away with it—it is difficult to explain the symmetry in the pattern of voting as released by the EC in the two


city corporations polls.

One wonders whether the ruling party high-ups are aware of this either. If that were the case, the people would have been spared the imprudent comments describing this election as being the "best" in the country's electoral history. One senior AL office-bearer, in his unfathomable wisdom, even accused the BNP, holding it responsible for the low turnout, without offering any plausible explanation. Where, may one ask, were the local AL leaders? What is it that

French philosopher Montesquieu considered the apathy of a citizen in a democracy as being more dangerous to public welfare than the tyranny of a prince in an oligarchy.

What one hopes our politicians would do—particularly the ruling party—is to determine how people's apathy and

demotivated even them from turning up or herding their supporters to the polling centres? Are we to believe that AL supporters were also swayed by BNP arguments, whatever those were, to keep their distance from the polling centres? It is hard to believe that the BNP has the power to coerce ruling-party supporters into keeping away from voting, when very few of its own agents managed to get inside the centres.

What was betrayed in those insensible, and some might say puerile, comments was either that the ruling party is not aware of the consequences of the issue, or their total indifference to

a welcome display of objectivity, had suggested—APATHY of the voters.

The word "apathy" should not be taken lightly, as our politicians have done, not in the case of human relationship and even less in the case of elections, voting and voters. A display of apathy or indifference, which is worse than hatred, reflects an abysmal situation in the state.

American author Helen Keller termed the apathy of human beings as the worst kind of evil for which science has discovered no remedy yet. She was, of course, speaking of it in terms of human relationship. But it can be the eventual slide to cynicism can be arrested. The reasons for people turning their back on elections are not far to seek. It is only the politically blind and deaf who are unable to get the message that the people's abstention conveys. Such an eventuality will be detrimental to politics, democracy and public interests. That is something totally unacceptable. Is it not the time to ponder on the matter, particularly in the centenary year of the colossus who had dedicated his life to democracy, the rights of people and freedom of speech?

Intellectual property raises costs of living

ANY medicines and medical tests are unaffordable to most of humanity owing to the ability of typically transnational pharmaceutical giants to abuse their monopoly powers, enforced by intellectual property laws, to set prices to maximise profits over the long term.

Most basic research is funded by government grants, and in recent years, by philanthropic initiatives. When a profitable opportunity presents itself, venture capitalists fund "last leg" efforts to patent an innovation and "take it to market", as the patent holder "takes all".

Patents, a form of intellectual property rights (IPRs), are believed by many to be necessary to incentivise innovation, and to recover research and development costs, by creating a temporary legal monopoly.

IPRs are monopoly rights
After securing patents, patent holders
typically take additional measures to deter
and undermine potential competitors,
and to consolidate and extend their
monopoly position for as long as possible
by any means available. Private companies
have then used their monopolies to
charge exorbitant prices.

In 2015, Turing Pharmaceuticals bought the rights to Daraprim—a drug used by cancer and HIV patients to fight deadly parasitic infections—raising its price 50-fold from USD13.50 to USD 750! The "price gouging" company was controlled by Martin Shkreli, dubbed "Pharma Bro" by the US media and once deemed "America's most hated man".

Private companies eager to extend their monopolies try to "evergreen" them, by registering "follow-on" patents involving minor variations closely linked to the original invention. By evergreening, the patents system has been used by companies to create long-term monopolies.

Others engage in "patent trolling", obtaining many patents to profit from litigation or licensing, without inventing anything or making products of their own. Trolling enables patent owners to blackmail those in need of their patents, sometimes by creating "patent thickets"—webs of overlapping IPRs—and related bottlenecks, limiting the utilisation of patented knowledge and effectively hindering further innovation.

Before the US withdrew from the Trans-Pacific Partnership (TPP) in January 2017, TPP provisions would have extended IP protections to cover "biologics", i.e., naturally occurring substances, such as insulin for diabetes

patients. These onerous TPP provisions have been suspended in the successor Comprehensive and Progressive TPP (CPTPP) following US withdrawal, but can easily be reinstated, e.g., to induce the US to rejoin the TPP.

Tripping up public health
Through various means, US-style
IPR regimes have spread worldwide
since the adoption of the World Trade
Organization's (WTO) agreement on
Trade-Related Aspects of Intellectual
Property Rights (TRIPS). Under TRIPS,
all WTO members have to provide a
minimum level of IPR protection which
includes, among other things, patent
protection for a minimum of 20 years,
including for imported IPRs registered in
other countries.

from pharmaceutical giants and their governments to limit, if not eliminate, the scope of these exceptions.

Malaysia is the first country to use "compulsory licencing" under TRIPS to produce sofosbuvir for Hepatitis C treatment. The drug, from patent owner Gilead, costs almost RM 300,000 (USD 68,000) for the full course, while generic substitutes cost just over RM 1,000. US "big pharma" has applied pressure on Malaysia to stop using its compulsory licence.

IP for intellectual piracy

Where developing countries have made use of TRIPS concessions, they have faced international pressure from pharmaceutical giants and their governments to limit, if not eliminate, the scope of these exceptions.

The Indian Council for Scientific and Industrial Research (CSIR) objected, arguing that turmeric had been used in India for centuries, providing historical references in Sanskrit, Urdu, Hindi and other languages. The US patent was eventually revoked because it lacked the "novelty" element, but it required herculean efforts.

Alternatives

Developing countries are now no longer able to require technology transfer, further limiting their ability to develop their own technological capacities and capabilities. Hence, many developing country governments are told they have no other way to industrialise except by generously inducing transnational companies to locate parts of their "value-adding" activities in their economies.

The book "Innovation, Intellectual Property and Development", by Joseph Stiglitz, Dean Baker and Arjun Jayadev, suggests alternatives to incentivise innovation, especially relevant for developed economies. These include: centralised direct R&D financing; decentralised funding through tax breaks for research spending; using prizes to recognise and reward innovative research; and establishing open source platforms to promote free knowledge flows.

Without the strong private monopolies enabled by current IP rules, the currently unaffordable prices of medicines and other products can be significantly reduced while developing countries will have much better prospects for developing internationally competitive industrial capacities and technological capabilities.

TRIPS also stipulates conditions for using the "compulsory licence" concession allowing governments to license the use of a patented invention to a third party or government agency without the consent of the patent-holder.

There is moot evidence that TRIPS benefits developing countries by attracting foreign investment, promoting technological transfer and increasing innovation. Instead, TRIPS has imposed substantial, avoidable costs on developing countries.

Where developing countries have made use of TRIPS concessions, they have faced international pressure capacities and their influential partners. Such companies may re-package medicinal products and processes from developing countries' "traditional knowledge systems" to secure patents on them, including naturally occurring substances known as biologics.

Turmeric is widely used in India for medicine, food and dye, among other things. In 1995, the US granted the University of Mississippi Medical Center a patent for the use and administration of turmeric powder to heal wounds, granting it an exclusive right to sell and distribute turmeric.

Changing the shy world of adolescent girls

Lessons from installing a girls' toilet facility

ACK in 2017, we had an opportunity to build a small and experimental toilet in Jhalokati, with the simple intention of helping adolescent girls in a rural school who had no real toilet to avail. We designed a cost-efficient, environment-friendly, safe, and sanitary toilet for them to access easily and to improve their menstrual hygiene. We also wanted to help them change their common perception of a toilet from a dark, dingy, and stigmatised space to a positive, light-filled, ventilated, and gender-friendly facility.

The toilet project soon evolved into a research topic, an opportunity to look at some of the typical social and hygiene-related problems that rural girls encounter at their schools.

Our hope was that this prototype toilet project would change the attitudes of school teachers, parents, local community leaders, and even adolescent boys regarding specific health needs of girls. Furthermore, a gender-friendly toilet would improve

the self-esteem of girls, enabling them to become more conscious and productive citizens.

It was a significant learning experience. We gained insight into how hygiene, adolescence, and social conditions intersect, while encountering a host of surprising repercussions in project management. In Bangladesh, 40 percent of adolescent girls do not attend school during the first three days of their period. Only 11 percent of schools have separate toilets for girls with water facilities, 3 percent have the facility to dispose of sanitary products, and 69 percent of school girls never change sanitary napkins during school time. About 45 percent of girls complain about the unavailability of water in school toilets. According to the Bangladesh National Hygiene Baseline Survey-2014, only 10 percent of students use disposable pads and only 12 percent schools have improved toilets for girls. Most of the time school girls use rags instead of sanitary napkins, resulting in urinary infections. This situation leads to a pervasive culture of school absenteeism among adolescent girls, eventually creating unfortunate conditions for many to drop out from school. Subsequently,

the evil of underage marriage rushes in. During the course of our toilet

design, we realised that research on girls' hygiene management as well as its influence on their education and wellbeing is scarce. Moreover, very little has been done to improve design guidelines and placement of toilets within a given school premise that specifically supports adolescent girls' special needs. Often times young girls never receive accurate information, guidance, and access to affordable sanitary options.

We came to the realisation that inadequate access to a comfortable, convenient, and secure toilet at schools is one of the most common forms of gender discrimination, experienced regularly by girls across rural Bangladesh. The most troubling part of this discrimination is that it occurs due to the community's pervasive apathy and unwillingness to address the issue. Menstruation is a taboo subject and everybody wants to avoid having to discuss it. Although considerable effort has been undertaken by NGOs and community groups to ameliorate the situation, there is still silence both at school and home. Neither parents nor teachers take necessary steps to educate girls on the subject. This form

of silence, further complicated by societal ignorance of and indifference to menstrual hygiene, breeds a fertile ground for discrimination and denigration.

We recently completed the construction of the toilet that we proposed back in 2017. A core concept of our toilet design was "no girl alone." Often times girls feel reluctant to go to the solitary toilet facility at school because they are afraid that they would be harassed on the way to or once inside the toilet. Our solution for this particular problem was to provide three functions—toilets, ablution space, and handwashing—so that multiple girls can be inside the facility at the same time as mutual protection. The toilet includes a low-cost, key-based sanitary pad dispenser. Furthermore, our design proposes to use waste water for the adjacent community vegetable garden that the girls will be responsible for maintaining. This way they will take ownership of the toilet, thereby feeling inspired to sustain it as best as they can. Maintenance of the facility in small teams is their responsibility.

Just because one has a good, philanthropic intention doesn't mean that people at the receiving end will accept something with open arms: in fact, there were serious obstacles. The toilet project required a monumental effort to get it approved by the omnipotent school committee. We first suggested a precondition that the local community would pay 10 percent of the total construction cost; a partial community ownership would mean better monitoring and maintenance of the facility. But the suggestion was met with dead silence!

The divisiveness of the school committee was forbidding. Not everyone agreed that a toilet for girls was even necessary. So much attention devoted to girls was perhaps unacceptable. Eventually, the committee agreed on the necessity of a gender-friendly toilet on the school premise and approved it. However, in the meeting minutes, the clause for the 10-percent community contribution

toward the construction cost was surreptitiously deleted.

Once the construction of the toilet began, local goons arrived to demand money from the contractor, who couldn't oblige because it was a small project with very little room for profit. His plea didn't soften the goons; they returned at night and destroyed the under-construction toilet. We were shattered. How could people be so insensitive and heartless? We approached the local political powerwielders and appealed for intervention. After multiple telephone calls and police visits to the school, things were under control, thanks to our "connection." The toilet finally came to reality after much consternation and high drama. This is only the first part of the story.

We recognise that the toilet may change neither the misogynist culture of a rural school nor the shy world of adolescent girls. The toilet may even fall into disrepair and become a putrid place as elsewhere. To stop that from happening, we thought it would be important to tie the idea of toilet hygiene with curricular reform in such subjects as civic responsibility, environmental sustainability, gender studies, and conscientious use of water. These ideas, even if they are executed at a micro-scale, are intimately related to the nation's broader interests because school girls will emerge as better human beings and, as mothers, also enlighten their progeny. We also believe that our small project can spur local initiatives for not just public health and wellbeing, but also social justice. We will continue to study the girls' response to the toilet facility as an everyday frontier to change society, one step at a time.

Coronavirus and the politics of xenophobia



a ship full of remains quarantined and docked at Yokohama, while racism takes root and

flourishes under the shadow of an outbreak.

A novel virus, which has affected around 60,000 individuals, killed over 1,350 people globally, and reached 24 countries till now, has laid bare how it takes only a nudge to unleash xenophobic—intentional, subconscious, or institutional—values against a certain community.

Questionable memes attacking the Chinese as a whole are flooding the Internet. These justify the racial attack against the Chinese by basing it on their "food habits". The scientific journal, Nature, has mentioned the coronavirus's probable ties to pangolins—animals used for making "Traditional Chinese Medicine"—although the declaration is yet to be made formally.

Once I saw a comment that stated that even though being xenophobic against the backdrop of the coronavirus's outbreak was not and should not be justified, the Chinese needed to "be called out for their food habits". An

entire community, viewed as a single body, was inculpated, just like that. A blanket generalisation shunning the diversity and multiplicity of a community was evident in that

That comment, unfortunately, does not echo an isolated view. It echoes a view shared by many who, knowingly or unknowingly, fall into the traps of hasty generalisation. It also echoes subtle xenophobia.

I can only imagine what their (those who propagate xenophobia) responses would be had the communities they belong to been on the receiving end of a global xenophobia. Among others, those who share the Muslim identity can understand it well—for example, how it feels to be accused of being an Al-Qaeda fan due to the havoc wreaked by extremist terrorist groups.

In Leicestershire, two students were pelted with eggs, upon mistakenly deemed to be Chinese. In Los Angeles, a woman was verbally abused on public transport because of her Chinese descent after the virus's outbreak. A half-Chinese boy was "chased" and "cornered" in his school. The internet is filled with such stories of xenophobic behaviour against the backdrop of the global outbreak. #IAmNotAVirus, a vivid window into the high-spirited surge in racism, is now trending on Twitter.

The current scenario makes one reach some unsettling conclusions:

that xenophobia has always been there and the outbreak of a virus is only the pathway that allows and sustains its channelling; that racism probably stays at a distance until a moment comes when only the tag of a certain community is related to a certain thing or event causing global concerns; that no one is safe from the talons of hasty generalisation—even though you are totally a different, autonomous being, the communal tag drilled into your identity will perhaps always incriminate you for things you have no control over; that regrettably, a community is often

singularised, and utmost panic, at times subconsciously, at times consciously, drives its multiplicities into the wasteland.

It is absurd to think that earlier we had to derive these observations from terror attacks and now other mediums are gaining the limelight. In the future, we will probably be exposed to newer mediums uncovering xenophobia, bigotry, and other forms of toxic biases.

In the age of social media, memes seem to be the frontrunners for blatant expression of racism, as they gain attention of the masses by making

derogatory puns and reigniting old biases against the Chinese culture in a new light. This is no new, divine finding; but the heavy normalisation of using a certain culture as fodder for racist, prejudicial, biased entertainment only reaffirms the fact that the perception generated by these racist means gives rise to the proliferation of this sick process. It also shapes the thinking of impressionable groups that find themselves on common platforms for directing their inner racism and, in the process, singularising a community on the grounds of stereotypes based on race ₹ and culture. Old stories, new windows.

The invisible trap of generalisation atches its victims in the atmosphere of trepidation and fear surrounding public emergencies. Even though it sets out to catch its victims, it gives one the opportunity to choose between sides—a blatantly xenophobic one that capitalises on individual safety and views and warrants prejudices in a moral light, and a thoughtful one that allows oneself to believe that a certain community is not a solitary build-up of the same bones.

It is, perhaps, one of the many tests of the current time to see how people all over the globe can avoid the trap or fall into it.



Family burnt alive as 'bandits' kill 21 in Nigeria

Armed attackers burned 21 people alive, including 16 members of the same family, in a revenge attack by criminal gangs on a village in northern Nigeria, residents said yesterday.

Gunmen on motorcycles raided the village of Bakali in Kaduna state on Tuesday, shooting and burning homes and vehicles to avenge a raid on their hideout by local vigilantes, inhabitants said.

"They killed 21 people in the attack," Bakali's community leader, Sani Nuhu, told AFP.

Residents said the assailants burned alive 16 members of the same family, including six children, and five members of a local self-defence group after locking them in a house.

A police spokesman said the force

had "received report of an attack by bandits on Bakali village" but was "still awaiting details".

The area where the attack happened has in recent years been a haven for criminal gangs who steal cattle and kidnap people for ransom.

Local communities have formed vigilante groups to protect themselves but this has failed to end the violence.

Residents said that prior to the attack vigilantes working together with the Nigerian security forces had stormed the criminal gang's camp in a

Last week the police said it carried out a major operation in the area that saw security forces "neutralise over 250 terrorists and bandits".

There was no independent confirmation of the toll.

Beijing outlines plans to improve air quality more in 2020

Beijing will cut smog levels further this year by putting more new energy vehicles (NEV) on its roads, reducing diesel-fuelled truck numbers and tightening its supervision of vehicle emissions and refined oil products, the city said on Thursday.

Beijing Municipality government also said it will aim to cut emissions in the petrochemical

The Chinese capital recorded an average concentration of tiny airborne smog particles known as PM2.5 at 42 micrograms per cubic metre last year, the lowest level since the country began an anti-air pollution campaign

Nevertheless, that PM2.5 level is still more than four times the World Health Organization's guideline of 10 micrograms per cubic metre of

"Beijing will make its best effort to improve air quality, with annual PM2.5 concentration and three-year average concentrations continuing to fall," the Beijing Municipality government said in a statement on

The city said it aims to have 400,000 NEVs - plug-in hybrids, battery-only electric vehicles and those powered by hydrogen fuel cells - by the end of the year, up from the 225,000 on its roads

at the end of 2018. It aims to speed up the elimination of high-emission cars and replace diesel-fuelled trucks with NEVs, which it will use for all its postal, intra-city delivery, environmental sanitation departments and for its airport and public bus systems.

Meanwhile, Beijing said it will strengthen its supervision of in-use vehicles by carrying out checks on at

least 1.5 million heavy-duty diesel

It will set stricter standards on gasoline and diesel, with lower olefin, aromatics and polycyclic aromatic hydrocarbon (PAH) contents.

Emission levels at petrochemical firms will have to be cut by more than 30% in 2020 from the 2017 level, while industrial coating and furniture companies will undergo emission assessments by local authorities, according to the statement.

The city has seen PM2.5 concentrations of over 120 micrograms per cubic metre for five consecutive days since Sunday, despite the production and transportation disruptions due to the coronavirus

"Pollutant emissions from heavy industry and residential heating, which account for two-thirds of the total in the Beijing-Tianjin-Hebei region, did not decline during the national holiday," said the Ministry of Ecology and Environment (MEE) in a statement on Thursday.

While emissions from coal-fired power plants and steel mills fell by around 10% from their pre-holiday levels, there was little change in pollution level from the coke, petrochemical, glass and non-ferrous metals industries, the MEE said.

Iran starts election campaign with thousands barred from standing

Iran's week-long parliamentary election campaign started on Thursday, state TV reported, a vote seen as a popularity test for the clerical establishment at a time when relations with Washington are at their worst since the 1979 Islamic revolution.

The Guardian Council, which must approve candidates, has rejected around 6,850 moderate or conservative hopefuls in favour of hardliners from among the 14,000 applicants seeking to contest the Feb. 21 vote.

About a third of lawmakers have also been barred from standing again.

"The 7,150 candidates who are running for parliamentary elections have started campaigning on Thursday," state TV reported.

Pragmatist President Hassan Rouhani has criticised the disqualifications, but like supreme leader Ayatollah Ali Khamenei he has called for a high turnout as the country faces challenges over its disputed nuclear programme.

at "which parts have influence," and in which combinations.

In an initial study, diners were placed in different lighting conditions, but there was no effect on how much they ate, how long the meal lasted or how the soup was perceived to taste, except that it was reported as less salty in dim lighting. The researchers speculated that this could be because our sense of taste is heightened when our ability to see is reduced.

A second study was conducted nvolving 159 participants, adding table linen as an additional variable and eating in a group, rather than alone.

In the group that ate with dim lighting and a tablecloth, people consumed a mean 51% more soup than those who ate in dim light without a tablecloth. The neutral, gray-and-white checked tablecloth had a far stronger overall effect on the length of meal, amount consumed and enjoyment than lighting level.

Ströbele-Benschop said the findings could be useful in encouraging people in retirement homes, hospitals or schools to eat. While it could be difficult to improve the ambience in such settings, staff could do something as simple as choosing colorful plates, she suggested.

"It's the combination of decorative aspects," she said. "Any ambient factors could promote more enjoyment."

While eating more is not always lesirable, she said improving the atmosphere could help encourage diners to choose healthy food by making it seem to taste better.

The researchers wrote that the human body has a "sophisticated appetite control system which includes a variety of internal signals.

There is an "abundance of physiological, environmental and osychological influences on our daily food intake," including "eating with others, odor, color, physical surroundings," they said.

An Oxford University study from 2015 found that heavy cutlery enhances the enjoyment of food, while 2008 research from Stanford University found that participants rated wines they were told were more expensive as tasting better.

Ströbele-Benschop said the most mportant factor on Valentine's Day was to be "with the person you love" and create something you will both enjoy.

But a tablecloth can't hurt. "Valentine's is a day when it's all about ambience."

test will not be easy. But it would be great if we could arrange it successfully. It will be difficult to determine how the method will work and how the different departments will pick their students. But I hope the authorities will address all these issues.

He said all public universities enjoy autonomy. "It's not fully correct that quality of education at large universities, run under the 1973 ordinance, are far better than in other public universities.

Former DU professor Syed Manzoorul Islam said arranging a unified admission test is a good move and all the preparations should be made properly.

He recommended holding a dialogue with all stakeholders, including the admission seekers and initiative, to discuss the matter. 'We have to reach a consensus

on the issue after hearing all the arguments from the stakeholders. It's not a matter of imposing something on somebody. Manzoorul said introducing such

a test would be a daunting task. "If we don't make proper preparations, we might have to regret the decision

Immediate past UGC chair Prof Abdul Mannan refused to make any comment on the issue. Prof Chairman

Empowering, not interfering the way forward

The Young Tigers' World Cup triumph, the guarded approach from the Bangladesh Cricket Board following that historic result and, most importantly, the players' willingness to keep their feet on the ground -- all of these factors

have created a positive vibe in the country's cricket. It was nice to hear everybody emphasise on planning for the future so that today's heroes could prepare themselves for bigger challenges instead of only bubbling with

emotion and euphoria. As a custodian of Bangladesh cricket, Nazmul Hassan also rightly pointed out the importance of planning for the future so that highest number of players from this bunch could represent the national team in the future.

Hassan's motto of taking initiatives for these young players so that they can enhance their skills for a sustainable future career is appreciable but some may beg to differ with one of his observations, which he stated during a press

conference on Wednesday in Mirpur. The issue of the national team's performances were also broached while speaking about the success of the Bangladesh U-19 team and at one point, Hassan proudly said that he wanted to be 'Mr. Interferer' again in order to

rescue the Tigers from the doldrums. We did not hear any one from outside from the team management talk about any technical

Tigers given option to sit out

BCL third round begins today

For the past week, all the media attention was grabbed by the Akbar Aliled team that brought home the nation's first ever World

Cup, which they won by defeating their Indian counterparts in a thrilling ICC Under-19 World Cup final in Potchefstroom last Sunday. The champions have left for their

hometowns and the focus now returns to the Bangladesh national side, whose recent performances have become a grave concern for the Bangladesh Cricket Board (BCB). The Tigers returned early this week

after an abysmal showing in Pakistan. The Mominul Haque-led side recorded their sixth consecutive Test defeat when they succumbed to a thumping innings and 44-run defeat against Pakistan during their first World Test Championship fixture of the threephased tour of the country.

However, most of the side that played in the Pakistan Test, were not included in the squads for the third and final round of the Bangladesh Cricket League (BCL) which is scheduled to

begin in Cox's Bazar today.

The next assignment for Bangladesh is a home series against Zimbabwe that includes a lone Test, three ODIs and two T20Is respectively starting from February 22 before the Tigers leave for the third phase of the Pakistan tour in April. And keeping in mind the busy schedule, BCB opted to give the four fast bowlers who were in the Test squad Abu Jayed, Ebadot Hossain, Al-Amin Hossain and Rubel Hossain -- a rest while giving the batsmen the option to sit the round out.

"Most players [who played in the Pakistan Test] were given choices by the board about whether they want to play [BCL third round]. It was actually decided that the fast bowlers will rest and the batsmen were given a choice. The camp [for Zimbabwe series] starts on February 18 and the BCL will end on 17. So, the gap in between is very little," explained national selector Habibul Bashar yesterday.

The final round of the first-class tournament will see East Zone battle it out against North Zone at the Sheikh Kamal International Cricket Stadium while at the Academy Ground of the same venue, table-toppers South Zone will square off against Central Zone.

Only three players -- Saif Hassan, azmúl Hossain Śhanto and Nayeem Hasan -- who were in the squad that played in Pakistan will be playing in the final round of BCL.

Soumya Sarkar, however, has a different reason for missing the BCL. The left-armer will be getting married this month and will be unavailable till February 29

Mushfiqur Rahim, who opted out of the Pakistan Test, is however expected to play for North Zone today. It was earlier reported that Mushfiqur might be dropped from the Zimbabwe Test. However, Bashar informed yesterday that the stalwart is playing the BCL as he has not played the Pakistan Test and was an automatic pick for his BCL side.

The former national skipper also informed that the situation about Mahmudullah will be cleared in two or three days' time. It was earlier learned that Bangladesh coach Russell Domingo will be having a conversation with Mahmudullah, who has been undergoing a lean patch in the longer formats recently, and would be asked to rethink his future in Test cricket.

Kumar Sangakkara, the MCC president and captain of its 12man squad on a week-long tour of Pakistan, believes in actions more than words, which is why he's in the country to ensure Pakistan is back on the cricketing map.

Addressing a press conference on Thursday he said it had been 47 years since the club last visited Pakistan and 10 years for him personally.

"Cricket belongs to everyone, but for the players to have that platform and display their skills you need to have that support," Sangakkara said in Lahore. "The fact is that you need to have an

Sangakkara, who took over the charge as MCC president in October 2019, further said it's difficult to put into words what a strong Pakistan brings to world cricket, and how it's important to hammer home the message that touring Pakistan is now safe.

'Rather than a direct message by saying something to them, the best thing that we can do is send that message by the way we play in the field," Sangakkara

Chelsea get Ziyech Ctg Abahani cruise, Kings toil for just €40m



Hakim Ziyech will join Chelsea from Premier Dutch champions Ajax this summer in League a 40 million-euro deal, the two clubs confirmed Thursday.

The announcement ends days of speculation over the future of the 26-year-old attacking midfielder, a Moroccan international

"Ajax and Chelsea have reached an agreement for the transfer of Hakim Ziyech. The player will join the Premier League club on July 1st 2020 and will finish the season in

Amsterdam," the Eredivisie champions said in a statement. Chelsea confirmed the deal, praising Dutch-born Ziyech as a "prolific scorer throughout his career."

"Ziyech is a left-footed attacker who is comfortable playing off the right flank and coming inside, as he has often done in recent years to such devastating effect for Ajax, or on the left to attack with width and deliver into the box," Chelsea said.

The London-based side added: "The move is subject to the player agreeing personal terms and he will remain at the Dutch club for the rest of this season."

Ziyech joined Ajax in 2016 from fellow Eredivisie club FC Twente for a fee of 11 million euros, and has now scored 49 goals in 160 appearances for Ajax. His contract at Ajax was due to run until June 2022.

Ziyech was a key figure in Ajax's sensational run to the Champions League semifinals last year. But he reportedly wanted more football in Europe's top flight after the Dutch side were eliminated in the group stage this year -- in part because they lost at home to Chelsea and later threw away a three-goal lead at Stamford Bridge.

Bashundhara Kings, who started the season by lifting the Federation Cup five weeks ago, were made to sweat against Baridhara. The holders could hardly find any holes in the opposition defence but still fortunate to leave with three points courtesy of a strike from inspiring Costa Rican forward Colindres.

After a barren first half, Bashundhara Kings pushed hard for the lead and Argentine midfielder Nicolas Delmonte saw his left-footed shot from 30 yards go inches over in the 46th minute.

Spanish coach Oscar Bruzon strengthened the attacking line-up by sending on the fresh legs of Mahbubur Rahmn Sufil and Colindres rattled the sidebar in the 69th

Educationists split over **UGC** move

Renowned educationists are divided over the University Grants Commission's move to introduce a central entrance test for public universities.

Opposing the move, some academics said a uniform admission test would force the universities to "compromise on quality of students". They insisted that the universities should have the power to choose their students to "uphold their academic speciality".

They also expressed concern that the autonomy of the universities might be affected if the new admission system was introduced.

Educationists supporting the move said a central admission test would reduce hassles of admission seekers and their guardians.

However, educationists from both the groups said introducing such an admission test would be a daunting task and there should be a mechanism to stop any irregularities, including leak of question papers.

The UGC is all set to introduce the central admission test this year to reduce the hassles of admission seekers.

Speaking to reporters after holding a meeting with 12 VCs if public universities on Wednesday, UGC Chairman Prof Kazi Shahidullah said, "We have unanimously decided that a central admission test will be held this year to enroll students at public universities."

Prof Emeritus of Dhaka University Serajul Islam Choudhury said a uniform entrance test is needed to reduce the hassle of admission seekers who now take several tests within a short time.

"They need to travel to different cities and towns which

KSA sends 183 back

Saudi Arabia sent back 183 Bangladeshi migrant workers, including 20 female workers, on Wednesday night and in the early hours yesterday, according to Brac Migration Programme.

A Saudi Airlines flight carrying 89 workers landed at Hazrat Shahjalal International Airport in Dhaka around 11:20pm Wednesday, Brac said.

Another flight of the same airlines brought back 94 Bangladeshi workers around 1:10 am yesterday, it added.

Brac Migration Programme, with the help of Prabashi Kalyan Desk set up by the expatriates' welfare ministry at the airport, provided the returning workers with immediate support.

Shariful Hasan, head of Brac Migration Programme, said some 3,635 migrant workers, 175 of whom are female, were sent back by Saudi Arabia in January alone.

Many of the workers returned home "empty-handed", said Shariful.

He urged recruiting agencies to be more mindful while sending workers abroad so that they do not have to return home in this manner.

He called upon the government and Bangladesh mission authorities in the Kingdom to identify the reasons behind the deportation.

If you're hoping to impress a date with a romantic home-cooked meal today, Valentine's Day, don't forget the tablecloth.

Diners eat more and for longer, and rate the food as tasting better when seated with tablecloth, according to a study published in the journal "Food Quality and Preference."

Participants in the experiment by the University of Hohenheim in Germany were divided into four groups, eating tomato soup with or without a tablecloth, in high or low lighting. The tablecloth was found to have the biggest impact on how the quality of the food was perceived, the amount eaten and how long participants ate for.

Professor Nanette Ströbele-Benschop, the lead researcher in the study, told CNN the results were "fascinating."

She said previous studies had shown that environmental factors are important in how we perceive our food and she wanted to look
