We're looking for alternatives

PM tells JS regarding import of raw materials from China following coronavirus outbreak; 'country's economy better than that of Singapore'

Sheikh Prime Minister Hasina yesterday said there was nothing to panic about coronavirus fallout as the country was taking steps to import raw materials from markets other than China.

"We're facing a little problem; many things have to be imported from China. But we're cautious enough," she said in parliament.

The prime minister was taking part in a discussion on the thanksgiving motion on the president's speech. It was her concluding speech at the sixth session of the current parliament.

"We're taking steps to import raw materials, including chemicals, for the pharmaceutical industry ... we're enquiring about the alternatives, we're taking measures to import even from markets that may cost us more. There's nothing to panic about.

She urged businesspeople not to stock any essential items out of fear, warning that if they do so, that might be a waste.

Hasina also claimed that Bangladesh is now economically stronger than Singapore. "I can at least claim that we are stronger than Singapore in terms of economic progress," she said.

Earlier, in her valedictory speech in the



House, Opposition Leader Raushan Ershad asked how did Finance Minister AHM Mustafa Kamal say Bangladesh would cross Singapore in terms of economic progress. Hasina said, "But I will

say that Singapore is a small country with a smaller population. The [Singapore] country is a disciplined one.

We are a small country but we have more population.

She said that ensuring development in Bangladesh was very tough. "Besides, Singapore has no opposition [party]. There is a state-run newspaper in Singapore and that newspaper is controlled by the government.

"Ensuring development in Singapore is easy due to the political and economic environment that prevails in the country. On the contrary, we have to face arson attacks, killing and torture.

She also said Bangladesh was receiving a huge amount in investments.

Bangladesh is the most attractive

destination for investment in the South East and South Asia ... Not only among the South Asian countries, we are also ahead among the South Eastern countries." In her speech, Raushan also said, "Many



IEDCR boss cautions against rumours STAFF CORRESPONDENT Government officials

BNP Chairperson Khaleda Zia yesterday again sought bail from the High Court on health grounds. She wants to have treatment abroad.



Khaleda submitted the bail petition to the HC through her lawyer Sagir Hossain Leon.

The BNP chief said she has been suffering from several diseases like diabetes and dental problem, and her physical condition has been deteriorating since December 12 last year.

She is now seriously ill. She cannot move freely, take food, and medicine without the help of others. She needs immediate treatment/therapy abroad, like in the UK, says the petition.

The HC is yet to set any date for hearing the petition.

On an average, 17 women and children were allegedly raped each day last year, shows data based on cases filed with police stations across the country.

The number of such cases rose by 19 percent compared to the previous year, shows the data of the Police Headquarters.

The actual number could be higher as many victims refrain from lodging complaints due to social stigma associated with rape as well as insecurity and fear of harassment, say experts and rights activists.

According to the PHQ statistics, 6,321 rape cases were filed with police stations from January to December last year. For the period in 2018, the number was 5,123.

The statistics rings an alarm bell as the number of alleged rape victims exceeds those given by different rights bodies.

For example, Ain o Salish Kendra (ASK), in its annual report released recently, said 1,413 victims were either gang-raped or subjected to rape last year. The number almost doubled compared to the previous year, it said.

The ASK report, prepared on the basis of media reports, said 118 of the victims were aged six or bellow, 210 victims between seven and 12, and 234 victims were aged 13-18.

Another recent report, published by Bangladesh Mahila Parishad, said 1,370 rape incidents were reported last year.

Talking to The Daily Star about the PHQ data, Rokeya Kabir, executive director of Bangladesh Nari Progati Sangha (BNPS), said the situation was very grave. "The picture is also grim when it's about women repression."

Hospital director at Wuhan dies; global economic impact spreads Agencies

The death toll from the new coronavirus outbreak rose again yesterday but Chinese and international health officials sought to calm global nerves, citing a study showing most cases are mild and warning against excessive measures to contain the epidemic.

Nearly 1,900 people have now died and more than 72,000 people have been infected by the virus in China, with hundreds more cases in some 25 countries.

The epidemic has triggered panic-buying in Singapore and Hong Kong, concerns about cruise-ship travel and the postponement of trade fairs, sports competitions and cultural events in China and abroad.

The outbreak is threatening to put a dent in the global economy, with China paralysed by vast quarantine measures and major firms such as iPhone maker Apple and mining giant BHP warning it could damage bottom lines. Several countries have banned travellers from China and major airlines have suspended flights.

Saidpur airport to turn regional

Nepal to start using it soon DIPLOMATIC CORRESPONDENT

The government has decided to expand the airport in Saidpur for Nepali flights to improve connectivity, trade and tourism with the South Asian Himalayan nation.

Foreign Minister AK Abdul Momen revealed the plan after meeting with his Nepali counterpart Pradeep Kumar Gyawali at the Meghna State Guest House in the city yesterday.

"Now a technical committee will be formed to assess what kind of flights can land and take off from there," Momen told reporters.

A Nepali delegation, led by Gyawali, arrived in Dhaka Monday on a three-day visit. During the meeting yesterday, the two sides discussed ways of improving trade and commerce, connectivity, tourism, energy cooperation etc.

"We are expanding the Saidpur Airport. Currently, 12-14 flights are operated there daily. So, people can come to Dhaka easily," Momen said.

Bangladesh Ambassador to Nepal Mashfee Binte Shams told The Daily Star that presently there are flights between Dhaka and Kathmandu, but Bangladesh wants to turn Saidpur Airport into a regional one. The government is working to upgrade it into an international airport.

The Saidpur Airport is only around 15 minutes from Nepal's Bhadrapur and Biratnagar airports. The people in Bangladesh's northern districts can travel to and from SEE PAGE 10 COL 2

Weinstein jury to begin deliberations

Jurors will begin deliberating the fate of ex-Hollywood titan Harvey Weinstein on Tuesday in his highprofile sex crimes trial that marked a watershed moment in the #MeToo movement.

The disgraced movie mogul, 67, faces life in prison if the jury of seven men and five women convict him of predatory sexual assault charges in New York

More than 80 women have accused Weinstein of sexual misconduct since allegations against him ignited the #MeToo global reckoning against men abusing positions of power in October 2017.

But the jury is considering charges related to just two: ex-actress Jessica Mann and former production assistant Mimi Haleyi, with many claims too old to prosecute.

Mann, 34, says Weinstein raped her in March 2013, while Haleyi alleges he forcibly performed oral sex on her in July 2006.

The proceedings, which began

hearing testimony on January 22, threw up complicated issues surrounding consent and abuse of power for the jury.

Under cross-examination, both Mann and Haleyi acknowledged at least one consensual sexual encounter with Weinstein after the alleged assaults.

Defense lawyers presented dozens of emails and text messages in court that appeared to show both Mann and Haleyi on friendly terms with Weinstein years after the alleged attacks.

His team said the relationships were consensual and transactional, arguing that the accusers used sex with the defendant to advance their own careers.

Prosecutors said he was a career sexual predator who took advantage of his powerful position in the American film industry to prey on aspiring young actresses.

Weinstein, the producer of "Pulp Fiction" and "Sin City," is the first man accused of abuse in the #MeToo movement to face a criminal trial.

Earlier, the Supreme Court's HC Division denied her bail twice in the case and the Appellate Division once. Anti-Corruption Commission chief counsel Khurshid Alam Khan, who received a copy of the petition, told The Daily Star that Khaleda sought bail in the graft case on merit and medical grounds.

"We have gone through the impugned judgment and order of conviction and sentence but did not notice any apparent or glaring infirmity in the same," the bench said rejecting the petition.

In the order, the bench also said Attorney General Mahbubey Alam has assured this court of his readiness for an expeditious hearing of the appeal against the trial court verdict and therefore, there is no possibility of delay in hearing the appeal on nerit.

"In the above view of the matter, we do not find any cogent reason for granting the appellant bail at this point of time. Accordingly, the application for bail is rejected," the HC judges said in the order.

A Rohingya woman was beaten to death by two others in their camp in Teknaf, Cox's Bazar yesterday.

The deceased, Nur Nahar, 40, was wife of Nur Alam, a resident of Leda Rohingya camp (Block B) in Hnila union.

Section 94 (1) of the Act says In every establishment, where 40 (forty) or more female workers are ordinarily employed, one or more suitable rooms shall be provided and maintained for the use of their children who are under the age of 6 (six) years".

"The said rooms shall be adequately furnished and in particular, 1 (one) cot or cradle with bed shall be kept therefore each child, and there shall be at least one chair or any similar seat for the use of each mother while she is feeding or attending to her child, and adequate and suitable toys shall be supplied for the comparatively older children", according to section 98(7) of the Act.

Following the same writ petition, another HC bench on October 27 last year issued a rule asking the authorities to explain why they should not be directed to take necessary steps to set up breastfeeding and baby care corners at all public places.

The court asked the authorities concerned of the government to show cause why the women and children affairs ministry should not be ordered to formulate a guideline to establish breastfeeding and baby care corners at all workplaces, shopping malls, airports, bus stops and railway stations, and public, private and autonomous institutions across the country.

The writ petition said that mothers feel uneasy to feed their children at workplaces and other public places as there is no specific breastfeeding and baby care corner.



WHO urges calm as death toll climbs

FROM PAGE 1 The World Health Organization, which has previously said travel restrictions were unnecessary, rejected the suggestion that all cruises should be halted after hundreds of passengers were infected on one vessel off Japan

"Measures should be taken proportional to the situation. Blanket measures may not help," WHO chief Tedros Adhanom Ghebreyesus told reporters in Geneva. The WHO has praised China for taking

drastic measures to contain the virus.

Authorities have placed about 56 million people in hard-hit central Hubei under an unprecedented lockdown.

Other cities far from the epicentre have restricted the movements of residents, while Beijing ordered people arriving in the capital to undergo a 14-day self-quarantine.

The official death toll in China hit 1,868 Tuesday after another 98 people died, most in Hubei and its capital Wuhan, where the virus emerged in December. More people died outside China so far.

There were nearly 1,900 new cases -- a drop from the previous day. Reported new infections have been falling in the rest of the country for the past two weeks.

Tedros warned that it was too early to tell if the decline would continue.

The situation remains dire at the epicentre, with the director of a Wuhan hospital dying yesterday -- the seventh medical worker to succumb to the COVID-19 illness.

But a study among 72,000 confirmed, suspected and clinically diagnosed cases showed that 81 percent of patients had only mild infections.

Those most at risk were the elderly, and people with underlying medical conditions.

The study released by China's Centre for Disease Control and Prevention also showed that the death rate stood at 2.3 percent, falling below one percent for people in their 30s and 40s.

Zhong Nanshan, a prominent expert with China's National Health Commission, told reporters that 85 percent of patients can improve "if they have good life support,

treatment conditions, and nutrients".

The research was cited by WHO officials, who said the COVID-19 illness was "less deadly" than its cousins, such as Severe Acute Respiratory Syndrome (SARS) or Middle East Respiratory Syndrome (MÉRS). "This is a very serious outbreak and it

has the potential to grow, but we need to balance that in terms of the number of people infected," said Michael Ryan, head of WHO's health emergencies programme.

"Outside Hubei this epidemic is affecting a very, very tiny, tiny proportion of people. There have been some 900 cases around

the world, with only five deaths outside the mainland -- in France, Japan, the Philippines, Taiwan and Hong Kong.

Another 88 people tested positive for the virus on the quarantined Diamond Prince cruise ship off Yokohama in Japan, raising the number of infections to 542,

Since the US repatriated more than 300 American passengers on Monday, Britain became the latest country to offer its citizens a way off the boat, after similar plans by Canada, Australia, Hong Kong and South Korea.

Attention was also turning to the Westerdam, a cruise ship in Cambodia, where many of the 2,200 people aboard passengers were allowed to disembark after all initially received a clean bill of health.

They were met by Cambodia's premier, taken on a bus tour of the country's capital, and allowed to fly around the world.

But an 83-year-old American woman was later diagnosed with the virus after arriving in Malaysia.

Ads Covering Bus Windows BRTA fines two companies STAFF CORRESPONDENT

Amid growing safety concerns -- especially for female passengers, Bangladesh Road Transport Authority (BRTA) has started a drive against transport owners who are covering windows of their buses with advertisement, blocking inside and outside views

A mobile court led by BRTA Executive Magistrate Mazharul Islam yesterday fined two bus companies Tk 10,000 each for violating Road Transport Act-2018 by covering widows with advertisements.

The two companies -- Dhaka Chaka and Green Dhaka -- averted further punishment by giving written bond that they would remove advertisements from all of their buses within next seven days. Another bus company -- Shatabdi Paribahan -- also gave similar promise.

BRTA decided to launch an investigation recently after receiving several allegations of uses of advertisement on bus windows, compromising passengers' security, especially of female passengers, the state transport regulator SEE PAGE 4 COL 5

Utility bill fiasco wastes 22 days

Power restored at BGMEA building, demolition finally on in full swing

Demolition of the much-talked-about BGMEA Bhaban -- constructed illegally over a decade ago -- began in full swing yesterday, after power connection was restored to the building.

After nearly a year-long delay, Rajdhani Unnayan Kartripakkha (Rajuk) began demolition of the Bangladesh Garment Manufacturers and Exporters Association building on January 22.

Rajuk said the 16-storey building would be demolished in six months. The capital's development authority hired Messrs Four Star Enterprise, a local company, which began the work on January 27 due to some legal bindings.

However, demolition work had been continuing at a snail's pace until yesterday, as the company did not get any power connection at the building to use heavy machinery -- due to a pending electricity bill of BGMEA with Dhaka Power Distribution Company (DPDC).

Four Star had to depend on two generators, which slowed down the entire process. "Finally, the issue has been resolved with intervention of the authorities concerned," said Nasrullah Khan Rashed, its director.

He said they have got a 440-volt power line and will continue working to complete the demolition within six months.

One more victim of Monday's fire in Narayanganj succumbed to his injuries yesterday at the Dhaka Medical College Hospital (DMCH).


Kiron Miya (45), who was admitted to the hospital with 70 percent burns, died at 10am, said DMCH police outpost in-charge Bacchu Mia, quoting the doctors.

Six other victims of the deadly blaze from the gas explosion were undergoing treatment at the burn unit of the hospital, three of whom are in critical condition, the official added.

Abul Hossain (25) sustained 45 percent burns, Hiron Miya (25) 22 percent, Kawser Miya (16) 25 percent, Mukta Aktar (20) 15 percent, three-year-old Elma Aktar 14 percent burns, while 10-year-old Apon sustained 20 percent burn injuries.

Abdullah al Arefin, deputy director of Narayanganj Fire Service and Civil Defence, told The Daily Star that family members fell asleep without turning off the gas stove on the day.

As a result, gas accumulated overnight, causing the explosion after fire was lit in the kitchen, the deputy director added.

Supply and Sewerage Authority has proposed hiking water prices by 80 percent for residential and commercial uses recently.

Wasa has proposed Tk 20 for each unit (1,000 litre) of water for residential use. The existing price is Tk 11.57. For commercial purpose, it has recommended Tk 65 against the existing rate of Tk 37.04.

According to a report of TIB, nearly 45 percent people in the capital do not get the desired amount of water from Wasa. Besides, about 35 percent complain of poor-quality water throughout the year, while 91 percent clients of Wasa have to boil the water before drinking, although it is supposed to be safe.

TIB stressed the need for taking opinion of experts and asked to arrange public hearing to improve the service of Wasa, by forming a separate regulatory structure.

On April 3, 2011, a HC bench ordered its demolition. Two days later, the Appellate Division, however, stayed the order for six weeks and asked the BGMEA to file a leave to appeal petition against the verdict.

On March 19, 2013, the HC in its verdict ordered the relevant authorities to demolish the building in three months. The court also directed the BGMEA to refund money to the buyers of floor space within a year.

In April last year, an Appellate Division bench ordered the BGMEA building be demolished after April 12. The court termed the building "a cancer in the Hatirjheel project".

On April 16, Rajuk went there along with law enforcers and bulldozers. People were, however, still inside and the authorities had to pull out for the day. The building

was then sealed off.



Two sustain burns in gas cylinder blast

Two youths suffered burn injuries in a fire yesterday evening, supposedly caused by the explosion of a kitchen gas cylinder in Shyampur area of the capital.

The injured were identified as Md Sajib (24) and Hafizul (23). They were rushed to the burn unit of Dhaka Medical College Hospital (DMCH).

The duo live at a tinshed house near Dhaka Match Factory in the old part of Dhaka.

Zakir Hossain, a roommate of the injured, told reporters that both of them work at a workshop. They came home from workplace in the afternoon and were preparing to cook.

The cylinder exploded when the stove was lit around 6:30pm, he said.

Quoting physicians of the burn unit, DMCH police outpost in-charge Bacchu Mia told reporters that Hafijul suffered 30 percent burns, while Sajib eight percent burns.

I am a victim of conspiracy: Nasir

After losing the Awami League party ticket for the mayoral post in the upcoming city polls, incumbent mayor of Chattogram City Corporation (CCC) AJM Nasir Uddin yesterday told journalists that he was a victim of "conspiracy, propaganda and lies".

"The post of mayor is not the biggest thing for me... politics is my main priority. Had anyone come to me and asked me to leave the post, I would have left it gladly," said Nasir, adding, "There was no need to spread false propaganda against me."

Nasir, also general secretary of Chattogram city unit AL, was looked over for the party's nomination on Saturday, which instead went to Rezaul Karim Chowdhury, joint general secretary of the same unit.

Speaking at a views-exchange meeting at Chattogram Press Club, Nasir said he did not have any grief, anger, or frustration over missing out on the nomination.

"I was just hurt to see false propaganda in social media against me," he said. "My photo with a relative of a killer of Bangabandhu went viral on social media in a bid to establish that I have a relation with the killers, which is hundred percent false... I do not know the person."

"I was inaugurating a business in the port city and its owner was a former vice president of Chittagong University unit Bangladesh Chhatra League," he said.

"When I go to a programme, many people come to me and take photos; I do not necessarily know them all. I had never met the person in the photo [before then]. Now that person may be a relative of a killer of Bangabandhu, but I do not know him," he said, adding that "conspirators" had propagated the photo to spread propaganda.

"I did politics against the killers of Bangabandhu putting my life at risk. I have been doing politics holding the ideology of Bangabandhu throughout my life, and I SEE PAGE 4 COL 2

Road crashes claim 4 lives

At least four people were killed and three injured in road accidents across the country in the last two days, report our correspondents and news agencies.

In Bhola, Jihad (16) was killed and three were injured after an auto-rickshaw collided with his motorbike in Boidderpul area of Borhanuddin upazila yesterday noon.

Officer-in-Charge (investigation) of Borhanuddin Police Station Abdul Quader said the accident left Jihad dead on the spot. The injured were admitted to Bhola Sadar Hospital.

In Panchagarh, Md Masud (20) was killed after two tractors collided in Banglabandha Land Port area of Tetulia upazila around noon yesterday, said police.

Due to the collision, Masud was run over by one of the tractors, leaving him dead on the spot, they added.

In Chapainawabganj, Wasim Ali (49) was killed after a truck ran him over while he was crossing the road in Kansat Abbas Bazar area of Shibganj upazila around 7am yesterday, said police.

The truck driver and his helper fled the spot after the accident.

In Satkhira, Shamsur Rahman Sana (40) died after a speeding truck hit his motorbike in Patkelghhata area of Tala upazila around 2pm on Monday.

The deceased was a manager working for Dutch-Bangla Bank.

Witnesses said Shamsur lost control of his motorbike and fell off. At that moment, a speeding truck hit Shamsur, killing him on the spot.

Police were trying to catch the truck and its driver.

BUS DRIVER HELD OVER DEATH OF **TWO STUDENTS**

Police yesterday arrested a bus driver over the death of two students in a road accident in Bangabandhu Bridge area in Tangail.

The arrestee is Shahinul Islam (25), driver of a Govindaganj Special bus, reports our Tangail correspondent.

A police team of Bangabandhu Bridge East Police Station, led by Sub-inspector Jayed Bin Abdullah, arrested him from Govindaganj Bus Stand area in Gaibandha, said Kazi Aiyubur Rahman, OC of the police station.

On Sunday, two students of Medical Assistant Training School (MATS) in Tangail -- Mayen Uddin Hamim Turjya and Sadia Islam Nodi -- were killed after a bus ran them over while they were crossing the highway.

After the accident, driver and helper of the bus fled the scene, leaving the vehicle behind. Turjya's brother filed a case with the police station on the same day.

The protests escalated several days ago after UGC asked BSMRSTU authorities to shut the department down and complete academic activities of the existing batches.

Protesting the move, history students went on a sit-in programme in front of the administrative building, padlocking its gate on February 6. On February 9, they also padlocked gates of the academic building, leading to a complete halt of academic activities.

Mentionable, then BSMRSTU vice-chancellor Prof Khondoker Nasiruddin introduced the history

department is not approved, they started demonstrating. Meanwhile, general students


UGC FORMS PROBE BODY

A youth was killed and four persons were injured when a chunk of concrete fell on them during an eviction drive conducted by Bangladesh Railway (BR) in Sararchar station area of Kishoreganj yesterday.

Authorities said the five gathered in the area just to see the drive.

The deceased -- Nimai Chandra Banik (25) -- was from Uttar Sararchar in the district's Bajitpur upazila. He was declared dead at Jahurul Islam Medical College Hospital, according to police.

The injured -- Antor Saha (18), Rubel Mia (24), Kamal Mia (37) around the illegal structures before

adjacent villages -- were taken to repeatedly asked people or onlookers Bajitpur Upazila Health Complex, said Bajitpur Police Station Officer-in-Charge Md Khalilur Rahman Patwary.

"We are planning to allocate shops to the victims, which will be set up on the BR land on completion of the drive," he added.

The official said they were able to demolish around 120 structures till the postponement.

India launched far-reaching economic reforms in 1991, its stature in the world rose steadily. The country was already recognised as a

thriving democracy and an example to the world of how to manage diversity in a free and open society. Its enhanced economic clout and the size of its increasingly prosperous market added to its appeal. Its self-branding as the world's fastest-growing free-market democracy worked; world leaders queuing up to visit New Delhi became a burden for a generation of diplomatic protocol officers.

But in recent months, it has all begun to fall apart.

The reason is not hard to find. India's domestic political environment has turned toxic under Prime Minister Narendra Modi's Hindu nationalist government, owing to a train of divisive, socially discriminatory policies, accompanied by incendiary political rhetoric bordering on Islamophobia. Moreover, a series of disastrous economic decisionsnotably demonetisation and the botched implementation of a nationwide Goods and Services Taxput many small entrepreneurs out of business and threw millions of people out of work, further convulsing Indian society. And economic failure has only driven Modi's Bharatiya Janata Party (BJP) to double down on its political agenda, animated by the prejudices of its Hindutva ideology.

In particular, a series of decisions suggests the depth of the alienation, stoked by BJP policies and attitudes, of India's 180-million strong Muslim population. In recent years, the BJP has criminalised an Islamic form of divorce,

talaq-e-biddat; abolished the autonomy enjoyed by India's only Muslimmajority state, Jammu and Kashmir; campaigned for and celebrated a Supreme Court judgment awarding the site of a destroyed mosque to Hindus; and amended India's citizenship laws to give fast-track citizenship only to non-Muslim refugees and migrants from three neighbouring countries. These actions sparked weeks of

protest across the country and have subverted India's pluralist secularism. And if that wasn't bad enough, the heavy-handed and brutal response to protests in Delhi and Uttar Pradesh, where 27 Muslim protestors were shot dead, campuses invaded, and students assaulted, has shaken India's reputation as a democracy to be admired.

The "Rising India" narrative rested on the economy's performance and potential, and on India's success at managing its internal differences democratically and largely peacefully. Rapid economic growth opened up

new opportunities for cooperation with foreign countries: neighbours wanted to take advantage of their proximity, while major powers saw a useful partner worth courting. The contrast with China's rise as an authoritarian state was implicit. The Indian system, many felt, was not only more attractive, but also worked just as well.

No longer. Thanks to BJP's divisive sectarianism, driven by narrow partypolitical goals, India's stature in the world has never been lower. The recent developments have embarrassed India's friends in the neighbouring Muslim countries of Bangladesh and Afghanistan, shaken the confidence of foreign investors, antagonised influential members of the US Congress, and earned the government a chorus of disapproval. Major foreign newspapers, whether on the right (like The Wall Street Journal or the Financial Times) or the left (like The Guardian and The Washington Post) have published critical editorials about India in recent months. The drumbeat

of daily reporting and commentaries is relentlessly negative.

At home, even neutral figures known for their habitual reticence on political matters have expressed alarm. Former Foreign Secretary Shivshankar Menon recently described the government's amendment to the Citizenship Act as a "self-inflicted goal" that has isolated India and resulted in the country being routinely mentioned alongside Pakistan as an intolerant state. The divisive policies of the government, he added, has given our adversaries "platforms to attack us" and left India with "no international support apart from a section of the Indian diaspora and some extreme right Members of the European Parliament.'

Several world leaders, including French President Emmanuel Macron, German Chancellor Angela Merkel, the visiting Norwegian king, Harald V, and chiefs of United Nations agencies on human rights and refugees, have

criticised the government's recent moves. For the first time in over 40 years, Kashmir was discussed in the UN Security Council. The bipartisan consensus on strong bilateral relations that has existed in the United States for 25 years, irrespective of the government in Delhi or Washington, has been broken.

What the world thinks matters more than ever before, not least because India is far more dependent on external trade and investment. Foreign investment requires trust and faith in the future, which is fast eroding. The world increasingly sees India as an intolerant, narrow-minded country. Its credit ratings have been downgraded. Seven countries have issued travel warnings.

The Indian economy's stumbling performance and its domestic political divides have created new foreignpolicy challenges in an increasingly difficult external environment, with a transactional President Donald Trump taking a cost-benefit view of the US-India relationship and Chinese President Xi Jinping strengthening his support for India's hostile neighbour, Pakistan. Amid a period of domestic and global unpredictability, India's place in the twenty-first-century world, which once seemed so promising, is again being called into question.

The Indian government shows little sign of waking up to the consequences of its domestic policies. It seems to assume that a country of 1.3 billion people with the world's fifth-largest economy, a member of the G20 and the Brics, cannot be ignored. It consoles itself that its actions still garner popular support in India. But an India that is perceived as bigoted, with a government that, intoxicated by intolerant majoritarianism, is wilfully driving sectarian wedges between its people, can forget about the global embrace on which its future depends.

which is already deemed to be more VER the urban than rural. And this trend will decade, continue for the coming decade. This mega trend is also linked to the climate change issue, as many millions of people currently living in vulnerable rural areas such as low-lying coastal areas and drought prone areas of the world will be forced to migrate due



areas in future. We must prove that we are able to learn from our mistakes and not repeat them when it comes to protecting the wetlands east of Dhaka, and not build over them.

Finally, on the issue of the knowledge economy, we are extremely well placed with the raw material for exploiting this opportunity, namely

of human induced climate change which will be felt in all countries both rich and poor. While efforts to keep global mean temperature below 1.5 degrees (which may already be out of reach) or at most 2 degrees centigrade must continue, these efforts will not affect the climate change impacts for the coming decade which are already locked in due to the greenhouse gas emissions from previous decades. Hence, every country, whether rich or poor, must prepare to adapt, as well as deal with the inevitable loss and damage that will happen due to human induced climate change over the next 10 years.

The second major trend, which is related to the first, is the loss of biodiversity with perhaps a million species of plants and animals being lost including important ecosystems and habitats over the next decade. The recent unprecedented wildfires in Australia which killed over a billion animals is a harbinger of this trend, which will only get worse over time.

The third mega trend is the rapid urbanisation of the global population

to climate change impacts and will almost certainly end up moving to cities.

The fourth and final mega trend is related to technological development, sometimes linked to artificial intelligence (AI), or more generally, to knowledge generation and use which is likely to change manufacturing to be less and less dependent on human labour over time.

All four of these global megatrends are very relevant for Bangladesh and can either hold back our development, or if we play our cards right, may prove to be good opportunities for us to enhance our resilience and ensure a better development pathway that enables us to not only overcome the negative aspects but indeed take advantage of them.

Here are some ideas on how this might be achieved.

The first issue of climate change is already high on our national agenda and with the soon to be published revised Bangladesh Climate Change Strategy and Action Plan (BCCSAP) that will take us to 2030, we will have a blueprint for what needs to be done in order to transform Bangladesh from being one of the world's most climate

vulnerable country to becoming one of the world's most resilient one. This will require us to mainstream or integrate climate change actions into everything we do, both within government ministries and agencies, as well as in civil society and private sector. The good news is that this is already beginning to happen, so it needs to only be accelerated going forward.

On the issue of protecting biodiversity, the Bangladesh parliament has taken a pioneering role of declaring a "planetary emergency" which addresses both climate change as well as biodiversity and this

now needs to be put into planning and practice. There are two major potential problems we need to keep in mind, and avoid if we can. First, once the Khulna region is opened up to economic development due to the inaugural of the Padma Bridge, we must ensure that this development is nature-based and does not destroy our Sundarbans. Second, the development of the eastern side of Dhaka, over what are some of our last remaining wetlands in this region. If we merely repeat the mistakes we made with the current area of Dhaka, then we will get ourselves into trouble for the new

young girls and boys, but only if we can rapidly change and improve the education that we are providing to them. The young people of Bangladesh are amongst the brightest anywhere in the world, and have the potential to become problem-solvers not just for Bangladesh, but for all the global megatrends mentioned above and hence a resource for all countries.

However, this will require a very rapid transition from our traditional education system, from its emphasis on exam-oriented job-seeking outcomes, to a problem-solving modality where we produce job creators and not just job seekers. The good news is that this transition will not cost any more money than we are spending already, but will require a new kind of thinking and practice from both the government as well as the universities and academic sector of the country. If we are able to make this transition in thinking and implement it, then Bangladesh can emerge as a global champion in tackling all the global megatrends mentioned above.



Turkey ramps up Gulen crackdown

Turkish prosecutors yesterday ordered the arrest of nearly 700 people, including military and justice ministry personnel, state media said, intensifying moves against a network accused of orchestrating a 2016 coup attempt, in which about 250 people were killed. The latest operations marked an escalation by police against alleged supporters of Gulen, a one-time ally of President Tayyip Erdogan who subsequently became his arch foe.

Bushfire crisis hit 75pc of Australians: survey

Three in four Australians -- almost 18 million people -- were affected by the country's deadly bushfire crisis, according to a survey released vesterday that also pointed to plummeting support for the government and for coal projects. The Australian National University study showed the vast human scale of the five-month crisis, which killed more than 30 people. Scientists say the fires were fuelled by drought and unfavourable weather conditions that were exacerbated by climate change.

Pak cop killed as blast hits polio vaccine team

A policeman was killed and two others wounded yesterday by a roadside bomb aimed at polio vaccination workers in Pakistan's restive northwestern city of Dera Ismail Khan. The attack came a day after Islamabad launched a nationwide anti-polio drive. There was no immediate claim of responsibility, but the Taliban and other militants have targeted polio vaccinators in the past.

Why China detains Uighurs?

Leaked data show growing a beard or applying for a passport is enough to put someone behind bars

Chinese authorities are monitoring the Uighur population's everyday movements and behaviour and sending people to internment camps over facial hair and having too many babies, leaked documents have revealed.

In one case, authorities sent a Uighur man to a "re-education camp" and monitored 15 of his relatives after he grew a long beard.

Officials concluded that the man's facial hair and his wife's use of a veil indicated they had been "infected with religious and extremist ideas", it is claimed.

The 137-page document handed to German news channel DW and the BBC is said to list 311 people who were sent off for "re-education" in the county of Karakax in 2017 and 2018.

Reasons given for detention include fasting, growing a beard, applying for a passport and breaching



official birth policy by having too many children.

It lists personal details of more than 3,000 individuals from the far western region of Xinjiang, including the full names and identification numbers of more than 1,800 family members, neighbours and friends connected to the 311 sent to the Karakax camp. Children are also said to feature on the list. It provides details of downloaded videos and internet chat messages, hightech surveillance with facial recognition

cameras and the widespread use of spies, house visits and interrogations. "The level of detail is overwhelming," Rian Thum, an expert at the University of Nottingham told DW. "I think it is

of Nottingham, told DW. "I think it is interesting to imagine that these things exist across Xinjiang. The data that is out there must be staggering."

While most of the detainees were later approved for release - albeit under constant surveillance – dozens were forced to work in factories, according to the documents.

Up to two million Uighur Muslims and other ethnic minorities have been detained in camps as part of a supposed counterterrorism campaign since 2014.

China has insisted it is running what it calls "vocational training" centres to combat extremism in the region. However, former detainees have alleged inmates are subjected to torture, medical experiments and gang rape.

Last month it emerged that more than 100 Uighur graveyards had been demolished by the authorities in what human rights groups described as an escalation of the communist regime's campaign to destroy the Muslim minority's culture.



Bezos launches \$10b fund to combat climate change

Amazon CEO Jeff Bezos has pledged \$10 billion to a new fund to tackle climate change but activists have urged the world's richest man to first clean up the e-commerce giant's own lacklustre environmental record. The e-commerce tycoon said the Bezos Earth Fund would "fund scientists, activists, NGOs -- any effort that offers a real possibility to help preserve and protect the natural world." Hundreds of Amazon employees last month signed a blog criticizing the online retail giant's climate policies and demanding it do more to tackle climate change. Amazon has been accused of creating vast amounts of waste from the packaging it uses for doorstep deliveries, as well as for the greenhouse gas emissions from huge vehicle fleets.

Gunman kills ex-wife at Bangkok shopping mall

A man killed his ex-wife and wounded another person at a shopping centre in Bangkok yesterday, police said, just 10 days after a mass shooting at another mall in Thailand's northeast. The gunman fled the Century The Movie Plaza mall, near the Victory Monument in the capital and is still on the run, police said. He had gone into a beauty clinic at the mall where his ex-wife worked and opened fire, killing her and wounding a bystander, Colonel Kissana Pattanacharoen said. On Feb. 8 and 9, a soldier killed at least a dozen people at the Terminal 21 shopping centre in the city of Nakhon Ratchasima. He had earlier killed his commanding officer, other soldiers at his base and several people at a Buddhist temple.

Ghani wins Afghan polls



Ashraf Ghani has secured a second term as president of Afghanistan, according to final results of the September 28, 2019 poll released yesterday by the country's election commission. Ashraf Ghani won 50.64 percent of the votes, election commission chief Hawa Alam Nuristani told a press conference in Kabul. The results had been delayed for nearly five months after allegations of vote-rigging from Ghani's main rival, Afghanistan's Chief Executive Abdullah Abdullah, forced a recount. Earlier this week, Abdullah's team said they would not accept fraudulent results.

Voting in Iran's election 'a religious duty': Khamenei

Voting in a parliamentary election this week is "a religious duty" for Iranians, Supreme Leader Ayatollah Ali Khamenei said yesterday, days before the vote seen as a referendum on the clerical establishment's popularity.

Iran's hardline Guardian Council vetting body has rejected some 6,850 moderate or conservative hopefuls in favour of hardliners from among the 14,000 applicants seeking to contest the Feb. 21 vote. About a third of lawmakers have also been barred from standing again.

"Today, voting is not only a revolutionary and national responsibility, but it is also a religious duty," Khamenei was quoted as saying by state television.

Due to the large number of disqualified candidates, hardliners loyal to Khamenei are likely to dominate the 290-seat parliament.

Friday's vote will have no major influence on foreign affairs or Iran's nuclear policy, which is determined by Khamenei.

"Elections are a means to strengthen the country ... A weak parliament will have long-term affects ... a weak parliament will negatively affect our fight against enemies," he said. "The election will neutralise American's ill intentions ... the vote is the Islamic Republic's prestige."

Tensions have been high between Iran and the United States since 2018, when US

President Donald Trump exited a 2015 nuclear deal between Tehran and world powers, reimposing sanctions that have battered the country's economy.

In retaliation, Iran has gradually rolled back its commitments under the deal.

Confrontation with America, economic hardship and an airline tragedy have battered Iranians' confidence in their leaders, posing a potential problem for the authorities in a parliamentary election this week.

Campaigning will end tomorrow, on the eve of the vote, for which 58 million Iranians are eligible to vote out of a population of 83 million.

'Babies freezing to death'

Out in the open in freezing weather, Mustafa Hamadi and his family settled into their makeshift tent in the village of Killi, in the northwestern Syrian province of Idlib - their second displacement in less than a year. The sub-zero temperatures on the night of February 11 kept them awake so, just before midnight, Mustafa moved the gas heater inside the tent.

By morning, Mustafa, his wife Amoun, their 12-year-old daughter Huda and their granddaughter Hoor, who was just three years old, were all found dead of carbon monoxide poisoning.

According to Nizar Hamadi, the tent - constructed of metal pipes and nylon sheets - had no proper ventilation and did little to insulate Mustafa's family from the cold.

This is one of the many stories that are becoming common in the refugee camps in Syria.

Since intensifying a major Russiabacked offensive in December, regime air strikes have hit targets indiscriminately. Hospitals and displaced persons camps were

not spared. UN officials said relief agencies were overwhelmed by the humanitarian crisis as nearly one million civilians, most of them women and children, had fled towards the Turkish border in bitter winter conditions to escape the onslaught.

In addition to the indiscriminate bombing of civilians, the lack of adequate shelter has resulted in

not spared. UN officials said relief agencies were overwhelmed by the humanitarian crisis as nearly one snowy fields, the UN said.

According to figures from the UN humanitarian body OCHA, 36 percent of newly displaced families are housed by relatives or find rental accommodation, while 17 percent found refuge in already overcrowded camps. At least 15 percent sought shelter in unfinished buildings and 12 percent are still "looking for shelter".

Women and children - who comprise more than 80 percent of the newly displaced people - are again among those who suffer most.

Describing the situation in Syria as having reached a "horrifying new level", Mark Lowcock, the UN head of humanitarian affairs and emergency relief, said in a statement on Monday that the displaced are "traumatised" and "babies and small children are dying because of the cold."

In Kalbeet camp a few days ago, a five-month-old baby, Areej Majid al-Hmeidi, froze to death, according to Abu Anwar, an official and resident of the facility near the Syrian-Turkish border

NEARLY 1,900 DEAD

Mainland China's official death toll hits 1,868. More than 72,300 people have now been infected there and 900 cases recorded around the world. The World Health Organization (WHO) however, says that epidemic outside China is only affecting a "tiny" proportion of the population and the virus has a mortality rate of around two percent. With drugmakers racing to develop a vaccine, Chinese health officials urge patients who have recovered from the coronavirus to donate blood so that plasma can be extracted to treat others who are critically ill.

CRUISE SHIP OFF JAPAN

The number of people infected aboard a cruise ship quarantined off Japan since February 3 leaps to 542 -- by far the biggest cluster outside the epicentre in China. Australia, Britain, Canada, Hong Kong and South Korea have said they will follow the United States in evacuating their citizens from the ship.

APPLE PESSIMISTIC

The iPhone maker Apple announces it will miss its March quarter revenue forecast and global iPhone supplies will fall, triggering a fall in Asian stock markets. Dependent on Chinese components and with a big Chinese market, Apple has been hit by travel bans and mass quarantines inside China forcing factories to suspend operations and shops to close.

ACTIVIST ARRESTED

Amnesty International says Chinese police have arrested a prominent activist who criticised President Xi Jinping's handling of the coronavirus epidemic while in hiding. "Medical supplies are tight, hospitals are filled with patients, and a large number of infected people have no way to be diagnosed," activist Xu Zhiyong wrote in a February 4 article. "It's a mess."

INDIA BARS CHINESE WRESTLERS

India bans Chinese wrestlers from this week's Asian Championships in New Delhi because of the coronavirus outbreak. The International Exhibition of Inventions in Geneva is also postponed until September due to travel restrictions, as a third of the inventions were to come from mainland China and another third from Hong Kong. Bussa Krishna first began worshipping Donald Trump four years ago when the US president appeared to him a dream.

Since then, after a run of good fortune, the Indian real estate broker has transformed his modest home into a shrine to the US leader, who is due in India on Monday for a twoday visit.

"My love for him has transformed into reverence. That has given me immense happiness. Hence instead of praying to other gods, I started praying to him," Krishna told Reuters.

Krishna, who lives alone in a village in Telangana, has erected a life-size statue to Trump in his yard, while his walls are scrawled with the leader's name - to the annoyance of his extended family.

"I am facing difficulties because of my relatives," Krishna said. "They tell me that I am disgracing them in society. I told them that just like you believe and worship Shiva, I believe and worship Trump. Neither of us can stop the other from doing so."

Krishna is not the only Indian who reveres Trump.

In New Delhi, members of the Hindu Sena, a rightwing fringe group, have begun rehearsing a welcome song in his honour.

"We like Donald Trump because he openly spoke about India's feelings," Hindu Sena leader Vishnu Gupta told Reuters. "...He openly said that he would eliminate Islamic terrorism from its roots, that is why I am his fan."

Trump is making his first visit to India. Trump's itinerary starts on Feb 24 in the western city of Ahmedabad, where he will visit the former home of independence hero Mahatma and address an estimated 125,000 people at a rally. He is due in the capital the following day.

Celebrated actor Tapas Pal passes away

PALLAB BHATTACHARYA, from New Delhi

Tapas Pal, celebrated film actor and former lawmaker of West Bengal's ruling Trinamool Congress, passed away in Mumbai, due to a cardiac arrest at the age of 61, according to reports.

Pal, who was visiting his daughter in Mumbai, complained of chest pain at the Mumbai airport during his return to Kolkata. He was rushed to a hospital in Juhu, but breathed his last at around 4 am (local time) yesterday. The actor was suffering



from heart complications and was in and out of hospitals for treatment since the past two years.

Pal joined politics from 2001. He was a two-term member of Lok Sabha, Krishnanagar, from 2009 to 2019, and a member of the West

Bengal legislative assembly from the Alipore constituency in Kolkata from 2001 to 2009. He is survived by his daughter and wife.

He remained away from cinema since his arrest by the Central Bureau of Investigation (CBI) in the Rose

Valley chit-fund scam in December 2016 and was bailed out after 13 months. He was also imprisoned after his arrest.

Known for his romantic roles, Pal rose to popularity in Kolkata with his debut in Tarun Majumdar's Dadar Kirti in 1980. He went on to become a household name for his lead roles in Saheb (1981), Parabat Priya (1984), Bhalobasha Bhalobasha (1985), Anurager Choyan (1986) and Amar Bandhan (1986), among other films.

Pal won a Filmfare Award for his role in *Saheb*. He made his Bollywood debut in Hiren Nag's Abodh (1984), opposite Madhuri Dixit.

Actors Ranjit Mallick and Chiranjeet and director Buddhadeb Dasgupta offered their sincere condolences to Pal's family and described him as a brilliant artiste.

"I am yet to come to terms with the news, even though I knew that he was not keeping well for some time. He was like my younger brother," Mallick said.

A large congregation of artists, curators and scholars came together at the recently concluded Dhaka Art Summit (DAS) 2020. The biennial event was an investigation and reflection on how forms of artistic productions and practices impact our lives. Her research interests include colonial, modern and contemporary visual culture, knowledge production, art education, decorative arts and historiography. She teaches at the University of Toronto and is affiliated with the Centre for South Asian Studies. She is the author of Raja Deen Dayal: Artist-Photographer in 19th-Century India (2013, co-authored with Deborah Hutton), Embellished Reality: Indian Painted Photographs (2012), and the editor of Bollywood Cinema Showcards: Indian Film Art from the 1950s to the 1980s (2011). We caught up with her for a brief conversation during her visit to Dhaka.

Could you elaborate on some exhibitions that are instrumental in educating people about contemporary South Asian art? A few art exhibitions have done a good

research that went into that exhibition and the execution took nearly ten years. Dayal had a prolific career, with over 40,000 photographs to his name. His studio also remained active after his death in 1905. For this project, my colleague Deborah Hutton and I looked through many archives and clues from different places and years. Sometimes, we found an important document just before we were scheduled to leave and so, we had to work quickly. Another project, The Family Camera (2017) was equally challenging, but for different reasons. For this one, I managed five co-curators, multiple interns, and a tight deadline to arrange the exhibition in time for Canada's sesquicentennial celebrations.

What are some of the main hurdles you face in representing South Asia art to Canadian audiences? One of the main challenges in

audiences is to figure out ways to make the material relevant to people from different backgrounds. As a curator of South Asian art at a North American museum, I think a lot about the people and how to address their varying degrees of familiarity with the region of South Asia. Locally, there is a significant South Asian diaspora population in Canada, and there are non-South Asians who have extensive connections to South Asia. There are also audiences who know very little about South Asian culture. My curatorial approach is to provide people with basic information but also to challenge them with depth and complexity. I also try to present information that challenges stereotypes. Moreover, I think we need to shift from the mode of explaining things to a predominantly white audience to consciously choosing to address the South Asian viewers.

Going by the PHQ statistics, the alleged rape victims included children below six; girls in schools, colleges and universities; middle-aged female domestic and garment workers; and elderly women. Some of the victims were raped allegedly by police members or while in the custody of law enforcers.

The conviction rate in such cases is extremely low.

Between 2012 and 2016, less than 2 percent of all reported rape incidents ended in conviction, shows the PHQ data. During that period, 18,668 rape cases were lodged with police stations across the country

under the Speedy Trial Tribunal Act so rapists can be handed punishment quickly. "The government should research why rape incidents are increasing and take accordingly." measures

Bengal forest department, as per the documents seen by The Daily Star.

But in the '80s, the plots were recorded as khas land in BS (Bangladesh Survey).

Baktiar Nur Siddiqui, divisional forest officer (north) of Chattogram forest circle, said the forest was recorded mistakenly as khas land, allowing the district administration to lease out the land.

But a reserve forest cannot be leased out until it is declared de-reserved by the president of the country and receives approval of the prime minister, he explained.

Baktiar told The Daily Star that Halda Tea Valley, taking advantage of the forest department's poor manpower, has been encroaching on the forest for over a decade.

Whenever forest staff tried to prevent them, tea estate staff have attacked, threatening forest staff at gunpoint, and vandalised vehicles, the official said.

The forest department has filed 17 cases since 2006 over incidents of encroaching, grabbing, razing forest and attacks on forest department officials by tea estate staff, led by its manager Jahangir Alam.

The cases were filed in 2006, 2012, 2015, 2017, 2018 and 2019.

He added that the department needs more support from the administration and police to stop such encroachment, given the shortage of manpower.

On January 1 this year, at least three excavators were seen cutting hills at Badurkhil block of the reserve forest which is under the status quo. Subsequently, a team of the Department of Environment (DoE) visited the spot on January 5.

of DoE Chattogram, told The Daily Star that they found preliminary evidence of hill cutting in order to build a road. Ferdous was transferred that month and does not know the current status of the matter.

Harunur Rashid Patan, inspector of DoE Chattogram, said they have not yet submitted a report on the matter.

A forest court sent tea estate manager Jahangir Alam to jail on January 14 this year in connection with a case filed in 2017 for encroaching on the forest and assault. The case is currently under trial and Jahangir obtained bail this month.

Contacted, Md Jana Alam, senior assistant secretary of AC Land and acting UNO of Fatikchhari upazila, told The Daily Star that the land claimed by the forest department was not under the reserve forest.

In a digital survey at Badurkhil point, the reserve forest was found to be 100 metres away from the disputed leased land, the acting UNO claimed.

"As the forest department filed a case seeking amendment to the BS ledger, the court imposed a status quo at Badurkhil. So, both parties have to follow the status quo until the court delivers its verdict," he said.

Baktiar said that the forest department has been complying with the status quo since the court imposed it. But, he says, Halda Tea Valley continued grabbing forest land as forest staff could not prevent them adhering to the court order.

He added that the digital survey was incorrect, as it did not include the Badurkhil point as part of the reserve forest.

Elias Hossain, deputy commissioner of Chattogram district, told The Daily Star that the land is recorded in the

Ferdous Anwar, then deputy director name of deputy commissioner in the BS and the court verdict on the land record amendment case will show if the forest department has a valid claim or not.

> Asked about forest encroachment by Halda Tea Valley, the DC said the forest department can guard their forest with their own forces. "If they seek any help, we will consider it," he added.

> Nader Khan, managing director of Pedrollo Group, which owns Halda Tea Valley, denied the allegations of grabbing forest land, assault on forest staffers, and destroying saplings.

"We did not attack anyone or raze any hills within the reserve forest. All we did was within our leased area," he added.

SPATE OF ATTACKS

Tea estate staff first attacked in March 2006 by removing the demarcation pillar and cutting down around 100 trees at Balukhali beat of Ramgor-Sitakunda reserve forest

Just two weeks later, led by tea estate manager Jahangir Alam, another attack was launched on forest staff at Edilpur beat to expand the estate's territory.

Halda Tea Valley also built a bridge within the reserve forest, destroying trees under social afforestation projects and hill cutting using an excavator at Edilpur block in 2017. Forest staff tried to stop them, but in vain.

In August 2019, forest officials were prevented from planting saplings at Anandapur of the Ramgor-Sitakunda reserve forest by Halda Tea Valley staffers.

The latest PHQ statistics shows that out of the 6,321 rape cases filed last year, charge sheets were filed in 4,231 cases, while police found no evidence of rape in 745 cases.

The rest of the 6,321 cases are now under investigation.

Incidents of rape are continuing unabated at a time when public outcry against the crime is getting louder.

Recently, even some lawmakers, both from the treasury and opposition benches, demanded in parliament that rapists are killed in "crossfire".

On January 19, the High Court directed the government to form a commission within 30 days under the law ministry to stop rape and violence against women.

Hearing a writ petition filed in the form of public interest litigation, the court also issued a rule asking the authorities to explain why rapists should not be awarded capital punishment if the victims are under 16.

Experts and rights activists blame the culture of impunity, low conviction rates, degradation of moral and social values, easy availability of pornography, culprits getting political backing and the use of rape to show dominance over women as primary reasons behind the rise of sexual violence, including rape, in the country.

"Androcentric thinking by police, lawyers and others associated with the judicial system and the absence of strong protests against rape are also to blame," said noted rights activist Rokeya Kabir. "Those committing the crime are hardly being punished," she said.

Prof Mahjabeen Haque, chairperson of Dhaka University's educational and counselling psychology department, sees another reason for the rise in rape cases

"Sometimes, wide media coverage of rape incidents, especially the detailed description of the crime, instigates rapists to look for targets,' she said, suggesting that the media should be more careful and act more sensibly while reporting on rape.

Saying that the existing law was stringent, Salma Ali, another rights activist, stressed the need for ensuring modern forensic labs in hospitals with adequate experts and logistic support for victims.

Enactment of a witness protection law and proper use of the evidence act are also crucial to prove a case in the court, she said.

Salma suggested rape cases be tried

remain secret, he said.

"The number of formal complaints is on the rise. Police are recording cases soon after receiving complaints and arresting the accused in quick time," said the AIG.

He, however, said not all the allegations were true and that there were allegations of harassing people by filing false cases.

Sohel Rana also said police were proving shelter, treatment and legal services to the victims through the victim support centres. "Police attach the highest importance to every incident of women and children repression. They submit probe reports completing investigation in due time."

He, however, said enforcement of law would not be able to stop rape unless preventive measures were taken to address various social, cultural, and psychological issues which turn someone into a rapist.

UNCONTROLLABLE BRICK KILNS IN LALMONIRHAT Use of topsoil threatens agriculture

OUR CORRESPONDENT, Lalmonirhat

Vast tracts of agricultural land in Lalmonirhat are losing fertility as owners of brick kilns, no less than 47 in total, are allegedly compelling landowners to sell topsoil from their farmlands.

In many places, the powerful and influential kiln owners are removing up to five feet of soil from a particular piece of land even though the landowner had agreed to sell only one foot of topsoil.

After losing the topsoil that

the farmers are spending more money on chemical fertilisers and pesticides than the money they had received in exchange for the topsoil.

chemical fertilisers and pesticides is causing long-term damage to the land, the surrounding waterbodies and ultimately the ecology in the district.

Bidhu Bhushan Roy, deputy director of Department of Agricultural Extension (DAE) in Lalmonirhat,

Cautioning farmers about the negative impact of selling topsoil, he said if four to five feet of Moreover, the excessive use of topsoil is removed from a piece of land, it becomes barren and it might take around 12 to 15 years to regain fertility.

After visiting areas near several of such brick kilns, this correspondent also found truth in the allegation.

Finally a wooden bridge for 100 villages in Netrakona

As a makeshift arrangement, a wooden bridge with bamboo poles on the Sumeswari river in Netrakona's Durgapur upazila has been made for the first time to ease people's longstanding sufferings

People of some 100 villages in Kullagara and Gaukandia unions have been suffering for years for want of a bridge on the river at Birisiri point in the upazila.

Especially schoolchildren and critical patients are the worst sufferers due to the communication problem.

Earlier, the villagers had to face various trouble to reach the upazila and district headquarters but the bridge will now ease their sufferings during the dry season, said Shubra Sangma, adding that motorcycles and CNG-run auto-rickshaws can also ply the bridge.

Some 20 years ago, a fund was sanctioned for The villages include Ranikhong, Khujiura, construction of a concrete bridge at the point but Boheratoli, Charpara, Boroikandi, Jagotkura, the authorities concerned are yet to take any steps

to build a bridge there, said the UP chairman. At least the makeshift wooden bridge has brought a sort of relief to thousands of commuters, he said.

Each person has to pay around Tk 10 to cross the bridge, said local people.

Md Bakul Mia, a toll collector of the ferry ghat, said they made the makeshift bridge at a cost of Tk 7 lakh to ease longstanding sufferings of people in the villages.

Mohammd Al Amin, a resident of Dakhhin Bhawanipur village, said "The wooden bridge will be used for four months from December to March and during monsoon, we have to use engine-run boats to cross the river.

Villagers aid during the rainy season, it becomes difficult for them to cross the area due to strong current in the river. The situation worsens when hilly waters from across the border flood the area.

"Due to lack of easy communications, the villages are separated from the Durgapur upazila headquarters. The areas are still underdeveloped due to poor communication system", said Rasel Mia, a student of Susang Durgapur Government College.

During the rainy season, the problem turned so serious and they have to cross the river on boat amid risk of accident, said Sanjida Akter, an HSC examinee from the same college.

Nazrul Islam, a farmer of Bhawanipur village, said the people of the area are mainly dependent on agriculture, but they are facing serious problems to bring their produces to the markets of the town for years for want of a permanent bridge at the point.

Talking to this correspondent, Executive Engineer of Roads and Highways Department in Netrakona Didarul Alam Tarafder said they are doing feasibility studies for construction of 870-metre-long concrete bridge on the river at Birisiri point.

Cassia-leaf farming gaining popularity

About 60 farmers in Jhenidah's Kaliganj upazila are now cultivating the item on commercial basis

AZIBOR RAHMAN, Ihenidah

Commercial cultivation of cassialeaf, locally called tejpata, is gaining popularity day by day in Jhenidah's Kaliganj upazila as the item gives good profit compared to other crops.

Farmers in the upazila are counting a good profit and earning additional income by cultivating the item, used as spice for adding to flavour and taste to dishes, as it needs a little investment but has a high demand among consumers.

According to Kaliganj Upazila Agriculture Office, this year cassia-leaf is being cultivated in 30 bighas of land in the upazila.

Farmer Abul Kalam Azad of Sundarpur village said he has been cultivating cassialeaf for the last four years.

This year he cultivated the item on 35 decimals of land and there are 130 plants in his plot.

He applies fertilizer on his plot two times a year, he said, adding that the leaves of a tree sell twice a year.

He gets 25 to 30 kilogram of leaves from each cassia trees and sell the produce at Tk 70 to Tk 80 per kilogram, Azad said.

Leaves can be harvested after two years of planning the tree, he added. Azad said he got 23 maunds of leaves from his 130 cassia plants in 2019.

Another Jahid Hasan of Durgapur village said he cultivated cassia-leaf on one bigha of land spending Tk 12,000 this last year.

He has already sold the produce at Tk 55,000 till January 10 and is expecting to get Tk 20,000 more from selling the item this month.

Kaliganj Upazila Agriculture Officer Jahidul Karim said about 60 farmers in the upazila are now engaged in cassia-leaf cultivation.

Nowadays, farmers are getting more interested in cassia-leaf farming as it required a very little cost but gives good profit, he said, adding that, a matured cassia-tree can produce 40 to 45 kilograms of leaves a year.

'Not good enough', but still key

It is not news that Bangladesh have been abysmal in Tests, at least that is what the margin of their recent failures suggest.

Since 2019, Bangladesh have played a total of six Tests and their best result in the longest format was when the rookie Afghans thumped the by 224 runs at home in September last year.

All the other five Tests saw the Tigers at the wrong end of an innings defeat, with the innings and 44-run humiliation in Rawalpindi against Pakistan earlier this month being the latest addition to the horrendous list.

That list might grow further if the Mominul Haque-led side cannot get back to winning ways in the lone Test against Zimbabwe -- considered one of the easier opponents they have faced in the past year -- starting from February 22 in Mirpur

Bangladesh's strength at home has been spin. And although reliance on spin has at times backfired -- the thumping by Afghan spinners last year being a prime example -- it also bore fruit on many occasions. It was the spin ploy that did the business when the Tigers registered their best-ever Test result -- beating the West Indies by an innings and 184 runs in November-December, 2018.

Bangladesh's spin attack, be it at home or overseas, has mostly revolved around premier allrounder Shakib Al Hasan. However, Shakib has missed a majority of Bangladesh's assignments since 2018 mostly due to injury. Since 2018, Bangladesh played a total of 14 Tests, nine of them without Shakib.

In eight of those games when Bangladesh were without their best player, Taijul Islam PHOTO: FIROZ AHMED played the lead spinners' role. Aside from four of was why Taijul was a bit irritated when asked why

those matches in seam-friendly pitches overseas, where Taijul managed just five wickets, he remained the Tigers' best bowler at home and his return of 30 wickets in four games speaks volume of how good he has been at home.

Although Taijul's prowess with the ball did not see the team yield a positive result most of the time, it was mostly due to a failure as a team. The left-armer was the one to come up with crucial breakthroughs in most games and perhaps that

Bangladesh had suddenly lost their spin prowess in recent times in Shakib's absence.

"Maybe those of us who are spinners are not good enough. We're not like Shakib bhai and since things were going well when he was there, maybe that is the only answer," Taijul said after the Tigers' practice session at the outer nets in Mirpur yesterday. "We don't have spinners of that quality and that's why such results are happening.

In the past two years, Bangladesh were able to win three Tests, two under the leadership of Shakib. It is true that Shakib's presence impacts the team immensely because of wily spinner's ability to create pressure at one end and enable other bowlers to extract wickets.

And just as an irritated Taijul mentioned, Shakib's ability and the experience brought in by the top all-rounder in a sport cannot be replaced. Still, even without Shakib, and despite lacking resources, the Tigers had to rely on spinners, especially at home.

If the Tigers bank on spin, it will be Taijul who will have to play the leading role. The other two spinners in the squad are Mehedi Hasan Miraz and Nayeem Hasan. Miraz, who just returned from a finger injury, has not been in good touch for a considerable time. And although Nayeem goes to the Zimbabwe Tests on the back of some excellent domestic performances, the 19-yearold still lacks Taijul's experience in the format.

The Tigers have included a total of five pacers in their initial 16-member squad for the Test, which will later be trimmed to 13. While the squad selection suggest that the Tigers might not bank as heavily on spinners as they usually do at home, that only means the role and impact of spinners, even if it is not much, will greatly depend on Taijul's performance during the Zimbabwe Test.

ICC to organise T20 Champions Cup in 2023-31 cycle?

The International Cricket Council (ICC) plans to organise a T20 Champions Cup in the 2023-31 cycle, according to ESPN Cricinfo. A total of 48 matches will be played in the tournament where top ten teams will compete. This is the same number of games which was played during last year's 50-over World Cup.

As per the ICC's proposal, there would be a T20 Champions Cup in 2024 and 2028 and an ODI Champions Cup in 2025 and 2029, alongside the T20 World Cups in 2026 and 2030, and the ODI World Cups in 2027 and 2031. ICC plans to hold all these events for both men and women teams.

The 50-over Champions Cup can be considered the same as the Champions Trophy. However, the T20 Champions Cup can be treated like a World Cup.

ICC's full-member nations have been

given until March 15 to submit expressions of interest to bid for global events in the 2023-2031 cycle.

"Give yourself something to chase Goals aren't everything but they're a nice reminder when your mind is going in different directions, to bring you back on track and give you a focus.

Taylor said he was keen to be in

the frame for New Zealand's bid for a maiden T20 World Cup title when the men's tournament kicks off in Australia in October.

He would also not rule out the next one-day World Cup in India in 2023, having played in the heartbreaking defeat to hosts England in last year's title-decider.

"First and foremost I want to get to next year -- the Twenty20 World Cup and then the home summer -- and then I'll have a good idea on how I'm placed at the end of next summer.

"Whether there is still a drive, whether I'm good enough, whether I'm fit enough, and whether I deserve my spot in the side. If I can tick all those, then definitely 2023 is an option."





Tea estate feasting on reserve forest

Keeps defying status quo from Ctg court; forest department watches helplessly

A tea estate in Chattogram has continuously been encroaching on one of the oldest and richest reserve forests in the country. Over the years, it has foiled forestation attempts and continuously damaged trees while expanding its territory.

Defying a court order, Halda Tea Valley has been ravaging the Ramgor-Sitakunda forest in Fatikchhari since the district administration leased 1,052-acre land to the estate in 2003 mentioning it as khas land.

The forest department officials say 134 acres of the leased-out land was within the reserve forest, and they sought amendment to the land record that shows it as khas land

A Chattogram court in June 2017 imposed a status quo on the 845-acre area, which include 134 acres of the forest, following a case filed by the department, they added.

But the tea estate continued cutting trees and expanding its territory while the forest department is unable to take any action until the matter is resolved, in compliance with the court order.

The 845-acre comprises the three plots recorded as forestland in RS (Revisional Survey) in 1927-28.

Before this, these plots were recorded as reserve forest in a Calcutta gazette issued in 1893 by the then Assam-SEE PAGE 10 COL 2

HUMANITARIAN CRISIS IN SYRIA Air strikes hit hospitals, camps

Nearly a million fled Russiabacked regime offensive

REUTERS, Beirut/Geneva

Government air strikes have hit hospitals and displaced persons camps in northwest Syria and killed about 300 civilians as President Bashar al-Assad's forces press an assault against the last rebel stronghold, the United Nations said yesterday.

UN officials said relief agencies were overwhelmed by the humanitarian crisis as nearly one million civilians, most of them women and children, had fled towards the Turkish border in bitter winter conditions to escape the onslaught.

"Civilians fleeing the fighting are being squeezed into areas without safe shelter that are shrinking in size by the hour. And still they are bombed. They simply have nowhere to go," UN human rights chief Michelle Bachelet said in a statement.

Syrian and Russian warplanes meanwhile kept up raids on the town of Darat Izza in Aleppo province yesterday, witnesses said, one day after two hospitals there were badly damaged.

At Al Kinana Hospital, blown-out walls and dustcovered medical cables and supplies were strewn about the hospital after two staff were wounded on Monday, witnesses said.

Appearing on national television on Monday, Assad said the rapid military gains presaged the eventual defeat of the nine-year-old insurgency against him although it could still take time. The rebel factions include Turkishbacked rebels and jihadist militants.
