







## **Promises yet** to be kept

Families of Chawkbazar fire victims get no compensation, no help in one year

As bodies after bodies were wheeled into Dhaka Medical College's morgue on February 21 last year, there was no dearth of offers of help.

There was a realisation of the fact that the Chawkbazar fire was the result of a collective failure of the state and the society. The government as well as many from the private sector stepped in with promises of financial aid for the victims and their families.

A day after the tragedy, on February 21, the Ministry of Labour and Employment promised a compensation of Tk 1 lakh for the families of each of the deceased, who were either street hawkers, rickshaw pullers or workers at different establishments in the area. A press release signed by Monnujan Sufian, state minister for labour and employment, stated such.

On the night of Feb 20, 2019, Old Dhaka experienced one of the deadliest fire incidents in the country's history. The blaze originated from Haji Wahed Mansion at Chawkbazar before spreading to five buildings like wildfire. Firefighters took 14 hours to douse the fire.



The 71 victims include pedestrians, people travelling on rickshaws and cars, residents of the buildings, owners and staffers of the shops. Cause of fire is still unknown. But probe bodies suggest flammable chemicals fuelled the fire and caused it to last longer.

## Blaze over, not danger

The walls scorched black. A thin film of soot covering the burnt-out pillars and roofs. A smell of burnt remnants still wafting through the air around it.

This is Haji Wahed Mansion, a building in Chawkbazar's Churihatta where a chemical-fed fire last year left 71 people burnt to death a year ago.

The inferno forced the government to take a flurry of measures like sealing off and removing chemical warehouses in the area. Another major plan was to relocate chemical stores from the densely-populated neighbourhood to somewhere safe.

Still, Old Dhaka houses extremely hazardous stocks of flammable chemicals and risky factories without any safety measures whatsoever, putting lives of hundreds of people at serious risk of fires.

The government is still working on relocating chemical warehouses and factories from residential areas to a chemical industrial park, a move that began around 10 years ago following the Nimtoli blaze.

Shifting chemical factories and warehouses was one of the recommendations by the home ministry's committee formed after the Nimtoli tragedy. But the government could not complete it, thanks to problems in land acquisition and bureaucratic complexities.

Even the government's work to set up a temporary chemical hub is yet to be completed.

"There were huge hue and cry after the fire incident. We've seen mobile court drives and sealing off chemical warehouses. But as the public focus moved away from the Chawkbazar tragedy, many have restarted their business, SEE PAGE 10 COL 5

## Sinking into the depths of despair

70 Bangladeshi workers in Malaysia unpaid for months; employer yet to renew their work permits

Unpaid for five months, over 70 Bangladeshi workers in Malaysia are living at a factory dorm in Balakong with money borrowed from relatives. Their employer -- SSN Medical Products Sdn Bhd - also did not have their work permits renewed, even though those had expired last year.

This has left the workers even more vulnerable as law enforcers can now take actions against them, said the migrants and an independent researcher based in Kuala Lumpur.

"We were paid no wages since October last year. We are now borrowing from relatives or friends either in Malaysia or in Bangladesh for our survival," migrant worker Sagor Khan of Tangail told this paper over phone yesterday. For over a year, we were charged 150 Ringgit [Tk 3,000] every month for renewal of the work permits, but our company did not renew those. So, it

is now risky for us to go outside the factory because police can detain us. According to the workers, 130 Bangladeshis went to work for the company in February 2018 through Unique Eastern Pvt Ltd recruiting agency. However, over the last five months, some 60 of them left for not

The workers said they had to pay between Tk 3.5 lakh and Tk 4 lakh for the jobs in Malaysia.

The company had promised, in their contracts, that they would not have to pay for renewal of work permits and accommodation. But their employer took RM 200 from their salaries every month.

### One Bangladeshi patient in 'very critical condition'

Says foreign minister

One of the five Bangladeshis infected with coronavirus in Singapore is in "very critical condition", Foreign Minister AK Abdul Momen said yesterday.

Singapore's Minister for Foreign Affairs Vivian Balakrishnan gave the updates during a telephone conversation with his Bangladeshi counterpart earlier in the morning.

The 39-year-old Bangladeshi patient who has been kept in the intensive care unit (ICU) for the last 13 days has not been responding to the medicine given to him, the minister informed referring to the updates.

The patient had been suffering from respiratory and kidney disease before he got infected with coronavirus.

"They [the Singapore government] are doing their best to take care of him with medical services of the highest level," Momen told reporters following the inauguration of an OIC meeting in Dhaka.

## Death toll tops 2,000 in China

Number of cases drops; passengers leave Japan, Cambodia cruise ships

Hundreds of relieved passengers finally disembarked a coronavirus-stricken cruise ship in Japan yesterday after testing negative for the disease that has now claimed more than 2,000 lives in China and spread panic worldwide.

With 542 positive cases, the Diamond Princess is easily the biggest cluster outside China, and Japan has faced mounting criticism for its quarantine arrangements as the passengers disperse into the wider world. "I'm relieved... I want to take a good rest," said a 77-year-

old Japanese passenger, who declined to give his name. He said he would be boarding Japan's famously crowded railway system home. A fleet of yellow-dotted city buses, plus a dozen or

so taxis, whisked away the passengers, many of whom dragged their luggage behind them and waved to former ship-mates on balconies as they disembarked.

The promising sign out of China came from the National Health Commission, which reported 1,749 new confirmed cases, the lowest tally since Jan 29. Hubei - the epicentre of the outbreak - reported the lowest number of new infections since Feb. 11, while outside of Hubei there were just 56 new cases, down from a peak of 890 on Feb. 3.

The ongoing legal battle between Grameenphone and the Bangladesh Telecommunication Regulatory Commission (BTRC) over unpaid dues has reached a critical point.


The telecom regulator has refused to accept payment from the network provider to continue negotiations on a Tk 12,580 crore audit claim

## Woman dies in police custody

Family alleges torture; DB men picked her up not finding husband

A mother of two died several hours after she was picked up from home by Detective Branch of police in Gazipur on Tuesday night.

40-year-old Yasmin Begum's son said he saw multiple injury marks on her body. However, a doctor at the hospital, where she died, said there

Her 17-year-old-son Yasin Arafat Jisan said about 4-5 men in plain clothes, who introduced themselves as DB officers, showed up at their home in Bhawal in the evening and said they were looking

for his father Abdul Hai over allegations of drug dealing against him. When he and his mother told the men that Abdul was not at home, they started beating her up and took her into custody, he told The Daily Star.

Jisan said his sister, aged around 12, was at home at the time. Around 11:00pm, Jisan received a phone call from someone who told him that his mother had fallen ill and had been taken to Gazipur Shaheed Tajuddin Ahmed Medical College Hospital.

Due to difficulties in finding transport, he reached the hospital around 1:00am yesterday and saw that her mother had died.

## Every child under 'immediate threat'

Says UN report on climate change, poor diet

The world is failing to protect children from the health dangers posed by

climate change and poor diet, a landmark UN report said yesterday, warning that every child is under "immediate threat". According to more than 40 of

the world's pre-eminent child and adolescent health experts, not one country on Earth is adequately protecting the next generation from the impacts of carbon emissions, the destruction of nature and high-calorie and processed foods.

They said that excessive carbon emissions, produced overwhelmingly by wealthier nations, "threaten the future of all children" and will burden them with additional health dangers, from deadly heatwaves to the increased spread of tropical diseases.

The report, commissioned by the World Health Organization and UNICEF, also highlights the threat children face from harmful marketing of fat- and sugar-laden foods, alcohol and tobacco.

"When you look at the damage being done to children's lungs by air pollution, we've got a very limited time to sort this out," he told AFP.

"We have the solutions, what we don't have is the political leadership and will to make it happen.'

The report, published in The Lancet medical journal, ranks the performance of 180 countries when it comes to child survival, education and nutrition rates.

Under these criteria, less-developed nations such as Central African Republic and Chad perform particularly poorly compared to rich countries such as Norway and the Netherlands.

However the rankings are largely reversed when the impacts of air pollution from per capita carbon emissions were assessed.

On December 18 that year, a board meeting of the Bangladesh Labour Welfare Foundation decided to raise the compensation money to Tk 2 lakh. The ministry made a list of 27 deceased workers it would be helping out using the foundation's funds.

Earlier in April, 40 private banks deposited cheques worth Tk 30 crore in the government's national relief fund in assistance for all the victims, according to a report The Daily Star ran on April 4.

A few days before that, Dhaka South City Corporation (DSCC) Mayor Sayeed Khokon, at a public hearing at the capital's Cirdap, promised city corporation jobs to the families of the deceased.

All those promises, however, remain caught up in bureaucratic

The Daily Star correspondents spoke to the families of 40 of the 71 killed in the devastating fire in Chawkbazar's Churihatta. They did not get a single Taka from the authorities mentioned above, in the last one vear.

The only compensation they received was Tk 20,000 given to each of the families along with body bags at the DMC morgue. The money was to meet burial expenses.

That's it. Since then, zilch. authorities said they were working to tuition to children in the area. fulfil the promises, adding that the promised money and the jobs would be given "soon".

The apparent noncommittal "soon" does not help the young bride of 29-year-old Mahbubur Rahman Raju Miah, who used to work at a mobile phone servicing shop at Chawkbazar. They were married just

26 days before the fire killed Raju. When Raju died, she had not even completed her high school and all of a sudden, she realised she was pregnant. Still, she gathered courage and sat for her HSC exams and passed. She gave birth to a baby boy

later in November. Raju's brother Meraj said he visited the ministry in late August last year, a day after he got a phone call from there. "The date was August 30. They took our documents and said we need to wait for the head of the state to hand us our cheques, and so we left," he said.

"It has been more than five months since then, with no phone call and no news from the ministry.

The family members of paanwalah Mohammad Ibrahim went to the ministry's office on October 29 last year after getting a phone call from an official. Once there, they were told they wouldn't be getting anything.

"I went to the Secretariat building and then dialed the number I had received the call from. Someone on the other side asked me to wait. A person then came with a list and asked me whether Ibrahim's name was on it. It wasn't, and so we were not let in," said Ibrahim's brother-inlaw Nurnabi.

Nurnabi could not name the official who called him over the phone. "We feel like we were being harassed," he said.

The Daily Star collected a list of the deceased workers, who are supposed to receive the compensation from the ministry. Ibrahim is the first name on the list.

In the meantime, his wife's hope of getting the compensation is fading every day.

After Ibrahim's death, Bibi Hajera went back to their hometown in Feni and now makes shital pati (bamboo mats) to run her family with two daughters, aged three and seven.

There is another victim with a similar name, Mohammed Ibrahim, a rickshaw puller from Kamrangirchar. But the ministry's list does not include the name.

The Daily Star spoke to his sisterin-law Shireen, with whom Ibrahim's wife Rokhsana and her 10-year-old daughter currently live.

'My husband is also a rickshaw puller. He is the only earning member of the family. He only earns Tk 200-300 every day and its really tough to manage a family of seven with that money," Shireen told The Daily Star.

Begum's Ruma husband Mohammad Billal, another victim, left behind an empty pantry the day he died. "We had no rice at home, no vegetables, literally nothing. I was waiting for him to come home with groceries so that we could eat," said

Billal used to stitch curtains for a decorator shop. Ruma is supposed to get Tk 2 lakh from the ministry, but has not received a single penny yet.

Just days before the tragedy, a drug store employee Anowar Hossain Monzu, another victim, went on a picnic, along with his family, at Wonderela Green Park in Dhaka's Nawabganj. He posted photos of that day on social media on February 15 last year.

A year later, his son no longer goes to his school in Dhaka as his mother Nahida Rahman cannot afford the expenses. They now live in Noakhali's Begumganj with her brother. She struggles to run her family with a Asked, the ministry and the DSCC little money he earns from giving

> "I've failed to bear the expenses even at a village school. His uncles are saying they will bear the costs if my son is admitted to a madrasa.

'Everyone makes promises, but nobody actually helps," she said, adding that she moved to her brother's home as she could not pay the monthly rent of Tk 9,000 in Dhaka.

Asked why the money promised had not been handed yet, Md Rezaul Haque, director general of Bangladesh Workers' Welfare Foundation, said the process of verifying the victims'

identity was a lengthy one. "We have to cross-check information at the field-level through the DC office and the Department of Inspection of Factories and Establishments ... we are waiting to finish verifying the details of all the deceased before disbursing the money," he said.

Families of four more deceased workers said they did not even receive a phone call from the ministry.

The ministry had, however, given an emergency help of Tk 50,000 to each of 10 injured on February 24 last vear.

Contacted, Mayor Khokon's Protocol Officer Habibul Islam Sumon said they were working to provide jobs to the victims' family members.

"We will meet them at the anniversary of the fire, and give them cash, shops, and jobs," he told The Daily Star. Those will be financed completely from the mayor's discretionary funds," he said.

Asked why it took so long, he said, "It was very difficult for us to find the victims of the fire, and we have managed to get the contacts of only 31 people over last one year."

The Daily Star correspondents got the details of the 71 deceased and their family members in a day, from Churihatta Ekota Sangha, a social welfare organisation established by the locals in Churihatta after the fire incident.

Meanwhile, the DMC authorities have prepared the post-mortem report on 67 victims and would submit them to police soon, said Sohel Mahmud, associate professor and chief of forensic medicine department at the college.

"Of the 67, 45 have already been identified while the 22 others were identified through DNA tests," he told this daily.

#### Two 'robbers' killed in 'gunfight'

Two suspected robbers were killed in a "gunfight" between two dacoit groups in Sadar upazila of Magura early yesterday, said police.

The dead are Lablu Mondol, 38, of Faridpur, and Daul Hossain, 35, of Magura, said the law enforcers. Saiful Islam, officer-in-charge of

Magura Sadar Police Station, claimed two groups of armed robbers locked into a "gunfight" around 1:30am following feud over establishing supremacy in the area.

Hearing gunshots, a patrol team of police rushed to the spot and found two bodies lying on the ground. They recovered the bodies and sent those to Magura Sadar Hospital morgue for autopsies. Rest of the "robbers"

managed to flee the scene, he added. According to the OC, both the dead vere accused in several cases filed with different police stations in Magura, Narail, Jashore, Rajbari and Faridpur

dead robbers were arrested in Dhaka over a robbery case that was filed on January 24.

Police found robbed materials from them, he added.

Mucha Mollah, elder brother of Daud, told The Daily Star, "He [Daud] left our house three years ago. Suddenly, we came to know through villagers that he was killed in a gunfight this morning. I went to

Trawler Capsize

#### 3 bodies recovered from the Bay

Three people, including a child, drowned after a fishing trawler capsized in the Bay of Bengal in Cĥattogram's Bansĥkhali upazila yesterday.

The trawler with at least 35 passengers on board started from the upazila's Khankanabad area in the morning. The passengers were going to attend a religious programme (Urs) at Kutubdia Island of Cox's Bazar, said

The victims are Abdul Malek, 55, of Khankanabad village, Abdul Jalil, 30, of Gondamara village, and Md Minhaz, 12, of the same village.

Nazmul Haque, sub-inspector of Banshkhali Police Station, told The Daily Star that the trawler capsized near Bodorkhali estuary on its way to Kutubdia Island around 10:00am.

Most of the passengers managed to swim ashore, but four went missing,

Quoting the survivors, the police official said the trawler capsized due to overloading.

As of yesterday evening, police with the help of coast guard members recovered the three bodies from various points of Banshkhali channel in the Bay, he said.





But what if such is the condition of a place that is of utmost importance, bearing testimony to a nation's struggle for establishing their right to speak and express emotions in mother tongue? That too in the month of February, when Language Movement martyrs laid down their lives for the recognition of Bangla as a state language on the 21st of this month -- 68 years ago.

#### AN EPICENTRE OF HISTORY

The historic Amtala, where Language Movement activists gathered on February 21, 1952 to defy a curfew and protest the then Pakistan government's refusal to UNRECOGNISABLE recognise Bangla as one of the state 
THROUGHOUT THE YEAR languages of Pakistan, has become covered behind encroachers.

That day, protesters broke the

However, Ekushey did not end there; it rather planted the seed of freedom in the hearts of Bangalis and 19 years after the Language Movement, an independent country named Bangladesh was born.

In 1999, Unesco declared February 21 as International Mother Language Day, in recognition of the sacrifice of our language martyrs.

## Getting more out of books

In this era of connectivity, digital technology has a deep impact on book publishing and the way people read.

To keep pace with the change, a number of publishers are also providing readers with e-book facilities in this year's book

These electronic books -- a publication made available in digital form -- can be read on computers or handheld devices.

Some organisations have also introduced apps for readers to avail their services. Many have taken help of IT firms in this regard. Most of the stalls are located on Bangla Academy premises.

"Sheiboi" is one such app. "Anyone can use the app by downloading it from an online stores. The app requires opening up an account," said Nafees Istiaque, a volunteer at the stall 103.

He said the app has more than 3,000 books in its collection and at least 500 books can be read for free. "Some of the books require purchasing through bKash or banking system."

"We also take permissions from authors and publishers for selling the books. They

also receive a percentage from the sales, said Shah Abdul Islam, a volunteer at "MuthoBoi". They are offering 110 books for free out

of 600 books, he said. At stall-44, volunteers at "Boitoi" were

helping people use it. The app has more than 600 books and one can read around 200 of them for free, said Afrina, a volunteer at the stall. "We are adding

new books every day." Price of the books range from Tk 12 to 100.

"I use e-books when I travel. It's convenient to carry," said Dhaka University student Sazia Akhter.

#### ENROLLING EXTRA STUDENTS SC fines City Univ Tk 10 lakh

The Supreme Court yesterday fined City University Tk 10 lakh for enrolling more than 50 students to the law department each semester, violating a UGC decision.

The university has been asked to pay the fine to Bangladesh Bar Council.

Students will be allowed to appear for the bar council enrollment test, if City University pays the fine, the apex court added. A four-member bench

of the Appellate Division headed by Chief Justice Syed Mahmud Hossain passed the order after disposing of a review petition filed by the bar council, seeking necessary order to this effect.

Earlier, the apex court fined Tk 10 lakh each to five private universities for the same reason.

## Land surveyor held, Tk 93 lakh recovered

Rapid Action Battalion (Rab) yesterday detained a surveyor of Cox's Bazar district administration, and seized around Tk 93 lakh in "bribe money" from his possession and from houses of two other surveyors in different areas of the town.

Md Wasim, a surveyor of district acquisition land administration's branch, was detained from a house in Taraboniarchara area. Tk 16 lakh, cheques of different banks and government papers were recovered from the spot.

Other surveyors -- Farid and Ferdous managed to escape but Rab recovered Tk 60 lakh from Farid's house and Tk 17 lakh from Ferdous' residence, in Baharchara area.

Maj Mehedi Hasan, Ramu Company Commander of Rab-15, said works of around 50 development projects of the government are going on in Cox's Bazar, and land acquisition for those projects are also ongoing.

There are long-standing allegations that a vested quarter is realising huge sums of money from land owners centring land acquisition, and several victims have already given written complaints, he said. Based on that, a Rab team conducted raids in different parts of town, detained one and recovered the money and other documents.

A case was filed against Wasim with Cox's Bazar Model Police Station.

Several victims alleged that not only these three, but also many other surveyors and staff of land office of the district are involved with the quarter, who hold land owners at hostage. Victims do not get remedy as several top officials allegedly get share of the money, they said, adding that land owners are forced to take help from surveyors and brokers in exchange of 20 to 50 percent commissions, they added.

A former deputy commissioner of Cox's Bazar and ADC were arrested earlier for their alleged involvement in bribery centering a mega project.

DC Kamal Hossain told reporters that he came know about the development, but said it was Wasim's personal offences and legal and departmental action would be taken against him.

He, however, rejected other allegations.

## Pinpoint crab breeding season to protect industry

Speakers say at roundtable

STAFF CORRESPONDENT

A group of Khulna University scientists yesterday said the government should properly identify the peak breeding season of mud crabs based on scientific evidence, to protect mother crabs and halt the industry's decline.

At present, harvesting crabs from the Sundarbans, a prime natural source for catching the crustaceans, is banned in January and February, they said at a roundtable discussion at The Daily Star Centre.

However, March-April is the peak breeding season of mud crabs at the location, they said, referring to their study

Abundance of fully mature mother crabs can be seen from late February to late April. Alongside March and April, February should also be included in peak breeding season to protect mother crabs,

CARE Bangladesh and The Daily Star, with support of Swiss Agency for Development and Cooperation, arranged the roundtable on "Prospect and Challenges of Crab Cultivation: Policy Perspective".

In 2017-18 fiscal, Bangladesh exported about 11,000 metric tonnes of crabs and earned around Tk 217 crore in foreign currency. Some three to four lakh people are directly and indirectly involved in the crab industry, from harvest to export, according to the report.

Prof Yousuf Ali of Khulna University's fisheries and marine resource technology discipline said in 2013, 32,000 metric

Sundarbans West Division Forest Officer Bashirul-Al-Mamun said crab harvesting from natural sources have increased since 2017.

The coronavirus outbreak has reduced crab export from the Sundarbans significantly, said SM Mahbub Alam, coordinator of NGO-based initiative Nowabenki Gonomukhi Foundation.

## Alarming number of rape cases in 2019

When will this culture of impunity end?

CCORDING to data from the Police Headquarters, 6,321 rape cases were filed with police stations in 2019, a 19 percent increase from the 5,123 cases that were lodged in 2018. Another report published in the Prothom Alo identified the rapes of 211 women and children in the first month of 2020 alone. Let that number sink in

It is an understatement to say that we are appalled by the rape statistics that are splattered across our papers every single day, but what is even more appalling is how few of these rape survivors are given justice in the end. The comments of certain lawmakers in mid-January to "crossfire" rapists sound even more hollow now—why make emotional statements to rile up public sentiment when Women and Children Repression (Prevention) Tribunals and the district courts are still failing to complete rape trials within 180 days as stipulated by the law, and less than two percent of rape cases are leading to convictions?

Data from one-stop crisis centres across the country also show that around 78 percent of rape survivors who visited the centres do not choose to pursue legal action, even after taking the initial step of treatment. This means that the actual number of rapes in Bangladesh are likely to be far higher than the data shown by the PHQ. In fact, the higher incidence of rape cases in 2019 may be a reflection of survivors feeling more emboldened to come forward with their stories. However, given the low rates of conviction and the culture of impunity that currently exists, along with the social stigma faced by survivors that often leads to out-of-court settlements and a promise of silence for the sake of protecting their "honour"—a vile and outdated sentiment used to cover up the worst forms of violence—this trend may soon be reversed.

On January 19, the High Court directed the government to form a commission within 30 days under the Ministry of Law to stop rape and violence against women. We urge the authorities to immediately set up this commission, as well as to take the advice of legal experts in enacting witness protection laws and strengthening the use of the evidence act to ensure speedy trials and punishments for rapists. Additionally, we urge the authorities to provide legal aid and create safe spaces for rape survivors who are susceptible to being pressurised by their family members and local communities. Let us not forget that a large number of rape victims are minors in incredibly vulnerable positions, and an even larger portion of these rapes are committed by people in positions of trust. Without urgent action, we may never be able to get a clear picture of how many women and children are silently suffering abuse in this country.

## Forest grabbers on the prowl

Forest department needs increased manpower to do its job

T is bad enough that we have only 11.2 percent forest area left in the country (according to a 2016 report by ADB), which is much less than what is required for a proper ecological balance. But it is particularly upsetting that even the remaining forests including the reserved ones are being encroached upon by powerful grabbers across the country. According to a report by The Daily Star published on February 19, a tea estate in Chattogram has been ravaging the Ramgor-Sitakunda reserve forest in Fatikchhari upazila for over a decade and expanding its territory illegally. The tea estate authorities foiled the forestation attempts by the forest department, cut down trees indiscriminately, and even built a bridge inside the forest ignoring a court directive. What is more, whenever forest department officials tried to prevent them, they were attacked by the tea estate staff who threatened them at gunpoint and also vandalised their vehicles.

Visiting the forest area recently, our correspondent has seen at least three excavators cutting the hills at Badurkhil block of the forest. Reportedly, there had been some mistakes in the land records, in both the Bangladesh Survey (BS) and the digital survey, which have led to the dispute between the forest department and the tea estate. However, since the court imposed a status quo at Badurkhil after the forest department filed a case seeking amendment to the BS ledger, both parties should follow the status quo order until the court delivers its verdict. Sadly, the tea estate authorities are not complying with the court order and continuing with their illegal activities.

Since the forest department does not have the manpower to stop the powerful grabbers, the government needs to take urgent steps in this regard. The department also needs more support from the local administration and police in dealing with such cases. Our reserved forests must be saved at all costs and necessary action should be taken if the government wants to reach its goal of increasing the country's forest coverage to 20 percent by 2030.

## Central admission tests: Turning the wheels too hastily?

HE idea of the proposed central admission tests in public universities has been promoted as a fairer, inexpensive alternative to the existing system of university entry. The new

system promises to be the most efficient way of relieving admission-seekers and their parents of tremendous physical, mental and economic pressures that they endure due to separate university tests. This change demands a massive cultural transformation in higher education. But the way it has been put forward seems to be unnecessarily hasty and does not raise confidence that reasonable efforts have been made to implement it across a large and complex system.

If implemented, the standardised tests are expected to be a transformative event, a life-determining one for the students. That is why, due diligence is required before the plan is set in motion. But the current situation gives one the impression that everything is happening too fast. Not even the new admission procedures have been publicised yet. The lack of visible preparatory efforts to steer and monitor the implementation of the uniform testing system, given that not enough time is left before the next admission season, is deeply worrying.

Since no pilot experiment has been conducted before taking the decision of implementing it countrywide, no one really knows how the whole system will work and what challenges it will face. While it is of utmost importance that the universities have a stake in decision-making at every step of the way, it has not been the case. So, the decision seems to have been imposed from the top.

The big question now is how it will be conducted; who will ultimately be responsible for such a massive-scale testing situation; who will develop the questions and who will evaluate the scripts. Not just the students, but teachers also have no clear idea about these issues. Perhaps it would have been more logical to take such an important decision after developing necessary strategies to counter possible challenges. For example: at a time when preventing the leakage of question papers is still an ongoing struggle and a highly sensitive and important task, a single leakage can ruin the chances of its success. Even the quality

of invigilation in different places may have different standards. Also, in order for the students to make informed choices, they need a discipline-based ranking of universities. We do not know when and on what basis it will be done.

This concern is particularly important because of a problem that is inherent in our culture of educational policymaking. Contemporary experience shows that major changes in our education sector occurred too quickly and without necessary preparations, resulting in failures to achieve intended outcomes. Replicating reforms and changes implemented successfully in other countries often turned out to be a recipe for disaster here. The testing system is not just a way of measuring competency or proficiency; more importantly, it is effectively a way of shutting down access to public-funded higher education. The proposed central tests appeal to the logic of convenience above anything else. This is important, but at what cost? What will happen to the diverse enrolment mechanisms, essential for a good number of disciplines? We are still in the dark about the whole process. Almost no discussion took place involving stakeholders at universities.

The major challenges that any unified system faces are related to ensuring equality and diversity. Our education system has become increasingly pressurised with centralised exams. The addition of another massive, centralised



and annual tests runs the risk of imposing additional burden on an already highlypressurised system. If the centralised exam is the only thing considered by universities for enrolment, and there are no interviews or other admission criteria, then it will be hard to control the mushrooming of coaching centres. Due to this special characteristic, it runs the risk of increasing inequality in education by widening urban-rural gap and regional differences. If the uniform tests take place as a singular annual affair, it may put excessive strain on students by shrinking the horizons for many of them, especially those from the poor and disadvantaged backgrounds. Soon it may also turn into a dreaded and stressful exercise. That is why, implementing another such exams requires careful consideration and gradual advancement.

If we are relying only on MCQ for standardised exams, leaving out comprehensive tests and diverse admission criteria, then we're actually going backwards, since many universities are already implementing those things to value creative and critical thinking. To ensure that students with diverse interests do not fall behind in their quest for securing the subject of their choice, holding general testing and subject-specific cluster testing can be a possible solution.

On the other hand, every testing involves evaluation. While standardisation of testing has been talked about quite a lot in recent years, the issue of standardisation of evaluation has not been raised at all. If we are to see a comprehensive evaluation system for the integrated tests, it will demand massive preparations involving a huge number of teachers, not just those who are affiliated with the ruling party. I have not yet seen or heard anything about any preparation of that sort.

At this point, it is hard to imagine how the proposed central tests will be able to overcome the challenges faced by the existing system (like the difficulty in selecting innovative talents who are otherwise not very competitive, question paper leakage, and so on). A bottom-up approach to address these will be much more useful.

It is possible to address most of the concerns of the autonomous universities about the proposed system through careful planning and necessary engagement. In that case, any arrangement must uphold the autonomy of the universities. We expect that the issue of the unified system will be discussed by the academic councils, the highest body for taking any academic decision in public universities, and a decision will be taken as soon as possible. For the UGC and the government, there is no harm in recognising the central role of the universities in the whole testing and evaluation process, given that they are the leading autonomous institutions of the country. The universities should have the final say—maybe through comprehensive tests (if not included in the standardised tests) and interviews—when it comes to enrolment. The introduction of the new system, therefore, requires long and engaged discussions.

# How the free-rider problem affects youth employability

N economics, the free-rider problem is referred to a market failure which L is often associated with public goods. It occurs when someone benefits from the consumption of a shared resource or privilege without having to pay a fair share for it. Let's look at the classic example of streetlights. Suppose a locality is considering installing an additional streetlight which has a certain cost. Once built, everyone on the street would have full access to the light and thereby receive equal benefits from its consumption. Even the people who refuse to pay for the light would enjoy its benefits. On the other hand, the additional resource cost of a new member on the street consuming the light

Similarly, consider the mundane task of cleaning a common area inside a house such as the living room. Now, imagine having a roommate who claims to be unaffected by tidiness and thereby leaves the entire strenuous task of cleaning on your shoulders. However, no matter how hard you try, there is no way you can fully prevent your selfish roommate from enjoying the comfort of the clean room.

What this means in economics is that these goods being consumed are both non-excludable and non-rivalrous. In other words, the free rider gets a good slice of the pie without having to pay for it and there is no way to deny them their share.

If you are a high-school or college student, trapped in a group task with lazy members, this phenomenon might sound familiar to you. Oftentimes, we come across at least one member in every group assignment who skilfully glides past the workload without putting in a single ounce of effort. Since the nature of these assignments requires teachers to award equal grades to all members of a group, the "slackers" receive full credit for the work they had no contribution in. These assignments contribute significantly to the grades we receive on each course and consequently to the highly prestigious degree that we like to flaunt after graduation.

Several studies around the globe have confirmed that employers are increasingly rating "group work" as one of the most important criteria in the recruitment process. Therefore, college curriculums focus a great deal on teambuilding skills but they often fail to achieve the desired outcomes because of the situation described above. Sadly, the free-rider problem is not limited to just group tasks. Every now and then, we find that one person in the class who turns in someone else's work as their own. Thanks to plagiarism-checker software, students have at least improved on their paraphrasing skills. But this also puts a question mark on the quality of our degree. What knowledge is derived from completing courses that have allowed us to reap

unemployment rate for graduates with a university degree to be 38.6 percent. Even though unemployment for the highly educated is currently a common phenomenon worldwide, it is an alarming issue for a country like Bangladesh where jobs have been growing by only around one-eighth of the rate at which the economy has been growing.

Surprisingly, it is also common knowledge that employers in most of the large organisations of the country, particularly in the RMG sector, prefer to countries in the World Bank Group's Migrants and Remittances Report (2018), we are far behind the Philippines, India, Sri Lanka and Pakistan in terms of sending skilled workers abroad. Out of the workers who have been sending remittance to the country since 1976, only 33 percent were skilled. These workers face various problems in foreign countries and earn low wages owing to their lack of skills and inadequate training.

Even though much is discussed about the problem of unemployment

the benefits of somebody else's hard work? What kind of workforce are these beneficiaries capable of creating?

In a recent study by the Centre for Development and Employment Research (CDER), it was found that youth unemployment in Bangladesh has most severely affected the highly educated group of the workforce. According to the labour force survey (2016-17) of Bangladesh, 29.8 percent of people with a secondary-level education and 13.4 percent with a tertiary-level education were unemployed. A similar survey by Bangladesh Institute of Development Studies (BIDS) reported the

recruit foreigners for the top managerial positions of their companies. This dependency on foreign workers is an indication of the inability of our highly educated youth in fulfilling workplace roles. There is overwhelming evidence that our fresh graduates often fail to exhibit the skills or training they are expected to have by virtue of their educational degrees.

in our country and the failure of our educational institutions and policies, very little attention is given to the declining work ethic of our students and workers. The free-rider problem is real and it undermines, and imposes a threat to, the quality of education being delivered in our universities. It is high time we stopped blaming our educational institutions for everything that is wrong and started taking responsibility for lacking the required skills because of our unethical practices and half-hearted dedication to learn as we graduate.

her "parole" has come up in discussion, even amongst the leading members of the ruling Awami League. The high officials and lawyers of BNP are emphasising on the fact that "parole" is not equivalent to being discharged from prison. They are further stating that since the charges brought against Khaleda Zia are for political reasons, if the government wishes, it can grant bail to the BNP chairperson based on her medical condition. And if her bail petition is approved, then she will be sent to the UK for better treatment.

BNP Secretary General Mirza Fakhrul Islam Alamgir learnt of Khaleda Zia's condition from her family members, who were the only ones granted permission to meet with the former prime minister. The possibility of Khaleda Zia's release raises a number of issues. According to the law, does she have the opportunity to get bail? Is there a possibility of her being released on parole? If she is released on parole, will she be able to go abroad for treatment?


First, let us look into the possibility

There are no laws passed by parliament on parole. It is within the ambit of the Home Ministry. According to the policy of the ministry dated June 1, 2016, there is scope for a conditional temporary release. When someone close to a prisoner of a significant status or other classes passes away, a parole can be granted to them.

The policy states that the time of the temporary release will not exceed 12 hours. However, in certain cases, if the government wants, the time period can be adjusted, but there is no specific allocation of the time frame. During the time, the prisoner must be constantly

under observation by the police. According to the policy, when released on parole, the prisoner will be handed over to the police by the jail authorities and the police will hand over the prisoner back to the jail authorities within the designated time.



Apart from getting out on "parole" there is a scope to seek presidential clemency. According to Article 49 of the Constitution, if someone admits one's guilt, such clemency can be given. The president has the power to reject the plea for clemency. He can also pardon



A few days ago, Khaldea Zia's sister and a few other relatives had visited her in jail. A senior BNP leader told The Daily Star that after the visit, Khaleda Zia's relatives reported that her health was in the worst possible state; both her arms had become bent with stiffness; she could not eat properly. According to Khaleda's relatives, this was the first time she had resigned herself to the idea of bail or release on parole. remarking: "Do whatever you think best." It seemed to them that she was at the end of her life and that was why she made that remark. But one thing is for sure—under no circumstances will Khaleda Zia seek presidential clemency, as according to her, she has not committed any crime.

According to a source, BNP as a party will not appeal for parole. Only if her release on parole is guaranteed will the family appeal for it. Then BNP can claim that the family, on humanitarian grounds, had requested parole. The appeal would have nothing to do with

Almost all BNP leaders believe that her health is more important than anything else and appealing for release on parole will not taint her "no compromise" image. BNP leaders think that even if the government tries to propagate such a notion, the people of this country will not believe it. If Khaleda Zia is released on parole on humanitarian grounds, it will be a positive development for BNP's politics. Yet they cannot shed the apprehension of what the head of the government is thinking. Despite talks between Obaidul Quader and Mirza Fakhrul, this unease has not been alleviated. It is not the court on which Khaleda Zia's release depends; it depends on the decision of the government. And this decision lies mainly with the head of the government.



## Is Pakistan's press freedom under threat?



WEEPING new regulations restricting social media in Pakistan put freedom of expression and the media at the heart of the struggle to counter both civilisationalist and authoritarian aspects of an emerging new

The regulations, adopted without public debate, position US social media companies like Facebook and Twitter at the forefront of the struggle and raise the spectre of China's walled-off internet with its own state-controlled social media platforms becoming the model for a host of illiberals, authoritarians and autocrats.

The regulations, which take effect immediately, embrace aspects of a civilisational state that defines its legal reach, if not its borders, in terms of a civilisation rather than a nation state with clearly outlined, internationally recognised borders that determine the reach of its law and that is defined by its population and language.

The regulations could force social media companies to globally suppress criticism of the more onerous aspects of Pakistani law, including constitutionally enshrined discrimination of some minorities like Ahmadis, a sect widely viewed as heretic by mainstream Islam, and imposition of a mandatory death sentence for blasphemy.

The new rules force social media companies to "remove, suspend or disable access" to content posted in Pakistan or by Pakistani nationals abroad that the government deems as failing to "take due cognisance of the religious, cultural,

ethnic and national security sensitivities of Pakistan." The government can also demand removal of encryption.


Social media companies are required to establish offices in Pakistan in the next three months and install data servers by February 2021. The government justified the rules with the need to combat hate speech, blasphemy, alleged fake news and online harassment of women.

The Asia Internet Coalition, a technology and internet industry association that includes Facebook and Twitter, warned that the regulations "jeopardise the personal safety and privacy of citizens and undermine free expression" and would be "detrimental to

Pakistan's ambitions for a digital economy."

The introduction of the regulations reflects frustration in government as well as Pakistan's powerful military with social media companies' frequent refusal to honour requests to take down content. Pakistan ranked among the top countries requesting Facebook and Twitter to remove postings.

On the assumption that Facebook, Twitter and others, which are already banned in China, will risk being debarred in Pakistan by refusing to comply with the new regulations, Pakistan could become a prime country that adopts not only aspects of China's 21st-century Orwellian surveillance state but also its tightly controlled media.

The basis for potential Pakistani adoption of the Chinese system was created in 2017 in plans for the China Pakistan Economic Corridor (CPEC), a USD 60-billion-plus crown jewel of the Belt and Road, an infrastructure, telecommunications and energy-driven initiative to tie Eurasia to

The 2017 plan identifies as risks to CPEC "Pakistani politics, such as competing parties, religion, tribes, terrorists, and Western intervention" as well as security. The plan appears to question the vibrancy of a system in which competition between parties and interest groups is the name of the game. It envisions a full system of monitoring and surveillance to ensure law and order in Pakistani cities. The system would involve

deployment of explosive detectors and scanners to "cover major roads, case-prone areas and crowded places...in urban areas to conduct real-time monitoring and 24-hour video recording."


A national fibre optic backbone would be built for internet traffic as well as the terrestrial distribution of broadcast media that would cooperate with their Chinese counterparts in the "dissemination of Chinese culture." The plan described the backbone as a "cultural transmission carrier that would serve to "further enhance mutual understanding between the two peoples and the traditional friendship between the two countries."

Critics in China and elsewhere assert that repression of freedom of expression contributed to China's delayed response to the Coronavirus. China rejects the criticism with President Xi Jinping calling for even greater control.

Pakistan's newly promulgated regulations echo Mr Xi's assertion during the Communist party's January 7 Politburo Standing Committee meeting that "we must strengthen public opinion tracking and judgment, take the initiative to voice, provide positive guidance, strengthen integration, communication and interaction, so that positive energy will always fill the Internet space... We must control the overall public opinion and strive to create a good public opinion environment. It is necessary to strengthen the management and control of online media."



## Russia warns Turkey after Erdogan vows Idlib ops

Aid groups say tens of thousands of lives at stake as they have nowhere else to go

Turkey and Russia exchanged warnings yesterday after President Recep Tayyip Erdogan threatened an "imminent" operation in Syria to end the regime's brutal assault on the last rebel enclave.

Syrian aid workers called urgently for a ceasefire and international help for nearly a million people fleeing the regime onslaught in the country's northwestern Idlib province -- the biggest wave of displaced civilians in the nine-year conflict.

Turkey, supporter of some rebel groups in Idlib, has been pushing for a renewed ceasefire in talks with Russia, which backs the Syrian regime. Ankara is eager to prevent another flood of refugees into its territory adding to the 3.7 million Syrians it already hosts.

The Syrian NGO Alliance said displaced people are "escaping in search of safety only to die from extreme weather conditions and lack of available resources".

Erdogan said talks with Moscow over the past fortnight had so far failed to achieve the desired result" and warned that Turkey would launch an offensive into Syria unless Damascus pulled its forces back by the end of the month.

He called for Syrian forces to retreat behind Turkey's military posts in Idlib, which were set up under a 2018 deal with Russia designed to hold off a regime advance.

The Kremlin quickly responded to Erdogan's threat, warning that any operation against Syrian

forces would be "the worst scenario". With the Russian-backed offensive, Syrian troops have reconquered swathes of Idlib and retaken the key M5 highway connecting the country's four largest cities as well as the entire surroundings of Aleppo city for the first time since 2012.

Iran reports first coronavirus cases

Two people in Iran tested positive yesterday for the deadly new coronavirus, the health ministry said, in the Islamic republic's first cases of the disease. Kianoush Jahanpour, a ministry spokesman, said the cases were detected in the holy city of Qom, south of the Iranian capital. The United Arab Emirates was the first country in the Middle East to report cases of coronavirus last month.

#### Old is gold

A helmet used by French soldiers in World War I provided better protection from overhead blasts than a modern American model, according to a US university study. Biomedical engineers from North Carolina's Duke University tested the performance of several models of World War I helmet and the US Advanced Combat Helmet by subjecting them to shock waves. "We were surprised to find that the 100-yearold helmets performed just as well as modern ones," said study author Joost Op 't Eynde. "Indeed, some historical helmets performed better in some respects," Op 't Eynde said.

### UK eyes highskilled workers

Britain will prioritise access for high-skilled workers from around the world in its post-Brexit points-based immigration system, the government said on Tuesday, setting out its plans to put an end to a reliance on "cheap labour from Europe".

Concern over the impact of high levels of immigration from the European Union was one of the key drivers behind Britain's 2016 vote to leave the bloc and the government has said it plans to bring overall migration numbers down.

The new system, in place from Jan 1, 2021, will assign points for specific skills, qualifications, salaries or professions and only give visas to those who have enough points. It will treat EU and non-EU citizens the same.

It will mark a sea change for businesses who have grown used to having access to a large pool of EU workers, particularly since 2004 when the accession of several former communist states in central and eastern Europe saw a big influx of migrants coming to Britain to work.

"We have got a number of routes through the points-based immigration scheme that will enable people to come here with the right kind of skills that can support our country and our economy," interior minister Priti Patel said.

"We need to shift the focus of our economy away from reliance on cheap labour from Europe and instead concentrate on investment in technology and automation. Employers will need to adjust," the government said in a policy document.

The Home Office said it would follow a recommendation made last month by the Migration Advisory Committee (MAC), an independent body which advises the government, to lower the minimum general salary threshold for skilled migrants to 25,600 pounds (\$33,330) a year, from

30,000 pounds. Skilled workers will need to meet criteria including the ability to speak English and

## US, China escalate media spat

Building onto the recent trends in robotics, especially among the Bangladeshi students, Abrar Shahriar Swopnil and Subha Nawar Pushpita's debut book, Roboticser Masterplan, was released at the Ekyshev Boi Mela 2020, recently. Most of the available books and articles on Robotics is mainly in English, which can be a barrier in basic robotics learning. The urge to creating more such books in Bangla is what inspired the brother-sister duo to write this

There were injury marks on her legs, arms and some other parts of the body, Jisan said.

Meanwhile, Deputy Commissioner Manjur Rahman of DB in Gazipur told The Daily Star yesterday that Yasmin was arrested with 120 yaba pills and taken to the DB office in the city. She later fell sick and was taken to hospital.

Her family members were arrested with drugs several times before, he added.

Jisan said his father was a drug addict and only came home once or twice a week, but he was not accused in any case. He and his mother ran the family by working in a poultry farm in the area.

He added that the officers did not find yaba pills in his mother's possession.

The hospital's Residential Medical Officer Rafiqul Islam said Yasmin was brought to the hospital around 10:00pm with chest pain and breathing difficulties. She was referred to the National Institute of Cardiovascular Diseases, but she died about an hour later.

It was primarily suspected that she died due to cardiac arrest, but there were no injury marks on the body,

The cause of death will be known after the autopsy report is prepared, he added.

The body was handed over to the family around 2:00pm yesterday after an autopsy at the hospital.

Jisan said he will file a case. A three-member committee led by Md Azad Mia, additional commissioner of police in Gazipur, was formed yesterday to investigate

the incident, said Gazipur Metropolitan Police Commissioner Anwar Hossain. The committee was asked to

submit the probe report in seven working days.

He declined to elaborate but Myanmar recently introduced new requirements for companies to disclose beneficial ownership, and for banks to undertake better customer due diligence. Two sources with knowledge of the FATF's proceedings and its investigation into Myanmar said the watchdog found that implementation

Twelve countries are on the FATF's grey list. Myanmar's expected inclusion on the list follows its first evaluation by the FATF since the watchdog changed its assessment methodology in 2012.

The two are developing vessels to send tourists just beyond the border of space (80 kilometers or 100 kilometers, depending on the definitions chosen by both). Tickets for Virgin started at \$250,000 when they first went on sale in the mid SpaceX's offering is far more

ambitious and powered by the same reusable Falcon 9 rocket that puts satellites into space and send astronauts to the ISS. At the same time, Boeing is also

eveloping a crew capsule called Starliner, also with the intention of transporting US astronauts to the ISS.

Like SpaceX, Boeing also envisages sending tourists into space, but the program's development is hampered by major glitches that resulted in the early termination of an uncrewed test flight in December.

## Blaze over, not danger

said Abdul Barik, a resident of Chawkbazar.

"It's true that you will not find any chemical store on the roadside in Churihatta as many traders shifted those to other places after the fire. But some of them are still stockpiling chemicals in secret places in the neighbourhood.

'We live in panic, as the existing chemical warehouses may cause incidents like Chawkbazar again."

The actual number of chemical warehouse and stores in old town is hard to come by. But the leaders of Bangladesh Chemical and Perfumery Merchant Association claim they have over 1,500 members.

But at least 7,000 to 8,000 shops and stores housed in residential buildings in Old Dhaka are not affiliated with the association, said the leaders.

These warehouses store various chemicals including glycerine, sodium anhydrous, sodium thiosulfate, hydrogen peroxide, methyl ethyl ketone, thinner and isopropyl. If these chemicals come in contact with fire, there is a high risk of explosions.

Besides, a large number of rubber, plastic and sandal-making factories have been operating in some areas.

According Bangladesh Environment Conservation Rules 1997, no industry using hazardous chemicals or goods can operate in and around a residential area; and the factory owners must have environmental clearance certificates before they can use the materials.

Ignoring the government ban, various unscrupulous traders store inflammable chemicals.

During a recent visit to Chawkbazar area, The Daily Star found no change in the plastic recycling factories in the neighbourhood.

Mehedi Hasan, assistant office secretary of Bangladesh Plastic Babosayee Samity, said, "We have only shops and warehouses of plastic granular. The plastic raw materials are non-combustible.'

But experts say during a fire, such material can help spread the flames. However, Mehedi said, "We are doing this here for generations. Why should we go?"

correspondents These saw chemical stores in Mitford, Armanitola, Islambagh, Bongshal, Siddique Bazar and Babu Bazar areas of Old Dhaka.

There is a chemical warehouse around 500 metres from the Wahed Mansion. Some five to six rooms store raw materials for painting. The caretaker said the owner does

not live in the area, and declined to

Wahed Mansion, said, "We have heard that chemical stores have moved to another place. But there are still some stores operating inside residential buildings.

resident of Chawkbazar, preferring anonymity, said, "We have seen fire department carrying out awareness activities occasionally in the area. But the efforts could not put much impact on businessmen and homeowners as they prioritise profit over safety.

Before the fire, chemicals were being transported in day time but now it is done at night, he alleged.

Mohammad Belayet Hossain, a member of Bangladesh Chemical and Perfumery Merchant Association, said this business is ages-old and it is not possible to shift overnight.

Still, many warehouses have moved to different places on their own in the last one year.

"For example, some shifted to Demra, some to Narayanganj, but the relocation was not done in a planned way. Therefore, chemical warehouses are spread across different areas of the city and we have no control over them," said Belayet, a former general secretary of the association.

But none could shift to the government designated places as those are still not ready, he said.

The government has long been saying about establishing a permanent hub but those are only limited to rhetoric. "Whatever the government does, it has to consult with us as we know how to maintain chemical," he added.

Brigadier General Md Sazzad Hussain, director general of Bangladesh Fire Service and Civil Defence, said, "After the Chawkbazar incident, we stopped issuing any licence. All the chemical stores were not relocated from Old Dhaka. Some of them are still doing their business.

Md Abdul Halim, secretary of industries ministry, said they are hoping to relocate the chemical warehouses temporarily to Shyampur and Tongi by June and December this year respectively.

"The work for relocation is going on in full swing," he said.

About the permanent chemical village, he said they will complete the land purchase procedure by June. "We will be able to shift the entire chemical industry in next two years."

Expressing frustration, architect Iqbal Habib said, "If we consider the home ministry's recommendations, we will find that basically nothing changed except some awareness.

"Fire incidents are still taking place on a small scale regularly. It means Chan Mia, a meat seller close to another big tragedy is looming."

## Couple bloom tulips first in Bangladesh

During the mid-80s, I got engaged with Bangladesh Television's agricultural documentary programme Mati O Manush Bangladesh (Soil & People). During that time, I met a Belgian named Jean Paul Perrin, who came to Bangladesh through an NGO and had a bondage with floriculture or flower farming. He worked on gerbera flower back in 1988 and also worked on chrysanthemum and carnation flowers. He was successful in some of them. He also tried to cultivate tulip, the most acclaimed ornamental flower. Jean even showed me a bulb of tulip which was the first tulip bulb I had ever seen. But the flower did not bloom that time and he could not become successful in growing tulip in Bangladesh. I had been fortunate enough to visit Keukenhof of The Netherlands back in May, 2015. For the very first time, I could see tulip and had the idea how its magnificent field would look like.

A few days back, I went to Kewa village located in Gazipur's Sreepur upazila. Today, I will tell my dear readers an outstanding story of a young entrepreneur couple. They are involved with floriculture and flower farming for about 15 years. They have managed to bloom Tulip on Bangladeshi soil for the very first time. When I first heard this, it sounded unbelievable. So many projects, so many people have tried to make it happen from time to time but no one succeeded. But this young duo hasn't only been able to grow tulip, but has successfully managed to grow capsicum, gladiolus, gerbera, China rose and many other flower varieties. Delwar Hossain along with his wife Shelly Hossain made this miracle happen a month back.

I don't know where Jean Paul Perrin lives now as I don't have any contacts with him. But

"People from our region are coming here, seeing tulips, taking selfies; not everyone can afford to visit Kashmir or The Netherlands to enjoy this view. It is a great pleasure to us," added Shelly.

"If everything goes fine, we have plans to sell next season," both said with a wide smile on their faces.

They have kept the tulips under net house. The couple say it would have been better if they could mix urea with some more fertilizers and pour the liquid mix into the flowers, but instead they are giving the inputs directly. They look forward to get water soluble fertilizer. The agriculture officers have already confirmed that they have a very good soil to grow tulips here. Delwar and Shelly believe more tulips can be grown in the colder regions like the northern district of the country. They are trying to grow tulips in a larger shade so that they can sell it next year. The market price for each tulip

would be around Tk 70 (USD 0.82) per flower. Shelly looks after the international communication. She has seen a great possibility

The couple is very serious about learning the language skills which will soon deliver them even better news in the near future.

"My background and studies tell me to go

for teaching profession, but all my passion and my world is bonded with Delwar and this beautiful flower orchard," says Shelly. "The most important fact is both of us

love nature, trees, flowers and farming. We have been married for the past 14 years and anything you love, won't disappoint you,' believes Delwar.

'My father was a traditional farmer and it was in my blood to carry on with the heritage of profession," says Delwar.

Flowers always make me feel good. So, at first I bought gladiolus bulbs, worth Tk 4,000 (USD 47.05), knowing that I would be able to sell each flower at Tk 15 (USD 0.17)," Delwar

"Then I bought 20,000 bulbs from Sher Ali Sardar, a flower farmer from Jashore's Godkhali. I have sold almost 35,000 sticks of flowers at Tk 24 per stick and earned around Tk 8,40,000 (USD 9881) from gladiolas.

## We are victims of political vindictiveness

A group of locals, whose structures near the Dhamai river in Barlekha upazila were demolished by local administration, alleged that they have been victims of political vindictiveness. Locals claimed that their properties

#### 3 to die for murder



## Racket pocketing crores of taka a month

An illegal gas line racket in three upazilas of Brahmanbaria has been plundering natural gas worth crores of taka from gas supply lines each month.

The organised criminals are so reckless that they are even issuing "demand notes" and "bill books" to their clients, mentioning the name of Bakhrabad Gas Distribution Company Limited (BGDCL), and collecting "monthly gas bills" in bank accounts they opened with different banks.

racketeers include public representatives including a chairman of a union parishad and several local political leaders, alleged locals.

They said in Brahmanbaria Sadar, Sarail and Ashuganj upazilas, the crime syndicate so far "sold" at least 15,000 illegal connections and they usually collect Tk 60 thousand to Tk 90 thousand of a consumer's house from the main line.

However, sales division officials at Bakhrabad Gas Distribution Company Limited (BGDCL) said the number of illegal connections in those upazilas would be around 5,000 and they traced 54,031 feet of illegal gas line in those areas.

Most of the illegal connections BGDCL found were in Suhilpur and Budhal unions under Sadar upazila, the officials said, adding that BGDCL has 24,000 valid residential gas connections in the three upazilas.

Locals requesting anonymity, apparently for security reasons, said the key figures in the illegal gas line racket include Suhilpur Union Parishad (UP) Chairman and Jubo League's Sadar upazila unit Joint Secretary Azad Hajari Angur, a member of the same UP and Jubo League's Organising Secretary of the same unit Mohsin Khandaker, Belal

Kazi Pabel and Kazi Manzu from Ghatura village in the same union, and Sahed Mia from Madhhayapara of Brahmanbaria town. Engineer Zahidur Reza, deputy general

manager of BGDCL in Brahmanbaria, said they disconnect illegal connections routinely and last year alone, with assistance from the local administration, they so far confiscated 17,953 feet of gas pipes that were laid illegally. The gas line racket is so powerful that

they are often attacking BGDCL officials during disconnection drives, he said, adding that on Monday, they handed over two people to police for attacking four BGDCL officials during a drive in Kalishima area of Brahmanbaria Sadar upazila.

The pace of disconnecting and confiscating illegal pipes by BGDCL is not fast enough as the gas line racket

for each connection, based on the distance Mia from Bakail village in Suhilpur union, lays kilometres of illegal pipeline in one night. As such, the number of illegal gas connections are on the rise, said locals.

Requesting not to be named, a resident of Malihata village in Suhilpur union said he paid Tk 70 thousand for an illegal connection to his house two and a half years ago. Like others, he was not given any "bill book", but he has been paying his "gas bill" against the "demand note" each month to an account with United Commercial Bank.

Another resident of the same village said after getting gas connection from the same people, he found out later that the documents he had received against the connection were all fake.

According to Bangladesh Gas Act 2010, consumption of natural gas illegally is punishable by three months to a year of jail term and subject to fines between Tk 10 thousand and Tk 5 lakh.

### Sinking into the depths

Sagor said they got wages regularly in the first two months but since then delays in payment began. Every month they

had to ask the management for pay. Around a month ago, operations at the factory, which is some 20km away from Kuala Lumpur, stopped, he said.

The migrants filed a complaint with the Malaysian labour department and on February 8 wrote to Bangladesh High Commission in Kuala Lumpur seeking intervention.

"We have not had any help from the Bangladesh high commission. We are now in total uncertainty," he said. He said they also tried to contact the recruiting agency but failed to get any help.

Noor Ali, managing director of Unique Eastern Pvt, said he had no idea that the workers were facing problems.

"Let me talk to them. I will take immediate action," he told The Daily Star yesterday evening. Abu Hayat, an independent researcher and migrant rights activist based in Kuala Lumpur, said it was

unfortunate that none of the authorities were extending a helping hand to the migrants. These workers paid so much for migration that they need more than two years in Malaysia to recover the cost,

"Bangladesh high commission should intervene in the

issue immediately and ensure justice for them," he said. The workers could be transferred to other companies or compensated, Abu Havat said.

He said labour recruitment from Bangladesh has been suspended since September last year following allegations of irregularities. Now, talks for a new recruitment deal

between Bangladesh and Malaysia are at the final stage. The Daily Star could not get in touch with SSN Medical Products Sdn Bhd for comments.

Earlier, the Supreme Court's HC Division denied her bail twice in the case and the Appellate Division once.


On August 8, 2011, the Anti-Corruption Commission filed the Zia Charitable Trust graft case with Tejgaon Police Station against four people, including Khaleda. They were accused of abusing power in raising funds for the trust from unknown sources.

A special court in Dhaka jailed Khaleda and three others for seven years in the case on October 29, 2018.

Bangladesh Cricket Board president Nazmul Hassan put to rest the speculation

surrounding the future of Bangladesh ODI captain Mashrafe Bin Mortaza by saying he would lead the team against Zimbabwe, but hinted that the series would probably be the 36-year-old's last as ODI captain as the board were contemplating the appointment of a long-term captain with the 2023 World Cup in mind.

The BCB boss expressed his disappointment over the poor performances from the national team recently and urged the Tigers to not take Zimbabwe lightly and to go into the series with a new mindset.

"I have been seeing in the media over the past few days that things will be great after beating Zimbabwe. I don't see that happening. I have no hope. I told them, 'if you take them lightly, Hassan told the media yesterday.

"If someone asks me what Bangladesh's worst performance was at home, I would say losing to Afghanistan. It was unacceptable. If we lose to Afghanistan, we can lose to Zimbabwe. We need to have a new mindset. Our seniors must take major responsibility and it has to be a team game."

Hassan also slammed the T20I side for losing 2-0 to Pakistan recently and also

## Coronavirus now hits volleyball

Bangladesh Volleyball Federation (BVF) has deferred the Bangabandhu Asian Senior Men's Central Zone Volleyball Championship after some participating nations expressed reservations connected to the coronavirus outbreak, as well as some financial constraints.

Although there are no infected patients in Bangladesh, teams in the region are reluctant to travel after the outbreak in China's Wuhan, with the International Solidarity World Ranking Archery Championships in Bangladesh also being postponed on Monday.

The meet was scheduled to take place from March 22 to 28 at Suhrawardi Indoor Stadium in Mirpur with the participation of eight nations Turkmenistan, Uzbekistan, Kyrgyzstan, Maldives, Nepal, Bhutan, Afghanistan and hosts Bangladesh -- but the championship is now

likely to be held in September.

"We did not get a good response as Sri Lanka and one of the central Asian nations wrote to us to express concerns about the coronavirus outbreak while some others told us informally. That's why we, on February 15, decided to defer the championship by six months and hold it in September," BVF general secretary Ashikur Rahman Miku told The Daily Star yesterday.

Miku also said that uncertainty over financial assistance from the youth and sports ministry also played a part in the deferment.

"The ministry had told us they would provide financial assistance to organise the tournament but we are still in the dark about whether we will get that help," said Miku. "We could have organised the championship by managing sponsorships like before but we could not do it because the BVF president [Atiqul Islam] was

busy in the DNCC election campaign. National team captain Horosit Biswas

believes the deferment will help them achieve better results as they needed at least four months' preparation to regain the title they clinched in the 2016 edition held in Dhaka.

"We lacked preparation because players scattered after the National Championship. We were also supposed to go to Iran to avail better training facilities for two months but we could not because of the political crisis between Iran and America," Biswas told The Daily Star yesterday.

Biswas informed that they will go after the completion of the Bangabandhu Bangladesh Games to be held from April 1 and have uninterrupted training until the championship.

"We will compete in the ABC Challenge Cup in Kyrgyzstan in June featuring teams like Iraq, Saudi Arabia, Sri Lanka, Malaysia, Hong Kong and Thailand. It is a better tournament than the Central Zone championship, so it will help us perform better at home in September.

Atletico have built a reputation on upsetting the apple cart but they have endured a terrible season, losing to a third division team in the Copa del Rey, suffering numerous injuries and falling 13 points behind leaders Real Madrid in La Liga.

"Lagging behind in the league, out of the Copa and (former captains) with Diego Godin and Gabi gone, everything pointed to the end of an era," said newspaper AS.

"Then suddenly, no. Against the hardest test of all, the best team in Europe, Simeone's Atletico rose again and produced one of their best performances in years.'

Borussia Dortmund's lethal teenage striker Erling Haaland scored twice in eight minutes to lead them to a 2-1

win over Paris St Germain in their Champions League last 16, first leg on Tuesday. The Norwegian, 19, who joined

in the last transfer window and has eight goals in five Bundesliga matches, stabbed in from close range after a quick-fire passing move in the 69th minute. He then thundered home an

unstoppable shot for his second goal in the 77th, two minutes after PSG's Brazilian forward Neymar had levelled for the French champions.

Haaland, the first Dortmund player to score in his first league, German Cup and Champions League matches, has reached 10 goals in seven games in Europe's elite competition this season, including eight for Salzburg in the group stage, faster than anyone.

He is only the second teenager to net 10 Champions League goals, after Kylian Mbappe, and is the first teenager to score 10 in a single

campaign in the competition. He is also the first player to score with two different teams in the same season in the competition.

"I still need to improve, keep working," Haaland said. "I want to go far in the Champions League. With the second goal I enjoyed the moment."

PSG, who were eliminated at this stage of the competition in the previous three seasons, had fit-again Neymar and French striker Mbappe back in the starting lineup but were almost completely shut out by an efficient Dortmund backline.

"Obviously, maybe we deserved the draw but Dortmund were very good," said PSG defender Thomas Meunier.

"They didn't lose one game here at home this season and we saw today it is so difficult. We thought they had defensive problems, but we didn't create many chances.'

In a cautious first half the French side had the slight advantage in possession but Dortmund carved out the only real chance after 27 minutes with a curled shot from Jadon

Mbappe and Neymar were kept under tight surveillance, just halftime."

### Structures close to city rivers to be relocated

State Minister for Shipping Khalid Mahmud Chowdhury yesterday said the government would take up a project to relocate religious and educational establishments built within the boundaries of the rivers in and around the capital. "We don't want to evict religious

structures. We have discussed with the government whether it would be possible to build these structures in a planned way," he said at a meeting in this regard.

Khalid said the government wanted to free the rivers surrounding the capital to make the city livable.

The state minister was speaking at the meeting with officials of religious affairs ministry, Islamic Foundation, Bangladesh Inland Water Transport Authority and two Dhaka city corporations.

He said 113 religious and educational establishments were built along the Buriganga, Turag, Balu, Shitalakkhya and Dhaleshwari rivers.

Of the establishments, 77 are mosques, madrasas, orphanages, and shrines, five graveyards and places for washing dead bodies, an Eidgah, 14 schools and colleges, and 13 temples, bathing places and crematoriums.

"We are yet to make any move against those structures which are related to religious sentiment. A discussion is underway in this regard," the state minister added.

### SpaceX to send four tourists into deep orbit



SpaceX announced a new partnership Tuesday to send four tourists deeper into orbit than any private citizen before them, in a mission that could take place by 2022 and easily cost more than \$100 million.

The company signed the deal with Space Adventures, which is based in Washington and served as an intermediary to send eight space tourists to the International Space Station (ISS) via Russian Soyuz rockets.

The first of these was Dennis Tito, who paid \$20 million for an eight hour stay on the ISS back in 2001. The last to go was Cirque du Soleil founder Guy Laliberte, in 2009.

### Global watchdog to put Myanmar on watchlist

Myanmar is set to be placed on a watchlist by a global finance watchdog this week, amid concerns of moneylaundering by transnational drug traffickers and weak regulation of its financial system, two sources familiar with deliberations said.

A decision to put Myanmar on the "grey list" by the Paris-based Financial Action Task Force (FATF) would mean the inter-governmental body had found "strategic deficiencies" in the country's ability to counter moneylaundering and terrorism financing.

While being on the list does not carry any sanctions, it could curtail the growth of financial, investment and trade flows to and from the Southeast Asian nation, a high-level official, speaking on condition of anonymity, told Reuters.

Kyaw Win Thein, the head of Myanmar's Financial Intelligence Unit who is attending the FATF meeting in Paris this week, told Reuters that Myanmar "is not on the grey list so far". Its fate will be decided at a plenary meeting on Thursday, he said. The FATF typically announces its decisions on Friday at

the end of its Paris plenary meetings. Kyaw added that Myanmar's government has developed
