Youth hacked to death

Locals set house of alleged attackers on fire in Gazipur

Miscreants hacked a youth to death while he was trying to save his friend at Gazipur city's Bhurulia yesterday.

Nayeem Sarker (22) was a student of Model Institute of Science and Technology. His friend Munna, also a student of the institute, was injured, said police.

Sadar Police Station Officer-in-Charge Muhammad Alamgir Bhuiyan said Munna was chatting with a friend on the institute premises when the girl's two brothers --Royal and Rana -- with other youths rushed to the spot and beat Munna up.

Munna tried to go away but they waylaid him in front of local Mahbub Market. The gang beat him there again, prompting him to call his friend Nayeem over phone.

When Nayeem arrived, the two friends and other youths scuffled over the issue and, at one stage, the gang hacked them

indiscriminately, said the OC. Locals took them to Shaheed Tajuddin Ahmad Medical College Hospital where the doctors declared Nayeem dead.

Police detained Royal's father Tipu Sultan and one Emon (20) for interrogation, said

Centre: A condemned cell for animals". According to the report, the wildlife

conservation centre in Tilagarh Eco Park has turned into a death trap for animals since it started operations in November 2018. At least 33 animals and birds died at the centre since it was opened, said Forest Department officials.

Confirming the number of deaths, more animals went missing, the report said.

Chayanbrata Choudhury, acting beat officer of Tilagarh Forest Beat, said four deer, four chukar partridges, four peacocks and one swamp hen were among the dead.

Besides, 20 love birds either died or managed to escape from the cage, he added. An insider who closely monitored the animals, however, said the number of deaths was as high as 50, and at least 10
