Rohingya 'yaba trader' killed in Cox's Bazar

A Rohingya man, allegedly a yaba trader, was killed in a "gunfight" with BGB in Cox's Bazar's Ukhiya upazila early yesterday.

The incident took place at Rahmat-er Beel area of Palongkhali union of the upazila around 3:30am, said Lt Col Ali Haider Azad Ahmed, commander of Cox's Bazar Battalion-34 of Border Guard Bangladesh.

The deceased was identified as Md Jubayed Mia, 22, a resident of Block-A at Leda Rohingya Camp in Teknaf, the BGB official said, adding that 20,000 yaba pills, one pipe gun, and two fresh cartridges were recovered from the

"A BGB patrol team observed a group of unidentified men suspiciously moving into Bangladesh from the Myanmar side, near a cyclone centre in the area, around 3:30am and asked them to halt and identify themselves. In response, the men opened fire at the BGB personnel, prompting them to retaliate, triggering the gunfight," Lt Col Ali Haider said.

"At that point, the men kept firing at the BGB personnel and fled from the scene. Later, the BGB team found one man injured at the spot. He was taken to Ukhiya Upazila Health Complex where the on-duty doctor pronounced him dead," the BGB official said.

"The identity of the deceased was later confirmed through different sources," he said.

Cox's Bazar police later recovered the body and sent it to Cox's Bazar Sadar Hospital morgue for autopsy, the BGB official also said.

CRACKDOWN ON DISSENT Fourth Saudi prince arrested

The crackdown on dissent against Crown Prince Mohammed bin Salman within the Saudi royal family widened with the arrest of a fourth prince, the

New York Times reported. The detention of Prince Nayef bin Ahmed, a former head of army intelligence, suggests the full extent of the action remains unclear, according to the newspaper, citing two Saudis close to the royal family.

Prince Nayef is the son of Prince Ahmed bin Abdulaziz Al Saud, who was arrested the day before along with his nephews, former Crown Prince Mohammed bin Nayef and Prince

The detentions cast a shadow over Prince Mohammed bin Salman's attempts to burnish his country's tarnished international reputation as it hosts this year's Group of 20 gatherings. Saudi officials saw the meetings as an opportunity to showcase the kingdom as a business and tourism destination, and highlight social changes in a country that banned women from driving until 2018.

Saudi Arabia's image took a beating after activists were detained and Saudi agents murdered journalist Jamal Khashoggi.

"The Saudi leadership's challenges have snowballed in recent days," said Ayham Kamel, head of Middle East and North Africa at the Eurasia Group consultancy. Recent developments may have made King Salman and Prince Mohammed's branch of the royal family "more sensitive to risks of a coup," he said.

Manchester and Kuwait City. There will be no flight to Doha until further notice as the Qatar government yesterday imposed a travel ban on people from 14 countries, including Bangladesh.

On Saturday, the Kuwait government announced a sevenday travel ban on people from Bangladesh and six other countries.

Biman then cancelled its flights to Kuwait for two weeks.

Those who bought tickets for Doha or Kuwait will get a full refund from Biman's sales centres, said in a press release.

Hazrat Shahjalal International Airport Group Captain Director Touhid-Ul-Ahsan said China Southern Airlines had stopped its operation from Dhaka while China Eastern was operating only one flight a week instead of seven.

US-Bangla Airlines has also reduced the number of its weekly flights to two from seven to Guangzhou for want to passengers.

Besides, Thai Airways, Singapore Airlines, Saudia and several other airlines have also reduced their flights on different routes, said the HSIA

"Around 28 airlines used to carry between 20,000 and 25,000 passengers to and from HSIA per day. The number has significantly fallen, he added.

"Celebration of the birth centenary of Father of the Nation Bangabandhu Sheikh Mujibur Rahman will be inaugurated through televisions and other electronic and social media," Kamal Abdul Naser Chowdhury, chief coordinator of the committee, told a media briefing in the capital.

He said a technical team, led by lawmaker Asaduzzaman Noor, would draw up a new detailed plan the opening of the yearlong

Officials said e-passport service was

now available at the DIP's Agargaon, Uttara, Iatrabari. Cantonment, Secretariat and foreign ministry regional passport offices.

Only the government officials can submit e-passport applications from the Secretariat office. Besides, the office at the foreign ministry provides diplomatic passports.

The DIP on March 5 launched the e-passport service at its regional office in Gazipur. The service will be offered from three regional offices in Narsingdi, Manikganj and Munshignaj this week.

In Gopalganj and Mymensingh, the service will be launched on March 16 and 18 respectively.

According to officials, the service will be available at two passport offices in Chattogram division, and in Feni, Noakhali and Cumilla this month. The service is likely to be launched in all eight divisional cities within next month.

Speaking to this correspondent, several e-passport applicants said they could not fill in the application form online due to some problems.

the form, error messages popped up. Besides, they didn't receive any confirmation message from the DIP after paying the applicable e-passport fees online using cards of different

As a result, the applicants were forced to take help from different computer shops near the Agargaon regional passport office. complained that they had to pay the shops Tk 300 to Tk 500 for submission of a single application online.

Asked about the problems, Brig Gen Saidur said they were aware about those. Three people were already arrested in this connection, he added.

The e-passport project director said filling up the form online was very easy, but some applicants were facing problems as they were not

Meanwhile, the e-gate service is not available yet for the general e-passport

Saidur said the service would be offered to all e-passport holders after a couple of months when there would be enough trained manpower.

There are two types of e-passports booklets with 48 and 64 pages, and their tenures are five years and 10

Fees for e-passports varies from They said as they were filling in Tk 3,500 to Tk 12,000, depending on the number of pages and time for delivery. An additional 15 percent VAT is applicable with the fees.

Law ministry to decide

Regarding law ministry's steps, the home minister further said, "The law ministry and us, neither will be able to go beyond the law. We have sent her [Khaleda's] appeal for legal opinion. But the actions must be taken through the judicial process and nothing will be done beyond it.'

HAJJ SERVICE BOOTH IN ALL **REGIONAL PASSPORT OFFICES**

The home minister was addressing reporters after the inauguration of the Hajj Service Booth 2020 at the Department of Immigration legal support and go to court to release and Passport (DIP) in the capital's

DIP Director General Major General General Mirza Fakhrul Islam Alamgir Shakil Ahmed presided over the inauguration ceremony.

DG Shakil Ahmed said they are launching the Hajj service booth in country to facilitate arrangements for hajj aspirants.

There will be a designated person in every service booth and hajj aspirants will get all passport-related facilities from a single place, said the DG.

Every hajj aspirant will be provided special card after their passport enrolment and any family member or relative will be able to collect the passport using the card on behalf of applicant, he said.

"We need to ensure our best services to them so that they can get their passports in due time," added the director general.

Addressing the programme, Md Nurul Islam, secretary of religion affairs ministry, said they have analysed the database of hajj aspirants and found that every year, around 50 percent of total hajj aspirants need to submit applications for new

The special initiatives of passport ist the najj to perform the holy prayer, added the secretary.

After the inauguration ceremony, all regional passport offices across the the home minister handed over passports to six hajj aspirants.

Regarding the service booth, DIP DG Maj Gen Shakil Ahmed said they are planning to keep the booth running round the year. Once the hajj season is over, the service desk will be used to provide services for physically less able passport applicants, he

Public Security Division Senior Secretary Mostofa Kamal Uddin, Md Shahiduzzaman, secretary of security service division of the home ministry and Md Nurul Islam, secretary of religion affairs ministry, were present at the ceremony as special guests.

According to Directorate General of Health Services (DGHS), 101,354 dengue cases were reported last year, of which 49,544 were outside Dhaka.

The number of deaths was 156. During the hearing of a suo moto rule, the HC bench of Justice Tariq ul Hakim and Justice Md Iqbal Kabir Lytton on November 12 formed the probe committee led by Dhaka District Judge Md Helal Chowdhury to identify the persons responsible for outbreak of mosquito-borne diseases like dengue and chikungunya in

Dhaka. The inquiry committee talked to experts on how to prevent the spawning of Aedes mosquito, which causes dengue fever.

In the report, the committee said an integrated initiative is needed to prevent the spread of dengue, chikungunya, and other mosquitoborne diseases.

In its recommendations, the committee said though it is the duty of city corporations to fight mosquito, it is not possible for them to do that alone. It will have to be done in a coordinated way.

Coordinated efforts will have to be taken by all service-providing Rajuk, organisations Wasa, Bangladesh Police, Dhaka Cantonment Authority, Civil Aviation Authority, BRTA, Bangladesh Railway, Bangladesh Water Development Board, Directorate General of Health

Services, Metro Rail Authority, Department of Environment, Bangladesh Meteorological Department, Rehab, house owner associations or welfare associations and others.

probe committee also recommended taking up short-, mid- and long-term plans to fight

mosquito. As the dengue and chikungunya have been spread across the country, the probe committee suggested forming a separate authority or body to control mosquito centrally. There will be a modern laboratory, research cell and skilled entomologists under

the authority. committee's The recommendations include forming a high levelorministry level monitoring cell for mosquito control activities and constituting mosquito control monitoring cells incorporating officials and employees from division, district, upazila, union and other city corporations and municipalities.

It also suggested formation of monitoring committees incorporating high officials from every district to oversee mosquito control activities regularly.

The committee proposed examining the effectiveness of insecticides and chemicals in every two years and taking steps accordingly.

It asked the authorities to carry out two surveys every year to find the density of mosquito in the city

The committee suggested building separate warehouses to keep pesticide and equipment to control mosquito.

It also asked the authorities to give more importance on larviciding instead of adulticiding to fight
