Open waste dumping a nuisance in Tangail town

Massive waste dumping beside busy roads continues for long, exposing the abysmal condition of waste management system in the century-old Tangail municipality.

The residents as well as commuters are vulnerable to serious health hazards as the unscrupulous act causes serious pollution of the environment, especially air and water, and spreads horrible stink across

Established in 1887 during the British Tangail municipality currently comprising 29.43 square-kilometre area has a population of around two lakh

But the ancient municipality is yet to

The municipality comprises 18 wards but there is arrangement of waste removal from 10 wards fully and from three wards partly, officials said, adding that the rest five wards remain out of the waste removal system.

Some 65 to 70 tonnes of different waste, including that from households, is collected in the municipal area daily on an average while the authorities can arrange removal of 50 to 55 tonnes of it, they said.

According to Local Government (Municipality) Act of 2009, waste management as well as protecting citizens' health and local environment is important

Tangail-Mymensingh Road in Rabna Bypass area, entrance to the town from the north, and beside Tangail-Aricha Road at a spot between Kagmari and Baby Stand areas, entrance to the town from the south.

The bad smell spreading across the large area causes immense sufferings for locals, pedestrians as well as passengers and transport workers on the busy road.

The situation turns more serious when the waste, including remains of dead birds and animals, spread on the road during rain and storm," said Noya Miah, a resident of Rabna Bypass area.

"The municipality has continued

But huge waste is being dumped beside the environment protection laws, whereas one of their main responsibilities is to keep the town clean through proper waste management system," Goutam Chandra Chanda, a senior research officer of Bangladesh Environmental Lawyers Association (BELA).

Jamilur Rahman Miron, mayor of Tangail municipality, said they have been planning to make a waste dumping place for the municipality since 2004 but could not arrange necessary land for it.

"Recently, we have chosen a land in Rabna Bypass area for making a modern waste dumping site for the municipality. Process is on to buy the land under a World Bank project," he said.

Man held over rape of 4-yr-old

Police yesterday arrested a man in Manikganj over rape of a 4-year-old girl.

The arrestee was identified as Abul Hossain, 50, son of Sarafat Ali from Bormi area in Gazipur's Sreepur upazila. Manikganj Police Station Officer-in-Charge (OC) Rokibuzzaman said acting on a written complaint filed by the child's mother, they arrested Abul Hossain around 10:00am at his rented house in Manikganj town.

Abul Hossain had been a resident of the same area for long time. Although he claims to be a bus driver, he did not have any driving licence.

According to the complainant, a resident of the same neighbourhood, the man allegedly raped her daughter one week ago, on last Wednesday.

The young girl was given treatment at a medical facility and she was out of danger, the OC said, adding that process was underway to produce the accused before a court soon.

Couple found dead in Joypurhat

A teenage boy and a girl, in a romantic relationship, were found dead within a 12-hour span on Tuesday and yesterday at separate locations in Joypurhat town.

According to police, the girl, Taznuba Nabila Neer, 16, daughter of Abus Salam from Arafat Nagar area in Joypurhat town, was a student of 10th grade at Joypurhat Government Girls' High School.

Police identified the boy as Imran Hossain, 17, son of Farid Hossain from Madarganj area of the town. He was an intermediate first-year student at Joypurhat Mahabidyalay.

After hearing the news of Taznuba's death -- by hanging at her home on Tuesday afternoon -- Imran, a drug addict, made several attempts to take his own life at his home on Tuesday night, police said.

Imran's parents foiled all his suicide attempts and they rushed him to a drug rehabilitation centre in Joypurhat town later that night.

However, the boy also succeeded in hanging himself there early yesterday morning.

Police recovered Taznuba's body on Tuesday night, while Imran's body yesterday morning.

They sent both bodies to Joypurhat Modern Hospital for conducting autopsy, said Shahriar Khan, officer-incharge of Joypurhat Sadar Police Station.

An investigation into the deaths was launched, he added.

Mob forcibly cut youth's hair

The incident, which took place during a mobile court drive in the area, drew criticism on social media. A photo of the incident that went viral

on Facebook shows that a crowd stopped the youth and someone started forcibly cutting his hair in the afternoon. Assistant Commissioner (AC) Saved

Mahbubul Haque, who was present nearby, seemed helpless before the angry crowd. The youth was apparently terrified while

his hair was being cut. AC Sayed Mahbubul Haque told The Daily Star that he led a mobile court in the area after receiving complaint from locals

that illegal activities were taking place there. "A crowd gathered at the spot and tried

to harass the youth. At one stage they cut his hair. I prevented them from causing further nuisance," he said. The victim had gone to the area with a

group of youths who camped there. The youth could not be reached for his comment as he kept his mobile off after the

Locals said there are allegations that

a section of youths often get involved in illicit acts in the beach area. Milton Ray, upazila nirbahi officer of Sitakunda, told this correspondent that the district administration of Chattogram formed a one-member committee led by an additional district magistrate to investigate

the matter. The committee has been asked to submit report within three working days.

PUST teacher recruitment test postponed

The authorities of Pabna University of Science and Technology (PUST) yesterday postponed a test for recruiting teachers in History and Bangladesh Studies Department of the university.

The decision came after the High Court on March 2 this year issued a stay order on the recruitment test.

Hearing a writ petition filed by three examinees of a previous recruitment test, the high court bench of Justice Sheikh Hasan Arif and Justice Md Mahamud Hasan Talukder passed the

The court also asked the PUST authorities as to why the petitioners did not get the scope of applying for the fresh test or they were not issued admit cards based on the previous test. The high court bench asked the authorities concerned to respond within 28 days.

In October last year, the previous recruitment test was cancelled over controversy of bribe.

On March 29, 2017, the PUST issued a circular for recruiting lecturers in the department and the recruitment test was held on October 24 last year. Six applicants were selected for viva after they passed the test.

The PUST authorities later cancelled the test and announced a fresh test on March 12.
