Digital transactions

Speakers say about social safety net programme

Speakers at a roundtable yesterday said digital financial transactions saved time and expenses of social safety net programme beneficiaries across the country, and ensured transparency of transactions.

The programme, titled "Social security allowance: use of digital payment system" was organised by Bangla daily Prothom Alo in association with USAID and World Vision at the newspaper's office in the capital.

Speakers said there are still some challenges, but it can be overcome through raising awareness on digital security. Speaking at the meeting, Senior Secretary Shamsul Alam, a member of the Planning Commission, said only 13 percent of people were under the coverage of the social safety net programme in 2009, but now around 58 percent people have been brought under this programme. Due to increased usage of technology, the problem of middlemen has been resolved, and now poor and pregnant women, widows and the elderly get their allowances directly.

He mentioned security-related problems, like hacking PIN numbers, as "teething problems" that mobile literacy can overcome, and asked service providers to reduce their service charges.

Fred Witteveen, country chief of World Vision Bangladesh, said they are providing long-term financial assistance to the rural poor, especially women and youths, which is impacting future generations.

"The effectiveness of special safety net programme has been increased because of digital transactions," he added. Syed Nurul Basir, director of Department of Social

Services, said the social welfare ministry has implemented the G2P (government-to-people) only in 18 districts of five divisions, but they are confident of implementing the project all over the country by 2021.

Director of Institute of Public Health Nutrition Khalilur Rahman, Deputy Secretary of PMO Innovation Unit Monirul Islam, Chief External and Corporate Officer of mobile financial service Bkash Sheikh Monirul Islam, National Project Director of "Sopno", a project in coordination with the LGRD ministry and UNDP, also spoke at the event.

The government has decided to transfer Buet student Abrar Fahad murder case from Dhaka Metropolitan Sessions Judge's court to the Speedy Trial Tribunal-1 of Dhaka for finishing its trial proceedings quickly.

The decision was taken under Section 6 of the Speedy Trial Tribunal Act, 2002, and Law Minister Anisul Huq has approved the relevant file regarding the transfer.

Earlier, Abrar's family met the minister and requested him to transfer the case to a Speedy Trial Tribunal, a law ministry official told The Daily Star yesterday.

On October 7 last year, Abrar, a second-year student of electrical and electronics engineering department at Buet, was beaten to death by a group of BCL men at the university's Sher-e-Bangla Hall in Dhaka.

Speakers tell discussion

Speakers at a discussion yesterday said the Citizenship Amendment Act in India must be an internal matter of the country, and the Indian government should promise CAA would not affect Bangladesh.

People in Bangladesh become concerned when many Indian ruling party leaders say people who are living there illegally would be sent here, although the issue is still a sub-judice matter, they claimed.

They were speaking at a discussion on Bangladesh-India relationship, at Cirdap auditorium in the capital.

Delivering a keynote paper, advocate Abu Hena Razzaki, chief executive of Bangla Foundation, said the Indian government has not yet formally made any statement that CAA would not affect Bangladesh, though Indian foreign secretary Harsh Vardhan Shringla assured it to Prime Minister Sheikh Hasina during a recent visit.

"No doubt CAA is an internal issue of India, but I condemn the disorder what have been witnessed in the country in last few months" he said. Citing the rise in deaths of Bangladeshis near Indian

borders, he said the Indian Border Security Force (BSF) should play a responsible role to stop extra-judicial killings on the borders.

He also condemned the violation of human rights in India centring the Kashmir issue.

Bimal Sankar Nanda, a professor at University of Calcutta in India, said India always hails development activities in Bangladesh, as those would also benefit India. The Indian government wouldn't take any initiative that

could hamper the development of Bangladesh. However, national security would be the first priority of India. Chairing the discussion, Abul Quasem Fazlul Haque,

a professor at Dhaka University, stressed on boosting bilateral ties between the two neighbouring countries.

Dr Namrata Kothari, a teacher at South Calcutta Girls College; Shahab Enam Khan, a professor at Jahangirnagar University; and journalist Keramot Ullah Biplob spoke at the discussion, among others.

missing for three days He's accused in Digital

Security Act case filed by MP Shikhor

Journalist Shafiqul Islam Kajol, an accused in a case alongside 31 others under Digital Security Act has been missing since Tuesday afternoon. His family filed a general diary with Chawkbazar Police Station in this regard yesterday.

"We could not establish any contact with him, as his phone was found switched off till now," his son Monorom Polok told The Daily Star last night. "We want his safe return," he appealed.

Kajol, the editor of Pokkhokal magazine, worked as a photojournalist including the daily Samakal and Bonik Barta, his colleagues said.

He was accused alongside editor-in-chief of Bangla daily Manabzamin and 31 others in a case filed on Monday by Awami League lawmaker Saifuzzaman Shikhor, with Sher-e-Bangla Nagar Police Station.

'Freeze 91 accounts of Enamul, Rupon'

Dhaka court orders authorities

A Dhaka court yesterday ordered to freeze 91 bank accounts of former Awami League leader Enamul Haque Enu and his brother Rupon Bhuiyan in two money laundering cases filed with Gandaria and Wari police stations.

Judge KM Emrul Kayesh of the Senior Special Judge's Court of Dhaka passed the order after two CID inspectors submitted two separate petitions for freezing the accounts in which Tk 19 crore was deposited.

CID Inspector Sadeque Ali submitted a petition for freezing the accounts of Enamul and CID Inspector Mehedi Maksud submitted another for freezing Rupon's accounts. The cases were filed on September 25 last year.

The same court yesterday rejected their bail petitions in two other corruption cases for illegally acquiring Tk 21 crore and Tk 14 crore -- respectively by Enamul and Rupon -- widely known as "Casino Brothers"

Enamul is former vice-president of Gandaria unit Awami League while Rupon is its former joint general secretary.

The Anti-Corruption Commission filed the corruption cases against the two brothers with its Integrated District Office-1 of Dhaka on October 23 last year.

On January 13, they were arrested in Dhaka's Keraniganj along with one of their accomplices Sheikh Sunny Mostofa. Sunny, who was also arrested on charges of giving to the brothers at his house in South Keraniganj.

Enamul and Rupon went into hiding after law enforcers launched a crackdown on illegal casinos, bars and spas in September last year.

Wanderers Club, of which Enamul was the director, was first raided by Rab on September 18.

On February 25, a Rab team launched a drive at their house on Wari's Lalmohon Saha Street and recovered Tk 26.55 crore in cash and FDR worth Tk 5.15 crore.

They also recovered around one kg of gold, 9,300 USD, 174 Malaysian ringgit, 5,350 Indian rupees, 1,195 Chinese yuan, 11,560 Thai baht, 100 UAE dirhams and some gambling chips from the flat.

Rab suspected that the money was collected from their illegal casino business. Enamul and Rupon were the directors of a casino at the Wanderer's Club in Motijheel.

Welfare Minister Zahid Malique disclosed the information at a press conference at the ministry yesterday. "Around 3.40 crore


children aged between nine months and 10 years will be given vaccination in two phases," he said.

Students up to grade-IV or equivalent classes of around 1.73 lakh schools will be brought under the campaign from March 18 to March 24.

The remaining children will get this vaccine at some 2.44 lakh permanent and makeshift vaccination centres, said the health minister.

All children will be brought under the campaign, Zahid Maleque

The minister said the number of people infected with measles-rubella rose to 27.1 in 10 lakh people in 2019.
