# ICU, HDU shut down at pvt hospital in Ctg

The Intensive Care Unit (ICU) and High Dependency Unit (HDU) of a private hospital in the port city has been closed down, after a patient died from pneumonia there three days back, said police and hospital authorities.

Doctors and nurses who attended the patient were asked to be home quarantined as precautionary measure after the incident.

The incident took place on Friday at Royal Hospital Private Ltd in port city's GEC area, but the incident came to light after police visited the hospital on Sunday night.

The deceased, Bibi Morium (34), was admitted at the hospital with breathing difficulties on Mach 19, said hospital

Chairman of the hospital Dr Farid Ahmed told The Daily Star, "The woman had breathing problems and cough, and she was undergoing treatment at the ICU of the hospital.

"According to lab reports, she died from severe pneumonia. We've sent doctors and nurses who attended her at ICU on leave for home quarantine, and closed the ICU for 30 hours," said Dr Farid Ahmed.

Matiur Rahman, executive director of the hospital, told this newspaper, "As precautionary steps, we shut the ICU and

HDU of the hospital after her death." "After the incident, doctors and nurses were panicked, and demanded Personal Protection Equipment (PPE) to continue work at the hospital, but we are struggling

to provide them the equipment," he added. Hospital and police sources said the woman was a resident of Korbaniganj area under Kotwali Police Station, and her symptoms were similar to that of novel coronavirus. However, she could not undergo any Covid-19 detection test.

After the death, intelligence personnel, Special Branch (SB) of Chattogram Metropolitan Police (CMP) visited the hospital and talked to doctors and officials on Sunday night.

Ansar Ali, husband of Bibi Morium, told The Daily Star, "My wife had been suffering from breathing difficulties and cough for a long time. When I rushed her to the hospital, doctors at first refused to admit her over coronavirus threat.'

## SCC disinfecting city to fight coronavirus outbreak

To fight the outbreak of coronavirus, Sylhet City Corporation (SCC) started a special drive to keep the city disinfected by spraying and spreading bleaching powder mixed liquid.

The drive started on Saturday evening and has continued every day and night since, to cover all areas as soon as possible.

Dr Md Jahidul Islam, chief health officer of SCC, said, "We are using calcium hypochlorite, which is commonly called bleaching powder, with a ratio of 10gm in per litre of water.

"At bazaars of the city, we are spreading a thick liquid that contains more bleaching powder and also spreading powder directly," he said.

He said, "In shopping malls, we are spraying the liquid with handheld sprayer and finally for roads, footpaths and roadside walls we are using our spraying vehicles for the cleaning liquid." Starting the drive at Sylhet railway station

and bus terminal area at Kadamtali on Saturday morning, the corporation sprayed disinfectant at all bazaars and several shopping malls. Major roads of Chowhatta, Kumarpara, Nayasarak, Kazitula, Barutkhana, Naiorpul and Zindabazar areas were already covered on Sunday, the SCC official said.

In daytime, we are not being able to spray disinfectant in roads and footpaths, so we're conducting the drive after 11pm in the night, Dr Jahidul said.

Contacted, Prof Dr Ashraful Alam, head of the department of chemistry at Shahjalal University of Science and Technology in Sylhet, said, "Bleaching powder is the most convenient and effective method of disinfecting. The corporation is doing a very good job."

"The liquid can also be stored at all public places for people to use, and the cost of making the liquid is very affordable for all," he said.

SCC Chief Health Officer Dr Jahidul said, "We are already planning to set several wash blocks in different parts of the city and we will consider the suggestion of keeping liquid disinfectant in the wash blocks."

"Until the virus outbreak passes, the drive will continue by rotation and we also need help from the citizens to raise awareness," he said.

A woman was burnt allegedly by her husband in Mymensingh on Sunday.

Police said Shirina Akter (22), mother of a one-year-old son, was initially taken to Mymensingh Medical College

Shirina lived with her husband Sohel Mia, two stepchildren and the man's first wife in Pungai village under Tarakanda upazila, said the law enforcers.

Sohel, a day labourer and son of Suruj Mia from Pungai, married Shirina, daughter of Siraj Ali of the same village, four years ago, Tarakanda Police Station Md Abul Khayer quoted the family and locals as saying.

There has been a dispute between Sohel and Shirina over dowry since their marriage, said the OC.

In the afternoon on the day, Sohel beat her indiscriminately as she refused to bring money from her father, said the police officer, adding that, at one stage, he burnt her pouring kerosene on her.

Hearing her screams, neighbours rushed to the spot and took her to MMCH. Shirina sustained more than 70 percent burns, the police officer quoted MMCH doctors as

# Bangladesh may see more floods

water and sanitation for potentially billions of people".

"Collaboration on informationsharing has long provided an important anchor for broader collaboration on transboundary issues -- as for example between Bangladesh and India on flooding -- and climate change is likely to increase the imperative for this," the report read.

The report said intense monsoon in August 2017 affected 40 million people in Bangladesh, India and Nepal, claiming nearly 1,300 lives and putting 1.1 million people in relief

"Floods could cost South Asia as much as \$215 billion each year by 2030. Floods are also expected to contaminate water sources, destroy water points and sanitation facilities, and therefore pose a challenge to universal access to sustainable water and sanitation services," it observed.

"The frequency of floods has as late in the year," Brac University Prof Emeritus Ainun Nishat told The Daily Star yesterday, adding that India and Bangladesh have been sharing data on water levels of rivers, including flood forecasting.

Climate change and increasing demand for water will stress the region's groundwater resources, as the availability of surface water is affected by increasing climate variability. Groundwater use in the region could increase by 30 percent by 2050, the report said.

Increased concentration pollutants when conditions are drier is of concern for groundwater sources that are already of low quality in certain locations in India and Bangladesh, it added.

Bangladesh's irrigation and water supply to major cities are heavily dependent on groundwater but the groundwater is not replenished in a proper way, Nishat said.

"Groundwater is depleting and affect the availability, quality and increased over time. The report said Bangladesh "medium performs low' implementing the Integrated Water Resources Management (IWRM).

"Our integrated water policy is basically geared towards supporting agriculture. We do not have any specific water plan for fisheries, environment and many other sectors. The situation is very poor in ecosystem management," Nishat said.

The current national development plan recognises that Bangladesh cannot undertake meaningful water resource development programmes on its own and aims to strike new transboundary agreements, the report added.

"So far, however, a water-sharing agreement is in place for only one of its 57 transboundary rivers - the Ganges -- with India," it said.

### A noble change in dire times

Chief Executive Officer Sheikh Moshfikur Rahaman of Greater Unity for Reality told The Daily Star, "We decided to stop the gathering of customers at our café as a precaution against the coronavirus outbreak. "Observing that masks are being

sold in the market for Tk 20 to Tk 30, and people, including doctors, are not getting enough masks, we started making the product here from March Three professional tailors along

with 30 volunteers are currently working in three shifts from 9:00am to 11:00pm for making the protective gear, said Moshfikur. 'We pay the tailors Tk 2.50 for every mask. At present, we can make a mask

by spending Tk 6.50," he said, adding that till Monday they have produced more than 3,000 masks. "We do not need profit. But our

production cost is increasing as we are not getting raw materials like elastic in Bagerhat and have to collect those "Even if the production cost rises

and we incur loss, we will supply masks for a price below Tk 10." In 2016, they started the cooperative society, which also owns an agro farm and currently has more

"Any organisation can collect 500 masks and an individual can obtain only five from us at a time," he said, adding that the district administration, police, government hospitals, political parties and voluntary organisations nave brought masks from them.

However, the organisation is now shifting their production from masks to protective gowns, as they feel most institutions in Bagerhat have acquired sufficient masks.

"We have already made two gowns and hope to make more," Sheikh Mosfikur told The Daily Star on Monday.

The cooperative is also creating awareness about the virus in the rural and urban areas by making public announcements using loudspeakers,

SM Forruk Hasan Jewel, an advisor of Greater Unity for Reality, claimed that the price of masks in Bagerhat has come down since their organisation started making and selling the product for a price below Tk 10.

"When these organisations come forward, unscrupulous businessmen become alert," he said.

"If a small organisation like us can influence a decrease in price [of

shortage of essentials easily," he said. When asked about Greater Unity for Reality's surgical masks, the civil surgeon of Bagerhat Dr KM Humayun Kobir told The Daily Star the products

are of the same quality like those

supplied by the government. We told our doctors four or five days ago to buy masks from the market. They told me that masks are difficult to find in the market and those available are Tk 70-80 per piece. Now the price has decreased to Tk 15-

20 per piece," he said. Commending the initiative taken by Greater Unity for Reality, he said the organisation also took a gown sample from them.

"We can comment about the quality of their gown once we receive one," he added.
