Sajida, Renata team up to fight Covid-19

Sajida Foundation and Renata Ltd, formerly Pfizer Ltd, have teamed up to tackle the Covid-19 pandemic, said a press release.

They will work in collaboration with Directorate General of Health Services.

Sajida has already reached 5,16,534 people through its different initiatives.

The foundation turned its Narayanganj hospital into an isolation unit and prepared an ICU to treat Covid-19 patients, one of the first hospitals from the private sector to do so.

With support from Renata, it has already distributed about 9,000 sets of personal protective equipment.

Till date, Sajida has distributed food and hygiene packages to more than 10,000 people belonging to poor urban households and slums, the press release further said.

Sajida is aggressively engaged in educating communities about Covid-19.

It has also installed more than 400 locally designed hand-washing stations, and another 800 stations will be established in the weeks to come.

Sajida and Renata will marshal all their resources to fight this pandemic, aiming to reach a million people in the upcoming months.

3 killed in road crashes

Even amidst the coronavirus-induced lockdown, three people were killed in separate road accidents over the last two days, report our correspondents.

In Dinajpur, biker Harunur Rashid (45) was killed after his motorbike collided with another one in Nawabganj upazila yesterday morning, upazila police said.

Police said Harunur was going to Bhaduria Bazar in the upazila.

On the other hand, at least two people were killed and four others injured in road accidents in Dashmina and Galachipa upazilas of Patuakhali on Monday.

In Dashmina, rickshaw-van puller Rafiqul Islam (30) died after losing control and hitting a tree at Lakshipur while on his way to Dashmina town with two passengers.

The collision occurred around 7am and injured all three. Locals rushed them to Dashmina Upazila Health Complex where doctors referred Rafiqul to Barishal Sher-E-Bangla Medical College Hospital. He died around 11:45pm.

In Galachipa, Nesar Uddin Hawlader (45) died in a tragic mishap at Badnati ferry ghat area yesterday.

The accident occurred while Nesar was loading watermelons on a truck parked at the ghat. At one point, truck driver Raju started driving in back gear, not noticing Nesar, and crushing him under the wheels.

Md Monirul Islam, OC of Galachipa Police Station, said they arrested driver Raju.

Tabligh Jamaat asks followers to return home

Dr Hasan Shahriar Kabir, Chattogram divisional director of Directorate General of Health Services (DGHS), told The Daily Star it is now just matter of time to open an ICU in CGH. "Initially, it was decided that five ventilators will be given to CGH, but we requested the ministry to double the number, considering the importance of the hospital for treating Covid-19 patients," he said.

Jail official held with 522 yaba pills

An assistant chief of Cumilla Central Jail security was arrested over possession of yaba pills on Monday afternoon.

The arrestee is Tarikul Islam (45) of Chattogram's Sitakunda upazila.

Cumilla Central Jail Superintendent Shahjahan Ahmed claimed, "On information, we searched Tarikul and seized 106 pills from his pocket. Following that, another 416 pills were seized from under his bed. We found a total of 522 pills." Shahjahan said Tarikul was handed over to police after a case was filed in this connection.

Md Billal Hossain, inspector of investigation at Kotwali Police Station, confirmed the matter. He said a case was filed on Monday evening against the jail official for illegally possessing the yaba tablets.

Dr Shamim Jahan, deputy country director for Save the Children in Bangladesh, said at present it is difficult for Bangladesh to meet the expected surge in demand for ventilators to help respond to the coronavirus outbreak.

"We are in this together; no single country can confront Covid-19 alone. It is therefore essential that world leaders -- in particular the G20 countries -- commit to a coordinated global plan underpinned by debt relief," she said.

UNDP ROLLS OUT \$1.5M FOOD SUPPORT

The United Nations Development Programme (UNDP), with support from the UK Department for International Development (DFID) and Bangladesh government, is rolling out US\$1.5 million emergency food support for 50,000 extremely urban poor families, to help alleviate the hardships and potential impacts of coronavirus.

This initiative was taken under UNDP's Livelihoods Improvement of Urban Poor Communities Project (LIUPCP) -- a joint project being implemented by the Local Government Division of Bangladesh, DFID and UNDP with an aim to reduce urban poverty, said a statement yesterday.

Judith Herbertson, DFID Bangladesh country representative, said the livelihoods of a large number of urban poor have been severely disrupted due to the shutdown and the loss of income. The project is responding to the situation in a number of ways including providing hand-washing facilities and cash grants.

Additionally, the DFID has provided UK£3 million to UNDP to reach at least 2.16 million people in urban slums across 20 city corporations and municipalities, with awareness-raising information and hand-washing facilities.

"What we are trying to do under this initiative, is to make things easier for the people to follow the public order -- which is to stay home and prevent the virus from spreading and therefore this partnership will deliver food at the doorsteps of the poor households," said Sudipto Mukerjee, resident representative of UNDP Bangladesh.

Over 5,000 prisoners

Mridha's lawyer Advocate Khandker Mahub Hossain told this correspondent that there are more than 5,000 prisoners in the jails across the country who have been convicted and sentenced to life imprisonment in different cases.

But, they do not know how long they will have to serve in jails, although life sentence refers to 30 years' prison term as per law, he said.

Even, the jail authorities are confused over this issue, as the SC has not yet delivered its verdict on the review petition, the lawyer said, adding that a convict, who is sentenced to life imprisonment by a court, is supposed to serve in jail for 22 years after the remission from 30 years' as per the law.

They will have to wait to know the duration of their sentence until the SC deliver its verdict on the review petition regarding the meaning and tenure of a

convict's life imprisonment, the jurist said.

Contacted, Inspector General of Prisons Brig Gen AKM Mustafa Kamal Pasha told The Daily Star that a prisoner, who is sentenced to life imprisonment, usually has to serve in jail for 20 years after the relevant remissions from 30 years' term.

Replying to a question, he said he is not aware of the SC decision about the tenure of life imprisonment.

During the proceedings of the review petition of Mridha, the SC bench headed by Chief Justice Mahmud Hossain heard expert opinions from four amicus curiae (friends of court) -- Advocate AF Hasan Ariff, Barrister Rakanuddin Mahmud, Advocate Abdur Rezak Khan and Advocate AM Aminuddin -- on the issue.

Advocate Khandker Mahub Hossain and Advocate Shishir Manir appeared for the petitioner while Attorney General Mahubey Alam argued for the state.

The political alliance said the number of cases were gradually growing in Bangladesh, creating panic among people.

Acute food crisis hits village

Some 30 other families in the area are facing similar food crisis as the families are under self-isolation, with no support from the government, said Ing Chong Mro, karbari (head of the area) of Kapru Para.

During the outbreak of a contagious disease, many communities in the hills build makeshift gates with bamboos called Khasur at the entrances of their villages as part of their traditions, Ing said, adding no one is allowed to cross

this gate until the dust settles.

The food crisis is quite similar in many areas of Lama, Thanchi, Alikadom, Ruma and Rowangchhari as the authorities claimed they could not reach out to the people living in these areas due to the remoteness.

"We have not received any relief till now while villagers do not go outside as we have locked our Para with Khasur", said Long Toi Mro, karbari of Champa Jiri Mro Para.

Thowai Ching, headman of Thanchi's Sekdu mouza (a mouza is comprised of several hilly areas), said hundreds of families in his mouza was suffering from acute food shortage.

The most affected areas of the mouza are Thong Nung Khumi Para, Soti Chandra Tripura Para, Jonirang Para, and Hasturang Para, said the headman.

Indigenous people in remote Tindu, Remakri, Boro Madok and Choto

Madok of Thanchi upazila also alleged that no one, including the government officials, visited the areas after the shutdown was imposed.

People living in these areas do not fall under the purview of government's development programmes while non-government organisations find it difficult to reach there due to the lack of transportation facilities, locals claimed.

Contacted, Shamim Hossain, additional deputy commissioner (general) of Bandarban, said, "We, along with Bandarban Hill District Council, have already distributed 347 tonnes of rice for around 30,000 families in the district following the shutdown was announced."

"It is really difficult for us to reach the people living in the remote areas, but we are planning to help them", said the ADC.

Last week, Afghan officials said they would release 100 Taliban prisoners who were sick or over the age of 50.

In exchange, the Taliban were expected to free 20 members of the Afghan security forces. Ultimately both sides would aim to release the 6,000 prisoners they are holding.

US Secretary of State Mike Pompeo welcomed the arrival in Kabul of

the Taliban team as good news.

Despite the coronavirus pandemic, Pompeo last month travelled to Kabul and the Qatari capital of Doha in a bid to nudge the prisoner process forward.

Afghan government officials have said the Taliban were demanding the release of senior commanders involved in some of the most violent attacks in recent years.

INDIRA SENDS MESSAGE TO BHUTTO
The Prime Minister of India Indira Gandhi has sent a message to President Zulfikar Ali Bhutto of Pakistan, expressing India's readiness to start direct talks with Pakistan with the aim of ensuring a long-term and stable peace in the subcontinent. The message proposes to hold talks without any preliminary conditions. Meanwhile, a government spokesman of Pakistan stresses that Pakistan's attitude is favourable to the proposal of holding a summit meeting to settle disputes between the two countries.

3 SEPARATE SERVICE HEADQUARTERS

Bangladesh government today announces that the combined command of the Bangladesh Forces has been abolished and replaced by three separate service headquarters, each under a chief of staff. The decision is part of an announcement appointing chiefs of staff for the three services following the resignation of General MA Osmany yesterday.

Private univs seek review

On Monday, the UGC in a statement said, "Several universities have taken the decision to assign students' grades without holding semester finals or evaluations, and to enrol new students without admission tests. This is unethical."

It also said that some universities were trying to take online tests and some of them also started enrolling students for the summer semester during this crisis in the country.

Independent University Bangladesh (IUB) is one of the universities that decided to assign grades among students for the outgoing spring semester without holding semester finals and to enrol students without any admission tests and instead based only on their SSC and HSC results.

Brig Gen (Retd) Anwarul Islam, registrar at IUB, said that this matter has created much confusion among the managements of private universities.

"We expected some sort directive from the private university division [of the UGC], but it came from the media and the PR department of the UGC", he said.

He said that a semester closes with awarding grades among students. It is difficult to prepare for the next semester without completing the previous one.

He said that IUB authorities have asked all course instructors to assign grades based on the available semester assessments -- the midterm, quizzes, presentations and assignments.

Students who would like to improve the assigned results are requested to contact their respective course faculty members for additional assignments; the nature of the assignment is at the discretion of the faculty member, said Anwarul.

"No students would be seriously affected. We have kept a mechanism to address the genuine concerns of the students. We were just two weeks from closing the semester," he added.

"Regarding grading, we have informed our students that we will notify them only after getting a proper guideline from the UGC. We will also wait for the instructions from the UGC regarding admission test,"

he added.

Anwarul said that most of universities do not take admission tests at all, adding, "We usually take admission tests. As we are not able to take exams, we come up with our own criteria that does not violate the criteria set up by the authorities."

The minimum requirement set by the UGC for admission to a private university is GPA 2.5, in both the SSC or HSC, or a total of 6 grade points.

United International University (UIU) has taken the step to enrol students based on SSC and HSC results.

UIU Vice Chancellor Prof Chowdhury Mofizur Rahman said they usually take admission tests. But due to special circumstances this time, they decided not to.

"If you say that it is unethical to take students based on SSC and HSC results, then I will ask what the need of SSC and HSC exams is," he said.

He, however, said that honouring the UGC, they will not go ahead with the decision now.

"I believe the association [APUB] would talk to them [UGC] and raise the issue to review the directives," he added.

"We can sit with them after our office opens," UGC Chairman Prof Kazi Shahidullah said.

He said that many private university authorities have communicated with the commission and assured that they will abide by the UGC decisions.

"They can complete classes online, but they have to take exams only after normalcy returns. Students should not think about exams in this dangerous situation. Also, not all students have internet connections." "You cannot take online exams, as there are issues regarding cheating, unfair means and transparency of the exams."

There is no scope for giving grades without semester finals.... If the situation worsens, we will think about assigning grades based on midterms and assignments," he said.
