50 lakh poor households to get cash | A vintage year for potato farmers aid through MFS from May 14

QR-based smart cards will be issued within Ramadan for distributing food aid

The government's move to provide cash assistance to 50 lakh poor families hit by the coronavirus pandemic is finally taking off, with the four major mobile financial service providers set to deliver it from May 14.

The disbursement will be kicked off by Prime Minister Sheikh Hasina, who will hand over Tk 2,500 each to ten families, said Md. Shah Kamal, senior secretary of the ministry of disaster management and relief.

The MFS operators will have to send the Tk 2,500 with the cash-out charge to each family and for disbursement purpose, the government will bear only Tk 15 (0.6 per cent) for each disbursement, said Tanvir A Mishuk, managing director of Nagad, a joint venture of the postal division and a private firm that will disburse the highest amount of Tk 425 crore.

"As our cash-out charge is 1.45 per cent, we will send an additional Tk 36.25 with the government fund of Tk 2,500 to each family. And we will get Tk 15 from the government for that."

The other operators will also get Tk 15 from the government but since their cash-out charge is higher they will have to send that full cash-out value to the beneficiary families, he added.

Market leader bKash will disburse Tk 375 crore, Rocket Tk 250 crore and SureCash Tk 200 crore. In another move, the government

has also planned to give food aid to the poor and low-income families who are battling food insecurity and hunger.

food Before the assistance disbursement begins, the government will complete the distribution of Quick Response (QR) code-based card.

Only the cardholders will get food support from the government, which will eliminate corruption in the process, said NM Zeaul Alam, senior secretary at the Information and Communication Technology (ICT) Division under the Ministry of Posts,

Telecommunications and Information

With the view to plugging the loopholes in the current distribution system, the ICT and Disaster Management and Relief ministries have created a database of poor households

The database initially has 50 lakh entries but once it is fully up and running there would be 1.20 crore beneficiary families, said officials at the two ministries.

The database and the issuance of smart cards will help remove duplication, eliminate ghost lists and reduce corruption related to the government's safety net programs, Alam said.

The initiative comes at a time when the countrywide shutdown, enforced to fend off the coronavirus

outbreak, has forced tens of thousands

of people to remain half-fed or unfed and government officials are frequently seizing subsidised rice, meant for distribution among poor and low-income people, from the illegal possession of a section of local government representatives and

members of the ruling Awami League.
The government had a plan to develop a database and issue smart cards earlier but the coronavirus outbreak has precipitated the process, Alam said.

"We expect that the database will be ready within Ramadan," he said.

The database contains the National Identity (NID) number of recipients, their mobile phone numbers, address, the person's age and the number of family members such that all duplications and other irregularities can be avoided, according to officials.

"If any beneficiary does not have the numbers, we will definitely include them. But our target will be to incorporate as much information as possible," Alam said.

The NID and mobile phone number are the two main tools to identifying a

NAGAD STANDS BY PM IN FIGHT **AGAINST COVID-19**

Nagad yesterday donated Tk 60 lakh to the Prime Minister's relief and welfare fund in a ceremony held at her office to fight the ongoing coronavirus pandemic.

Ahmad Kaikaus, principal secretary to the Prime Minister, received Nagad's donation cheque in her presence.

Potato growers are making profits this year on the back of reduced yield, higher demand and increased exports, said farmers and cold storage

Farmers are selling the biggest vegetable crop at Tk 15-17.5 per kilogram, higher than Tk 11.25-15 a year ago, as many farmers who grew other vegetables are incurring losses owing to the supply chain disruption between producing regions and cities resulting from the ongoing shutdown.

However, the lockdown aimed at battling the coronavirus pandemic did not hurt northwestern district Joypurhat's potato grower Muzharul Islam and tens of thousands of others.

They completed harvesting before the shutdown was enforced on March 8 and stored a part of the tuber traditionally in their home yards and the rest in cold storage to release the crop slowly into the market before the next crop arrives by the end of the year. "This has been a very good year for

us. We have got attractive prices," said Islam over the phone on May 5.

He planted potato on more than three acres of land and bagged more than 80 maunds of the tuber on each

He sold the vegetable at Tk 10-Tk 10.25 a kg in March, the first month after the harvest.

The prices were 38 per cent higher than the production cost of Tk 7.4 per kg estimated by the Department of Agricultural Marketing (DAM) in a study in February 2017.

Some 275km southeast from Joypurhat, farmers in the main potatoproducing district Munshiganj, are also content for the higher prices. Mohammad Monir Hawlader is

one of them. The farmer at Tongibari in the district sold potato at Tk 650-Tk 700 per maund at farm gates. One maund equals 37.32 kg.

Farmers in the northern districts planted potato on less area, he said.

Originally a foreign crop, the potato was assumed to be brought by Portuguese navigators in the 17th century to the subcontinent and initially, it was cultivated in areas around Calcutta, according to Banglapedia.

in Bangladesh and acreage crossed two lakh hectares in 1999 and three lakh hectares in the next six years, thanks to growing popularity of the vegetable, according to data from the farmers following the traditional

Food and Agriculture Organization. Today, Bangladesh is the six largest producer of the tuber. In fiscal 2018-19, 96.55 lakh tonnes were grown, time, prices may increase by Tk 4-Tk 5 which is nearly double the production

Its cultivation expanded gradually per kg in the retail markets in Dhaka city yesterday, up 31 per cent from a year ago, data from the Trading Corporation of Bangladesh showed.

The root vegetable stored by methods are now being sold in the market and cold storages would begin releasing the tuber after May. By that

from a decade earlier, showed Bangladesh Bureau of Statistics.

Farmers grew potato on 4.64 lakh hectares in the current fiscal year, down 1 per cent from the previous years, the Department of Agricultural Extension (DAE) said.

The total yield would fall to nearly 90 lakh tonnes this year because of the reduced acreage, said Mosharraf Hossain, president of the Bangladesh Cold Storage Association (BCSA).

"Demand for potato has increased as it is given along with rice as food relief to the poor and vulnerable people. Prices also went up in March amid stockpiling by consumers after coronavirus cases were first reported in the country," he said, adding that prices rose to Tk 21 a kg at farmers' end at that time.

Cold storages could manage to store 60 per cent of their combined capacity of 55 lakh tonnes until early this week and couldn't use the full facility because of a lack of availability of workers owing to the shutdown, he

Cold storages stored potato up to 95 per cent of their total capacities last

Potato exports stood 42,000 tonnes until April, exceeding last year's total shipment of 35,000 tonnes, said Md Azahar Ali, director of the plant quarantine wing of the DAE.

Including export and industrial processing, Bangladesh's demand for the tuber was estimated at 72-77 lakh tonnes by the DAM in its study.

Yields would increase if they get quality seeds, said Islam, the grower in Joypurhat.

BB eases rules to fast-track lending to large industries, service sector

The Bangladesh Bank yesterday eased the rules of the stimulus package worth Tk 30,000 crore for the large industries and service sector with a view to helping borrowers get loans quickly.

Now, borrowers will not need credit rating for their companies to qualify for loans as stated earlier in the guidelines of the BB.

The change came as many clients have failed to secure credit ratings from agencies due to the ongoing shutdown. This has created a roadblock for them in availing loans

The BB has asked lenders to analyse the credit risk of each borrower following their respective policy before taking decision on lending. And banks will have to select clients on bank-customer

relationship. The BB on April 12 formed the package to be provided in the form of refinancing scheme. Under the scheme, lenders will get funds from the BB as working capital at 4 per cent interest and give out the loans

Banks will have to provide at least 50 per cent of each loan from their own sources to enjoy the refinance scheme. They

will be allowed to get an interest subsidy of 4.50 per cent.
