Atiq to take office as **DNCC** mayor today

His DSCC counterpart Sheikh Fazle Noor Taposh will take helm on Saturday

Dhaka North City Corporation Mayor Atiqul Islam takes charge of office today while his counterpart for south city corporation Sheikh Fazle Noor Taposh will assume office on May 16.

Though the newly-elected mayors and councillors of DNCC and DSCC took oath for office on February 26, they had to wait until completion of the tenures of incumbent mayors.

Both the city corporations will not organise any programme marking the occasion, due to the ongoing shutdown for coronavirus, said officials. Five-year tenure of the incumbent public representatives of DNCC expires today while that of DSCC on May 16.

Mohammad Zamal Mostafa, panel mayor of DNCC, said he will hand over his mayorship to the elected mayor this afternoon.

Tariq Shikder, media coordinator of the newly-elected DSCC mayor, said the mayorship will be handed over on May 16 as the first board meeting of incumbent Mayor Sayeed Khokon was held on that day five vears back


He said after assuming office, the new mayor will hold a board meeting along with newly-elected councillors soon.

Elections to the DNCC and DSCC were held on February 1.

As the newly-elected mayors had to wait for more than three months to take over duties, senior most panel mayor of DNCC had to perform

Ward-4 Councillor Mohammad Zamal Mostafa took charge as the senior most councillor of the current three-member mayor panel. Atiqul resigned from his mayoral post on December 30, 2019 to take part in the

In DSCC, current Mayor Sayeed Khokon is discharging duties till completion of his five-year tenure. "My tenure will end on May 16 as per the first board meeting; until then, I will continue to discharge my duties as mayor," Khokon said last month.

Bangabazar market, two fashion outlets shuttered in capital

Police yesterday shut down the Bangabazar market and two fashion outlets in the capital for flouting health safety directives to prevent transmission of coronavirus.

Bangabazar in Gulistan was closed around noon, HM Azimul Haque, additional deputy commissioner (Ramna Zone) of Dhaka Metropolitan Police, told The Daily Star.

"The space inside the market is too narrow and congested that it was not ideal to open shops at this time. Besides, no health measures were taken inside it," the

Earlier in the morning, police shut down two shops of local fashion brands Aranya and VIVE in Dhanmondi, said Abdullahil Kafi, ADC of Dhanmondi Zone.

He said they did not build any tunnels or spray gates in the shops. Besides, arrangement of hand sanitizer did not seem to be enough

They can open the outlets after ensuring health measures, the police official further

The government decided to reopen shopping malls, all types of shops and other businesses from May 10 on a limited scale ahead of Eid-ul-Fitr. Those would remain open from 10am to 4pm every day,

Take steps to prevent dolphin killing in Halda: HC to govt

The High Court yesterday directed the authorities concerned of the government to immediately take necessary steps to prevent the killing of dolphins in Halda river in Chattogram.

It also asked the director of Department of Environment in Chattogram to submit a report to this court through email within 72 hours, detailing which measures have been taken to prevent killing of dolphins in Halda river and ensure their protection.

The High Court bench of Justice Obaidul Hassan came up with the order and rule after holding a virtual hearing on a writ petition filed by Supreme Court lawyer Barrister Abdul Qaium Litan seeking necessary directives to protect the dolphins and environment.

Barrister Abdul himself argued for the petition while Attorney General Mahbubey Alarm, Additional Attorney General Murad Reza, Deputy Attorney General Samarendranath Bishwas and Deputy Attorney General Amit Talukder

Chattogram, and Upazila Nirbahi Officer represented the state during the virtual

This is for the first time in the history of Bangladesh that the High Court heard a writ petition through digital means.

During the court proceedings, Justice Obaidul Hassan extended thanks to President Md Abdul Hamid, Prime Minister Sheikh Hasina, Chief Justice Syed Mahmud Hossain and Law Minister Anisul Huq for launching virtual court functions for hearing and disposing of cases using technology.

Virtual court functions are the first step in establishing e-judiciary in the country, the HC judge observed.

The extent of losses could not be assessed immediately, he added.

'How will we pay full fees amid this crisis?'

Private univ students demand waiver on tuition

A large group of private university students are demanding remission of tuition fees for the next semester, as their guardians are financially struggling due to the ongoing coronavirus crisis.

They are also saying activities of next semester should be delayed until the pandemic ends and everything returns to Most private university students come

from middle and lower-middle-class families, which are struggling with money. Burdening them with payment of tuition fees will add more stress to an already stressful situation, they said. "How will our parents pay fees when

their earning sources have disappeared? Only government workers are getting salaries; the rest are either not getting wages or receiving reduced salaries," said Anny Sen, an organiser of Besarkari Biswabidyalaya Chhatra Oikya.

The alliance is campaigning for the remission online. They have sent a charter of demands to the prime minister, education minister and University Grants Commission (UGC) via email.

Bangladesh Students Union (BSU) and other organisations held a human chain maintaining social distance in the capital on May 9, for remission of tuition fees for at least one upcoming semester.

Polash Datta, project lead of independent research organisation Dataful, said in a study, they found 84 per cent private university students said the pandemic has impacted their family income.

Furthermore, 43 per cent of students want the next semester to be delayed by one to six months.

The study was done on 317 students of 24 private universities via online between April 24 to May 3.

Private University Students Unity (PUSU) and Facebook group-based platform Private University Students Alliance of Bangladesh (PUSAB), both demanded remission of tuition fees.

Nishat Sunny, an organiser of PUSU, said it is too early to enrol students for the

332 foreigners leave Dhaka, 138 Bangladeshis come back home

A total of 332 Indian and Pakistani citizens stranded in Bangladesh left Dhaka for their respective countries by two separate special flights of Air India and Pakistan International Airlines (PIA) yesterday.

Of the total, 176 were Indians and 156 Pakistanis, SM Wahidur Rahman, deputy director of Hazrat Shahjalal International Airport (HSIA), told The Daily Star.

Meanwhile, 138 Bangladeshis stranded in India and Pakistan, returned home yesterday by two special flights of Biman and PIA, sources at HSIA and Biman said.

Of the Bangladeshi returnees, 80 returned from Mumbai, India, by a Biman flight which landed at HSIA at 6pm, said Tahera Khandaker, deputy general manager (public relations) of Biman.

Carrying 50 Bangladeshis, the PIA flight landed at Dhaka airport at 12:59pm, Wahidur said.

Wait for justice not over yet

Yesterday was the fifth death anniversary of blogger and science writer Ananta Bijoy Das, who was hacked to death in broad daylight in Sylhet by a group of masked assailants in 2015.

Five years into the murder, family members and friends are still awaiting Ananta, an advocate for secularism and science, became the third victim

in a spate of attacks against free-thinkers by militant groups in 2015, following science writer Avijit Roy and Oyasiqur Rahman. Ananta's brother Ratneswar Das filed a case with Airport Police Station accusing four unidentified miscreants and mentioned that Ananta was

murdered by militants in a planned way. After two years, on May 9 of 2017, CID pressed charges against six persons in a revised charge-sheet. The accused are Shafiur Rahman Farabi, Mannan Yahya alias Mannan Rahi, Abul Khaer Rashid Ahmed, Abul Hossain alias Abul Hussain, Harunur Rashid, and Faisal Ahmed.

Mannan Rahi and Abul Khaer were university students in Sylhet. Mannan confessed before a court on September 2, 2015 that he along with Khaer and two others hacked Ananta with a machete for his write-ups on "promoting freethinking".

Abul Hossain, Faisal Ahmed and Harunur Rashid are on the run. Mannan died at Dhaka jail on November 2, 2017.

The trial of the case started on May 7 last year at Sylhet Additional Metropolitan Magistrate Court. Later it was transferred to the Special
