#### Atiqul takes charge as DNCC mayor

Dhaka North City Corporation (DNCC) mayor Atiqul Islam yesterday said they will start a massive drive from Saturday to destroy Aedes larvae and breeding grounds.

Addressing at an online press conference after taking charge as mayor, he said their mobile courts are also conducting drives at residences and underconstruction buildings since May 10.

Atiqul said they have introduced free dengue testing facilities from May 11 at five maternity clinics and 22 health centres in DNCC. Regarding coronavirus, he said they would facilitate eight sample collection booths with help of Brac, set up at eight DNCC community centres.

They have already handed over Mohakhali kitchen market building to DGHS to turn it to a coronavirus treatment hospital and isolation centre, he said.

About distribution of relief, the mayor said they are planning to introduce QR code system to monitor distribution properly. He said DNCC has distributed food assistance to 3 lakh families and will continue during this lockdown.

"I will host Facebook live once a month to know about problems of residents and will try to solve it," the mayor said.

## Brac to set up 100 walkin kiosks across country

Brac is going to set up 100 walk-in kiosks across 19 risky regions of the country, to expedite the government's initiative of scaling up testing capacity for the novel coronavirus.

Of these, at least 50 will be installed in Dhaka by next week, while fifty more kiosks will be set up across the country soon, the world's top NGO said in a statement yesterday.

Initially, Brac installed kiosks at Bangabandhu Sheikh Mujib Medical University and Shaheed Suhrawardy Medical College Hospital on a pilot basis. Later, more kiosks were set up at Sheikh Fazilatunnesa Mujib Memorial KPJ Specialized Hospital & Nursing College, and in Narayanganj, in line with the directive from the Directorate General of Health Services (DGHS).

"We have also identified several spots to install kiosks in consultation with two Dhaka city mayors," said Morseda Chowdhury, associate director

of Brac's Health, Nutrition and Population Programme in a statement. As of May 11, she said, 17 kiosks have been installed at 14 spots in Dhaka as per DGHS directive, and work on installing more booths is in progress.

"Brac is yet to receive any new funds in this regard. However, the organisation is diverting some of its funds from the Department for International Development (DFID) of the UK government to continue its proceedings," Chowdhury said.

While kiosks set up at hospitals will be operated by respective hospital staff, two trained medical technologists from Brac will collect samples at the kiosks set up elsewhere from suspected Covid-19 patients from 9am to noon Saturday through Thursday.

Once collected, the samples will be sent to testing facilities designated by DGHS, and patients will be informed results via text messages.

# Stymied by the traffic shutdown

Over 3 lakh people working at automobile workshops struggling to make ends meet

No cacophony of metals clinking, no yelling of experts to apprentice mechanics, only skeletons of under-repair vehicles parked by the roadside testifies that there used to be automobile workshops on Motiheel's Culvert Road. These days, an eerie silence pervades the area.

Ever since the government's stayhome order, the scenario of Culvert Road's workshop hub has changed immensely, along with the fate of motor mechanics who worked there.

These workers -- who help keep the wheels of the transport sector moving -- are now struggling to take care of their families.

According Bangladesh Workshop Malik Automobile Samity (BAWMS), about three lakh people living on automobile workshop earnings are facing hardship during the shutdown.

Not only them, the backward pinch of the economic debilitation

caused by the novel coronavirus.

According to Bangladesh Bureau of Statistics (BBS), vehicles and parts worth around Tk 1,147 crore were imported only in January this year, from which the government earned a huge revenue.

The government also collects a lot of revenue from automobile workshops. However, when traders and workers find themselves in trouble, the government is nowhere to be seen, union leaders alleged. "We pay tax and VAT worth

nearly Tk 1,000 crore to the government each year. But during this time of crisis, they're indifferent to our plight," said BAWMS Secretary General Jahangir Alam. The organisation represents 20,000 workshops around the country.

In Jashore municipality, several hundred automobile workshop workers demonstrated for relief in the last week of April, sources said.

Most motor mechanics get paid linkage industries that gear the on a weekly basis. As the closure transport sector are also feeling the has prolonged, they have already finished their meager savings, said

Shahin Kabir, general secretary of BAWMS Jashore unit. The unit has nearly 1,000 registered workshops where over 3,000 people work.

Shahin said he sought help district administration, municipality and three large private transport manufacturers on the last week of April.

Unable to pay salaries, workshop owners have turned to banks, but to no avail. "Banks have denied giving us loans," Jahangir said. "We need the money to pay our staff and keep the industry alive.

### HC rejects Sangram editor's bail plea

The High Court yesterday refused to grant bail to Abul Asad, editor of Bangla daily Sangram, in a case filed under Digital Security Act on charges of "circulating provocative report and sedition".

The bench of Justice Jahangir Hossain Selim passed the order following a virtual hearing on a bail petition by Asad. It said lawyers for the accused may place the petition before it after regular functions of the court resume.

Asad is now in Kashimpur jail. A Dhaka court sent him to jail on December 14, said his lawyer Shishir Manir.

During the hearing, Attorney General Mahbubey Alam vehemently opposed the bail petition, saying that the accused has committed a serious offence by terming convicted war criminal Abdul Quader Molla a martyr in his newspaper.

Asad's lawyer Advocate Khandker Mahbub Hossain prayed to the HC to grant his client bail, saying that he is 80 and suffering in jail for five months with asthma and

Afzal Hossain, a freedom fighter, filed the case with Hatirjheel Police Station. Police detained Asad on December 13 after mob vandalised the daily's office, over publishing a report that termed Quader Molla a "martyr".

Molla, former assistant secretary general of Jamaat and known infamously as "The butcher of Mirpur" during the Liberation War, was hanged in 2013 after being convicted in a case for committing crimes against humanity during the war by the Supreme Court on September 17 that year.

# Drive resumes as Aedes larvae found in 5 spots

An entomological survey team supporting Sylhet City Corporation's (SCC) antimosquito drive found Aedes larvae at five locations of two wards in the city, as the drive resumed after being disrupted by the coronavirus pandemic.

After surveying seven wards, the team found traces in wards 25 and 26 -- mostly in stagnant water, inside tyres and sanitary materials kept in stores, said Dr Md Jahidul Islam, chief health officer of SCC.

SCC started the drive on February 23. As the mosquito menace was escalating, the corporation resumed the drive from Saturday and initiated entomological surveying.

"The survey was carried out with help from the civil surgeon's office. After finding traces of Aedes, we have taken initiatives to destroy them and ordered store owners to be vigilant," Dr Jahidul said.

The SCC health official said, "In June, we

will conduct another entomological survey covering all city wards and will also try to survey door-to-door."

He claims there is no shortage of larvicide and adulticide.

Many residents are complaining about mosquitoes. When asked why there are mosquitoes everywhere despite spraying and fogging, Dr Jahidul said, "Most city canals and drains are clogged, and so, they become mosquito breeding zones. No matter how much we spray and fog, mosquitoes will remain until these are

On March 11, a massive cleaning drive under "Clean Village, Clean City" project was initiated by the corporation but was halted due to the countrywide shutdown.

SCC Mayor Ariful Haque Chowdhury said, "As we resumed the anti-mosquito drive and have already sprayed larvicide and adulticide in six wards, I am hopeful that we will be able to control the mosquito menace and prevent any possible dengue outbreak."

# Stipends for 1.37cr pry students restart today

Distribution of stipends for some 1.37 crore primary level students resume today, with the beneficiaries set to get the money of October to November

The stipend was halted for over seven months as Primary Education Stipend Project (PESP) did not get extension on the time due to the coronavirus crisis. On May 4, Prime Minister Sheikh Hasina approved the project extension, officials said.

"We have deposited the money to bank on Tuesday and it would be disbursed to the all beneficiaries on Thursday," Yusuf Ali, project director of PESP's third phase, told The Daily Star yesterday.

Project officials send the money to students' mothers through mobile banking services. They disburse the money four times a year -- in April,

Students will get the stipend today for October instalment, Yusuf said. Yusuf said for October instalment each student fulfilling required criteria got Tk 100 per month, as a single beneficiary of a family. Similarly, two children from the same family received Tk 200 per month, whereas in case of three and four children, the stipend was Tk 250 and Tk 300 per

He said they will disburse instalments of January and April before Eid. He said after PM's approval, from January instalment, the amount of stipend will increase by 50 percent, and each primary student will receive a yearly amount of Tk 1,000 for buying school supplies.

From January instalment each student will receive Tk 150. Two children from the same family will get Tk 300, and three and four children will receive Tk 400 and Tk 500, respectively.
