Burnt unit had no fire safety

yesterday inspected 11 fire extinguishers used in dousing the flames and found that eight of them passed their expiry

"The partitions and rooftops were all made of flammable substances," said Mayor Atiqul. "The hospital authorities should have thought about fire risks when constructing this extension."

He added, "They should have sought

the expertise of the fire department before building this annexe.

The mayor also said a team trained to fight fire at United Hospital was hesitant to enter the annexe as it was an isolation unit for coronavirus suspects. While the mayor thanked United

Hospital for taking in coronavirus suspects, he said that all makeshift coronavirus hospitals must be made keeping fire safety measures in place. The government will have to take action against them if the investigation

concludes that negligence happened. It is the reality," the mayor said. The Building Construction Act provides for a punishment of seven years' imprisonment or a fine of Tk 50,000 or both in case of violation of the Bangladesh National Building Code and

Building Construction Rules of 2006. Meanwhile, a witness said there was inadequate fire-fighting measures inside the hospital.

Andre Dominic Paul's father Vernon Anthony Paul, 75, was one of the patients who perished in the inferno. Andre watched the fire happen from beginning till the end. He was waiting outside the isolation

unit around 9:40pm hoping to see a doctor when he heard a commotion; but he saw the door fling open and doctors and nurses file out.

The air-conditioner in the doctor's room sparked, spitting flames everywhere. "The sparks fell on the floor and a ward staffer rushed in with a wet

mop probably had disinfectant on it, so the fire spread in a split second from the floor to a bed with paper files on it," he said. The ward staffer threw the mop away and ran out.

They had no fire extinguishers inside the coronavirus unit, and they had to bring in fire extinguishers from the main building, which took some time, allowing the fire to spread. The fire hydrant was also in the main building and the hosepipe was too short to reach the flames because the isolation unit was further away," he narrated.

United Hospital authorities said the fire spread quickly, "as it was windy".

Meanwhile, fire service officials said oxygen cylinders inside the isolation units exploded and fed into the fire. "Some of the patients died of

asphyxiation and the others died by burning. They were all found lying in their beds," stated Abul Kalam Azad, senior station officer at Baridhara fire station.

"The fire service arrived at 10:04pm and by that time explosions could be heard. There was no scope of saving the patients.

The victims were Vernon Anthony Paul; Riyajul Alam, 45; Khodeja Begum, 70; Md Monir Hossain, 75; and Md Mahabub, 50. Of them, Vernon Paul and Khodeja Begum's blood samples came out negative for coronavirus and they were meant to be moved to the normal sections of the hospital, had the tragedy not occurred.

"My mother was brought here the day before Eid with asthma. She had a coronavirus test 15 days ago, but the result came out negative. But because the test was taken 15 days ago, the hospital suggested she be kept at the isolation unit," said Khodeja's son Mohammad Alamgir.

They got a second test done two days ago at Dhaka Medical College Hospital, and the results came negative yesterday.

"The patients inside were all bed-ridden and therefore they could not escape. The doctors, nurses and staff could," said Dr Shagufa Anwar, chief of communication and business development at the hospital, addressing journalists yesterday afternoon.

The government has formed a fourmember panel headed by Debasish Bardhan to investigate the incident.

United Hospital too is doing its own investigation and submitting a report on Sunday, said Dr Anwar. "We have formed an internal committee of 12 people, with personnel from security, human resources department and clinical management."

The hospital also filed a case with the Gulshan Police Station, reporting 'unnatural deaths".

"This is just a temporary establishment. I am not aware whether we needed to get a fire safety clearance for this emergency structure," said Maj Mohammed Moinul Hossain, manager of administration and security at United Hospitals Ltd, when asked why they did not get a fire safety clearance from the department concerned.

He could not state for sure how many fire extinguishers were inside the isolation unit.

"There were fire extinguishers in the area adjacent to the isolation unit, which is about 20 or 25 metres away. We also had a fire hydrant in the main building, but the fire hydrant can only reach a certain extent, following which we need the help of professional fire fighters," he said. "Besides, the fire got too big to handle in a very short amount

The two Exim Bank high-ups told Sikder Group officials there that the value of the property was lower than what the Group's MD had claimed. The Group officials then requested the two to visit another property at Purbachal.

The Exim Bank officials initially refused to visit the Group's property at Purbachal saying they had a meeting with Bangladesh Bank officials.

But the two finally agreed following request from Ron Haque. They saw the property at Purbachal from outside and refused to enter the site, saying they were running late for the meeting with BB officials, according to the case statement.

The two eventually entered the site upon Ron Haque's request. They, however, turned their car back towards the capital as they could not see the cars of Ron Haque and others.

On their way back to the city, they stopped their car on the 300-foot road, seeing the vehicles of Ron Haque and others, including NBL high-ups.

Ron Haque forced the two Exim Bank officials to apologise. At one stage, he fired from his pistol in an attempt to kill Exim Bank MD Haider. The bullet flew past Haider's left ear, said the statement. As Ron Haque was about to fire at

Baset strongly protested the filing of the "baseless" case and said his client firmly believes that there will be an impartial investigation and that the culprits will face legal action.

EXIM BANK'S STATEMENT On behalf of Exim Bank, Supreme Court lawyer Mia Mohammad Kawsar Alam in a statement yesterday said the complainant didn't raise any

allegations against the NBL. He said the plaintiff of the case rejected the NBL statement, which was "false", "imaginary" and "unacceptable". It was aimed at diverting the issue.

Matters such as a director of Exim Bank taking a loan from the NBL or a director's daughter seeking a loan from the NBL were irrelevant and had nothing to do with the case, Kawsar

It is surprising that a bank issued such a statement, citing irrelevant matters, he added.

He further said the NBL denied the fact that Ron Haque sought a loan. Sikder Group is a long-term borrower of Exim Bank and the incident took place over collateral for a Tk 500-crore

The lawyer also refuted the allegation that the complainant had filed the case to malign the NBL and its board of directors.

IMPACT ON BANKS Directors of two banks -- the NBL and the EXIM Bank -- had earlier taken loans from each other's banks, which led to conflict between them, said officials of the BB and commercial

The Association of Bankers, Bangladesh, a forum of managing directors of banks, on Wednesday considered writing to the BB to take steps to prevent recurrence of such unpleasant incident, the MD of a bank told this newspaper, seeking anonymity.

The ABB usually takes measures when any MD of a bank faces difficulties from delinquent borrowers or groups. But the organisation is now silent because of business-related conflicts between the directors of the two groups," said the MD.

Talking to this newspaper, Syed Mahbubur Rahman, the managing director of Mutual Trust Bank, said the latest incident, reported by the media, was completely unexpected.

This may have an adverse impact on banks as some foreign counterpart banks are asking what is happening in the country's banking sector, he said.

"We all should perform our duties responsibly in the interest of the banking sector or else both local and foreign entities will lose confidence in the country's banks," said Mahbubur.

Flash flood lashes Sylhet's Gowainghat

Flash floods triggered by heavy rains since Monday has inundated Gowainghat upazila of Sylhet, while overflowing water of the Sari river submerged vast area in the upazila.

The flash floods flooded hundreds of houses and disconnected road communications in the region, said Nazmus Sakib, upazila nirbahi officer in Gowainghat.

He also said that at least hundred trees and several houses were damaged due to nor'westers on Tuesday night.

Shahiduzzaman Sarkar, executive engineer of Water Development Board (WDB) in Sylhet, said the Sari river was flowing 48 centimetres above danger level at 3:00pm on Wednesday. The situation, however, started

water in the river was flowing 55 centimetres below the danger level at 9:00am yesterday. He further said that no embankment or dam of the river was

improving, he said, adding that the

damaged due to the flash flood. Meanwhile, Sultan Ali, agriculture officer in the upazila, said at least 15 hectares of Aush seedbed that was under risk were safe as the water

started receding. Abul Kalam Azad, district fisheries officer of Sylhet, said several fisheries were flooded in the upazila and

Sagar Sheikh from Golakhali village in Koyra said, "We have no way to survive. We have no accommodation and food. Nobody helped us."

He has decided to take shelter at his elative's house in a nearby village. Sources said about two lakh people n the area have been badly affected by the cyclone. The local administration has so far distributed 50 tonnes of rice, 500 packets of dry food and Tk

75 lakh among the cyclone victims in the upazila. Harshit Mandal, a local, also used to live near the Harinkhola

embankment. Asked if he received any relief, he said, "Only providing relief would not solve our problems as we don't have a place to live. We urge the government to repair the embankment as soon as possible."

The entire area would become uninhabitable if the embankment was not repaired, Harshit said, adding that the locals were already suffering from different waterborne diseases.

Dr Sujat Ahmed, civil Surgeon of Khulna, said huge quantities of saline water entered the area during the cyclone which was causing the

diseases. "People will face a crisis of drinking water due to salinity which would worsen the situation," he said.

The civil surgeon expressed concern that the salinity might cause health hazards in the area for a long time. Khulna Livestock Officer Kazi Mostahim Billah said about 60 percent

of the district's livestock was affected

by the cyclone. Around 40,000 cattle have been shifted to another upazila. Koyra UNO Shimul Kumar Saha said he visited the affected areas. "I have informed the higher authorities

about the prevailing situation there."

Trump planning new arms sale to Saudi Arabia, says

President Donald Trump's administration wants to sell arms to Saudi Arabia again, one year after pushing through a controversial \$8.1 billion contract despite congressional opposition, an influential US senator revealed on Wednesday.

"The administration is currently trying to sell thousands more precision-guided bombs to the President's 'friend,' Saudi Crown Prince Mohammed bin Salman, New Jersey Democrat Bob Menendez said in an op-ed published online by

The government wants to conclude the sale, the details of which have not yet been made public, "even though the Saudis seemingly want out of their failed and brutal war in Yemen," he

Menendez, the top Democrat on the Senate Foreign Relations Committee, recalled how the previous contract to sell various arms to Saudi Arabia as well as the United Arab Emirates was blocked by Congress after the murder of Saudi journalist Jamal Khashoggi.
