Consultancy deal for MRT-5 to be signed today

The third metro rail project of the country is being prepared for its physical work to begin from 2023, as the authority is set to sign a contract with a consortium of agencies, both foreign and Bangladeshi, today for general consultancy services.

Under the contract, the consortium, led by famous Japanese firm Nippon Koei, will prepare detailed designs, tender documents to procure a contractor and supervise the construction works of the Dhaka Mass Rapid Transit Development Project (Line-5: Northern Route), officials said.

The contract, which would be around Tk 1,123 crore without VAT, is scheduled to be signed at 11:00am today virtually due to this prevailing situation, Project Director Aftab Hossain Khan said. "This is major progress for the project," he told The Daily Star on Monday.

The MRT-5 (northern route), from Savar's Hemayetpur to Bhatara via Gabtoli, Mirpur and Gulshan, would be implemented at an estimated cost of Tk 41,239 crore.

The 20km line with 14 stations will consist of underground and elevated sections. The project commits to a 2028 deadline. This would be the first eastwest MRT corridor in Bangladesh.

The physical works of MRT-6, country's first metro rail project, from Uttara third phase to Motijheel, is going on, while the construction of MRT-1, which would be the country's first underground metro rail, from Airport road to Kamalapur, is expected to begin in December this year.

The government will construct six metro rails in the capital and its adjacent areas to ease traffic congestion and reduce environmental pollution. The six lines will create a 128.74km metro rail network, which will have

104 stations -- 53 underground and 51 elevated, according to Dhaka Mass Transit Company Limited, the agency implementing the project.

Aftab Hossain said the consortium comprises seven companies from Japan, France, India and Bangladesh. Most of these companies are involved in another consortium, which is giving general consultancy services for the MRT-6 project, he said.

Once the contract is signed, they would start preparing a detailed design for the project. "As air communication remains suspended, they would start the paperwork and will come to Bangladesh once airlines resume operation," he

In the meantime, they would start the process of acquiring land and procuring a contractor, he said, adding, We are hopeful about starting the physical work of the project in 2023 and complete it by 2028," he said

He further said that 13.5 kilometers of the line would be underground and 6.50 would be elevated. The design of MRT-1, which will also have an elevated portion from Natun Bazar to Purbachal, is almost complete. "Such structure is new in Bangladesh. However, designing [MRT-1] will help us," he added.

The Executive Committee of the

National Economic Council (Ecnec) in October last year approved the projects.

Aftab said that once they start land acquisition, they would require a huge amount of money. But they are going to get around Tk 700 crore from Annual Development Programme for the next fiscal year, which is less than half their demand, he added.

A total of Tk 2,000 crore would be needed for land acquisition and would start it once the consultants mobilised their workforce, some of which may face delay due to the pandemic situation.

Bangladesh's GDP

8.15 percent logged in the last fiscal

The GDP growth would be 1 percent in the next fiscal year, again lower the 2.9 percent earlier projected.

The International Monetary Fund said Bangladesh's economy would grow by 3.8 percent in FY20 and the Centre for Policy Dialogue said on Sunday that the growth would be at best 2.5 percent.

Talking to The Daily Star yesterday, Finance Minister Mustafa Kamal, however, said that the growth would be between 5.2 to 5.5 per cent this fiscal year given that the economy only began to feel the impact of the coronavirus pandemic in April, the 10th month of the fiscal year.

Bangladesh's growth prospect would be higher than the South Asian average of a negative 2.7 percent, according to the WB projection.

India's growth would further fall to a negative 3.2 percent this fiscal year and rebound to 3.1 percent next fiscal

For Pakistan, the economy would contract by 2.6 percent this fiscal year and 0.2 percent next fiscal year.

Nepal would expand by 1.8 percent this year and 2.1 percent next fiscal year and Bhutan would grow by 1.5 percent this year and 1.8 percent next year.

Sri Lanka would see a contraction

would contract by 13 per cent and Afghanistan by 5.5 per cent.

Bangladesh's economy is also vulnerable to supply chain disruptions, both domestic and those stemming from imports of intermediate goods, as well as travel-related disruptions to international contractors in sectors like construction, the WB said in the

Spill-overs from major trading partners could be more severe than expected, the report said. Bangladesh's pharmaceuticals and textile sectors are reliant on countries abroad for

intermediate inputs. The WB said private consumption has been severely hindered as large-scale lockdowns were instituted in several economies, including Bangladesh,

The tax-free income threshold is likely to be Tk 3 lakh, up from Tk 2.5 lakh fixed back in fiscal 2015-16.

Besides, the income tax slabs may be rearranged as well. The rates of income tax now stand at 10 percent to 30 percent but it may be cut to 5 percent to 25 percent in the next fiscal year.

Apart from the individual taxpayers, the government is also considering reducing the corporate income by 2.5 percentage points to 32.5 percent for non-listed companies with the view to strengthening their capacity such that they bounce back as early as possible from the devastating effect of shutdown.

The government is eyeing to collect Tk 182,000 crore next fiscal from valueadded tax (VAT) and supplementary duty, up 6.29 percent from this fiscal

Cigarette, the biggest sources of VAT and supplementary duty, is expected to contribute more to state coffer with its increased rates. The supplementary duty on cars would be hiked by a staggering 40 to 70 percent.

The government is also likely to earn Tk 37,800 crore from import and export duties in fiscal 2020-21.

Finance ministry officials said there is a strong likelihood of raising the import duties on mobile phone and SIM cards.

To achieve a higher tax collection target to finance the budget, the government may also increase the excise duty on accounts with debit or credit balance upwards of Tk 5 crore at any time of the year by as much as 15 percent.

The government is hoping to collect Tk 3,600 crore in excise duty next fiscal, up 61 percent from this year's goal.

Nasim still in deep coma, not breathing on his own

The condition of former health minister Mohammed Nasim remained unchanged yesterday as he was still in deep coma.

Mohammed Nasim is totally unconscious. He is not breathing on his own," Prof Dr Kanak Kanti Barua, chief of the 13-member medical board formed to oversee Nasim's health, told The Daily Star last night.

Asked whether the 72-year-old Awami League lawmaker from Sirajganj-1 was clinically dead, he said they would have to carry out the "brain stem function" test to reach a decision in this regard. "Mohammed Nasim's heart is still

beating, but his blood pressure remains unstable," added Kanak, also the vice chancellor of Bangabandhu Sheikh Mujib Medical University. Nasim, a presidium member of the

AL, has been undergoing treatment at the city's Bangladesh Specialised Hospital since June 1. Later, he tested positive for Covid-19. He suffered a brain stroke on June 5.

The BSMMU VC said a healthy person usually takes 18 to 20 breaths per minute.

"But Mohammed Nasim is not taking a single breath on his own. We have put him on life support," he added.

Dr Raziul Haque, a neurosurgeon at Bangladesh Specialised Hospital, said they would take a decision on turning the life support offafter conducting the 'brain stem function" test.

"But before doing that, we will have to seek the consent of his family members," Raziul told this newspaper.

Nasim has been on life support since une 6 as his condition deteriorated.

His son Tanvir Shakil Joy, also a former AL MP, told media on June 5 that his father had undergone a successful surgery after suffering a stroke.
