Youth stabbed to death in Khulna

Assailant killed by mob OUR CORRESPONDENT, Khulna

A youth was stabbed to death by her neighbour outside his home in Bajua area of Khulna's Dacope upazila yesterday morning over "grazing the latter's cows" in the field of a local

Incensed at the attack, a mob of locals beat the attacker to death.

The dead are Nilotpal Roy, 27, and his attacker Imran Hossain Émon Sheikh, 19.

Shyamal Roy, principal of Bajua Surendranath Degree College, told The Daily Star that Nilotpal's father Sukumar Raptan, assistant librarian of the college, was given the responsibility to look after the educational institution as it was closed due to the Covid-19 pandemic.

On Monday afternoon, Emon's cows were grazing on the grass of a field of the college. Sukumar asked him to take his cattle away as they were dirtying the area. The two exchanged heated words.

Informed about the matter over the phone, the principal asked Sukumar to let Emon's father know about the incident.

Yesterday, Sukumar went to Emon's home around 8:30am to inform the latter's father about the

Angered at this, Emon rushed to Nilotpal's home nearby, called him out and stabbed him with a knife, leaving him dead on the spot, said the principal.

Nilotpal, a Master's in physics from Khulna Government BL College, was looking for a job while his attacker Emon was an HSC examinee from Bajua Surendranath Degree College.

Saifuddin Ahmed, on-duty doctor of Dacope upazila health complex, said Emon was brought dead to the health complex around 11:00am. He said there were stab wounds to Nilotpal's abdomen.

Dacope OC Shafiqul Islam Chowdhury said the two bodies were sent to the morgue of Khulna Medical College for autopsies.

Asymptomatic

"It goes against my impressions from the science so far that suggest asymptomatic people - who never get symptoms - and pre-symptomatic people are an important source of infection to others."

Officials at the WHO were not immediately available for comment on the subject yesterday. Van Kerkhove was due to answer questions at a social media session later yesterday.

Smeeth and other experts said understanding the risks of transmission among people with mild or no symptoms is crucial as governments begin to ease the lockdown measures they imposed to try and reduce the pandemic's spread and gradually replace them with case tracking and isolation plans.

"This has important implications for the track/trace/isolate measures being instituted in many countries," said Babak Javid, a Cambridge University Hospitals infectious diseases consultant.

Some experts say it is not uncommon for infected people to show no symptoms.

A non-peer-reviewed study from Germany in May based on 919 people in the district of Heinsberg which had among the highest death tolls in Germany - found that about one in five of those infected were symptomless.

But data is sparse on how likely such people are to transmit the disease.

The co-head of Singapore's coronavirus task force told Reuters on Monday there had been asymptomatic transmission cases there, between people living in close quarters.

China said last week that 300 symptomless Covid-19 carriers in its central city of Wuhan, the pandemic's epicentre, had not been found to be infectious.

Keith Neal, a professor of the epidemiology of infectious diseases at Britain's University of Nottingham, said that while the question of how big a role asymptomatic transmission plays in new infections is unclear, what is known is that people with symptoms are responsible for most of the spread of the disease.

Floyd laid to rest in his hometown

FROM PAGE 12 delivered an emotional eulogy at the funeral before Floyd was laid to rest next to his mother Larcenia Floyd.

Thousands of well-wishers filed past Floyd's coffin in a public viewing a day earlier as a court set bail at \$1 million for the white officer charged with his murder last month in Minneapolis.

Many made the sign of the cross as they approached the open casket to say a last goodbye, while others took a knee or bowed their heads in silent prayer for a man who has become emblematic of America's reckoning with racial injustice.

Derek Chauvin, the 44-year-old white officer who was filmed pressing his knee on the handcuffed Floyd's neck for nearly nine minutes, made his first court appearance on Monday.

The 19-year veteran, who appeared by videolink from prison, faces up to 40 years if convicted on charges of second-degree murder, third-degree murder and manslaughter.

Chauvin did not enter a plea and the Hennepin County District Court judge set his bail at \$1 million with conditions, or \$1.25 million without. The conditions would require him

to surrender his firearms, not work in law enforcement or security in any capacity, and have no contact with Floyd's family.

Three other policemen involved in Floyd's arrest appeared in court last

week to face a charge of aiding and abetting his murder.

Democrats unveiled a wide-ranging police reform bill, one of the chief demands of demonstrators who have taken to the streets for the past two weeks in the most sweeping US protests for racial justice since the 1968 assassination of Martin Luther King Jr.

The Justice in Policing Act, introduced in both chambers of Congress, would make it easier to prosecute officers for abuse, and rethink how they are recruited and trained.

"The protests we've seen in recent days are an expression of rage and one of despair," House Democrat Steny Hoyer said. "Today, Democrats in the House and Senate are saying: 'We see you, we hear you, we are acting."

It is unclear what support the proposed reforms might find in the Republican-controlled Senate -- or whether President Donald Trump would sign such legislation into law, reports AFP.

Trump has adopted a tough approach to putting down the protests and he voiced his support for the police at a roundtable on law enforcement at the White House on Monday.

"There's a reason for less crime. It's because we have great law enforcement," he said. "There won't be defunding, there won't be dismantling of our police.'

Trump suggested yesterday that an elderly man seen bleeding from the head after he was pushed to the ground by US riot police was faking.

Less experienced drivers

Relaxing the experience requirement for licences for heavy vehicles was one of the major demands of transport workers when they enforced strikes in some districts in November last year, protesting the implementation of the Road Transport Act-2018.

Transport leaders said most of the bus and truck drivers were already driving vehicles with light or mediumsized vehicle driving licence.

In face of the demand of transport owners and workers' leaders, the government had in August 2018 relaxed the experience requirement for getting heavy and medium-sized vehicle driving licences. The relaxation of requirements in 2018 saw lightvehicle licence-holders needing just a year's extension to apply for mediumsized vehicle licences. Medium-size vehicle licence-holders, in turn, having already had a minimum of three years' experience driving light vehicles under the original rules, would be able to apply for a heavy vehicle after a years'

more experience. The government on several occasions extended the tenure of the relaxed requirements for up to six months. As per the latest extension order issued on November 27 last year, drivers could avail this opportunity until June this vear.
