Nurul Amin passes away

Mohammad Nurul Amin Suruj, a freedom fighter, died from novel coronavirus

at the Combined Military Hospital in Dhaka on June 11. He was 68, says a press release.

He left behind his wife, four daughters and a host of relatives to mourn him.

Amin retired from Bangladesh Ansar and VDP after serving with reputation. He was admitted to the

CMH on June 1. He hailed from Mymensingh and was given a guard of honour on the Biseshwari Government Pilot High School premises in Ishwarganj of the district

Later, he was buried at Muktijoddha graveyard in Ishwarganj following a namaz-e-janaza. During his funeral, a small number of people were present who maintained physical

Another elephant found dead in Ctg

For the third consecutive day, an elephant has died in the country from human-made objects, as a juvenile elephant was found dead at a village in Banshkhali upazila

Locals spotted the decomposing body of the elephant calf after a foul smell gripped the village.

On information, forest officials rushed to the spot and recovered the carcass to conduct a postmortem, Sheik Anisuzzaman, range officer of Joldi area under Forest Department (wildlife and nature conservation), Chattogram circle, said.

The elephant is a juvenile, aged 16, the official added. Kopil Uddin, chairman of Boilchari union parishad, told The Daily Star that some people might have killed the

elephant and buried it to hide the incident. However, it was revealed when a layer of mud receded after yesterday's heavy downpour, stinking up the whole

Later, Abu Naser Md Yeasin Neyaz, divisional forest officer of Chattogram Forest Circle, said they have performed the autopsy but it will take time to prepare the

"I have seen metal wire fence around orange and papaya gardens near the spot of the incidence which could easily have been connected to power. I assume the elephant could have died of electrocution. Let's see what the postmortem report tells us," he added.

With this, three elephants have died in the country in the last three days.

One of them was killed from electrocution at Teknaf on Friday, and another was killed at Bandarban possibly from injuries sustained from barbed wire fences.

A hurried meeting concludes without budget placement

Dhaka University's annual senate session was held yesterday, despite the absence of multiple members, including two provice chancellors and the treasurer of the university.

Prof Shibli Rubayat Ul Islam, former dean of DU's Business Studies faculty and chairman of Bangladesh Security Exchange Commission has been nominated as syndicate member in educationist quota.

Alumnus Majnun Chunnu has been nominated in registered graduate category and former Bangla Academy Director General Shamshuzzaman Khan was nominated in eminent citizen category.

One of the primary and arguably the most important agenda of the meeting -- annual budget -- was not placed in the

The VC told this correspondent that the tenure of the current members would end on June 16, hence he convened the meeting

A pro-VC and deans of two faculties wrote to the VC stating their unwillingness to attend the session.

"Considering mine and my colleagues" health and safety, I did not attend. Also, the budget was not placed so I didn't have anything to contribute at the meeting," Prof ASM Maksud Kamal, dean of Earth and Environmental Sciences faculty, told The Daily Star.

Pro-VC (Academic) Prof Dr Nasreen Ahmad echoed him, saying she felt it was useless to attend a session where there wouldn't be any discussion.

"I've read in the papers that the VC convened the meeting because he wants his chosen few in the syndicate. Is our VC that 'insecure' that he needs his people to boost him up?" she questioned.

"What wrong will the VC commit that he needs 'his' people in the syndicate?" she added, "I believe, if one remains fair, abides by rules and maintains transparency, then they can work with anyone. [Then] there is nothing to fear," she added

Several senate members alleged that VC Prof Md Akhtaruzzaman called the senate session hurriedly to nominate Prof Shibli in the syndicate, which is the highest decision-making body in the university.

"The VC issued notice on May 13 about the meeting but the university has been closed since March 18, which contradicts the Article 21 of DU order 1973, which says the VC has to issue notice to all members at least 21 working days prior to the session,' alleged a member.

Another senate member questioned the legitimacy of Prof Shibli's nomination under educationist quota, as the latter does not have a PhD or international journal publications.

DU sources said, the university authorities are likely to hold another senate session on July 23 to finalise the budget.

Yesterday's meeting, attended by 63 members, also nominated Md Ataur Rahman Prodhan, CEO and managing director of Sonali Bank Limited, as a member of University finance committee.

Decision on closure of schools, colleges today

The government is going to extend the closure of all educational institutions in the country in a bid to curb further spread of Covid-19.

"We are extending the closure of all educational institutions, but we will take decision about the fixing the dates tomorrow [today]," primary and mass education secretary Akram-Al-Hossain told The Daily Star.

He said he had a discussion with top officials of the education ministry regarding the matter and both the ministries will extend the closure till same date.

Two high officials at the education ministry and primary and mass education ministry said they are likely to extend the closure of school and All educational institutions have been closed since March 17, and the

government has now extended the closure until June 15 to prevent further spread of coronavirus.

On April 27, Prime Minister Sheikh Hasina said all educational institutions may stay closed until September if the situation caused by the coronavirus outbreak does not improve. Educational activities of about four crore students are being hampered

due to coronavirus crisis. Holding of HSC exams have been deferred for

an indefinite period. First-term exams of primary schools and half yearly exams of secondary school have also been deferred for the crisis. The government started TV education through Sangsad TV for secondary students on March 29, for primary students on April 7, and for technical

and madrassa students on April 19, so that students can make up for some of the losses due to closure of schools. Many guardians said it was only partially fulfilling the objective, as about a half of the country's people -- many of them underprivileged -- do

ASK prepared the statistics based on media reports and information collected by the organisation.

The death of 55-year-old Shanu Hawlader in the custody of Amtali Police Station in Barguna and 40-yearold Yasmin Begum in the custody of detective branch of Gazipur police created sensation during the period examined.

ASK said many journalists among other professionals were harassed in this period. At least 127 incidents of harassment on journalists took place at this time. Of them, 20 were harassed by the law enforcement agencies and 14 received threats from the ruling party members or its affiliates. Apart from that, 49 journalists were sued for their published reports.

Besides, 244 women were raped, of whom 71 were gang-raped, and 24 were killed after rape. Six rape victims also died by suicide in the last five months.

At least 182 women faced domestic violence and of them 54 were tortured

to death by their husbands while 25 related incidents dropped by 82 have maintained their defense of these died by suicide, it said, adding that at least 62 women were harassed sexually.

119 EXTRA-JUDICIAL KILLINGS IN 5 MONTHS: GGS

Some 119 people have become victims of extra-judicial killings between January and May. Incidents of "gunfight" dropped by 36 percent since March 20, amid coronavirus outbreak, the report said.

Of the deaths, 108 died during "gunfights" between law enforcement agencies and criminals while 11 died during "gunfights" between two groups of criminals, it said. The report said 114 people sustained injury during gunfights while 18 were arrested by law enforcers. A total of 98 gunfights took place since January, it added.

CGS shared the report styled "Peacegraphics" in the form of an e-newsletter with the media yesterday. Bangladesh Peace Observatory, an initiative of CGS, prepared it based on news published in 18 national and local dailies.

According to the report, 20 deaths have been reported while 18 others were injured in incidents related to border issue until May 31. Also, 107 people were arrested while 53 borderrelated incidents took place. Border-

percent since March 20.

It said 19 incidents of violence against minorities took place between January and May. Also, 42 people sustained injury and five were arrested in connection with violence against minorities.

Since January, 52 Rohingya community people died, 59 were injured and 549 got arrested.

In mob violence between January and May, 22 people died and 89 were injured. A total of 66 such incidents took place while 103 were arrested.

Besides, 116 incidents of abduction

took place while 25 people died, 56

were injured and 127 got arrested by law enforcers. The report said the country saw a 10 percent rise in domestic violence since March 20, amid shutdown. Since January, a total of 194 domestic

violence incidents took place, resulting in 157 deaths, 64 injuries and 85 arrests. Besides, 558 incidents of violence against children were reported between January and May. The incidents saw 258 deaths, 257 sexual

and 339 arrests. The report also mentioned 389 incidents of sexual assault and 46 incidents of "violent extremism".


