patients. This was such a tragic incident.. Saiful filed a case with Khulna Sadar Police Station against four persons, including the patient's husband, Abdul Ali Sheikh. Despite repeated attempts, this

correspondent could not get in touch with him. Police on Tuesday night arrested one Abdur Rahim over the incident. He was later shown arrested in the case.

Aslam Bahar Bulbul, officer-in-charge of the police station, said they made the arrest after scrutinising the video footage.

"The accused confessed his involvement and said names of other persons as well," the OC added.

Many locals said the accused are highly influential in the area. "We are trying our best to arrest them," said the

Contacted, Dr Sheikh Baharul Alom, president of Bangladesh Medical Association in Khulna, said they have decided to close all the medical institutions except the emergency department at KMCH and ones for treating Covid-19 patients until the accused are arrested.

Meanwhile, a pall of gloom has descended in the area following the death of Dr Rakib.

His wife, two children, relatives, friends and well-wishers are saddened beyond consolation and have demanded that the authorities arrest the perpetrators immediately.

FROM PAGE 3 Central jail authorities, however, only informed the court yesterday that Kajol was vet to be brought from Jashore. The magistrate fixed June 23 for a hearing on the petition and directed jail authorities to bring Kajol then.

The case against Kajol was filed by Saifuzzaman Shikhor, a ruling party lawmaker from Magura-1, with Sher-E-Bangla Nagar Police Station in the capital on March 9.

Another case was filed with Kamrangir Char Police Station against Kajol under the same act. Fifty-three days into his disappearance, Kajol was found by Border Guard Bangladesh in Benapole on May 3. He was then arrested -- initially on charges of trespassing, but was granted bail being produced before a Jashore

Later in the evening, he was shown held under section 54 of the Code of Criminal Procedure (CrPC) after police informed the court that three more cases against Kajol were now pending with different police stations in the capital.

The court then sent him to Jashore jail.

DMP summons goes

during an investigation by police into a police crime was clearly against the country's conventional law and practice.

"There is no scope for enquiring sources of journalists under the country's law. Because protecting confidentiality of the source is recognised as part of the basic and sacred duty of a journalist," the statement said.

Moreover, the job of journalists is to break the barrier of secrecy and inform the public about true and objective information, it added.

The DUJ leaders demanded immediate withdrawal of such a "psychologically stressful" letter.

After the news appeared in the media, Md Imam Hossain, joint commissioner (logistics) of DMP, who allegedly offered bribes to DMP Commissioner Shafiqul Islam, was transferred to its Public Order Management Division on June 9.

The move came days after Shafiqul in a letter to the inspector general of police sought transfer of Imam, an additional deputy inspector general of police, on charges of offering bribes.

Terming the joint commissioner "a corrupt officer", the DMP commissioner in his letter said there were graft allegations against Imam over various purchases. Imam even offered the commissioner a percentage from procurements. And that is why he should not be working in the DMP, read the letter.

Shafiqul further requested the police chief to transfer Imam immediately and take necessary steps in this regard.

DUJ WORRIED OVER BAB'S DECISION In another statement issued yesterday, the DUJ expressed concern over the decision of Bangladesh Association of Banks (BAB) that it would not publicise advertisements in newspapers, online news agencies and

The DUJ said the decision to stop advertising in the media by banks is tantamount to obstructing the expansion of the media and hindering the freedom of expression.

It said advertisement is one of the main sources of income for the media outlets. During this difficult time of the Covid-19 pandemic, it will not be sensible for any organisation to stop advertising.

The top DUJ leaders said the role of the media in shaping the country

and the nation would be affected by this decision. Stopping advertising in the media by making an announcement is

tantamount to hostile treatment of the media, the statement said. The journalist leaders called upon the BAB to withdraw the announcement.

"I have asked the private organisation which is operating the dialysis service in our hospital based on MoU with the government to look into the issue and come up with a solution soon. I have also informed the health ministry and expect to get results soon," he said.

The heavy rain will continue for the next two-three days,


According to the forecast, all fishing boats and trawlers over the north Bay have been advised to come close to the coast and proceed with caution till further notice.

"We have finalised the draft and uploaded it on the EC website, seeking opinions from political parties and citizens. Let's see what kind of recommendations we get from them," EC Senior Secretary Md Alamgir told The

"Parties that seek registration must comply with the conditions set in the new law," he said.

The EC prepared the draft of "Registration of Political Parties Act-2020", repealing the chapter VIA of the Representation of the People Order-1972 that now deals with the process of registration of political parties.

EC Joint Secretary SM Asaduzzman said they decided to write the law in Bangla in place of the RPO's English to make it easy to read. He added that they uploaded the draft law to its website www.ecs.gov.bd -- seeking opinions from all via email to

secretary@ecs.gov.bd by July 7. The three conditions are: a party needs to secure at least one seat with its electoral symbol in two previous parliamentary elections.

Securing of five percent of total votes cast in the constituencies in which its candidates took part in any of he aforesaid parliamentary elections.

It needs to set up a functional central office, by whatever name it may be called with a central committee, having offices at least in one-third administrative districts, and offices at least in 100 upazilas or metropolitan thanas. And the party must have a minimum 200 voters as its members in each upazila.

Parties that want to be registered with the EC must meet at least two conditions out of the three.

According to RPO-1972, a political party can get registration by securing at least one seat with its electoral symbol in any parliamentary election held since the ndependence of Bangladesh.

It also says all political parties should fix the goal of reserving at least 33 percent of all committee positions for women, including the central committee, and successively achieving this goal by the year 2020.

The draft law mentions that all political parties should elect members of all committees, including the central one. The proposed law also retains some other provisions of

It prohibits the formation of any organisation or body as its affiliated or associated body consisting of teachers or students of any educational institution or employees or workers of any financial, commercial or industrial institution or establishment or the members of any other profession.

A political party shall not be qualified for registration, if the objectives laid down in its organisation charter are contrary to the country's constitution.

Any discrimination regarding religion, race, caste, language or sex is apparent in its charter by name, flag, symbol or any other activity, it threatens to destroy communal harmony or lead the country to cessation.

The party will not be qualified for registration if its constitution reflects the objectives of maintaining and nourishing party-less or one-party system and others. Registering political parties with the EC began after an amendment to the RPO-1972 in 2008.
