Hospitals defy govt warnings

Patients suffer as many hospitals send them away for failing to produce Covid test reports

For 50-year-old Md Mostafa and his wife, last weekend was nothing short of a nightmare. He shuttled from one hospital to another in the capital with his ailing wife Sathi Khanam, a kidney patient, only to be turned

Sathi used to get dialysis done at the Kidney Foundation Hospital in Mirpur-2. But the hospital denied her treatment when they went there on Friday. It asked for her Covid-19 test report as a precondition for getting

The couple rushed to Kurmitola General Hospital and then to Mugda General Hospital with the hope of either getting tested or treatment but

They then went to Dhaka Medical College Hospital where they were told that only the patients admitted there could have their tests done.

"I was in utter distress as I heard most of the private hospitals are not treating patients amid the crisis. Then I came to know about a clinic in Dhanmondi. I took her there and finally got her dialysis done," said Mostafa, who used to work at a launch on the Dhaka-Barishal route.

Infection control ignored

Most hospitals don't follow WHO guidelines amid lack of dedicated manpower

In the absence of people dedicated to prevent and control infections at hospitals, healthcare-associated infections are rising across the country, affecting the general populace and healthcare professionals alike.

Although the World Health Organization has a guideline for Infection Prevention and Control (IPC), only a handful of private hospitals follow it.

Many lives could have been saved during the Covid-19 pandemic if the IPC protocols

IPC is a scientific approach to prevent harm caused by infection to patients and healthcare workers, according to WHO.

It is crucial in infectious disease management at the facilities and implementing this would require employees, including doctors and nurses, dedicated to looking after the aspects of infection prevention from every angle.

3,412 more test positive for Covid-19; 43 die STAFF CORRESPONDENT

Bangladesh reported 43 Covid-19 deaths, 38 males and five females, in the past 24 hours till 2:30pm yesterday, raising the death toll to 1,545 in the country.

Besides, 3,412 people tested positive for coronavirus in those 24 hours, reported authorities. With the latest update, the total number of Covid-19 cases stood at

According to the Institute of Epidemiology, Disease Control, and Research (IEDCR) website, males constituted 77 percent deaths and 71 percent infections in the country.

More than 50 percent of the total

Experts ring alarm over cattle markets

Clerics call for tweak in Eid-ul-Azha traditions to avoid virus risks

The country may face an acceleration in the already growing number of Covid-19 cases if the government fails to ensure the maintenance of health guidelines in cattle markets across the country ahead of Eid-ul-Azha, public health experts warned.



Slaughtering animals in open

spaces during the festival may also increase the risk of infection, they said. Meanwhile, Islamic clerics have urged a change in festival traditions to help curb further spread of the virus.

Several scholars from the Islamic Foundation and National Mosque Baitul Mukarram opined that it would be better for people to avoid the traditional rituals over animal sacrifice due to the pandemic.

They suggested following the Saudi Arabian system, in which the government centrally arranges the animals and the slaughter on behalf of people who just deposit money in a bank to pay for the whole process.

Citing examples of different countries, including Pakistan, the clerics said the government may also set up slaughterhouses in each locality instead of allowing slaughter at individual homes to avoid the risk of spreading the deadly virus.

Mufti Mizanur Rahman, senior Imam of Baitul Mukarram, told The Daily Star that the government, if possible, could arrange a central system for animal sacrifice this year as individual arrangements can increase the risk of infection.

Mufti Waliur Rahman Khan, a scholar of the Islamic Foundation, told this correspondent, "From the point of Islam and Shariah, there is no bar for the government to arrange a central system for slaughtering animals."

Healthcare experts feared dire consequences if the government allows makeshift cattle markets to operate in Dhaka and other big cities.

- Opportunities to Buy and Sell Freely: By opening a 'securities account' in the system maintained by Bangladesh Bank through the treasury division of a bank/financial institution (FI), investors can purchase T-Bills/T-Bonds from the primary or secondary market. Afterward, T-Bills/T-Bonds can be freely sold to other investors in the secondary market at any time before
- Tax Rebate Facilities: At present, for resident investors, there is no source tax on the interest income on T-Bills/T-Bonds. Furthermore, similar to savings certificates, at present, individual investors are enjoying tax rebate facilities against investments in T-Bills/T-Bonds.
- 7. Investment Process for Non-Resident/Foreign Investors: Non-residents/foreigners can purchase T-Bonds. SAUDI MAKES HAIJ DECISION

No pilgrims from abroad allowed

Biman, hajj agencies face huge loss; pilgrims already registered to get their deposits refunded

Private hajj agencies and Biman are set to incur a huge financial loss as the Saudi government has decided not to allow anyone from abroad to perform hajj this year amid fears over coronavirus pandemic.

If the decision is implemented, around 1,400 members of Hajj Agencies Association of Bangladesh (Haab) will be deprived of around Tk 5,500 crore, and Biman Bangladesh Airlines Tk 800 crore, said officials concerned.

The Saudi government's decision not to allow people from other countries, including Bangladesh, to perform hajj came as a blow to the private hajj agencies as they will not be able to earn Tk 5,500 crore by sending pilgrims to Saudi Arabia, Haab President M Shahadat Hossain Taslim told The Daily Star yesterday.

He said around 1.30 lakh Bangladeshis attended hajj last year and only 7,000 of them were sent by the religious affairs ministry. "Around 1.23 lakh hajis performed hajj

through private agencies." This year, 1,37,198 Bangladeshis were scheduled to perform hajj, which is likely to be held on July 31,

Of them, 17,198 were scheduled to perform hajj under government management, and the rest under private management, said Taslim.
