Khairunnesa Afsar, a freedom fighter from Mymensingh, passed away from old-age complications at a Dhaka hospital yesterday. She was 97.

She was buried at her family graveyard in Bhaluka's Mamarishpur with state

honours yesterday, following a namaz-e-janaza at Bhaluka Degree College premises after Asr prayers.

Khairunnesa was one of the few female freedom fighters in Mymensingh, said Bimol Pal, a freedom fighter and researcher.

Khairunnesa, mother of Mymensingh-11 lawmaker Kazim Uddin Ahmed, left behind six children and a host of relatives and wellwishers to mourn her.

She was the wife of Maj Afsar Uddin, a sub-sector commander and chief of Afsar Bahini in Bhaluka and adjacent areas during the Liberation War.

Sust to withdraw DSA case against student

Shahjalal University of Science and Technology (Sust) authorities now want to withdraw a case they filed against a student under Digital Security Act.

Sust Registrar Mohd Ishfaqul Hussain, the case's plaintiff on behalf of the university, filed an application for the withdrawal to Jalalabad Police Station yesterday. Okil Uddin, officer-in-charge of the police station,

confirmed the matter to The Daily Star. "Although the case was filed here, we cannot withdraw it. We'll forward it to the court, which will decide about the withdrawal."

Earlier on June 15, the registrar filed the case, accusing Mahir Chowdhury, a final-year economics student, for allegedly posting derogatory remarks on Facebook about former health minister Mohammed Nasim, after his death. This correspondent could not get the registrar's

comments, as he did not receive phone calls.



Three persons were found dead along rail tracks in the capital's Kuril area since Wednesday evening.

One of the deceased was identified as Al Amin (16), a day labourer, according to police.

Aminul Islam, subinspector of Dhaka Railway Police Station, said Al Amin was crushed under an outbound train leaving Dhaka yesterday morning.

He died on the spot, Aminul added.

Meanwhile, the bodies of two unidentified persons, aged 20 and 40, were found in Kuril on Wednesday evening, said They may have been

hit by a train, and crushed them on the nearby rail

The bodies were sent to Dhaka Medical College morgue for autopsy yesterday.
