Khairunnesa Afsar no more

Khairunnesa Afsar, a freedom fighter from Mymensingh, passed away from old-age complications at a Dhaka hospital yesterday. She was 97.

She was buried at her family graveyard in Bhaluka's Mamarishpur with state honours yesterday, following a namaz-e-janaza at Bhaluka Degree College premises after Asr prayers.

Khairunnesa was one of the few female freedom fighters in Mymensingh, said Bimol Pal, a freedom fighter and researcher.

Khairunnesa, mother of Mymensingh-11 lawmaker Kazim Uddin Ahmed, left behind six children and a host of relatives and well-wishers to mourn her.

She was the wife of Maj Afsar Uddin, a sub-sector commander and chief of Afsar Bahini in Bhaluka and adjacent areas during the Liberation War.



Sust to withdraw DSA case against student

Shahjalal University of Science and Technology (Sust) authorities now want to withdraw a case they filed against a student under Digital Security Act.

Sust Registrar Mohd Ishfaque Hussain, the case's plaintiff on behalf of the university, filed an application for the withdrawal to Jalalabad Police Station yesterday.

Okil Uddin, officer-in-charge of the police station, confirmed the matter to The Daily Star. "Although the case was filed here, we cannot withdraw it. We'll forward it to the court, which will decide about the withdrawal."

Earlier on June 15, the registrar filed the case, accusing Mahir Chowdhury, a final-year economics student, for allegedly posting derogatory remarks on Facebook about former health minister Mohammed Nasim, after his death. This correspondent could not get the registrar's comments, as he did not receive phone calls.

Akram said all 65,620 government primary schools are offering one year pre-primary education. Some 34,799 government primary schools have separate classroom for pre-primary education, and there are assistant teachers at 37,672 government schools.

According to a unesco report in 2016, at least 52 percent of developed countries have three-year pre-primary education, and 33 percent countries have two-year pre-primary education, said primary and mass education ministry officials.

Officials say pre-primary education is really important, as it is during the first five years that around 90 percent of a child's brain development takes place.

Three people found dead on rail tracks in capital

Three persons were found dead along rail tracks in the capital's Kuril area since Wednesday evening.

One of the deceased was identified as Al Amin (16), a day labourer, according to police.

Aminul Islam, sub-inspector of Dhaka Railway Police Station, said Al Amin was crushed under an outbound train leaving Dhaka yesterday morning.

He died on the spot, Aminul added.

Meanwhile, the bodies of two unidentified persons, aged 20 and 40, were found in Kuril on Wednesday evening, said the SI.

They may have been hit by a train, and crushed them on the nearby rail tracks.

The bodies were sent to Dhaka Medical College morgue for autopsy yesterday.
