

A Supreme Court lawyer yesterday filed a writ petition with the High Court seeking its directive on the health secretary and director general of the Directorate General of Health Services to take necessary steps so that reports of Covid-19 tests are handed to patients quickly.

Advocate Moniruzzaman Lincon submitted it as public interest litigation through email to the HC, saying most Covid-19 test reports are being provided seven to 10 days after collection of samples.

Coronavirus-positive patients showing no symptoms mix with others freely, and can affect them, he said in the petition.

Moniruzzaman told The Daily Star that the HC may hold hearing on the writ petition today.



'Self-serve' report pickup and time-travelling tests

Mistakes, mismanagement of Covid-19 testing at port city's BITID raise eyebrows; authorities say they are short-staffed

mistakes and mismanagement in Covid-19 test results have been growing at the Bangladesh Institute of Tropical and Infectious Diseases (BITID) in Chattogram city, as the centre continues to work through the health crisis with limited resources.

Russel Chowdhury (not his real name) from Sitakunda upazila said his report had Iune 28 as the date of sample collection, while he had collected the report itself on June 27 (Saturday). The report also said the intended date for its collection was

"I gave my sample in late May; since then, I have come here at least five times to collect my report, but to no avail," he

"I came to know through the BITID hotline in mid-June that I tested positive for Covid-19."

anomalies in it, I am having trouble trusting its accuracy," he said, adding that a stack of reports were left in a basket at the corridor of BITID when he went to pick it up, and no responsible staff was present to take care of those.

This correspondent visited the spot yesterday, and found truth in the claim. Test reports -- that are of paramount importance to patients -- were found left in a basket on a table at the corridor of BITID.

Kumkum Biswas from Sitakunda also expressed her concerns over the matter. "Patients and their attendants are rummaging through for their reports in the basket. Some get it, some do not. Any report can go missing in this ruckus," she said, "Moreover, as the reports are left

open, privacy of patients is violated." Contacted, Prof Dr Shakil Ahmed, incharge of BITID laboratory, said the date of delivery of Russell's report would actually be on May 29. "It was a printing mistake.

An integrated South Asia the key: analysts

International relations analysts have called for a new move to strengthen South Asian integration for the sake of improving the lives of its huge population, a lot of who are poor, human rights and environment.

They said as China-US rivalry continues to grow, these powers will continue to have their influence in the region that has been least integrated so far because of trust deficit. China has lucrative economic offers to the smaller South Asian countries but they run risks of debt trap and authoritarian

As coronavirus pandemic is re-exposing the fragility amid non-cooperation, it is high time the regional countries come together, remove their distrust and cooperate each other in economic, social, environmental development, analysts added.

India, as a major economy of the region, has even a greater role to play here, they observed at a webinar titled "In the shadow of Dragon: Globalization and Fractured Future of South Asia", organised by the Centre for Governance Studies (CGS)

Ali Riaz, a distinguished professor of political science at Illinois State University, said the rise of China and its influence on South Asia has put India in a difficult situation as smaller countries of the region are being drawn towards China because of its lucrative economic offers under the Belt and Road Initiative.

India, the major regional power, had to play an important role for the regional economic integration, but it has not done so -- a situation that facilitated China's entry in a big way.

For example, Saarc has been almost made into a dysfunctional regional body despite its immense potential, he added.

Ali Riaz said while Delhi has been focusing on political relations with its neighbours, China is doing the same. It is not the fact that the countries like Sri Lanka, Nepal and Bangladesh are very happily embracing China, they are balancing between China and India.

However, these countries need to keep in mind China's authoritarian approach in governance and economy, risks of debt trap as well as human rights issues, he said.

FITNESS DOCS OUTDATED FOR 10YRS 11,000 vehicles to be 'written off' tomorrow

Over 11,000 vehicles, including 1,572 belonging to different government agencies, have not had their fitness certificates renewed for more than a decade in breach of rules, and authorities are going to declare those "writeoffs" after tomorrow, officials said.

Most of such government vehicles belong to different projects and have not had their fitness certificates updated after the expire of project tenure, they said.

Bangladesh Road Transport Authority (BRTA) doesn't have any data on how many of these vehicles are in operation now. However, several BRTA officials said many of these vehicles might be running on roads, especially outside Dhaka, as "a significant number" of vehicles have updated fitness after a recent notice was circulated in this regard.

As per law, it is mandatory for a vehicle to go through fitness check-up every year and have its fitness certificate renewed to ply the roads.

The authority recently asked owners to renew fitness certificates of vehicles by June 30. Otherwise, they would be declared "write-offs", meaning their registration will be cancelled, it said.

"This is our routine work. We will cancel registration of vehicles which have not had their fitness certificates renewed in last 10 years after June 30," BRTA Director (operations) Sitanghsu Shekhar Biswas told The Daily Star

Phone theft racket active in city: CID

Five held from Gulistan

They mostly worked in small groups -- around three to four persons in each one.

The first group stole cellphones from public places and transports. The second one changed the International Mobile Equipment Identity (IMEI) of the phones so that law enforcers could not trace those while the third group sold the phones at markets.

To change the IMEI it cost Tk 200 to Tk 600, depending on the phone's model.

Over a 100 members of the syndicate are active in Dhaka and other divisional cities. Some are also involved with smuggling handsets from neighbouring country and supplying those in shopping malls.

Law enforcers came up with the findings while investigating a case of cellphone theft.

On Saturday, a Criminal Investigation Department team, in a special drive, arrested five persons from the capital's Gulistan area for their involvement in selling stolen cellphones, Kaniz Fatema, special superintendent (Dhaka metro east) of CID, told The Daily Star yesterday.

The arrestees are Khorshed Khan (30), Shamim Mollah (21), Miraz Uddin (20), Abdul Aziz (32), and Kabir Hossain (40). CID also seized 92 cellphones from their

Police Brutality On Jashore Student

3 cops took 'unethical benefits' to release Imran, SP tells HC

Superintendent of Jashore Police Muhammad Ashraf Hossain yesterday submitted a probe report to the High Court, saying that three police personnel of Kotwali Police Station had taken "unethical benefits" from the father of college student Imran Hossain for releasing him from their

The police personnel are: assistant sub-inspectors of Sajiali Police Box under Kotwali Police Station Sumaresh Kumar Saha and Sajdar Rahman, and constable Md Faruk Hossain. Imran Hossain, a second-year student of Kazi Nazrul Islam Degree

College under Jashore Sadar upazila, was reportedly tortured by police on June 3 without any specific allegations. The torture left Imran with damaged kidneys, his family claims. The SP also said in the report that departmental action has been taken

against the three for taking "unethical benefits", Humayun Kabir Pallob, a petitioner and a Supreme Court lawyer, said citing the SP's report. He submitted the probe report to the HC through Deputy Attorney General Samarendranath Biswas during a virtual hearing on a writ petition

in line with its June 23 order. Jashore Civil Surgeon Dr Sheikh Abu Shahin submitted a separate report to the HC through DAG Biswas, saying Imran was "drugged" when
