On July 1, 2016, five militants, armed with guns, machete and grenades, stormed the upscale eatery in the diplomatic zone in Gulshan and held the diners hostage before brutally killing 20 of them. The deceased included three Bangladeshis, seven Japanese, nine Italians and one Indian citizen.

The militants were killed during a rescue operation by army commandos. Two police officials and a chef of the café were also killed during the 12-hour standoff while another injured staffer of the eatery died later.

A Dhaka court on November 27 last year sentenced seven militants to death for their involvement in the attack, terming it a disgraceful attack aimed at assassinating the non-communal character of Bangladesh.

The Anti-Terrorism Special Tribunal acquitted one accused as it found him not guilty in the atrocity. The court handed down death sentences to seven for their involvement.

that you have deprived your ghostwriters financially. You did not pay the promised amount as well as royalty to them.

QAH: Consider someone has got Tk 12,000 to 15,000 but feels he deserved Tk 60,000. He can think like that and I have nothing to do with it. The issue is whether they got the promised amount for what they wrote. I have never deprived anyone financially or cheated them. Why did they write if they had felt that they were financially deprived? I have not forced or intimidated anyone to write.

What should be their logic to write for 45 long years if I had not paid them? I have fulfilled my promise of paying onetime honorarium. They have signed and taken the money without complaint. Those vouchers are still with me. Someone can think I paid them less, can feel they could have been better off if they had got more. You cannot make someone happy with money. They wrote only after accepting my proposal.

A few days before Sahadat Chowdhury died, I rang him and said I owed him some money. I asked him if he would be able to come or I will send somebody at his home with the

he told me he would come because it would also be an opportunity to see each other.

No writer except him (Sheikh Abdul Hakim) has ever complained

that I have not paid them their dues. TDS: Did you sign any contract with writers at that time?

QAH: No. We never signed any written contract, and never thought of doing so nor did they ask for it. It was also the case with Sheikh Abdul Hakim. It has always been considered as gentlemen's agreement.

TDS: Has he ever demanded money from you before submitting a copy right lawsuit?

QAH: No, not like that. When he left Sheba Porkashoni, he told me that his doctor advised him not to walk a distance and that it would not be wise for him to go to his workplace in Segun Bagicha from his residence in Mirpur. He had an open-heart surgery and I paid his medical expenses. Anyway, when he left, he told me that he would be able to write a book in a month or two. After two months, he sent me a legal notice and threatened to file a defamation suit if I fail to agree to make a deal with him. I did not find anything to compromise with him. After a few days, he demanded that I owe him Tk 2.9 crore, showing the calculation of a few books.

TDS: Was that claim meant unpaid

QAH: It has nothing to do with royalty. I paid them onetime money for their write-ups. Both Sheikh Abdul Hakim and

Sultan Mahmud were preparing to file cases against me. I responded to their lawsuits and categorically said their demands were beyond their rights. Sultan Mahmud backed out. After that they went to the

copyright office from where I was first served with a legal notice and then summoned for a hearing at court. I He became surprised and asked conveyed through my lawyer that I was physically not in a position to be that it was his honorarium for writing, present for hearing but they insisted that I must appear at court. At one stage, the court awarded

the rights of six Masud Rana books and one from Kuasha series to Sheikh Abdul hakim. The reason behind that was his name was printed in those books' inside pages although my name was in the covers. The writers who have written their own plots in a book, I have carried their names.

I have carried his name because he requested me. His logic was that if his name was mentioned in the Masud Rana books, it would help promote sales of his other by-name titles.

I have tried to convince the court that he cannot have the rights this way

because the series is mine. He wrote as a ghostwriter.

TDS: Are you aware of any such lawsuit by a ghostwriter in the international

QAH: I'm not aware of such lawsuits anywhere in the world. It would also not happen here had the greed not gotten the better of him.

TDS: The copyright court has awarded the rights of 260 books to Sheikh Abdul Hakim. What will you do now? QAH: I did not get justice. I have tried to convince the court that Sheikh Abdul Hakim's name was not anywhere in the book. How come he won the rights? I will take the next course of action in line with the law. There are 466 books in the series and 260 of them have been awarded to him, it's unacceptable.

TDS: Can Sheikh Abdul Hakim bring out a new book of Masud Rana series? QAH: Not at the moment. But he will be able to do so if he finally gets the

However, if I can prove in the higher court that he is not the creator and writer of the series, he will not get TDS: People in the social media have

been critical against you for using your name while the books are written by others. They are also questioning your ethical position for that act. QAH: Ghostwriting has been going

on for a long time. I have paid them to write and I don't find it unethical. I never tried to force or intimidate them

TDS: Was there any scope to use his name instead of yours in the books? QAH: Masud Rana series is mine and no one else can have their rights.

TDS: You had a very good relationship with Sheikh Abdul Hakim. But it has turned bitter now. How do you react

QAH: I have nothing to say. He has done what he felt was good for him. Now it's time for me to embark on my own journey alone.

Masud Rana known

home and offered me to write for Masud Rana series. My brother who was also present at that time told him (Qazi Anwar Hossain): "He can easily write; you can pay him Tk 500 for each write-up. At one point of the discussion, Qazi Saheb said: "Don't get upset, you start writing again."

I started writing again. (Along the way) so many dramatic events had taken place... I stopped writing for him on a number of occasions.

TDS: Did Qazi Anwar Hossain discuss the plot of each and every book of Masud Rana series with the writers including you?

SAH: Not all the time. He gave me a general concept while I built a story. Sometimes, I turned to him for advice. And because of that some people said I have tried to copy the style of Qazi Saheb. But that was not possible. His style of writing was very rich. It was impossible for me to emulate him. I have always tried to follow my own style. And Masud Rana is known to readers more for my style of writing. He wrote 20 books. I wrote 260. Around 2,000 copies were published during his time while it was 18,000 during my time and many books sold over one lakh copies. He paid me Tk 6,000-7,000 for each book.

TDS: Do you feel you were deprived? Qazi Anwar Hossain claimed that you have got the promised amount. He also said he paid the expenses for your bypass surgery.

SAH: He said a lot of things. He once

said I did not write a single book of Kuasha series. Then he retracted and said Sheikh Abdul Hakim wrote books for both Masud Rana and Kuasha series through appointment. He never disputed that I have written 260 books. He, however, failed to show any appointment letter.

TDS: Do you claim that you were supposed to get more than what you were paid for writing books?

SAH: No, not that. I have learnt from an incident that I'm not getting the royalty that I deserved.

TDS: Were you supposed to get the royalty? Wasn't that one-off amount? SAH: I have got the proof that he has been paying royalty to different writers for the last 36-37 years. In an interview in 2008, he said he pays royalty to each of his writers. The royalty money is deposited in the writers' names every month and they have the liberty to take the money any time they wanted.

TDS: Do you think you could have gotten similar response had the books of Masud Rana or Kuasha series been published by your name instead of Qazi Anwar Hossain?

SAH: Probably not. But had it been the case from the very beginning, it might have started slowly before picking up the pace.

TDS: Why did not you then think of carrying your name? SAH: I did not focus on so many

things at that time. I got the money and kept on writing. Never thought of carrying my name.

TDS: If you get the rights of Masud Rana series, will you bring out new books by your name? SAH: Definitely.

TDS: Do you think the books will be as popular as it was before? SAH: Definitely not. A book of Masud Rana series used to sell over one lakh copies before.

TDS: Do you have a proof of that? SAH: Many books saw as many as 18 editions. I have got papers showing up to seven editions. Even if I count only seven editions, they would probably owe me around Tk 12 crore. I can

prove that in the higher court. **TDS**: What is your basic demand now? SAH: Some might interpret it differently or a few might consider it as my weakness, but still I want to say if they properly compensate me, I will forfeit my copyright of 260 books. But

TDS: Qazi Anwar Hossain claimed Masud Rana is his series, every

those books must carry my name.

character is his creation. SAH: Apart from a few characters of Masud Rana series, rest are creation of mine. There are around seven characters like Masud Rana, Rahat Khan, Sohana and Sohel Rana created by him [Qazi Anwar Hossain]. I will not keep those names.

TDS: What do you mean by proper compensation?

SAH: I have demanded Tk 4 crore. They can come and negotiate with me. But my principal demand is the rights of my own books.
