Dhubri police also claimed that the men violated their tourist visa conditions by working while in Assam.

"Both of my sons are in jail. When their mother got to know about their condition, she fell extremely ill. Please do something to bring my sons back," said 65-year-old Lal Mia, father of Md Manik Mia and Md Rezaul Karim.

Manik had just gotten married several months earlier.

"I don't know when he will come back. How shall I survive without him?" asked Salima, his wife.

Dr Shah Mohammad Tanvir means their families are suffering financially too.

Anwara Begum, 67, is dependent on her sons Anwar Hossain and Raja Mian, both of whom are also among the imprisoned fishermen.

"Without my sons, I have to pass days on other people's mercy. If someone gives me a loaf of bread or some rice, I can eat something and share with my two grandchildren. Otherwise we all have to starve." PROTESTS ON BOTH SIDES OF

BORDER Rights activists in both India and Bangladesh protested the incarceration of the poor fishermen and demanded their immediate release.

Md Nahid Hasan, chief convener of a local people's committee on rail-river communication and environmental development, organised a human chain in Kurigram on May 13 demanding the fishermen's release.

On June 23, Bharat-Bangladesh Gana Sanghati (India-Bangladesh People's Solidarity) staged a demonstration in front of the National Press Club in Dhaka, the Press Club in Kurigram, and in front of the Bangladesh High Commission in Kolkata demanding their immediate release and repatriation.

MASUM, the Kolkata-based human rights organisation, has submitted an application to the respective government offices in Assam and West Bengal asserting innocence of the Bangladeshi citizens and praying for their release.

"This should be clear that these Bangladeshi nationals are not criminals as they are merely victims in this pandemic. Hence, criminally accusing them is baseless and reflects a grave violation of human rights. Therefore, these charges must be withdrawn immediately and proper arrangements must be made for their repatriation," states the application.

"This crisis calls for special measures and demands solidarity and sympathy towards victims like these people who have no ill-intention to overstay their legitimate duration and treating them as criminals when Losing their lone wage earners, they need utmost security from this particularly during this downturn, country is absolutely shameful.'

The newly discovered planet orbits a star similar to our Sun, and is found about 730 light years away. It is known as TOI 849 b, and conditions there are intense: it is so close to its star that a year takes 18 hours, and the surface temperature is around 1,500C.

That places the planet right in the Neptunian Desert, the region near stars where planets the size of Neptune are rarely found. The planet is strangely

close to its star, considering its mass," said David Armstrong from the University of Warwick, the lead author of the study, in a statement. "In other words, we don't see planets with this mass at these short orbital periods."

Researchers were able to conclude that it was just a planetary core by conducting detailed measurements, which found that the planet is about 40 times heavier than the Earth, but only 3.4 times as large. That density must mean that it is made up mostly of iron, rock and water, with only small amounts of hydrogen and

"The fact that we don't see those gases lets us know TOI 849 b is an exposed planetary core," said Dr Armstrong.

TOI 849 b was first found by Nasa's Transiting Exoplanet Survey Satellite, which hunts for planets by looking for the signature dip in brightness that happens when they move in front of their star. It was then further analysed by the HARPS instrument run by the European Southern Observatory, which uses the Doppler effect to measure exoplanets by looking for the wobble in their light that happens as they move nearer and further from us.

Gun attack leaves 24 dead in central Mexico

AFP, Guanajuato

Gunmen on Wednesday attacked a drug rehabilitation center in central Mexico, killing at least 24 people and leaving seven wounded, local authorities said.

According to preliminary information, the attackers "entered the scene, forced (the victims) onto the ground and shot them," said Pedro Cortes, secretary of public security in Irapuato, located northwest of Mexico City in Guanajuato state.

"We have reports that the (armed) subjects arrived in a red vehicle, no further information is known. The preliminary report we have is of 24 dead people and seven wounded," he added.

Authorities are working on locating the vehicle, Cortes said

The city of Irapuato said in a statement that three of the wounded were in serious condition, but that no one had been kidnapped during the attack. It added that the area would be off-limits so that an investigation could proceed.

The state of Guanajuato, home to major industry and a number of large auto manufacturing plants, is plagued by organized crime violence.

The state's wealth has attracted groups such as the powerful Jalisco New Generation and Santa Rosa de Lima drug cartels, which are also involved in extortion, kidnapping and fuel theft.

Guanajuato Governor Diego Sinhue gave his condolences on Twitter and stated that "coordinated intervention by federal and state authorities is necessary as the only way to successfully confront this situation.

The report was prepared based on news reports published or aired by 25 media outlets, including national and local dailies, online news sites, and television channels.

According to the latest report, highest 451 people died with Covid-19 symptoms in Chattogram division, followed by 338 in Dhaka division, 185 in Khulna, 170 in Barishal and 148 in Rajshahi.

Also, 83 people died in Sylhet, 70 in Rangpur and 55 in Mymensingh showing Covid-19 symptoms, the report said.

The report stated that 84 incidents of spreading rumour over Covid-19 were recorded in the country. At least 87 people, including the highest 35 from Dhaka division, were arrested in connection with those incidents.

Furthermore, 544 people were picked up and another 11,028 fined between March 8 and June 27 for committing various offences related to the virus outbreak, including relief the report added.
