The coronavirus pandemic has slowed down the implementation of at least 40 of the 49 projects funded by the Asian Development Bank.

Initial estimate shows that awarding of contracts may fall by 20 percent this year and disbursement of funds by 30 percent if no special measures are taken.

In six months till June 30, the achievement in awarding contracts was only 13.87 percent and that in disbursing funds 21.41 percent of the targets, show ADB documents.

Given the Covid-19, special measures will be needed to speed up the project implementation as lockdown has seriously impacted the project progress," read the documents. Against such a backdrop, the Tripartite Portfolio Review Meeting

(TPRM) for the ADB-funded projects will be held in Dhaka tomorrow. This is the first such meeting this year. The TPRM will be co-chaired by the secretary of the Economic Relations

Division and the country director of the ADB's Bangladesh Resident

Representatives of the implementing agencies for all the projects will take part in the virtual meeting.

Shahid 'bribed 2 Kuwaiti MPs Tk 20cr': report

Kuwaiti prosecution tells national assembly

Bangladesh MP Shahid Islam Papul gave 720,000 dinars (about Tk 20 crore) to two members of Kuwait's National Assembly as bribes to facilitate foreign workers' recruitment and financial transactions,

according to Kuwait's Public Prosecution. It revealed the information in a report to Kuwait's National Assembly after Papul confessed during interrogation, reported Arab Times on Sunday.

According to the Public Prosecution's memorandum, Shahid revealed that he gave MP Saadoun Hammad about 200,000 dinars, including 50,000 dinars at his residence in South Surra region, and 150,000 dinars in cheques through a Syrian national mediator, who is the deputy manager of a company.

The target of the bribes was to facilitate his transactions and complete his commercial procedures in Kuwait.

Papul further gave 370,000 dinars in cash to MP Salah Khorshid at his residence in instalments, in exchange for bringing in Bangladeshi workers, and excluding him from obtaining their job approvals from SEE PAGE 2 COL 1

DGHS-MINISTRY RIFT OVER REGENT

It'll frustrate virus efforts

The rift between the health ministry and the health directorate over the Regent Hospital scam will seriously hurt the government efforts to contain the Covid-19 outbreak, say experts.

The buck-passing not only demonstrates a lack of coordination between the government bodies but also exposes the shady links and corruption in The government must take action against the people involved and ensure

that the agencies engaged in Covid-19 response work in coordination, they added. "This [the government deal with Regent] was the work of a team. There

must be no blame game. This proves the lack of seriousness in the director general and the minister," said Rashid E Mahbub, former president of Bangladesh Medical Association (BMA). "It is the duty of the DG to point out illogical directives from the

minister and the minister should also consider that. Negligence is evident on both of their parts," he told The Daily Star. "Be it corruption or misjudgement, this has to be dug out. But for now,

it is more important to work together to tackle the Covid-19 pandemic." The Directorate General of Health Services (DGHS) signed a memorandum of understanding with Regent in March, turning it into a dedicated Covid-19 hospital, in a ceremony attended by Health Minister

Zahid Maleque and many high officials. The DGHS was aware that the hospital's licence had expired six years

On July 7, a Rab mobile court raided Regent Hospital's Uttara branch and sealed it off on charges of issuing fake Covid-19 test certificates and asking money from coronavirus patients illegally.

Sabrina washes her hands of JKG

Evidence against her pile up; placed on a 3-day remand

Since JKG Health Care's alleged involvement in the fake Covid-19 test report scam surfaced late last month, Dr Sabrina Arif Chaudhury has been claiming that she was never the organisation's chairman.

She also refuted her links with any forgery. Also in court yesterday, Sabrina, a suspended registrar (cardiac surgery) at the National Institute of Cardiovascular Diseases (NICVD), denied holding the post of chairman at

any private organisation, said court sources. Some documents, website of an event management firm connected to JKG Health Care, and Sabrina's LinkedIn profile, however, mention her as the chairman of Oval

Group, which was established in 2008. In its official documents, Oval Group says its sister concerns are JKG Health Care, Dhaka Expo, Oval ad, Vital Security Services (VSS) Limited, Oval IT, A&M Fashion,

Booking BD, Moment, and ROW-DY. Dhaka Expo's website still shows Sabrina as the chairman of the group. The firm's Facebook page also has photos where she is seen participating in its programmes.

Besides, Sabrina gave interviews to the media as a spokesperson for JKG after some of its staffers were allegedly assaulted at Titumir College on June 2, said

No one can leave station during Eid holidays

Says cabinet secretary at a press briefing

UNB, Dhaka

The government has decided not to extend the three-day Eid holiday and also not to allow the government employees to leave their workplaces amid the Covid-19 pandemic in the

"The three-day Eid holiday will not be extended further and no one can leave their respective workplaces or headquarters during the upcoming Eid-ul-Azha," Cabinet Secretary Khandker Anwarul Islam said at a press briefing after a cabinet meeting

He said this replying to a question if there was any directive regarding the novel coronavirus.

The cabinet meeting was held with Prime Minister Sheikh Hasina in the chair. She joined the meeting through videoconferencing from the Gono Bhaban, while other cabinet members were connected from the Bangladesh Secretariat.

NATIONAL HISTORIC DAY

The cabinet approved a proposal for declaring March 7 as the "National Historic Day" in a bid to observe the day nationally, commemorating the historic March 7 Speech of Father of the Nation Bangabandhu Sheikh Mujibur Rahman.

"The cabinet approved a proposal

placed by the cultural affairs ministry to declare March 7 as the National Historic Day and include it in the 'Ka' Serial [list] of the gazette notification concerned," said the cabinet secretary.

Following a writ petition, the High Court had earlier issued a rule asking the government to explain why it should not be directed to declare March 7 as the National Historic Day, Anwarul said.

One of the prominent industrialists of the country, Nurul left behind his wife Salma Islam, a Jatiya Party MP, one son, three daughters and a host of relatives to mourn his death.

Nurul Islam, also the founding Jamuna Television, had been in 1974. undergoing treatment at the hospital

since June 14. A ten-member medical board was formed for his treatment at the hospital. Besides, four specialist doctors from China and two specialist doctors from Singapore's Mount Elizabeth Hospital had given advice

through teleconference to treat him. He will be buried at the Banani graveyard today after a namaz-ejanaza at the Jamuna Future Park mosque after Johr prayer.

Speaker Shirin Sharmin Chaudhury, top leaders of different political parties, socio and business organisations, ministers including Road Transport and Bridges Minister Obaidul Ouader, Finance Minister AHM Mustafa Kamal, Home Minister Asaduzzaman Khan, among others, expressed deep shock at the death of Jamuna Group chairman.

Nurul Islam's Son Shamim Islam is the managing director of Jamuna Group, his three daughters -- Rosalin Islam, Monica Islam and Sonia Islam

are directors of Jamuna Group.

Nurul Islam took the initiative to build an international standard hospital in the capital to treat Covid-19. He had already finished the initial discussion in this regard.

Nurul Islam established Jamuna in chairman of Daily Jugantor and the arena of private industrial sector

Its journey began with the Jamuna Electric Manufacturing Co. Ltd, which pioneered the manufacturing electrical accessories and fittings in Bangladesh since 1975. There after JGI flourished as a giant conglomerate.

Jamuna developed and expanded its enterprises to diversify its product

In the course of 34 years of operation, Jamuna Group expanded into a dynasty of 24 large scale enterprises.

"Jamuna Group has been a big contribution towards the national exchequer in the form of taxes and by generating employment opportunities for a huge number of unemployed work forces. More than one lakh people work under different ventures of Jamuna Group," Mohammad Alamgir Alam told this correspondent.

From textile to real estate, Jamuna Group has diverse business interests in 38 sectors.

It has ventured into electrical, engineering, chemical, leather, garments and textiles -- including spinning, knitting and dyeing, and cosmetics, toiletries, beverages, real estate, housing, print and electronic media sectors.

Jamuna Group is also involved real estate development and one of the biggest projects it had undertaken was "The Future Park."

Kuwait's National Assembly has lifted immunity for interrogation of the two MPs in connection to Papul's case. Some officials were also detained for being involved in the alleged crimes.

Papul, managing director and CEO of Marafie Kuwaitia Group, is accused of human trafficking, money laundering, bribes and visa trading. He recruited 20,000 foreign workers, mostly Bangladeshis, in exchange for Tk 700,000 to Tk 900,000, but did not provide jobs and wages as per the contracts. His company is also accused of charging for annual work permit renewal.

Shahid, from Laxmipur-2, and his wife Selina Islam became MPs in the 2018 election allegedly through the power of illicit money from Luxmipur-2 constituency.

Bangladeshi Meanwhile, ambassador to Kuwait, SM Abul

Kalam's role has been questioned as Papul continued to commit such crimes for years. The ambassador in a letter to the foreign ministry in Dhaka gave a clean image of Papul, after the Kuwaiti media ran reports of his criminal activities.

40 projects hit by pandemic shutdown started to affect the economy

They will assess the impact of Covid-19 on project implementation, review key implementation issues that may affect progress, prioritise actions to meet the targets, and also discuss approval of proposed projects.

As of June 30 this year, Bangladesh's active portfolio with the ADB stands at \$10.81 billion in the form of loans or grants for 49 projects in six sectors. The amount includes \$742 million in loan for the projects approved this year.

Of the projects, 12 are in the transport sector; nine in education and health; eight in energy; eight in water, urban infrastructure and services; seven in agriculture, natural resources and rural development; and five in the finance sector.

The projects in transport and energy sectors account for 55 percent of the portfolio value.

IMPACT OF COVID, WAY FORWARD According to the ADB, Bangladesh was performing well till March when Covid-19 started affecting the implementation of the projects.

To contain the spread of the virus and ensure safety of workers and employees, the majority of the construction sites were closed following the shutdown, it

Since then, contracts under several packages could not be awarded and also funds could not be disbursed, seriously impacting the project implementation, the ADB mentioned in the documents.

39 more die, 3,099 test positive

Thirty-nine more people died from Covid-19 in the last 24 hours until yesterday, the death toll rose to 2,391.

During this time, 3,099 positive cases were recorded, taking the tally to 1,86,894, according to the Directorate General of Health Services (DGHS).

In the past 24 hours till 8:00am yesterday, a total of 12,423 samples were tested in 77 labs across the

Of them, 24.95 percent tested positive -- up from the previous day's positivity rate of 24.11 percent.

On July 5, the positivity rate was 19.57 percent.

During yesterday's briefing, Prof Nasima Sultana, additional director general of DGHS, informed that more 4,703 Covid-19 patients were recovered from illness.

The total number of recovered patients rose to 98,317, which is 52.61

percent of all confirmed cases. The death rate stood at 1.28

Of yesterday's deceased, 30 were

males and nine were females. Yesterday, 34 of the deceased died in hospitals while five died in their

Of them, 19 were from Dhaka division, five from Chattogram, seven from Khulna, three from Barishal,

two from Sylhet, and another from Mymensingh division. So far, Dhaka division witnessed the highest 1,195 (around 50 percent) deaths due to the Covid-19 followed by Chattogram with 623 deaths-

slightly over 26 percent. Age-wise: one of them was under 10, one was aged between 11 and 20, three between 31 and 40, six between 41 and 50, 13 between 51 and 60 and 15 was aged over 60 years.

Meanwhile, Prof Nasima Sultana explained the reason behind the decrease in the number of daily tests.

"As per the WHO guideline, there is no need for second time testing after recovery and the health ministry has also imposed fees for Covid-19 testing. We think these reasons have caused the decline in testing," Prof Nasima said.

She also said they observed a lack of interest in people to be tested.

"Our scheduled time for collecting samples is 11:00am to 3:00pm; but we are observing no gathering after 1:00pm," she added.

She urged the poor people who need Covid tests to visit the designated centres across the country, where testing is free.

A Malaysian court yesterday heard contempt case brought by the government against independent news portal Malaysiakini and its editor-inchief over readers' comments posted on its website, in a case widely seen as a test for press freedoms.

Rights groups have Prime Minister Muhyiddin Yassin's government of stifling dissent after a series of clampdowns against critics of his four-month-old administration.

Last month, Malaysia's attorneygeneral filed an application to cite Malaysiakini and its editor-in-chief Steven Gan for contempt over five comments posted by readers on its website that allegedly undermined public confidence in the judiciary. Malaysiakini and Gan, who could

face a jail term as well as a fine, have maintained they could not be held responsible and the offending comments had been immediately removed after they were contacted by police. vesterday's

Malaysiakini's lawyer Malik Imtiaz Sarwar argued that there was no evidence the portal intended to post the comments.

"One shouldn't be shooting the messenger unless one can actually show the messenger is the creator of the message being delivered," he told the court.

Government lawyer Narkunavathy said Malaysiakini should be held liable for facilitating the publishing, arguing the portal's filtering systems had been insufficient to prevent the comments from being posted.

"We say that they exercise control over the platform and, as such, they have to assume responsibility to expeditiously remove any comment that is adverse," she told the court.

Federal Court judge Rohana Yusuf Malaysia's highest tribunal needed more time to deliberate before reaching a decision.

The case comes as six employees of Qatar-based broadcaster Al Jazeera have been questioned by police over a documentary on Malaysia's detention of undocumented migrants that authorities have accused of being inaccurate, misleading and unfair.

"We talked to their employees. All said she was the chairman of Oval Group," the police official said.

Meanwhile, Sabrina was placed on a three-day remand yesterday in connection with a case filed over issuing fake Covid-19 test reports. She was arrested on Sunday, about three weeks after the scam came

to light. Police said as she is the chairman of JKG, she cannot avoid "the responsibility". Before being arrested, Sabrina told

the media and the police that she no longer had any ties to JKG. Besides, she sent a divorce letter to her husband,

The same day, the health ministry suspended Sabrina from the post of registrar at NICVD. According to the ministry's order, she was suspended for professional misconduct -holding the post of chairman of a private organisation while in public service -- and also corruption allegations.

The scam surfaced on June 23 after Tejgaon Police arrested Humaun Kabir Hemu, chief visualiser at Oval Group, and his wife Tanzina Patwary, chief of staff (nursing) at JKG Health Care, over their alleged involvement in issuing fake coronavirus test reports.

They were terminated, along with Sabrina, on June 8.

Police also claimed to have found pages with fake letterhead of Institute for Developing Science and Health Initiatives, a government certified Covid-19 testing laboratory, at the couple's home in the capital's

"Apart from collecting samples, they would give a set of 10 questions to each person. If five of the answers matched the symptoms of Covid-19, they would issue a fake certificate saying the person has tested positive. No tests were done, they would simply throw away the samples," AC Mahmud said.

FORCED INTO PROSTITUTION IN DUBAI

CID to seek Interpol help to nab traffickers

The syndicate that has been trafficking thousands of Bangladeshi girls for last eight years and forcing them into sex work is also involved in trafficking girls from India and Pakistan. It's Indian and Pakistani members trafficked the girls to Dubai.

The syndicate is operating brothels in Dubai under the guise of hotel business where girls, aged 18-20, from Bangladesh, India and Pakistan are forced into prostitution.

Talking to The Daily Star yesterday, several high officials of the Criminal Investigation Department (CID), investigating the syndicate, disclosed the

CID recently arrested ringleader Md Azam Khan and two other members Anowar Hossain Moyna and Alamin Hossain alias Diamond.

"We came to know about the racket's activities after interrogating the arrestees, talking with victims and analysing data," said a CID officer,

The officer further said they came to know that some local members in Dubai are also linked with the group.

Contacted, Imtiaz Ahmed, deputy inspector general of CID, told this correspondent yesterday that they have already got some names of the syndicate members, which include Indian and Pakistani nationals. All of them are now staying in Dubai.

"We are now preparing documents to seek Interpol's assistance through the National Central Bureau (NCB) in Police Headquarters (PHQ). It's a lengthy process and may take some time," he added.

ACC to probe allegations against Shahed, Sabrina

Anti-Corruption Commission (ACC) will enquire into allegations against JKG Healthcare Chairperson Dr Sabrina Arif Chowdhury and owner of Regent Hospital and Chairman of Regent Group Md Shahed over misappropriation of public money.

The commission has already formed a three-member committee led by its Deputy Director Abu Bakar Siddiqui in this regard, ACC's Public Relations Officer Pranab Kumar Bhattacharya told the media.

There are allegations against Shahed that he amassed several crore taka through microcredit and multi-level marketing business, forgery, dodging tax and bank loans with forged documents, said Pranab. After scrutiny, ACC decided to launch an

enquiry against Shahed, he added. On July 7, Rab filed a case against Shahed and 16 other staff of Regent Group and Regent hospitals after a mobile court found proof that hospital authorities issued fake Covid-19 certificates and charged patients for tests and treatment, violating an agreement with the government. Shahed went into hiding after the drive began on that day.

Two days later, Bangladesh Bank asked all banks to freeze his accounts alongside his business establishments' for 30 days. Financial Intelligence Unit of BB also sought information on Shahed's accounts and of persons or organisations linked to him.

On Sunday, National Board of Revenue (NBR) directed banks to freeze all accounts of Regent Group chairman and his farms.

Meanwhile, the ACC will also investigate allegation against Dr Sabrina for amassing Tk 8 crore through forgery. ACC's special investigation cell will lead the enquiry, confirmed Pranab Kumar Bhattacharya.

With the help of her husband Arif Chowdhury, Sabrina allegedly prepared 15,460 fake Covid-19 certificates. She was recently suspended from

the National Institute of Cardiovascular Diseases for "violating rules".

There are also allegations against her of amassing wealth beyond disclosed income.

No place for the greedy in AL: Quader

Issuing a note of warning, Awami League general secretary Obaidul Quader yesterday said those who are spoiling the image of the party by accumulating wealth illegally will



Malaysian rights group on revoking work permit of migrant Rayhan Kabir

Revoking the work permit of Bangladeshi migrant Rayhan Kabir, who appeared in the Al-Jazeera documentary "Locked Up in Malaysia's Lockdown", has been described as "blatant abuse of power".

Zaid Malek, coordinator for Malaysia-based human rights lawyers' group Lawyers for Liberty (LFL), said through no fault of his own, the 25-year old migrant worker has now been rendered undocumented by the authorities. The remarks came from a statement published on the group's web site.

In the documentary, Al Jazeera was critical of Malaysian government's

treatment of migrants during the coronavirus pandemic. Pakistani, Indonesian, Bangladeshi and Malaysians were interviewed in the However, Malaysian authorities issued a public notice last week seeking information on Rayhan Kabir. They also said Al Jazeera reporters will be

interrogated for investigation. On Sunday, Malaysia's Inspector-General of Police (IGP) Tan Sri Abdul Hamid Bador revealed that the Immigration Department had revoked the Bangladeshi's work permit and that Rayhan is now an undocumented

migrant and would be deported if found. Zaid Malek said, "The extent that the authorities are willing to go in order to hunt down one man for merely speaking up his experience of

injustice to the media is alarming. "The revocation of the Bangladeshi's permit is a blatant abuse of power and amounts to flouting of the law by the Immigration Department."

BOAT CAPSIZE IN BURIGANGA

Mayur-2 launch master arrested

Rapid Action Battalion yesterday arrested the master of Mayur-2 launch that hit and sank another vessel in Buriganga river on June 29, killing at least 34 persons.

Abul Bashar Molla (65) was arrested

from a house in South Keraniganj area around 1am, Sujoy Sarker, assistant director of Rab's Legal and Media wing, told The Daily Star. Bashar was one of the seven persons

charged with negligence -- causing the deaths -- in a case filed by River Police with South Keraniganj Police Station following the launch capsize. According to River Police, Bashar was in

the launch but sukani (launch staff) Nasir Mridha was steering the vessel when it hit another launch -- Morning Bird. Most of the 34 victims were from

Munshiganj district. Earlier on July 9, River Police arrested Mayur-2 owner and prime accused Mosaddek Hanif Swad from Dhaka.

Five other accused -- master Jakir Hossain, 54; engine driver Shipon Hawlader, 45; driver Shakil Hasan, 28; launch staff Nasir Mridha, 40; and Ridoy, 24 -- are still on the run.

DEATHS DUE TO DROWNING

Bangladesh's fatality rate 5th in Commonwealth

Says study based on 2017 data

Bangladesh had the fifth highest fatality rate due to drowning among all 54 Commonwealth countries in 2017, finds a study. About 37 percent of global drowning deaths occurred in these countries,

where 1,10,594 people died in that year, the study revealed. Half of the deceased were aged below 19 years, and 26 percent were under five years old, it said. Royal Life Saving Society (RLSS) released the study titled "Fatal

Drowning in Commonwealth Countries" yesterday. RLSS Commonwealth President Prince Michael of Kent, GCVO, said, "Understandably, people's attention is very much focused on the terrible worldwide effects of the Covid-19 pandemic. Sadly, this does not mean

that other avoidable deaths are not occurring throughout the world." He called upon the countries' governments to take steps to prevent unnecessary loss of lives through simple drowning prevention interventions.

In terms of total casualties, Bangladesh stood second with 14,029 drowning cases. The highest number of people -- 60,199 -- drowned in Approximately 14 percent of the country remains underwater

throughout the year, where frequent flooding turns disastrous. The combined number of fatal drownings in India, Bangladesh and

Pakistan makes up approximately 78 percent of such cases across the 54 countries, the study finds.

districts in Bangladesh. The brokers would lure girls with the hopes of a job that would pay Tk 50,000 per month,

Once the girls would agree, Azam took support from some agencies and managed tourist visas for them. The brokers would get Tk 10,000 for managing each girl, said

A high official of CID, requesting anonymity, said the syndicate always took four to five girls at a time and a broker traveled with them to Dubai.

"Once they reached Dubai, two brothers of Azam, who were also involved with the racket, took them to hotels," said the official, quoting two victims' confessional statement given in a court recently.

They would first be given jobs as receptionists or waitresses. A few days later, they would be forced to work at dance clubs and then as sex workers. The girls would be tortured if they refused.

Some eight victims have come back home in the last month with assistance of the Bangladesh embassy in the UAE, the official said.

In their statement, the two victims, who were trafficked to Dubai in January last year, said they were trying to escape and return to Bangladesh but could not as the group members kept constant watch.

Finally, they were able to manage the local number of Bangladesh embassy and sought help, they said. Jishan Ul Hoque, senior assistant commissioner of CID, said they are now collecting information of the victims,

who were trafficked by Azam's syndicate. "We have information that a huge number of Bangladeshi girls are still held there. We are also informing the authorities concerned at the ministry and the embassy to take initiatives to bring them back home safely," he added.

85km of RHD roads damaged by flooding

With 72 percent locomotives of BR already crossing their economic life, the government last year took initiatives to hire locomotives from India for the first time to help the railway overcome the crisis.

In April last year, BR sent a proposal to the railways ministry to "hire" or "get as courtesy" 20 railway engines (10 broad gauge and 10 meter gauge) from India until the first batch of 70 locomotives that Bangladesh bought from the US and South Korea starts arriving mid-next year.

"Until then, the 10 locomotives would be very helpful for them," he said. However, BR will not bring meter gauge (MG) locomotives from India. They did not get suitable MG locomotives as India phased out such engines long ago, Md Shamsuzzaman added.

According to BR documents of May last year, it had 178 MG locomotives, of which 139 have crossed their 20-year economic life. Of its 90 BG locomotives, 55 have completed their economic life.

Jatiya Party

Within two months of Ershad's demise, a rift between followers of Raushan and GM Quader became so bitter over party leadership and post of the Leader of the Opposition in Jatiya Sangsad that followers of Raushan through a press conference in September, 2019 declared her JP chairperson.

Relations between the two worsened further over becoming the Leader of the Opposition. However, GM Quader in the last one year tackled and resolved most of the divisions, party insiders said. "He also worked to build a bridge between the two," said a presidium member of JP. Asked, GM Quader said there is no division in the party.

Everyone is united to materialise the ideals of Ershad. "Ershad is our role model. Jatiya Party is moving forward

following the path he showed us, to fulfil the expectations of people. I believe, the party is on the right track," he said. Raushan Ershad could not be contacted for comments despite repeated attempts.

Virtual courts

The chief justice also decided to assign all judges of the HC division to conduct virtual court functions by rotation.

Thousands suffer as road condition awful

Two roads extending 16-km in Kulaura see only 40 percent work in scheduled time

MINTU DESHWARA, Moulvibazar

Thousands of commuters are badly suffering due to the awful condition of two important roads under the Roads and Highways Department (RHD) in Kulaura upazila of Moulvibazar.

The RHD in 2018 gave a Tk 36-crore work order jointly to Wahid Construction and Spectra International to repair and widen the 12-kmlong road from Nabin Chandra High School at Chaumohana in Kulaura upazila town to Jhilerpar in Prithimpasha union of the upazila and the four-km-long road from Robirbazar town to Tilagaon Bazar in Tilagaon union.

The work started in December 2018 with a schedule to complete on June 30 this year but only 40 per cent of the development work of the two roads has been completed in the period.

During a recent visit to the spot, this

Tilagaon, Sharifpur and Hajipur unions of Kulaura use the two roads to travel to the upazila headquarters and Moulvibazar district town.

Vehicles regularly plying the broken road often get damaged, said Arab Ali, joint secretary of CNG autorickshaw transport workers union in Rabirbazar-Kulaura unit, told this correspondent.

"Commuters including teachers, students and traders regularly use the Kulaura --Rabirbazar road. Usually it would take 20 minutes for a CNG autorickshaw to cross the road but it now takes double the time due to its awful condition," said Abdul Kadir, principal of Ali Amjad School and College.

Drivers also charge extra fare due to the road condition, he said.

Local resident Syed Ashfak Tanvir, general secretary of Robirbazar Club, told this correspondent learnt that the residents of different correspondent, "These roads have remained

areas of Rautgaon, Karmadha, Prithimpasha, unusable for four to five years. Now it has become more unsuitable due to the unfinished fixing work."

Sahadeb Sutradhar, sub-assistant engineer of the RHD, who is in charge of supervising the road repair work, said 40 percent of the work on the Kulaura-Prithimpasha and Rabirbazar-Tilagaon Bazar roads has been completed.

Asked about the slow pace of work, engineer Md Asaduzzaman, in-charge of the two contracting companies, said, the road work requires a lot of stones but the supply of stones through LC stopped due to Covid-19 pandemic.

Shahriar Alam, executive engineer of RHD in Moulvibazar, said, "There were some problems in the work of the contractor. Then in wake of the Covid-19 situation, the government extended the tenure of the ongoing work for one year. If the situation improves, the work of the two roads will be completed soon."

Bringing Birds Back to Town

Patuakhali town turning green

The Patuakhali municipality has launched a tree planting programme in order to beautify the town as well as to make the town habitable for birds.

Under the programme, the municipality will plant more than five thousand fruit, medicinal and beautifying trees in road medians and around lakes and water bodies in the town.

Mohiuddin Ahmed, the town mayor, inaugurated the programme recently by planting saplings on a road median in front of the town's old jailhouse.

Along with other local species of trees, some foreign plants such as Nakachua from Thailand and cherry from India have so far been planted to beautify a four-kilometre stretch of the median, stretching from Government Women's College to Jainkathi

Different trees including mango, kalo jaam, jackfruit, litchi, coconut, banyan, jalpai (Ceylon olive), amalaki (Indian gooseberry), tamarind, kamranga (star fruit or carambola), dewa (monkey jackfruit), neem, mahogany and chambal are also being planted on unused and vacant land surrounding ponds and water bodies in the town.

Jahangir Sikder, general secretary of Patuakhali Diabetic Association, said the townspeople used to enjoy chirping of different birds as Patuakhali town was full of large trees.

Over time, those trees have been chopped down and the number of birds declined after they lost their habitat. The planting of trees by the municipality is a laudable initiative that will help increase bird population again, he also said.

Lincon Bayen, coordinator of Bangladesh Environmental Lawyers Association, Barisal division, said birds play a vital role in maintaining environmental balance. Loss of food and habitat have put many species of birds on the verge of extinction, but people running after life in the fast lane have been ignoring this aspect of the environment.

Under the circumstances, the initiative taken by the municipality can set an example for all, he added.

Patuakhali Municipality Executive Engineer Jasim Uddin Arju said they have undertaken the tree planting programme considering the loss of food and habitat of many birds due to rapid urbanisation and destruction of the environment.

He also said that a total of around five thousand trees are being planted so the birds can nest in the trees while they can feed on the fruits of the trees.

When reached for his comment over this initiative, Mayor Mohiuddin Ahmed told this correspondent that the greenery and fruit trees in the town will not only provide food and shelter to birds, but also provide visual relief and tranquillity to townspeople who otherwise get tired of the hustle and bustle of the town.

People busy with their daily life will at least be able to enjoy the greenery because, after all, people appreciate beauty, said the

China announces retaliatory sanctions

China announced "corresponding sanctions" against the United States yesterday after Washington penalised senior Chinese officials over the treatment of minority Uighur Muslims in the western region of Xinjiang.

China's move comes as relations between the world's two biggest economic powerhouses have slumped over disagreements on issues including the coronavirus pandemic, trade, Huawei and a sweeping national security law imposed on Hong Kong.

The sanctions targeted Senators Ted Cruz and Marco Rubio, US Representative Chris Smith, Ambassador at Large for International Religious Freedom Sam Brownback and the US Congressional-Executive Commission on China.

Rubio and Cruz have both sponsored legislation that would punish China's actions in Xinjiang. Smith has also been a vocal critic of China on issues ranging from Xinjiang to Hong Kong and the coronavirus. All three are members of President Donald Trump's Republican Party.

"The US actions seriously interfere in China's internal affairs, seriously violate the basic norms of international relations and seriously damage Sino-US relations," Chinese Foreign Ministry spokeswoman Hua Chunying told reporters. "China will make further responses based on how the situation develops."

UN experts and activists say at least a million Uighurs and other Muslims are held in detention centres in Xinjiang. China describes them as training centres helping to stamp out terrorism and extremism and give people new skills.

The Congressional-Executive Commission on China monitors human rights and the development of the rule of law and submits an annual report to Trump and Congress.

Immunity may not last

Warns study; UN says world hunger worsening amid pandemic

Patients who recover from coronavirus infections may lose their immunity to reinfection within months, according to research released yesterday that experts said could have a "significant" influence on how governments manage the pandemic.

In the first study of its kind, a team led by researchers from King's College London examined

the levels of antibodies in more than 90 confirmed virus patients and how they changed over time.

Blood tests showed even individuals with only mild COVID-19 symptoms mounted some immune response to the virus. Of the study group, 60 percent showed a "potent" viral

response in the first few weeks after infection. However, after three months only 16.7 percent had maintained high levels of COVID-19-

neutralising antibodies, and after 90 days several patients had no detectable antibodies in their bloodstream.

The research suggests immunity cannot be taken for granted and may not last more than a few months, as is true with other viruses such as influenza.

Experts said the findings may change how governments plan for the next phase of the pandemic, including how they fund and organise vaccine research and development.

Meanwhile, according to a United Nations report published yesterday, nearly one in nine people in the world are going hungry. Economic slowdowns and climate-related shocks

are pushing more people into hunger, while nutritious foods remain too expensive for many, contributing not only to undernourishment, but to growing rates of obesity in all. Nearly 690 million people, or 8.9

percent of people around the globe, are hungry, the UN found. That number rose by 10 million people in just one year to 2019, found the study, which said eradicating hunger by 2030 - a goal set five years ago - will be

impossible if trends continue. Five United Nations agencies co-authored the report: the Food and Agriculture Organization (FAO), the International Fund for Agricultural Development (IFAD), the United Nations Children's (UNICEF), the World Food Programme (WFP) and the World Health Organization (WHO).

Nepal landslides toll rises to 60

Four days of continuous heavy rain and landslides have killed 60 people in Nepal. 41 people are missing, authorities said vesterday.

Myagdi district in western Nepal is the worst affected with 27 deaths. Rescue operations are under way. Hundreds have been displaced as landslides buried their homes. Local school buildings and community centres have been turned into shelters for the flood-affected people.

"In the first phase we rescued the injured people and that took us around 30-35 hours to complete. Now, we are continuing our search operation for the missing who are believed to be buried under the debris. Identification of the dead and arrangements for their cremation are being done, ' Thamsara Pun, village head of Dhaulagiri in Myagdi said.

Landslides and floods are common in the Himalayan country during the monsoon season. Landslides have also blocked roads and mudslides are hampering rescue operations, say local news reports. Last week, at least 12 people were killed in landslides

and 19 others missing, the country's police said on Friday. Three children are among those who died in landslides. Narayani and other major rivers in Nepal are swollen due to the continuous downpour in the last few days. Earlier, the meteorological office of Nepal had predicted

Taliban attack on Afghan intel office kills 10

Taliban militants clashed with security forces following a car bomb blast at a government compound in northern Afghanistan yesterday, killing ten people and wounding dozens more, officials said.

Sketching out the shades of discrimination laws: Colourism in context

THE Black Lives Matter campaign inspired informed debates and discussions on racism and colourism across the world. In this backdrop, several notable beauty conglomerates recently decided to remove words like 'white/whitening' and fair/fairness from their products' packs and communication with a view to evolving their skin care portfolio to a more inclusive vision of beauty. This move has resurfaced the debate on whether colour is as much a prohibited ground of discrimination as is race, among several other issues. Race and colour are seemingly overlapping but distinct grounds of discrimination. Although colourism is deeply

entrenched in our culture, skin colour is yet to be popularly considered as a prohibited ground of discrimination in Bangladesh. We submit that a creative interpretation of the provisions on discrimination in the Constitution on their own and a reading of the said provisions and international jurisprudence in tandem can accommodate 'colour' as a prohibited ground of discrimination. Additionally, we advocate for legislative and policy measures addressing commercials of products perpetuating a particular type of colour-based superiority.

The provisions pertaining to equality were among the least disputed or discussed provisions of the Bangladesh



Constitution in the Constituent Assembly Debates. Articles 28(1) and 29(2) list 'race' as one of the prohibited grounds of discrimination. The English text gives the impression that 'colour' is not a prohibited ground of discrimination as such. However, the proviso to article 153(3) of the Constitution states that in the event of conflict between the Bengali and the English text, the former shall prevail. The Bengali equivalent for the word race is 'barno', which is inclusive of both 'colour' and 'race'. In an event of conflict between the inclusive expression 'barno' and exclusionary English terminology, 'race', 'barno' shall prevail. This implies that even a very literal interpretation may make room for having colour as a prohibited ground of discrimination.

If such an interpretation fails to stand scrutiny, resort may be made to comparative constitutional law jurisprudence concerning 'discrimination on the basis of unlisted grounds.' As far as such jurisprudence concerns, discrimination based on listed grounds is presumed to be unfair, but no such presumption exists in case of discrimination based on unlisted

grounds. However, in any event when the party having the onus to prove that the discrimination based on any of the unlisted grounds is unfair, succeeds in proving so, his/her claim shall stand [see, Larbi-Odam v MEC for Education (North-West Province) (Constitutional Court of South Africa) (1998)]. Additionally, the duty of domestic courts not to straightaway ignore international obligations (as espoused in a number of judicial decisions in Bangladesh) and to let international law fill in for 'vacuum' in domestic law, too can come in play.

While including 'colour' as a ground of discrimination seems an arduous task (if not impossible) in the domestic context, international jurisprudence suggests otherwise. Historically, colour and race were used almost interchangeably. The issue arose while drafting the non-discrimination provisions of the Universal Declaration of Human Rights (UDHR). While one group supported retaining the four original grounds of the UN Charter (i.e. race, sex, language and religion) and understood race to include colour, others raised concerns that race and colour are not concepts that 'necessarily cover one another'. Ultimately, both race and colour were included as

prohibited grounds of discrimination. Both race and colour have been recognised as prohibited grounds in major human rights treaties to which Bangladesh is a party, including International Covenant on Civil and Political Rights (ICCPR), International Covenant on Economic, Social and Cultural Rights (ICESCR) and International Convention on the Elimination of All Forms of Racial Discrimination (ICERD). General Comment no. 18 of the UN Human Rights Committee notes that some prohibited grounds of the ICCPR are absent in several Constitutions and inquires about the significance of such omission. General Comment no. 31 reaffirms a state party's obligation under article 2 of the ICCPR to adopt legislative, judicial and administrative actions to uphold the rights guaranteed under the Covenant. In the same vein, the Committee in its 2017 Concluding Observations of Bangladesh's initial report reiterates the need for an anti-discrimination law containing a 'comprehensive list of grounds' including colour. The absence of anti-discrimination laws has also been highlighted in multiple observations of the Committee on the Elimination of Racial Discrimination (CERD) to Bangladesh's state party reports.

Over the past decades, civil societies and activists have consistently expressed disapproval of the beauty brands and their advertising tactic of portraying dark-skinned women as unattractive, unhappy and professionally unsuccessful individuals. Prohibiting beauty brands from selling skin lightening products may be seen as an encroachment on their business. However, allowing them to air commercials portraying the superiority of a particular skin colour (which in turn creates artificial colour-based hierarchies in society) may not be condoned

either. It is also very difficult to draw a separating line between the effects of manufacturing a skin lightening product and those of its commercials.

Such commercials perpetuate a social stereotype on the basis of colour which, alongside giving birth to many societal evils, tends to have a disproportionate impact across sections of the society who are likely to fall for drastic or immensely unsafe measures for lightening their skin colour. Some countries have adopted specific legislative measures addressing discrimination in advertising. Finland's Consumer Protection Law was amended in 2008 to prohibit discriminatory advertising (on an array of nonexhaustive grounds). A self-regulating ethics council came in place to oversee such matters. Similarly, in India, Drugs and Magic Remedies (Objectionable Advertisements) (Amendment) Bill 2020, has sought to bring skin lightening advertisements within the purview of law.

The recent decision of the beauty brands of renaming their products seems commendable. However, this decision also has the potential of downplaying the societal stereotypes perpetuated over the years. At this point, the issue of letting colourism sustain across generations through commercials and the sale of skin lightening products need to be rethought.

The Anti-Discrimination Bill which is yet to be passed as an Act of parliament in Bangladesh, is drafted in Bangla and uses the expression 'barno'. While upon coming into being as an Act, this bill too may fall short on making business entities compliant by making room for an expansive and inclusive interpretation, a combination of overarching policy guidelines and legislative initiatives may do the job.

Digital payment system to boost up the operation of virtual courts

THE Covid-19 crisis has tremendously increased the use of internet and accelerated the digitalisation of many businesses and services through introducing teleworking and video conferencing in different sectors. Just after the outbreak of the coronavirus, many countries having e-readiness took immediate steps to conduct judicial proceedings online. Bangladesh also embarked upon its journey of conducting judicial proceedings through virtual courts on 11 May, 2020.

The initiative of introducing virtual courts has already been praised by many, and to make this initiative more effective, introducing digital payment of fees (chargeable under the Court Fees Act 1870, compensation and fines leviable under the Civil Procedure Code 1908 and the Criminal Procedure Code 1998) applying Mobile Financial Service (MFS) is now felt necessary. Otherwise, the objective of introducing virtual courts may remain incomplete.

During the outbreak of the pandemic, the MFS has turned into one of the major tools of payment for individuals as most of the financial activities have gone online. Moreover, mobile phones are also becoming more accessible across the country and it is time to use these devices to

boost up the economy. According to the BTRC, the total number of mobile phone subscribers has reached 162.920 million at the end of this April, while the number of active internet connections has crossed the landmark of 10 crore this year.

It is to mention that the Court Fees Act, 1870 was amended in 2016 making provision for collection of fees electronically or digitally. According to section 25 of the Act, the government may appoint, in addition to scheduled banks, any MFS providers to receive court fees including fees chargeable for serving and executing processes issued by a certificate-officer in the proceedings in execution of certificates filed for recovery of land revenue or rent collectible in cash, electronically or digitally. In that case, MFS providers who receive fees shall be required to grant a receipt or e-receipt accordingly. The Act also mandates the government to make necessary rules, from time to time, for regulating the collection of such fees through MFS. However, the provision is yet to be implemented.

It is high time the amended provision of the

Act was implemented as transactions through MFS accounts are increasing every year due to the rising acceptance of digital payments by private and public entities. Even amidst this coronavirus outbreak, the MFS was resorted to disburse the stimulus packages announced by the government which include BDT 5,000 crore for payment of salaries of RMG workers and BDT 1,250 crore cash assistance among five million poor families hit hard by the pandemic. According to Bangladesh Bank, through MFS accounts there was average daily transaction of Tk. 1,425.34 and Tk. 1,283.39 crore in February and March of this year respectively and total number of active MFS accounts have reached 26.845 million till March of this year.

In addition to the foregoing, the government may issue directives for collection of compensation, fines, stamp duties and registration fees through MFS which will ensure more revenue collection for the government and contribute to the reduction of corruption as well. If such fees and fines are collected through MFS, litigants will be able to pay fees or fines relating to the suit or case without hassles and the

judiciary will be able to make its accounts more transparent. With the vision of Digital Bangladesh, the use of technology is currently reshaping every government level operation. It is expected that the government will take all necessary measures to introduce digital payment

system through MFS accounts in the country's judicial system. Bangladesh Bank has to come up with necessary directives for MFS providers to ease the collection of revenues through MFS accounts. The Supreme Court may also come up with a short-term, mid-term, and long-term action plan to introduce digital payment system in all courts across the country and make virtual courts sustainable.

Though the need for virtual courts only arose due to the unprecedented outbreak of the pandemic, the demand for e-judiciary is long awaited. The law ministry had taken a project worth Tk. 2,690 crore to establish e-judiciary even last year. The abstract idea of stepping into e-judiciary is now seemingly real with the enactment of the new Act. While we cannot predict how long the crisis will last, introduction of digital payment for collection of fees, fines or compensation would make the initiative of virtual court or e-judiciary more effective and successful.

Need for legal reform to regulate business ethics

THE study of business ethics and practices deals with issues like lack of corporate governance, insider trading, rampant practice of bribery, presence of discrimination, absence of corporate social responsibility, etc. At times, law guides the business ethics; but it is the basic framework that businesses may follow to gain public acceptance, and this is where lies the essence of business ethics. Developing ethical standards for businesses is crucial not only for the leaders to act virtuously as an example for the rest of the employees, but also for everyone associated with businesses to be diligent towards enforcement of policies and be realistic. Although, maintaining ethical expectation at all times may not be feasible and rules will inevitably be broken, therefore, the organisations/enterprises need to accept zero tolerance towards unacceptable business behaviours.

Although there exist critics who

do not believe in relying in the use of 'law' to evaluate 'ethical standards' of an organisation and tend to say that it cannot be said – if it is legal than it is ethical, or that anything not prohibited by law is obviously proper and ethical or to assume that legal standards articulate or establish ethical principles, since law and rules do not depict what a professional ought to do to be ethical. It is also true that enterprises/ organisations that lay the framework for business ethics in all features of operation are more likely to become and remain profitable than those who conduct their business in an unethical manner. Statistics from the last two decades have been quite enlightening as it has been seen that businesses succumb to core ethical standards impacting not only their immediate shareholders but also the industries and entire economy of the country. However, in the last decade or so, the responses from the business community towards violation and breaches of integrity are growing wider and stronger, which is encouraging as societies or for that matter companies are creating better ways to address the issues of eroding values, integrity and ethics. Anyways, the bottom line remains, for long term sustainability to a great extent depends on policies, standards and the legislative support, i.e., legal enactments,

statute and rules towards the framework



of business environment. In Bangladesh, the failure of legislative support towards effective good governance has resulted significantly for lack of business ethics and unsatisfactory culture of corporate social responsibility. Enterprises in private sector is busy in earning profit ignoring question of responsible behaviour by not bothering to earn trust and respect of their consumers/ customers; issues like sell of adulterated products, asking exorbitant prizes, capitalising certain product name and goodwill, fraudulent practices in weight and measurement, hoarding to earn profit with dishonest intentions are all such phenomena that signify the present scenario of business world in the country

Leaving aside the laws relating to companies/corporations where huge capitals are invested and also, some statutory provisions/requirements as well as social dicta do exist to encourage a culture that would further the practice of ethics and corporate social responsibility, the reality under the Partnership Act, 1932 is not at all congenial, rather to certain extent demoralising. The legal framework towards Rules on Conduct in the management of partnership business as contained under Chapter III and IV of the 1932 Act fails to demonstrate whether at all the legislature had any good intention to integrate ethics and social business etiquette as business standards, strategies and goals behind

the back of their head while making the law.

A review of the scheme as envisaged under sections 9-16 of the Act (in terms of broad headings of partners' rights and liabilities, rules of conduct for partners while participating in management of their business and concerns of mutual rights and liabilities) does not demonstrate any concerns for ethical behaviors of partners, or for that matter, 'aspects of social responsibility' of the entrepreneurs. Rather sections 12, 13 and 16 explicitly allow partners to determine their internal business environment freely 'as they like', since the above sections are all subject to contracts that partners may choose to decide, thereby possibly ignoring the prescribed legal requirements that were contemplated by the legislature.

The above observations may, to certain extent, be acceptable for the reason that the 1932 Act is an age old law of British period, and hence, the legislature could not contemplate modern expectations of business ethics and corporate social responsibility to be incorporated in the law. Almost 75 years have passed and modernity in business practices now demand the law to be amended to accommodate or totally be reformed (as Companies Act, 1913 was done) to incorporate present-day views of ethical practices and corporate social responsibility.

Child marriage has spiked during the pandemic

Monitoring and enforcement of law must be more vigorous

CCORDING to a telesurvey report conducted by Manusher Jonno Foundation (MJF), child marriage has sharply increased. MJF found 462 girls being married off in June, and 170 girls getting married in May. With families becoming poorer due to job losses and schools being closed, push factors have driven up the number of child marriages and this will likely continue if no interventions are made.

Poverty is a major driver of child marriage, but other factors include the illegal but widespread practice of giving dowry (where the younger the bride, the less will be the burden of dowry on the girl's family), and the general failure of the state to provide security to girls and women. Despite education being free till secondary school, girls are forced into marriage due to these factors. Growing awareness of the ills of child marriage have inspired organisations, public officials and law enforcers to stop child marriages, but these efforts have been too few and far between to make a major impact.

According to Unicef, Bangladesh has the fourth highest rate of child marriage in the world. This is hardly in line with our Sustainable Development Goals, which includes eliminating child, early and forced marriage by 2030. We are a signatory of the UN Convention on the Rights of the Child and have our own Child Marriage Restraint Act that stipulates 18 years to be the minimum age of marriage for a girl But the introduction of a special provision in the law that allows child marriage in "special circumstances" has created a legal loophole that allows parents and guardians to marry off their daughters long before they reach 18.

There is little doubt that child marriage is detrimental to society in every way. Children are robbed of their childhood, subjected to sexual violence, undergo risky pregnancies and deliveries and may even die during childbirth. They also have underweight babies who may either die early or be stunted for life.

On paper, Bangladesh is in total agreement that child marriage is an evil that needs to be eliminated. But in practice, the government and society in general has not done enough to remove this malaise, which is likely to get worse in the coming months. The government must therefore jumpstart its national plan of action to end child marriage, with special monitoring mechanisms during this pandemic. This means building greater awareness through media campaigns and enforcement of anti dowry and anti child marriage laws. The special provision that allows for child marriage must be removed. Religious leaders must be brought on board to help in this fight against child marriage. Public officials and law enforcers must all be part of this endeavour so that all members removed permanently in the best interests of our

High positive cases despite low testing is bad news

Extensive testing and enforcement of health guidelines are crucial

recent report in this daily shows that the coronavirus positivity rate in the country has soared in the last few days, despite a decline in the number of tests during this period. Frighteningly, the rate was 24.11 percent—the highest single-day positivity rate since the first case was detected on March 8, while the total number of infections in the country stood at 1,83,795 during the time of the report. The data gathered suggest that the transmission of the virus is declining in the urban zones but is on the rise in rural areas. These facts and figures hardly give us the true picture of the spread of the virus.

As we have repeated ad nauseum, without widespread testing, we will never be able to gauge the trend of the virus. It is deeply concerning that the number of Covid-19 tests has dropped significantly in recent weeks after the government imposed fees-Tk 200 (if samples are given to dedicated sample collection booths or public hospitals) and Tk 500 (if samples are collected from home)—on the tests from the beginning of this month. It is obvious that such a decision will surely be discouraging for the general public, especially the poor. At a time when it is crucial to conduct mass testing in every possible community, putting a price tag on it hardly seems wise. This means fewer people will get tested although the trend shows that more and more people are infected, resulting in infected individuals unknowingly spreading it to others. Unless people are tested and contact tracing is done with isolation and treatment for those who test positive, how the pandemic will be contained remains a mystery.

As we struggle with the worst public health crisis in the history of our nation, the government ought to boost up vigorous testing immediately—for free. It is important, moreover, that test reports are provided quickly so that appropriate actions can be taken. The government should identify hotspots, monitor the cases, systemically implement contact tracing and keep an accurate record of positive cases. Mass testing should continue uninterrupted. Better knowledge of the ground realities can guide us to take the most effective measures in tackling Covid-19.

human being like you and need the same basic rights which you enjoy. Please don't hate us. We don't want to be a burden. Allow us to study and work, and stand by us. We

will surely return home."

This was the ardent appeal of Sharifah Shakirah, who fled to Malaysia from Buthidaung township in Myanmar at the age of six. Sharifah was joined by four

other Rohingya youth at an eSymposium on June 9 to share their experiences of the Covid-19 situation in their respective countries of asylum.

The Covid-19 pandemic has wreaked havoc on the lives and livelihoods of people all over the world. It has

disproportionately harmed the marginalised—refugees, asylum seekers and the stateless people. The Rohingya survivors of Myanmar's genocide are no exception.

Rohingyas living in Burma are being subjected to state sponsored stigmatisation after the outbreak of Covid-19. Although so far one Rohingya and two Rakhines have been infected, the local authorities and the media are engaged in a hate campaign against the Rohingya, claiming "Bengalis", the slur word for Rohingya, have entered

Myanmar illegally and have brought

coronavirus with them. This has resulted in

a sharp increase in hate speech against the

Rohingya on Burmese social media.

The conditions of the Rohingyas in the internally displaced persons (IDP) camps in Burma are particularly dire. With a plethora of discriminatory restrictions, famine like conditions prevail in northern Rakhine. In violation of the explicit order of the International Court of Justice to protect the Rohingya, the Burmese government continues to pursue its genocidal policies against them, causing internal displacement of thousands. Many more are forced to flee to Bangladesh and the other countries of south-east Asia.

There are more than one million Rohingya in Bangladesh, 300,000 in Saudi Arabia, 150,000 in Malaysia, 30,000 in India and tens of thousands more scattered across the world. The refugee camps have very rudimentary facilities and are almost never well resourced. The lockdown has increased the suffering of the residents as problems of water supply, shelter repair and food supply appear, and health care services dwindle. Most Rohingyas in informal camps and shanties in urban settings live in crowded conditions, with poor water and sanitation facilities. All these make them particularly vulnerable to Covid-19.

vulnerable to Covid-19.

A large number of Rohingyas have to fend for themselves and work as wage labourers in the informal sector. The lockdowns and the overall economic slowdown have robbed them of livelihood opportunities and pushed them into an abyss of malnutrition and hunger. The absence of any social protection mechanism has further exposed them to coronavirus infection and other diseases.

Hundreds of Rohingya are passing a dreadful time in detention camps, many for years. Bereft of any contact with their loved ones, most cannot secure legal support. Scores of cases exist in which Rohingyas who served out their sentences still remain incarcerated, as authorities deny their release since Burma is not

willing to take them back

Curtailment of physical movement even within the refugee communities, mistreatment, threats of reduction of food or forcible relocation to uninhabited natural disaster prone sites, and sustained policies of internet ban in some states, have been of major concern to the members of the Rohingya community.

Refugees and asylum-seeking Rohingyas are being subjected to various forms of exploitation. Those who can still find work may have to work longer hours with reduced wages, and face degrading treatment. The condition of women and children is distressing. The presence of men at home for most of the day, compounded with additional stresses and strains, makes women vulnerable to domestic violence. The prolonged closure of counselling and legal aid clinics due to Covid-19 has further limited their ability to seek support.

Hate crimes against the Rohingyas in different countries have been widely reported. Often such stigmatisation, hate crime and xenophobia are state condoned and echo the genocidal ideology of Myanmar, the principal perpetrator of

to understand that "being refugees is not our choice; circumstances compel us to move to other lands".

The panelists regretted that most states and international actors continue to pander to the genocidal Burmese state and refuse to acknowledge Rohingyas "as Rohingyas", refrain from calling mass atrocities and crimes against the Rohingya "as genocide" and decline to term people fleeing genocide by crossing borders "as refugees". Needless to say, these acts of omission are nothing less than condoning genocide.

The Rohingya community is disappointed that they are left out of the decision making processes that involve their life and their future. Projects for refugees are designed by national and international bureaucrats, without any input of the community, nor is there any independent assessment about their efficacy. The publicly funded "big organisations do not consult us. They sign secret agreements without our knowledge and they make covert plans about our future with the country that committed genocide against us", noted the Coordinator of Free Rohingya Coalition (FRC).

communities after their eventual return home, then all Rohingya children and youth ought to be given the opportunity to develop their human potentials by arranging their access to appropriate education and skill development. There is an urgent need by all quarters (host states, donor agencies, intergovernmental actors and NGOs) to recognise the community's agency and create opportunities for self-empowerment and entrepreneurship. This will reduce the pressure on the host countries and international actors, as well as prepare the community members for their eventual reintegration in Arakan after their return to Myanmar.

The Rohingya members acknowledged the adverse impact of the refugee flow on the host communities and economic and environmental costs that countries like Bangladesh have to bear. They felt Burma should be made to pay appropriate reparation to the countries that are adversely affected by its actions, contributing to the refugee flow and incurring huge costs: social, economic and environmental.

Highlighting the ignominy that refugees and asylum seekers often have

All these conditions are propitious for human traffickers. Anecdotal evidence indicates that, taking advantage of the worsening condition of the Rohingyas in Covid-19 situation, trafficking and human smuggling syndicates have bolstered their operations to aggressively recruit Rohingyas in distress, both in Arakan and in countries of asylum. Currently, the region is experiencing the plight of the Rohingyas drifting on traffickers' boats with little food, drinking water or energy supplies in the Andaman Sea and the South China Sea. Torture, rape and degrading treatment are rife in the boats. These are stark examples of the Rohingyas' predicament, who have been subjected to both border closures by states and extortion by the traffickers. One panelist noted "in Myanmar, Rohingyas have no future and lead a sub-human life. They are forced to take help of traffickers to escape the atrocious conditions at home". Another made a fervent plea for the world

The panelists felt strongly about the efforts to securitise the Rohingya issue by a vested quarter. The burgeoning discourse, shaped by the manipulative Burmese state in connivance of pliant global media and some powerful states that have important stakes in Burma, of presenting the Rohingya as a security threat, needs to be countered by facts (and not perception), they argued. Such flawed approaches fail to acknowledge the reality—that Rohingyas are survivors of genocide.

The disenchantment of the Rohingya panelists about the "great democracies who champion freedom around the globe" was palpable. Thus far, the sternest action taken has been "banning a few members of the regime from vacationing in their countries". "This is not only travesty of justice; it is an indictment of the vested economic and political interests that these countries are mired in in Burma", the FRC Coordinator observed.

The panelists argued that if the Rohingya are expected to rebuild their



International Blockchain Olympiad 2020

The youth of Bangladesh shine on the world stage



N the last four months, the country has been swept up in the shadowy spectre of the coronavirus, snuffing the life out of our near and dear ones before their time. Lockdowns.

sanitisers, face masks and social distancing have dominated public discourses of late.

In all this gloom and despair, the news of university students and recent graduates from Bangladesh winning two of the top six awards at the recently concluded International Blockchain Olympiad held in Hong Kong is truly a breath of fresh air.

Blockchain is a very new technology that gained traction globally after Bitcoin—the very first cryptocurrency in the world based on the freshly-minted blockchain technology paradigm—debuted in 2009. Today, there are hundreds of use-cases of blockchain implementation, not just in crypto or digital currencies, but in everything from supply chain provenances, self-sovereign identities, user-centric medical records and

even Covid-19 contact and tracing. For those interested in blockchain, a primer on this new technology can be found in an earlier column printed in this daily under the title "Blockchain: Ticket to universality of truths?"

Bangladesh could join this select group
of countries that competed on the
international stage to showcase real-world
applications of blockchain and bring
home two of the top awards on its maiden
attempt. To be specific, the International

organising the event to promoting it and conducting the competition to even holding the award ceremony— everything was done online leveraging all the platforms at the disposal of society today. Emails, Facebook Messenger, Google Meet, Online Portal, WhatsApp, Zoom—the whole alphabet soup of modern tools and apps were put to effective use in planning, mobilising and conducting all aspects of the Blockchain Olympiad Bangladesh fully online, with participation from more than 450

Now we need to nurture such world-winning projects for professional deployment in our own soil, so that these very talented young minds don't have to seek opportunities elsewhere for realising their potentials.

Blockchain Olympiad itself is only three years old, which is organised by the City University of Hong Kong in partnership with the Hong Kong Blockchain Society.

Though new to this field, Bangladesh marked a historic milestone when it held its first national blockchain Olympiad in April this year, bypassing the pandemic lockdowns by going fully online. From

students and recent graduates from all parts of the country and the involvement of more than 60 organisers, jurors and mentors from diverse professions in government, academia and the industry. The Blockchain Olympiad Bangladesh has certainly been a trendsetter in fully-online operations that has already encouraged many other entities to adopt this method

in overcoming the restrictions imposed by the Covid-19 pandemic.

The 12 teams that were finally nominated by the Blockchain Olympiad Bangladesh organising committee to compete in the International Blockchain Olympiad held on July 3 to July 5 in Hong Kong, were intensively mentored and coached by nearly 30 top government, business and academic professionals over a period of one month. This helped the contestants improve and fine-tune their projects to the point where all 12 of them were awarded the certificate of merit—the only country to have been thus recognised.

The outstanding success of the young blockchain enthusiasts with some nudging from the professional elders proved once again that given the opportunity and right kind of guidance, our youth can compete with the best in the world and hold their

What do we do with the refuse of our Covid-19 afflicted healthcare system?



has remained a persistent problem for Bangladesh. Proper disposal of these wastes—general, infectious, hazardous, radioactive, and often containing pathogens—has never seemed to be taken

seriously by the authorities, resulting in rampant mishandling by all concerned. This newspaper has published numerous lead stories on this over the last few years, and written dozens of editorials, but these seem to fall on deaf ears. And while the hazards posed by mishandling of medical waste are myriad and dangerous, they have been exacerbated by the ongoing global health emergency, putting millions of lives at risk of contamination.

Although according to the Directorate General of Health Services (DGHS), any healthcare facility must have an incinerator, autoclave and effluent treatment plants to dispose of hazardous medical waste, in reality, only a few do. The operational ability of many of these facilities are also questionable at best. Let's take the case of Rajshahi for example, as pointed out in a report published on December 22, 2019, titled "Inaction making situation worse". While there are 205 healthcare centres in Rajshahi, there is only one incinerator, and that too in derelict condition—in fact, its chimney had broken down at the time the report was published. Even with a fixed chimney, the efficiency of the venerable incinerator remains uncertain—its burning capacity having fallen to 300 degree celsius from the required 3,000, as mentioned in the report.

Covid-19 has made the task even more difficult, for many reasons. First of all, the volume of medical waste has

ANAGEMENT increased significantly in the wake of the ever-spreading pandemic, and so have the kinds of medical waste. According to the Environment and Social Development Organization (ESDO), 14,500 tonnes of medical waste had been generated in the month of April alone in Bangladesh. Personal protective gear—especially masks, gloves and other one-time use items, featured prominently among the waste.

The problem is, these items are often not considered as medical waste-these items are after all "casually worn" by people to keep the germs at bay, and are equally casually dumped on the sideways, on the roads and in the open dustbins, like candy wrappers. A pictured published by this daily a few weeks ago, showed a PPE casually discarded near the Corona-isolation unit of DMCH. Used masks and gloves were floating on a fountain there. These images are symptomatic of the lack of understanding among PPE users of the significance of proper medical waste management, and perhaps even their apathy towards the issue.

Moreover, as reported by a local newspaper recently, some hospitals dump their medical waste in their backyards to be rid of them. These are later picked up by waste collectors—often young children who pick these up with their bare hands, gloves and masks being luxury items for them and transported to Matuail Landfill, near Kuwait Bangladesh Friendship Government Hospital, in small open vans or sometimes in garbage trucks. Scraps falling from these open vans or garbage trucks are not an uncommon scenario in Bangladesh, but while these are unpleasant sights under normal circumstances, they can be deadly during a pandemic.

But there is another side to this problem, a more sinister one: at a time of high market demand, discarded masks, gloves and empty bottles of hand sanitisers become valuable commodities, often traded on the black market and resold to the public, creating a greater risk of mass infection. According to

news reports, one such "trader" has been apprehended by law enforcers, but there might be others out there right now, selling used surgical masks, gloves, and fake hand sanitisers to innocent buyers in the streets.

At times, hospital authorities themselves become involved in the illegal trading of medical waste. In a report titled "Hospitals breach disposal rules", printed by this daily late last year, it was reported that "The main reason behind lack of proper disposal is that used plastic items can fetch money from the

Unable to deal with the surmounting volume of medical waste, some healthcare facilities are resorting to burning it out in the open, resulting in exposure of the people living in surrounding areas to the toxicity in the air released by the inappropriate burning of medical waste. Incinerators are recommended for burning medical waste for a reason, but only a few deign to care.

There is a set of "rules" to manage medical waste—the Medical Waste (Management and Processing) Rules 2008—



recycling businesses. While recycling without any harm to public health and environment is permissible, hospital records and evidence collected by The Daily Star point to the fact that even medical items made of plastic end up in the black market in connivance with the hospitals' authorities." While this is alarming even under usual circumstances, during a pandemic this can become fatal, putting hundreds and thousands of lives at

but it seems they are not being followed properly. For one, one of the rules suggest that "medical waste could not be mixed with other waste at any stage—while producing inside hospitals, while collecting from hospitals, while transporting, and would be processed separately based on classification". If we look around carefully, we would see the contrary mostly.

Perhaps it is the lack of political will on the part of the policymakers and concerned

authorities to deal with this persistent problem that had led to its snowballing, especially in the aftermath of the Covid-19 outbreak. We are in the middle of a pandemic and medical waste will only pile up in the weeks and months to come. The government, with whatever resources are available at its disposal, need to take immediate steps to address the situation before it endangers further lives.

The World Health Organization (WHO) and Asian Development Bank (ADB) have issued clear guidelines on how medical waste should be managed during Covid-19. The United Nations Environment Programme (UNEP) has also published a "Compendium of Technologies for Treatment/Destruction of Healthcare Waste" to support relevant authorities in fighting this other menace.

The authorities in Bangladesh should immediately form a committee consisting of medical experts, epidemiologists, environmentalists and legal experts to review the existing rules related to medical waste management and update them to face the emerging challenges posed by the upward trajectory of the pandemic.

Developed countries are now grappling to cope with the piling medical waste generated by Covid-19. And for Bangladesh, the situation is likely to get worse from here. Effective and immediate measures are now required to address this issue. The authorities need to learn from the best practices from countries that have already overcome the first phase of the pandemic, such as China and South Korea, and take inputs from the guidelines issued by WHO, ADB and UNEP, to prepare revised guidelines for Bangladesh. And of course, we need to ensure their strict implementation to make sure lives are not lost due to causes that could have been prevented. Our words are only as good as our actions.

Financialisation: Tackling the other virus

¬HE 1971 Bretton Woods (BW) system collapse opened the way for financial globalisation and transnational financialisation. Before the 1980s, most economies had similar shares of trade and financial openness, but cross-border financial transactions have been increasingly unrelated to trade since then.

Although Covid-19 recessions have rather different causes and manifestations from the financially driven crises of recent decades, financialisation continues to constrain, shape and thus stunt government responses with deep short-, medium- and long-term

It is thus necessary to revisit and contain the virus of financialisation wreaking long-term havoc in developing, especially emerging market economies. No one is financing work on a vaccine, while all too many with influence seek to infect us all as the virus is touted as the miracle cure to contemporary society's deep malaise, rather than exposed for the threats it actually

Global financialisation has spread, deepened and morphed with a changing cast of banks, institutional investors, asset managers, investment funds and other shadow banks. Transborder financialisation has thus been transforming national finance and economies.

The changing preferences of financial market investors have been reshaping the uneven spread of market finance across assets, borders, currencies and regulatory regimes. To preserve and enhance their value, new financial asset classes and relationships have been created.

Within borders, banks and shadow banks are lending to households, companies and one another, while national frontiers do not matter for securities and derivative markets, often financed via wholesale money markets.

Over the last four decades, the scope, size and concentration of finance have grown

authorities try to keep up with recent financial innovations and their typically transnational consequences.

Financialisation has involved reorganising finance, the economy, and even aspects of society, to enable investors to get more from financial market investments, effectively undermining sustainable growth, full employment and fairer wealth distribution. The following measures should help slow

financialisation and limit some of its adverse

Strengthen international financial regulation: While financialisation has become transnational, financial regulation remains largely national, albeit with some transborder effects of the most powerful, e.g., US tax rules and Fed requirements. Transnational finance has often successfully taken advantage of loopholes and "arbitrage" to great profit.

Multilateral cooperation to strengthen effective and equitable regulation will be difficult to secure as voting power in the only multilateral institution, the International Monetary Fund (IMF), remains heavily biased against developing countries.

Strengthen national capital account management: Transnational financialisation has made developing countries more vulnerable to transnational finance and its rent-gouging practices, while also causing greater instability, and limiting policy space for development.

Although the IMF's Article 6 guarantees the national right to capital account management, all too many national authorities in developing countries, especially emerging markets, have been deterred from exercising their rights effectively.

improve national regulation of finance: Improving effective, equitable and progressive national regulation of finance, particularly market-based finance, remains challenging, especially in emerging market economies where typically divergent, if not contradictory, banking and capital market interests seek to influence reforms differently in their own specific interests.

Strengthen bank regulation: There were few banking crises from the 1930s to the 1970s after banking was strictly regulated following the 1929 Crash. With financial deregulation from the 1980s, major financial and currency crises have become more frequent. More effective regulation and supervision are urgently needed, not only of banks, but also of "shadow banks", that account for a large and growing share of transnational finance.

Make finance accountable: Instead of improving regulations to achieve these objectives, the growth and greater influence of finance have led to regulatory capture, with reforms enabling, not hindering financialisation, including its adverse consequences. Political financing reforms are also urgently needed to limit the influence of finance in politics.

Promote collective, not asset-based welfare: Financialisation has been enabled by the reduced role of government. Nationalising or

re-nationalising pension funds and improved government "social provisioning" of health, education and infrastructure would reduce the power and influence of institutional investors and asset managers.

Ensure finance serves the real economy: The original and primary role of finance to provide credit to accelerate productive investments and to finance trade—has been increasingly eclipsed by financial institutions, including banks, engaging in securities and derivatives trading and other types of financial speculation.

Such trading and speculative activities must be subjected to much higher and more appropriate regulatory and capital equirements, with commercial or retail banking insulated from investment or merchant banking activities, e.g., insulating Main Street from Wall Street, or High Street from the City of London, instead of the recent trend towards "universal" banking.

Promote patient banking, not short-termist profiteering: National financial authorities should introduce appropriate incentives and disincentives to encourage banks to finance productive investments and trading activities, and deter them from pursuing higher shortterm profits, especially from daily changes in securities and derivatives prices.

This can be achieved with appropriate regulations and deterrent taxes on securities and derivatives financing transactions. An alternative framework for banking and finance should promote long-term investment over short-term speculation, e.g., by introducing an incremental capital gains tax where the rate is higher the shorter the holding period.

Ensure equitable financial inclusion: While financial exclusion has deprived many of the needy of affordable credit, new modes of financial inclusion which truly enhance their welfare must be enabled and promoted. Ostensible financial inclusion could extend exploitative and abusive financial services to those previously excluded. In some emerging market economies, for example,

levels of personal and household debt have risen rapidly, largely due to inclusive finance

New financial technologies: Financial houses are profitably using new digital technologies to capture higher rents. While technological innovations can advance financial inclusion and other progressive development and welfare goals, thus far, they have largely served financial rent-gouging and other such exploitive and regressive purposes.

For example, while big data has been used to track, anticipate and stop the spread of infectious diseases, it has also been more commonly abused for commercial and political purposes. National regulators must be vigilant that ostensibly philanthropic foundations and businesses are actively promoting "fintech" in developing countries without sufficient transparency, let alone consideration of its mixed purposes, implications and potential.

Minimise tax avoidance: Besides curtailing and penalising tax avoidance practices at the national level, tax accountants, lawyers and others who greatly enable and facilitate tax evasion and related abuses should be much more effectively deterred.

Strengthen multilateral cooperation to equitably enhance national fiscal capacities: Governments must cooperate better multilaterally to more effectively and equitably tax transnational corporations and high net worth individuals. Such cooperation should effectively check illicit financial flows with strict regulations to deter private banking, banking secrecy, tax havens and other international facilitation of tax evasion.

Existing initiatives need to be far more inclusive of, sensitive to and supportive of developing country governments. OECD led initiatives previously excluded developing countries, but their recent inclusion, while an advance, remains biased against them.

There will be soaps and hand sanitisers at all polling centres, and all voters will have to use it before and after casting votes, he said, adding that all election officials and voters would be wearing masks.

Voters will stand in line by maintaining a distance of at least three feet. Only one voter will be allowed to enter the polling booth at a time. All polling officials and agents of candidates will perform their duties maintaining proper distance, said the EC senior secretary.

"We have taken necessary steps to hold the elections peacefully," he said. While answering a question about the possibilities of low voter turnout due to coronavirus scare, Alamgir admitted that there is a chance of fewer people casting the vote.

Bogura-1 Jashore-6 and constituencies fell vacant following the deaths of ruling party lawmakers Abdul Mannan and Ismat Ara Sadique respectively.

The EC in February announced that by-elections to the two constituencies will be held on March 29. But they postponed the polls on March 21, considering the coronavirus situation.

On July 4, the EC said that elections to the two constituencies will be held on July 14.

There are about 5.22 lakh voters in the two constituencies -- 3.17 lakh in Bogura-1 and 2.04 lakh in Jashore-6 -- and voting will begin at 9:00am and continue until 5:00pm without any

There are 122 polling centres in Bogura-1 and 79 in Jashore- 6.

In Bogura-1 (Sonatala Sariakandi upazilas), five candidates are vying for the by-election, including AL candidate Shahdhara Mannan and Jatiya Party candidate Moksedul Alam. In Jashore-6 (Keshabpur), two

candidates are vying for the polls --Shahin Chakladar from the AL and Habibur Rahman Habib from the JP.

The BNP initially decided to take part in both the by-polls and collected nomination papers, but changed its mind and boycotted the elections when the EC declared the election date for the second time on July 4 amid the pandemic.

Locals said campaigns of only AL candidates were visible in the last few days. Many voters said they were not interested to go to the polling centres due to the fear of Covid infections, correspondents of this newspaper reported from Jahsore and Bogura.

Flooding in different areas of Bogura-1 may further lower the vote casting rate, said locals. Flood situation in Bogura is worsening again for the last two days.

Mamunur Rashid, 32, a resident of Chakratinath char in Sariakandi upazila, said as they had lost work due to the coronavirus and were dealt another blow by the flood, they could not even think of the election in this

"We are not interested to vote this time amid flood and coronavirus," said Hosneara Begum, 40, of Nawapara char under the same upazila.

EC Secretary Alamgir said 14 polling centers in Sariakandi and Sonatala were shifted elsewhere due to the flood.

Meanwhile, five people, including Intezar Rahman, 68, father of independent candidate in Bogura-1 Eyeasir Rahmatullah Entaz, were held with Tk 7 lakh from in front of Sonatala filling station on Sunday

Britain, France agree joint unit to fight migrant traffickers

The interior ministers of France and Britain on Sunday signed an agreement creating a new joint police intelligence unit to combat migrant traffickers and reduce the "unsustainable" numbers crossing the Channel illegally.

France's new Interior Minister Gerald Darmanin and his British counterpart Priti Patel met on Sunday in Calais in northern France, a regio where migrants have traditionally gathered in a bid to find a way to get

"We signed a new agreement to create a joint intelligence cell which

will crack down on gangs behind vile people smuggling operation," Patel wrote on Twitter after the meeting. She said they had discussed "the unsustainable levels of illegal

migration across the Channel." The Franco-British unit will allow services to share intelligence quickly and will consist of six British and six French police officers based in Coquelles outside Calais, Darmanin told reporters.

Traffickers "are those who take advantage of the human distress of people who want to cross the English Channel and who, no doubt, are not being punished sufficiently at the moment," said Darmanin.

The charity urged governments and donors to invest more funds behind a new global education plan to help children back into school when it is safe and until then support distance learning.

"We know the poorest, most marginalised children who were already the furthest behind have suffered the greatest loss, with no access to distance learning -- or any kind of education -- for half an academic year," Ashing said.

Save the Children also urged commercial creditors to suspend debt repayments for low-income countries -- a move it said could free up \$14 billion for education programmes.

"If we allow this education crisis to unfold, the impact on children's futures will be long lasting," Ashing said.

"The promise the world has made to ensure all children have access to a quality education by 2030, will be set back by years, " she said, citing the United Nations goal.

The report listed 12 countries where children are most at risk of falling behind: Niger, Mali, Chad, Liberia, Afghanistan, Guinea, Mauritania, Yemen, Nigeria, Pakistan, Senegal and Ivory Coast.

Flood takes a turn for worse

52 cm above the danger level at Teesta Barrage point and 64 cm above the danger level at Shimulbari point.

The Brahmaputra was flowing 45 cm above the danger level at Chilmari point in Kurigram yesterday morning, said local WDB officials.

According to the WDB and the Kurigram and Lalmonirhat district administrations, new areas are being flooded everv dav due to an abnormal rise in the water level of rivers.

Floodwaters have inundated 120 villages in 21 unions of Lalmonirhat's five upazilas. About one lakh people have been affected.

In Kurigram, flood has hit 250 villages in 42 unions of seven upazilas. It has affected about two and a half lakh people.

In Nilphamari, the Teesta was flowing 55 cm above the danger mark at Dalia point near the Teesta Barrage in Dimla upazila at 2:00am yesterday,

Rabiul Islam Lithon, chairman of Khagakharibari Union Parishad in Dimla upazila, said flooding has eroded about 80 percent area of Kisamoter Char, a shoal of the Teesta.

Tayeb Ali, 60, and his six family members are among the flood victims who have taken shelter on a groin dam across the Teesta. Tayeb said although they were unfed for days, nobody came forward with relief to help them.

In Sunamganj, the Surma was flowing 31 cm above the danger level at Sunamganj point yesterday morning. Over 70,000 families of the district's all 11 upazilas were affected in the last four days, said the district administration.

Flood victims are in distress as the crisis of food and drinking water is deepening.

Dilar Begum, an elderly woman from Hosenpur village in Sunamganj Sadar upazila, said she and her daughter-in-law used to work as day labourer to earn their living after the death of her son.

As they had no work for the last three months due to the Covid-19 situation and there is floodwater in their house now, it has become difficult for her to feed her four grandchildren, she added.



10m kids may never return to school

Warns Save the Children citing measures to contain Covid-19

The coronavirus pandemic has caused an "unprecedented education emergency" with up to 9.7 million children affected by school closures at risk of never going back to class, Save the Children warned yesterday.

The British charity cited Unesco data showing that in April, 1.6 billion young people were shut out of school and university due to measures to contain Covid-19 -- about 90 percent of the world's entire student population.

"For the first time in human history, an entire generation of children globally have had their education disrupted," it said in a new report, Save our Education. It said the economic fall-out of the crisis could force an

extra 90 to 117 million children into poverty, with a knockon effect on school admissions. With many young people required to work or girls forced into early marriage to support their families, this could see

between seven and 9.7 million children dropping out of school permanently. At the same time, the charity warned the crisis could leave a shortfall of \$77 billion in education budgets in low

and middle income countries by the end of 2021. "Around 10 million children may never return to school -- this is an unprecedented education emergency and governments must urgently invest in learning," Save the Children chief executive Inger Ashing said.

Global infections stand at 13 million, according to a Reuters tally, with more than half a million deaths.

UK using drones to send test kits

The UK's new Space Agency funding will be used to support drones that deliver coronavirus testing kits to a Scottish island.

Skyports, the company behind the drones, started a two-week trial in May with NHS Highland, which serves a group of islands off the west coast of Scotland.

The technology was able to cut delivery times between Oban and the Isle of Mull to around 15 minutes, instead of going via road and taking a 45-minute ferry crossing.

11 die after showing Covid-19 symptoms

At least 11 people died after showing Covid-19 symptoms in Cumilla and Satkhira in the last two

Eight of them breathed their last at Cumilla Medical College Hospital. According to the

hospital authorities, three died in 24 hours till 8:00am yesterday and five others from 8:00am Saturday to 8:00am Sunday.

The victims, residents of different parts of the district, were admitted to the hospital with fever, cold, and breathing difficulties. They were aged between 22 and 85, said Dr Mojibur Rahman, director of the hospital.

With the eight, 213 people have so far died at the hospital. Of them, 177 breathed their last with coronavirus symptoms and 36 after they tested Covid-19 positive since April.

Global record for daily virus cases

Says WHO as S Africa re-imposes nationwide curfew; Sri Lanka closes schools again

The World Health Organization reported a record increase in global coronavirus cases on Sunday, with the total rising by 230,370 in 24 hours as South Africa re-imposed a nationwide curfew and Sri Lanka ordered schools to shut again following a surge in new cases.

The biggest increases were from the United States, Brazil, India and South Africa, according to a daily report. The previous WHO record for new cases was 228,102 on July 10. Deaths remained steady at about 5,000 a day.

Latin America surged past the US and Canada to become the world's second worst-hit region for virus deaths yesterday as a Spanish court blocked a move to lock down some 200,000 people.

Since the start of July, nearly 2.5 million new infections have been detected across the globe, with the number of cases doubling over the past six weeks, according to an AFP tally based on official figures

Hong Kong re-imposed social distancing measures yesterday to combat a sudden spike in infections, banning more than four people from gathering in public, shuttering some businesses and restricting restaurants from catering to evening diners.
