



Six were injured after a bus plunged into a roadside canal in Janigaon of Sunamganj.

One killed, 12 injured in road accidents

Amid heavy rain and unfavourable road conditions, one person died and twelve were injured in accidents across three districts of the country yesterday.

Six people were injured as a bus plunged into a roadside canal in Janigaon area of Sunamganj. The accident took place around 10:30am when the driver of the vehicle lost control over the steering, said Sunamganj fire service's Station Officer Newton Das.

Fire Service and Civil Defence rescued six people, three of whom returned home after receiving primary treatment while the others were admitted at the hospital.

A team of divers from Sylhet and two units of Sunamganj Sadar and South Sunamganj fire services worked till 1:20pm to search for missing persons in the canal.

However, nobody was found and the search was declared over. Das added.

In Tangail, a truck driver died and his helper was injured when a truck fell into a roadside ditch filled with floodwater at Sadar upazila's Gharinda area yesterday.

The deceased is Akter Hossain (40) from Bogura. Md Shafiqul Islam, senior station

officer of Fire Service and Civil Defence in Tangail, said driver of the Bogura-bound wheat-laden truck from Dhaka lost control over the steering and the vehicle fell into the roadside ditch full with water. The driver died due to suffocation.

On information, firefighters rushed to the spot, rescued injured helper Md Asadul (50) and rushed him to Tangail General Hospital. Later, they recovered Akter's body and handed over to highway police.

In Jhalakathi, five were injured after a bus hit a leaning tree on the roadside at Rajapur upazila early yesterday.

The incident took place around 1:30am on Barishal-Jhalakathi-Bhandaria road. All five injured were passengers of the bus.

Quoting locals and victims, Jahid Hossain, officer in charge of Rajapur police station, said the bus of Saikat Paribahan was on its way to Pathorghata, Barguna from Chattagram via Rajapur upazila.

"The bus hit a tree at Boleybari. The roof of the bus came off from impact," he said.

On information, firemen and cops rushed to the spot. The injured were taken to Rajapur upazila health complex.

Rajshahi divisional commissioner, family members test positive

Rajshahi Divisional Commissioner Humayun Kabir Khondoker and his family members have tested Covid-19 positive and are on self-isolation in his government quarters.

His wife Nasrin Khondoker (45), and their son Tanjim Mahatab (17), also tested positive for the virus and they are staying with the 54-year-old divisional commissioner, the highest-ranking government official in the division.

The district's Civil Surgeon Dr Md Enamul Haque yesterday said that all the three family members tested positive on Monday night.

The divisional commissioner and his family members were staying at home most of the time other than essential government activities since the coronavirus began spreading, the civil surgeon said.

One of Khondoker's relatives visited their residence recently and later, the relative tested positive. Out of doubt, they had their samples tested, said the civil surgeon.

"Their health conditions are good and they are asymptomatic," he said.

In the last 24 hours, 75 people in the district tested positive, raising the tally of affected to 2,280. In Rajshahi city, the total number of the affected persons is 1,783.

In eight districts of the division, five persons died in 24 hours till 8am yesterday, raising the death toll to 138. At least 10,477 persons were infected with coronavirus in the division so far. Among the infected, 1,077 persons are undergoing treatment at different hospitals while 2,694 ones on home isolation. At least 4,592 persons recovered.

Inmate dies at CMCH

A prisoner of Chattogram Central Jail died yesterday morning while undergoing treatment at Chattogram Medical College Hospital (CMCH).

The deceased, Md Suman alias Five Star Suman (37), was from Ramganj of Laxmipur.

Kamal Hossain, senior jail superintendent of Chattogram Central Jail, told The Daily Star, "He came to the jail on August 1 last year after being arrested with yaba and firearms by law enforcers from Bayezid Bostami Police Station."

"He had suffered stroke in jail and fell sick on July 12 and was undergoing treatment at the hospital. He passed away this morning," he added.

The body was handed over to his family after autopsy.

US embassy hands PPE to armed forces

The US Embassy in Dhaka has provided personal protective equipment (PPE) to the Bangladesh Armed Forces Division (AFD) as part of its continued support for Bangladesh's Covid-19 response efforts.

US Ambassador Earl Miller and embassy representatives of the US Military's Indo-Pacific Command handed over the PPE to Lt Gen Md Mahfuzur Rahman on Monday.

This is the sixth in a series of planned PPE distributions from the US to Bangladesh. To date, the US has provided \$56.5 million in aid to combat Covid-19 in Bangladesh.

The US-donated equipment delivered on Monday includes surgical masks, washable face masks, hand sanitiser, surgical gloves, HAZMAT suits, and face shields. All of these were purchased from Bangladeshi companies.

AFD personnel are playing a key role in Bangladesh's Covid-19 response, supporting the public and Ministry of Health (MoH) initiatives throughout the country, including the opening of military hospitals to the public in support of Covid-19 treatment, said a statement of the US embassy in Dhaka.

Bank to constitute a nine-member committee to find out the loopholes in sanctioning, distributing and recovering the loans, and to make necessary recommendations and suggestions to this effect, he said.

Advocate Murshid said, "We have become aggrieved with the High Court directive as it did not direct the government to form a commission to look into the irregularities... That is why, we have filed the petition, seeking necessary directives to this effect."

The lawyer said he will place the petition before the chamber judge for its hearing soon.

Following the petition, the HC on November 3 ruled that loan defaulters must make down payment of 15 percent of outstanding amount to get fresh loans from any scheduled bank, as per the 2012 Bangladesh Bank circular.

The court, however, said the BB circular issued on May 16 last year will be valid for the next 90 days so that the borrowers can apply for rescheduling their bank loans.

The central bank issued the circular allowing borrowers, who became defaulters by December last year, to reschedule loans for 10 years by making a down payment of only 2 percent instead of the existing 10 percent.

The HC also ordered BB to constitute the nine-member committee. The central bank has also been ordered to follow the recommendations and suggestions of the committee.

The HC ruled that in future, any commercial bank has to appoint its top five officials, including the managing director, under the supervision of BB.

Besides, the minister said, Bangladesh is also producing and exporting drugs used in treatment of Covid-19 as the country over the years have developed its pharmaceutical industry.

The foreign minister instructed the ambassadors to apprise the Bangladeshi expatriates of the various incentives that

the government declared in addressing the fallout of Covid-19. He alerted them to be cautious about any negative propaganda against the country.

He said the government has declared a \$12.11 billion package to tackle the temporary strain that the country's economy is facing.

When contacted, Mymensingh city Mayor Ekramul Haque Titu, also an adviser of the organisation, said many throw away household waste here and there, obstructing sewerage system. BD Clean-Mymensingh's campaign can make people aware to some extent, he said.
