INTEL ON POSSIBLE 'MILITANT ATTACK' New security alert before Eid

The police have received intelligence that militant outfit "Neo JMB" could try to carry out attacks centring the Eid-ul-Azha.

The Police Headquarters has already instructed its various units to remain cautious about the Islamic State-inspired outfit and take necessary measures to prevent subversive acts.

The so-called IS has decided to announce formation of a new wing --"Bengal Ulayat" -- ahead of the Eid-ul-Azha. Analysing data on militant activities at home and abroad, it was found that such a declaration is made through a subversive act, the PHQ said in its instructions.

"Neo JMB" could try to carry out subversive acts. All police units need to be on alert and take necessary measures, it noted.

Talking to The Daily Star yesterday, Haider Ali Khan, additional deputy inspector general (intelligence and special affairs) at the PHQ, said, "We always take some preventive measures whenever there is any global development.

"The next month is August. In the past, militant outfits were found active in August. So we have stepped up security measures," he said.

The special units, including the Counter Terrorism and Transnational Crime (CTTC) unit, Anti-Terrorism Unit (ATU) and Rab have been asked to be on alert, he said.

"We have adopted a policy of zero tolerance against militancy as per the prime minister's directives...

According to intelligence, "Neo JMB" may choose embassies, religious institutions or police establishments as their targets.

Police officials have been instructed to beef up security, collect information on new tenants in cities, properly check identity of visitors to police installations, increase security in DMP's Diplomatic Division and religious establishments, and not to leave any police vehicles unattended, according to sources. 

Four months into the Covid-19 outbreak in the country, the government still appears to have no noticeable plan to contain the spread of the virus. Since the first three cases were reported in the country early March, the government departments supposed to deal with the crisis have been displaying inefficiencies and lack of coordination by making the wrong decisions, often ignoring the recommendations from expert committees.

While the country is witnessing a gradual rise in the numbers of death and infection, the need to control the raging coronavirus apparently became a secondary concern for the government centring most of its activities around restructuring the health services following a series of coronavirus testing scandals.

At least 2,23,453 people in the country have tested positive for the irus, and 2,928 of them died, and the fatality rate is on rise for the last

The Politico, an American political magazine, on Friday reported that US Attorney General William Barr "quietly reopened" the case as he directed the Board of Immigration Appeals (BIA) on June 15 to send Rashed's case to him for review.

The document doesn't include Rashed's name, but refers to "the matter of A-M-R-C," using his full initials. A lawyer for Rashed shared the Department of Justice (DOJ) communications with Politico.

"Barr's move is the first step in a process that could result in Rashed losing asylum after more than a decade and potentially facing deportation," it says.

Against this backdrop, public health experts cautioned that the number of new cases will rise by a lot if strict and effective containment measures are not taken during the Eid-ul-Azha holidays.

The country cannot afford to repeat the mistakes made before the Eidul-Fitr when thousands of people left the cities for their hometowns in crammed vehicles, ignoring social distancing rules. The daily new cases spiked soon afterwards.

But things are not likely to change this time.

The national technical advisory committee on Covid-19 had suggested not to let people leave Dhaka and three other major cities ahead of the three-day holiday from July 31-August 2.

But the government decided to let public transport operate, "maintaining" the health safety guidelines. In a circular issued on June 30, the cabinet division announced extending the duration of controlled movement and other restrictions until August 3.

Holidaymakers have already started leaving for their villages to celebrate the Eid with their loved ones and a massive rush is expected during the SEE PAGE 2 COL 2



Thousands of hectares of farmland damaged

The dreams of thousands of farmers in the floodhit areas of northern Bangladesh have been shattered as their crops and seedbeds washed away by floodwater.

In Lalmonirhat and Kurigram districts, around 40,000 farmers have been affected by the flood. Around 2,500 hectares of land have been damaged and about 20,000 hectares of arable land are still under floodwaters.

In Tangail, crops of over 11, 000 hectares of land have been inundated by the flood. As a result, around 27,000 farmers will have to incur loss, agriculture department officials said.

Nurul Haque, a farmer of Salangka village in the district's Kalihati upazila, said he cultivated Aush paddy in around 22 bighas of land but all have been inundated.

Shahed, who disclosed all this during interrogation in DB custody, was on a 10-day remand beginning on July 16 in the case filed for Covid-19 test report forgery and charging patients for testing and treatment, violating an agreement with the government, they added.

After five days of the remand, he was shifted to Rab custody.

In a development yesterday, Shahed was placed on a 28-day remand in four fraudulence cases -- seven days for each case -- filed against him with Uttara Paschim and Uttara Purba police stations.

Dhaka Metropolitan Magistrate Rajesh Chowdhury passed the orders after four separate investigation officers produced him before the court with a 40-day remand prayer.

Besides, Regent Group's Managing Director Masud Parvez was placed on a 21-day remand in three cases filed with Uttara Paschim Police Station.

Contacted on July 23, Kuddus Afrad, president of Dhaka Union of Journalists (DUJ), said he does not think Shahed used the media to cover up his crime.

"Rather, he used popular and influential figures in the society, people working in the administration. There were cases and warrants against him but law enforcers failed to act and take action.'

He further said intelligence clearance is required to get declaration for a newspaper. "When there were cases against him, how was it possible to get the clearance?" he questioned. COMPLAINTS PILE UP

Since Shahed's arrest in Satkhira on

July 15, many including businessmen, rickshaw pullers, job seekers, doctors and lawyers are communicating with law enforcers and filing complaints.

Talking to The Daily Star, a person from the capital's Khilgaon area claimed that he had to pay around Tk 2.5 lakh for his mother's stay in the Uttara branch of Regent Hospital for only seven days.

"My mother was admitted to the hospital with Covid-19 symptoms around 4:00am on June 2. She started to recover just a day after the admission. But the hospital authorities said they needed to keep her in the intensive care unit."

Requesting anonymity, he further said two days later, the hospital authorities shifted his mother to the general ward. On June 8, when they wanted to leave, the authorities handed them a bill of Tk 2.5 lakh.

Another victim said he stayed just

one day in the hospital with a leg injury but the bill came to Tk 50,000.

"I did not stay for a single hour in the intensive care unit but the authorities claimed that they kept me in the ICU," the man from Sylhet told this newspaper recently.

Investigators said they found complaints from a number of victims that they had to pay for an ICU bed despite staying in general beds.

If anyone refused to pay the bills, hospital staffers and in some cases Shahed himself would threaten to take his or her life, said a high official of DB.

"We have found a firearm from Shahed's personal vehicle. In primary interrogation, he told us that though he had bodyguards around him but he used to keep a gun to scare people," the DB official said on July 20.

During a drive on the night of July 18, DB police also recovered five bottles of foreign liquor and 10 bottles of Phensedyl.

Kazi Śhafiqul Alam, deputy commissioner of DB Uttara division, last week said two separate cases were filed regarding the arms and liquor recoveries.

Every day, he added, they were receiving various complaints against Shahed and getting information on his fraudulent activities.

On July 7, Rab filed a case against Shahed and 16 other staff of Regent Group and Regent Hospital after a mobile court found proof that the hospital authorities issued fake Covid-19 certificates and charged

patients for tests and treatment. Lt Col Ashique Billah, director of Rab's legal and media wing, said on Thursday that they managed to arrest around 11 out of 17 accused so far in the forgery case.

"We have already got investigation charge of two cases filed against Shahed, including the forgery and arrest with arms in Satkhira. Shahed is now in our custody. Rab has so far identified 48 cases against him," he said.

Earlier, on July 17, Rab formed an investigation cell to provide support to the people who were allegedly conned by Shahed.

We have closed the phone number of the cell yesterday [July 22]. So far, we received calls from 139 people who claimed to have been conned by Shahed," said Ashique Billah.

He, however, said people will still be able to submit complaints to them through email. Rab received complaints from 21 people through email, as of July 23.

"We have even got complaints that he takes money from different inmates in prison saying he would help them get released," added the official.

US AG reopens Bangabandhu killer

Contacted, Bangladesh Law Minister Anisul Huq preferred not to comment on it.

Foreign Minister AK Abdul Momen could not be reached for comments.

The Father of the Nation and most of his family members were killed in a coup d'état on August 15, 1975. His daughters Sheikh Hasina and Sheikh Rehana survived as they were abroad at the time, but the investigation into it stopped through an Indemnity Ordinance, which had protected the self-proclaimed killers. The ordinance was abrogated in November 1996 when the Awami League returned to power.

After a lengthy trial, the Supreme Court on November 19, 2009 upheld a High Court verdict, confirming capital punishment of 12 people. Five of the convicts -- Syed Farooq Rahman, Sultan Shahriar Rashid Khan, Bazlul Huda, AKM Mohiuddin Ahmed and Mohiuddin Ahmed -- were executed on January 27, 2010. Another killer, Aziz Pasha, died in Zimbabwe in 2001.

Those who remain fugitives include Maj (retd) Rashed Chowdhury, Col (dismissed) Khandaker Abdur Rashid, Lt Col (relieved) Shariful Haque Dalim, Maj (retd) Noor Chowdhury, Capt Abdul Majed and Risaldar Moslehuddin Khan.

and diplomatic efforts to bring back the fugitive killers. A taskforce was formed in 2010 to locate and bring back the six. However, only two of the six could be traced -- Rashed Chowdhury in the US and Noor Chowdhury in Canada. Two law firms -- in the US and Canada -- were also appointed for lobbying to bring the

killers back to the country. Prime Minister Sheikh Hasina wrote to US President Donald Trump in 2018 for the extradition of Rashed. Foreign Minister AK Abdul Momen, on different occasions, requested the high US officials for Rashed's repatriation.

After the killing of Bangabandhu, he was deputed to the ministry of foreign and then posted in different missions. He was terminated from jobs in 1996 when he was posted at the Bangladesh mission in Brazil. Instead of coming back to Dhaka, he fled to San Francisco, USA, with his family with visit visas. Within two months, they'd applied for asylum.

The Politico says, "That's where the Justice Department comes in. America's immigration courts aren't part of the judicial branch. Instead, the system that determines who gets to stay here is part of the DOJ, with the attorney general as the ultimate authority. The immigration courts

Bangladesh has been making legal are massively backlogged, and adjudicating asylum claims can take years."

That's how it went for Rashed. Nearly 10 years after he arrived in the US, an immigration judge granted him asylum. But the Homeland Security (DHS), which handles US government arguments against immigrants' efforts to stay in the US, appealed the judge's ruling. DHS lawyers argued his participation in the coup should disqualify him from receiving asylum.

Then, the BIA took up the case and in 2006 concluded Rashed deserved asylum. But there was still one open question: if he had violated the US anti-terrorism laws.

"So BIA sent the case back to the immigration judge to reexamine that issue. The immigration judge found no issue with granting him asylum, and Rashed's lawyers assumed the matter was resolved," says the Politico report.

"For almost 15 years, the case was closed. But now, thanks to Barr, it's back. And immigration lawyers say the move sends a chilling message to people who have received asylum in the US. It signals, they argue, that even after years of successful legal battles, any protection could still be revoked out of the blue," it added.

Despite the decreasing of daily tests, the positivity rate continues going up throughout this month.

On July 5, the positivity rate was 19.57 percent.

Meanwhile, 1,792 Covid-19 patients recovered in 24 hours till 8:30am yesterday.

The number of recoveries is now 1,23,882, which is 54.44 percent of all confirmed cases.

As of yesterday, 4,226 patients were indergoing treatment at different Covid-19 facilities across the country, while 285 were in ICUs.

There are 15,182 general beds and 533 ICUs for Covid-19 patients countrywide.

Besides, 668 people were put under solation in the 24 hours.

Among the yesterday's deceased, 40 were male and 14 female. Forty-eight of them breathed their last at hospitals and six at homes. The victims were aged between 21 and 90.

"We will provide seeds to the farmers who lost vegetables. Those who lost seedbeds of transplanted Aman would also get assistance from our management.

In Thakurgoan, a large amount of maize, green chilies and vegetables have been damaged due to the flood.

"I cultivated maize which were just around two weeks ahead of harvesting. But this floodwater damaged my maize. I have to incur a loss of around Tk 2 lakh," said Babu, of Yakubpur village in Sadar upazila.

In Sirajganj, crops of around 28,300 hectares of land have been submerged causing huge sufferings to farmers.

"I was taking preparation to harvesting jute. But jute on two bighas of lands went under water early this month," said Abdul Hai, a farmer of Betilchar village.

Normally, farmers prepare seedbed for Aman paddy cultivation during monsoon. But prolonged flood has destroyed 265 hectares of seedbeds this year, said Habibul Haque, DD of DAE in the district.

In Bogura, crops worth Tk 72.34 crores, cultivated by some 44,095 farmers, have been damaged by the flood in the first spell, according to DAE

Rafiqul Islam, a farmer of the Auchar Char in Sariakandi upazila, said he lost 16 bighas of jute due to the floodwater.

"Because of coronavirus, concentred to work in remote Shaol

The losses by second spell of flood could not be assessed immediately, said local agriculture officials.

In Gaibandha, crops worth Tk 15 crore were damaged by the first spell of flood. The damages in the second spell could not be assessed.

In Nilphamari, 607 hectors of land of Aman paddy, vegetables and seedbeds -- worth about Tk 1 crore -was damaged in the recent flood.

The district's agriculture officer Obaidur Rahman Mondol said the affected farmers would be rehabilitated and the authorities would provide them with seeds of different crops and fertiliser at free of cost.

In Manikganj, over 119,256 farmers have been affected as their crops on 30,517 hectors of land went under floodwater in last 26 days from July 1, said Shahjahan Ali Biswas, DD of the district's DAE.

"We are sending the report to the head office regularly. The affected farmers will be given fertiser and seeds during their cultivation after the floodwater recedes," he added.

In Sunamganj and Sylhet, paddy farmers fear that they would miss the chance of cultivating paddy this season as the deadline for preparing seedbeds are at the edge of expiring, while many seedbeds are being damaged by flood Around 40 lakhs people of 147 upazilas in 30 districts are affected

by flood this year, said a report National Disaster Response of Coordination Centre (NDRCC).

Seeking anonymity, a police highup, told this correspondent that they have already strengthened security measures in and around embassies and different areas of the capital. Checkposts have already been set up at different points in the city.

Contacted, Additional Inspector General of Police Md Kamrul Ahsan, the chief of the ATU, categorically said they always remain alert, and there is no scope for an agency like the ATU to let their guard down at any point of time.

Earlier on Friday, there was a bomb explosion in the capital's Purana Paltan area around 8:45pm. There was no casualty. Later, a bomb disposal team of the CTTC unit collected

evidence from the spot. Rahmatullah Chowdhury, incharge of the bomb disposal team, told The Daily Star that the elements of the Improvised Explosive Device (IED) were different from the ones they had recovered from different militant hideouts in the past.

The IED was designed to cause massive destruction but it didn't contain powerful explosives, he said. The following day, a bag was left unattended on a motorbike in the capital's Gulistan area. Police found a bomb-like object inside it around

9:30pm and the bomb disposal unit officer, were injured after a bomb was called in. It turned out to be a bomb hoax.

FROM PAGE 1 management system to the two city corporations -- Dhaka South City Corporation and Dhaka North City Corporation.

In a statement, TIB Executive Director Dr Iftekharuzzaman said according to the corresponding laws, Wasa is responsible for the construction and maintenance of major drainage systems while the city corporations look after connecting lines.

Of the entire drainage system of Dhaka, Wasa looks after 385 kilometres of drainage system whereas the city corporations are responsible for 2,500 kilometres.

Besides, there are 26 canals, a total of 74 kilometres in length, and 10 kilometres of box culverts maintained by Wasa

"Due to the legal complexities, the organisations blame each other to avert their responsibilities whenever the city suffers from waterlogging during the monsoon," said the TIB executive director.

"That's why it is necessary to amend the Acts and hand over the drainage management responsibility to a single organisation. In this case, the responsibility should be handed over to the city corporations as they represent the public. They need to be given the power to evaluate Wasa's activities," he said.

Saying that Wasa has failed to solve waterlogging problems in previous years too, Iftekharuzzaman added that Wasa in one its reports claimed they have become able to clean 20 out of 26 canals.

However, TIB in its research found that these canals are not cleared; instead, heavy solid waste has clogged the entry points of the canals.

Iftekharuzzaman said Wasa does not regularly monitor maintenance of its canals and drainage. Although responsible officers of Wasa are supposed to inspect drains and canals at least twice a month, they do not do and that creates scope for grabbing.

"Therefore, Wasa has no scope to deny its failure. On the other hand, city corporations could not avert their failures in maintaining drains and waste management," he added.

TIB in its research also found that in many cases, the city corporations do not dispose of the waste of canals and drains after cleaning by Wasa.

The TIB executive director said there remains a question over whether the city corporations are able to properly clean the 2,500 kilometres of drains under their purview.

Libya govt disavows visit by French uprising champion

Libya's UN-recognised government has disavowed a visit by French philosopher Bernard-Henri Levy, a champion of the 2011 ouster of longtime dictator Moamer Gaddafi whose standing has plummeted since the uprising.

Across Libya, the euphoria of the Nato-backed rebellion has long since faded as fighting has raged on between rival governments and feuding militias.

In the government-held west of the country, France is widely resented for the political support it has given military strongman Khalifa Haftar whose forces dominate a rival administration in the east.

Levy flew into Libya's governmentheld third city Misrata in a private jet on Saturday, airport sources said.

Syria town AFP, Beirut A bomb in a Syria border town

The blast from an explosive-rigged motorbike ripped through a vegetable market in the volatile town of Ras al-Ain, wounding at least 19 people, the Syrian Observatory for Human Rights said.

Such bombings are common in the town, which was held by Kurdish forces before Turkish troops and their Syria proxies seized it last October.

The Turkish defence ministry blamed yesterday's attack on the USbacked Kurdish People's Protection Units (YPG), which still controls much of northeastern Syria.

DUBIOUS COVID-19 CERTIFICATE Shajahan Khan's daughter barred from boarding London flight

Oaishe Khan, daughter of former shipping minister and Awami League presidium member Shajahan Khan, was barred from going to London at Dhaka airport yesterday, after she was found Covid-19 positive upon cross-checking her certificate.

Since July 23, international passengers are required to submit a Covid-19 negative certificate at the airport to be cleared for travelling.

The health desk at the airport came to know that she was Covid-19 positive through online cross-checking of a certificate she provided at the immigration, saying she was Covid-19 negative, officials at the airport said.

Generally, passengers submit their Covid-19 certificate at the airport health desk. Upon checking it, doctors at the desk issue a token certifying the passenger is fit to fly. The passengers then submit the token to the immigration police for clearance.

Digital Security Act 'to silence people'

University teachers tell webinar for journo Kajol STAFF CORRESPONDENT

A group of university teachers at a webinar alleged that the government wants to silence people using the Digital Security Act, and that is why many people, including photojournalist Kajol, were arrested under this law.

They made the remarks at a webinar titled "Kajol-er Mukti Ebong Mukto Chinta" (Kajol's release and free-thinking) on Saturday night.

"Where is Kajol?," a social media campaign led by Kajol's son Monorom Polok, organised the programme.

Jahangirnagar Speaking there, University's economics teacher Anu Muhammad said the main purpose of this law is to scare people by using the legal system.

Dhaka University's (DU) international relations teacher Md Tanzimuddin Khan said those who are trying to talk to protect people's rights, are being arrested under this law.

"This is a very dangerous time for

free thinkers... We can only praise the government, not criticise it" he added.

DU sociology teacher Samina Luthfa said a journalist carries out his professional duty for his livelihood, but now that is also under threat. "A journalist is being arrested whenever he talks about government's corruption, violation of rule of law."

She said the government has arrested some culprits including Regent Hospital owner Shahed, but masterminds behind the corruption are yet to be arrested.

JU anthropology teacher Sayeed Ferdous said the foundations of the state are being destroyed through this act.

"There is no effective opposition in the country and that is why mass people, artists, journalists, teachers are protesting against injustice, but that too cannot be done due to such an act," he claimed.

Ferdous said that many teachers are afraid to take online classes freely because they have to teach socio-politics and democracy and bring contemporary examples. "But the act does not allow this." SEE PAGE 4 COL 1

Petition filed to show Kajol arrested in yet another DSA case

Detectives have submitted a petition before a Dhaka court to show photojournalist Shafiqul Islam Kajol arrested in another case filed under the Digital Security Act.

Rassel Mollah, a sub-inspector of Detective Branch of police and also the case's investigation officer, submitted it on July 22 to the Chief Metropolitan Magistrate's Court.

Metropolitan Magistrate Baki Billah will hear the petition through videoconferencing today. A web link has been sent to authorities of Dhaka Central Jail, where he is. On March 11, Sumaiya Chowdhury Banna, member of

Bangladesh Jubo Mahila League's Central Committee, filed the case against Kajol with Kamrangirchar Police Station. On June 23, Kajol was shown arrested in a case filed

with Sher-e-Bangla Nagar Police Station, by ruling party lawmaker from Magura-1 Saifuzzaman Shikhor.

On June 28, Kajol was placed on a two-day remand in another case filed on March 10 with Hazaribagh Police Station by Usmin Ara Beli, a member of Bangladesh Jubo Mahila League's Central Committee.

Fifty-three days into his disappearance, Kajol was found by Border Guard Bangladesh in Benapole on May 3.

He was then arrested on charges of trespassing, but was granted bail by a Jashore court. However, that same evening he was shown held under Section 54 of the CrPC after police told the court three more cases against Kajol were now pending with different police stations in Dhaka.

Asymptomatic carriers can wreak havoc at garment factories

Speakers tell SNV-The Daily Star roundtable STAFF CORRESPONDENT

Interviewing 237 ready-made garments workers from 22 factories, SNV Netherlands Development Organisation found that four percent reported having been infected with Covid-19.

This was revealed in a virtual roundtable titled "Access to general and reproductive health services for RMG workers during new normal: challenges and opportunities" jointly organised by the development organisation and The Daily Star yesterday.

Hanifur Rahman, chairman of Bangladesh Garments Manufacturers and Exporters Association Standing Committee on Health Centres added the association's own finding, "We have found 492 Covid-19 positive patients so far, of whom, most were male. Of them, 415 recovered and returned to work.

Speakers iterated the need for community-based surveillance among RMG workers to understand the actual impact of Covid-19 on the community

"We do not have any information on the percentage of Covid-19 patients in this community. What we do know is that 12 lakh people have been tested and 2 lakh tested positive. I do not know how representative [of the real picture] small sample sizes can be," said Ubaidur Rob, country director at Population Council Bangladesh.

Dr Dabir Uddin Ahmed, chief executive officer of Centre for Woman and Child Health said, "The RMG workers are not being tested. The government is saying that they are providing testing facilities but the SEE PAGE 4 COL 2

EID-UL AZHA IN SYLHET

Cattle market on school ground sparks protests

Despite protests against it, local administration in Sylhet has permitted a temporary cattle market on the ground of an educational institute for Eid-ul-Azha, and the lessee has already started setting the haat.

The school is located in Lakkatora area of Sylhet Sadar upazila, right at the edge of Sylhet city. It was established in 2013 under a project to establish seven secondary schools in metropolitan city.

"As per the recommendation of the upazila council, we asked the district administration and they permission for the school ground," said Kazi Mahua Mamtaz, upazila nirbahi officer of Sylhet Sadar.

School headteacher Md Zahur Ahmed claimed that neither the council nor the administration asked them.

"The cattle haat will destroy the school compound. I have already contacted higher authorities and urged the upazila chairman to reconsider the decision," he added.

Moreover, hundreds of trees were planted on the school ground on July 18, marking the birth centenary of Bangabandhu Sheikh Mujibur Rahman, which may get damaged, he said.

The headteacher also submitted a

letter to the district administration in this egard.

But it is not only a matter of taking consent, but also a serious violation of the act that protects playgrounds, open space, gardens and natural water reservoirs of the country.

As per the section 5 of the act 36 (2000), leasing, renting or using such spaces for any other purpose is completely prohibited and a person may face up to five years in jail or Tk 50,000 fine or both for breaking the law.

Citing the act, advocate Emad Ullah Shahidul Islam Sahin, former president of Sylhet District Bar Association, said, 'Most educational institutes don't have playgrounds... protecting each and every should be of highest concern. Once they set haat, they will definitely try to make it a tradition."

Jahangir Kabir Ahmed, deputy director of Divisional Secondary Education Office, said, "This is not a good practice to lease out school grounds for commercial purposes. We are also sending a letter to our higher authorities to take necessary steps.

About the decision of permitting the haat, the UNO said, "We have no other option where we could maintain health SEE PAGE 4 COL 5

CATTLE MARKETS IN DHAKA 8 teams to monitor veterinary service

Don't allow hawkers at

67,229 get bail in 50 working days

The Ministry of Fisheries and Livestockyesterday formed eight monitoring teams to observe the activities of veterinary medical teams and other health related issues at all the cattle markets of two Dhaka city corporations ahead of Eid.

Each of the monitoring teams comprises a deputy secretary, says a ministry press release.

The ministry also formed 18 veterinary medical teams and one specialised veterinary medical team to provide services at the 17 cattle markets in Dhaka.

This year, Dhaka South City Corporation has approved 11 cattle markets while Dhaka North City Corporation approved six.

The ministry also formed four cattle market management monitoring teams and one control room management team to look into other issues at the markets.

The Department of Livestock constituted 1,213 veterinary medical teams for cattle markets across the country and other teams to monitor their activities.

Dhaka Metropolitan Police (DMP) Commissioner Md Shafiqul Islam yesterday asked the leaseholders not to allow hawkers or makeshift shops inside the cattle markets.

Sometimes criminals snatch money from traders and buyers after doping them, and so makeshift shops and hawkers should not be allowed on the market premises, he said.

He asked cattle haat lessees to set up permanent food shops and tea stalls inside the market, and submit identities of shop owners to police stations.

Shafiqul gave the directives at a meeting on maintaining law and order and traffic arrangements at the DMP headquarters recently, ahead of Eidul-Azha, said DMP Deputy Commissioner (Media) Walid Hossain.

The DMP chief said it will be better if facilities of selling sacrificial animals are available online in the name of each cattle haat.

"This system will be safe for buying animals. The haat authorities can avoid the possibility of financial losses by selling online too. If someone buys a cow online from outside instead of a cattle haat, no hashil [service tax paid by buyers] can be taken from them," he added

The commissioner has also asked the deputy commissioners of DMP crime divisions to ensure discipline in the movement of the cattle-laden vehicles.

Vehicle number and driver's name, identity and photograph should be taken and kept with the local police station so that the driver can be identified quickly, he added.

The commissioner said the buyers and the sellers in the markets must abide by the hygiene rules. "We hope that everyone will follow health guidelines at the haats," he added.

A total of 67,229 persons accused in criminal cases, including 755 children, have secured bail in 50 working days between May

12 and July 23. A total of 870 children, who were detained on criminal charges, were kept in three juvenile development centres till July 23 as 508 accused children were sent to the centres between May 12 and July 23, Supreme Court Spokesmen Md Saifur Rahman said in a statement.

According to the statement, the lower courts across the country have

heard and disposed of total 1,36,399 bail petitions in the 50 working days till July 23.

Conning people with false promise of VIP SIM cards

Taking advantage of online social networks, fraudsters have been conning people into buying "VIP SIM cards". They use unverified online pages and e-commerce sites for this purpose.

VIP SIM cards are meant to be phone numbers with digit repetitions and patterns that are easy to remember.

They promise to sell these VIP numbers to people after they pay the full amount through cashless transaction methods. After that, they tell the buyers to visit the nearest customer care centre of their chosen operator to collect the VIP SIM.

However, the sellers block their customers' numbers after they receive money. If the customers try from different numbers, they are verbally harassed and then blocked.

Criminal Investigation Department's Cyber Police Monitoring team arrested one conman -- Mithun Sarkar (29) from Madhukhali area in Faridpur on July 25.

The CID recovered Tk 10 lakh from Mithun and also seized his three mobile phones.

"We found ten Facebook pages that

Mithun was using to con people," CID's Cyber Police Special Superintendent Rezaul Masud said at a press briefing at its headquarters in Malibagh yesterday.

The VIP numbers with the same last eight digits of 017 series was selling at Tk 20,000; 019 series for Tk 17,000 while 018, 016 and 015 series were selling at Tk 15,000 on Mithun's Facebook page, the CID said.

"He didn't have any VIP SIM cards on him and the Facebook pages were just for conning people," Mohammad Mahmudul Islam Talukder, additional superintendent of CID's Cyber Police Centre, told The Daily Star.

The CID official said the "upper-middle class and high-profile people" contact them for VIP numbers. Many of them get cheated.

He said that some mobile operators earlier used to sell VIP numbers, but after BTRC's instruction, they don't sell it anymore.

Road accidents Novera Deepita take seven lives

Seven people were killed and five persons injured in road accidents in three districts during the last two days, according to reports from our local correspondents. In Cumilla, four people were killed and five injured as a

truck collided head-on with a human haulier on Cumilla-Sylhet highway in Horindhora of Mainamati under Burichang upazila yesterday.

The deceased were identified as Billal Hossain Bhuiyan (35), his sister Ripa Akhter (40), Sadhon Chandra Saha and Sazid, said Safayet Hossain, officer-in-charge of Mainamati Crossing Highway Police Station.

The OC said three of the victims -- who were the human haulier passengers -- died on the spot and the woman was declared dead at a local hospital.

The injured others were taken to Cumilla Medical College Hospital.

In Rangpur, a girl and her uncle were killed as an oncoming truck hit a motorbike they were riding at Shathibari in Mithapukur upazila yesterday.

Jui Akter (10) from Hajaratpur-Dublachari village in Mithapukur died on the spot and her uncle Lablu Mia (35) succumbed to his injuries on way to a hospital, said police. Jui was a third-grader while Lablu a deed writer.

The truck driver fled the spot with the vehicle.

In Panchagarh, a farm labourer was killed after a truck hit a bicycle he was riding on Panchagarh-Tunirhat road at Fulbarpara village in Sadar upazila on Saturday night.

The victim -- Lulu Mia (40) from the village -- died instantly, said police. After the accident, police seized the truck and detained the driver's helper Yasin Ali after locals handed him over to them.

He urged the government to accept constructive criticism, saying "otherwise democracy will not exist.

The platform "Where is Kajol?" is running a weeklong programme on its Facebook page since July 21. A number of teachers, journalists, rights and cultural activists have expressed solidarity with it.

Meanwhile, talking to The Daily Star, Kajol's son Polok alleged that the Digital Security Act completely undermines the government's claim of not intending to restrict the right to freedom of speech.

Polok said that his father was shown arrested in one of the three cases filed against him under the law.

"Among 32 accused in the case, only my father was in jail for 52 days in Jashore, and later he was shown arrested after 105 days since the case was filed. Even the case's prime accused, the Manabzamin editor, got bail," he said.

Kajol, the editor of the Daily Pokkhokal, was shown arrested under Digital Security Act in Jashore on May 3, after he was found at Benapole that day following his disappearance on March 10.

Maheen Sultan, lead researcher at Centre for Gender and Social Transformation, Brac Institute of Governance and Development said under-reporting could be an issue because workers could be scared that complaining about symptoms could lead to decrease in wages or loss of job.

Md Kawsar Ali, chief operating officer, Comfit Composite Knit Ltd, said, "After Eid we noticed a significant number of workers with flu-like symptoms. We are fearing that there will be movement during Eid, and there might be a health concern in August." He added that in his factory, pregnant women were asked to stay at home with full salary.

They also spoke about how access to health services for RMG workers have been affected during the pandemic. "We have about 2,000 workers.

services in our area. We had 22-23 deliveries during the pandemic and most of them went well. When the family contacted the certificateissuing authority -- National Institute of Laboratory Medicine and Reference Centre -- yesterday after returning from the airport, they were given another certificate which says she is Covid-19 positive, he added.

A rights organisation yesterday filed a writ petition with the High Court seeking its directives on the authorities concerned to refund the money and fees received from the patients who were cheated by Regent Hospital in the name of Covid-19 test and treatment.

Children Charity Bangladesh Foundation (CCBF), represented by its director Advocate Ishrat Hasan, lodged the petition as a public interest litigation through email.

The petitioner also requesting the court to order the authorities to give Tk 25,000 as an interim relief to each of the patients victimised by the hospital.

In the petition, the rights body prayed to the HC to ask the health and home secretaries, director general of Directorate General of Health Services and and managing director of Regent Hospital to make a list of the persons, who got fake certificates from the hospital and to publish a list of the names of the hospitals and diagnostic centres that have legal licence to conduct Covid-19 tests.

Barrister Md Abdul Halim, submitted the petition to the HC as the lawyer of the rights organisation, also requested the court to direct the authorities to take necessary measures to monitor the activities of the hospitals and diagnostic centres the at upazila level, regarding the test and treatment for patients.

Advocate Ishrat Hasan told The Daily Star that the HC may virtually hold hearing on the writ petition any day this week.

Crowded cattle markets pose risk as health rules grossly ignored

Cattle markets in Patuakhali are now buzzing with buyers and sellers of sacrificial animals ahead of Muslim religious festival Eid-ul-Azha to be celebrated in the country on August 1.

But the government-stipulated health rules, aimed at checking the spread of Covid-19, are hardly followed in these markets, locally called haats

Visiting several cattle markets in the district on Thursday and Friday, it was seen that most of the people do not wear mask while maintenance of safe distance remains elusive. Arrangement of washing hands is mostly absent.

Bridge Hat adjacent at Patuakhali town, Sehakathi Hat, Hajir Hat, Botalbunia Hat, Moukaran Hat under Patuakhali Sadar upazila, Badura Hat, Galachipa Hat under of Galachipa upazila, Kalaiya Hat, Baga Hat under Baufal upazila, Deuli-Subidkhali of Mirzaganj upazila are some of the notable haats.

Traders said there is not yet much sale of cattle although the prices are low.


Badura Haat, the largest cattle market in Galachipa upazila, saw thronging of thousands of sellers and buyers who seem to bother least about maintenance of safe distance and wearing mask properly.

There is no arrangement for hand washing or using sanitiser. No awareness campaign was seen on behalf of the market committee.

Abu Hanif of Amkhola village, came to buy cow at Badura Haat.

When asked why he was not wearing mask, he quickly took one from his pocket and put it on the face.

Asked why he did not have a mask, he said, "By the grace of Allah, nothing will happen to us." Afterwards he took a mask out of his pocket and wore it.

Abdul Motaleb Sikder, a lessee of Deuli Subidkhali Haat, said, "Everyone is talking about health rules. But it is not properly maintained as most of the rural people are not aware."

Mirzaganj Upazila Nirbahi Officer Sarwar

Hossain said a meeting has been held with the cattle market lessees of the upazila and all concerned have been instructed to comply with the health rules while selling the sacrificial animals.

Patuakhali Contacted, Deputy Commissioner Md Matiul Islam Chowdhury said, "The organizers have been instructed to follow the health rules in the haats. If the instructions are ignored, disciplinary action will be taken through mobile court.

Kalmakanda Upazila Three back-to-back flash floods devastate fish farmers

MD AMINUL ISLAM, Mymensing

When losses incurred by fish farmers in the entire district of Netrakona totals to Tk 10 crore, the ones in Kalmakanda upazila alone suffered around Tk 7 crore in losses due to three flash floods in one month.

The losses have been severe as nearly 2,500 fish ponds out of around 3,600 in the upazila have been washed away in the flash floods, said Anik Rahman, fisheries officer in Kalmakanda upazila.

While speaking with this correspondent, Netrakona Fisheries Officer Fazlul Kabeer said among 38,500 fish farmers in the district, around 3,600 -- mostly in Kalmakanda -- have been affected by the floods.

Other upazilas also affected by the floods are Sadar, Madan, Khaliajuri and Barhatta, he added.

Wabidul Haque, chairman of Kharnoi Union Parishad under Kalmakanda upazila, said 38 villages of the union experienced three back-to-back floods within a span of one month, thanks to floodwaters rushing down from hills up north through the Boithakhali and Ganeshwari rivers.

The floods in his union have washed away around 700 fish ponds, causing a damage of over Tk 1 crore, he added.

Fish farmer Nizam Uddin, from Bausam village in the same union, said fish from six out of his eight ponds were washed away, resulting in a loss of around Tk 4

lakh. "I run my family with income from fish cultivation. But now I'm stuck in a dire situation amid the ongoing crisis [of floods and Covid-19 pandemic].

Nurul Islam Mondol, from Sundarighat village, said he took a bank loan of Tk 10 lakh for fish cultivation in 10 ponds. But after fish from five of the ponds were washed away by floodwaters, he incurred a loss of over Tk 5 lakh.

"Now I'm in a deep crisis as I don't how would repay the loan," lamented the farmer.

Upazila Agriculture Officer Faruk Ahmmed said aside from fish farms, floods also damaged seed beds for Aman paddy on around 49 acres of land in Kalmakanda upazila.

Alarming rise of cattle theft ahead of Eid

About 400 cows stolen in Moulvibazar in a month

MINTU DESHWARA, Moulvibazar

Sharif Mia has been rearing his three cows worth Tk 1.50 lakh for the last two years to sell at the haat ahead of this Eid-ul-Azha, a festival marked by sacrifice of animals. He wanted to celebrate this Eid and pay back some loans by selling the cattle. But the cows were stolen in Rampasha village of Kulaura upazila in Moulvibazar last week.

"I am now in utter despair for my future after losing the cattle. How will I pay off the debts now and how will I buy new clothes for my children in the Eid?" said Sharif.

Dilip Roy, a tea worker at Champarai tea garden in Kamalganj upazila of the district, said he has been rearing two cows for long.

"The cattle were our only assets. I had a plan to spend my children's education cost and repay some loans by selling a cow before Eid. But a few days ago, the cows were stolen. And all my dreams have been shattered." he said.

Cattle lifting has increased in different upazilas of the district ahead of Eid-ul-Azha, forcing farmers to guard their cows during the night. Two weeks ago, alarming rise of cow theft in Kulaura and Kamalganj upazilas caused a stir across the country.

Farmers said around 400 cows have been stolen in different upazilas of the district in the last one month. The upazilas are Kulaura, Kamalganj and Sreemangal.

After the incident, farmers are worried about the rise of cattle lifting. The cattle farmers are now guarding with their minimum daily wage of Tk their cows in many areas at night to prevent theft.

Abdul Ahad, a resident of Dildarpur

Kamalganj police in Moulvibazar have recently arrested four people with two stolen cows.

upazila. Police are reluctant to lodge a complaint in cattle lifting when the victims visit the police station.

Solaiman Ahmed, former chairman of Islampur Union Parishad in Kamalganj upazila, said a total of 196 cattle have been stolen in the border areas including Champarai and Kurma tea gardens of the upazila in the last three months. After being stolen, the cows were sometimes sold out and slaughtered.

He further said that it is too tough for the tea workers to run the family 102. Due to this, they rear the cattle to survive.

Despite repeated pleas, the area, said 70 cattle out of 114 have been authorities concerned are yet to take stolen in Joychondi union of Kulaura any steps to prevent cow theft, said arrest the cattle lifters, said the SP.

Arifur Rahman, officer-in-charge (OC) of Kamalganj Police Station said they have arrested four peopl with two stolen cows from the border area a few days ago.

The law enforcers also seized pick-up van used for stealing cows from their possession, said the OC.

Hundreds of firefighters battle wildfire in Portugal **Reuters**, Lisbon

More than 700 firefighters yesterday battled a wildfire sweeping across a part of central Portugal, with strong winds complicating efforts to tackle the blaze.

The wildfire has been raging in the municipality of Oleiros since Saturday afternoon but it has now spread to two neighbouring municipalities and has already forced the precautionary evacuation of several people.

A 21-year-old firefighter died in a road accident on Saturday evening while fighting the fire and six others were injured.

"I would like to send a word of solidarity, encouragement and thanks to the firefighters ... for the work they do for Portugal and for all of us," Prime Minister Antonio Costa said in a statement.

The fires are small compared with a massive fire that hit the region in June 2017, killing 66 people and injuring more than 250.

Dozens arrested, 21 police hurt in Seattle; one shot dead in Texas

US police used flashbang grenades, pepper spray and tear gas as protestors marched in cities across the country on Saturday amid a wave of public anger over Donald Trump's planned "surge" of federal agents into major metropolises.

The demonstrations against racism and police brutality -- sparked by the death in Minneapolis of unarmed African-American George Floyd -- come as the US president faces an increasingly tough battle for reelection, and is campaigning heavily on a platform of "law and order".

Protestors marched in Austin, Texas, as well as Louisville in Kentucky, New York, Omaha, California's Oakland and Los Angeles, and Richmond in Virginia -- where riot police fired chemical agents at a Black Lives Matter march, according to US media.

In Seattle, the sounds of repeated

streets, and smoke rose from an area where demonstrators had set fire to trailers by a construction site for a youth detention facility, an AFP reporter observed.

Protestors slashed car tires and smashed trailer windows. Police in riot gear faced off against the protestors, some holding umbrellas

against falling pellets of pepper spray. Late Saturday, Seattle police said 45 people were arrested in connection with the demonstrations, which they designated a riot, according to the force's official Twitter account. The post also said "21 officers sustained injuries after being struck by bricks, rocks mortars/ other explosives. Most officers were able to return to duty. One was treated at a hospital for a knee injury."

Police Chief Carmen Best implored people to "come in peace to the city," and castigated the demonstrations.

small detonations rang out in some community's safety, for officers' safety or for the businesses and property that they destroyed," local media reported her as saying.

In Texas, one person was killed when several shots were fired amid the Black Lives Matter protest in downtown Austin on Saturday, authorities said.

Footage posted during a Facebook Live showed the moment when several shots rang out in the Texas capital as about 100 people marched and chanted, "Fists up! Fight back!"

The latest violence came after police and federal agents fired tear gas and forcefully dispersed protestors further south in Portland early Saturday, also in anger over Trump's heavilycriticised surge of security forces.

The city, the biggest in the state of Oregon, has seen nightly protests against racism and police brutality for nearly two months, initially sparked

HANDLING OF CORONAVIRUS CRISIS Calls grow in Israel for Netanyahu to go

"We won't leave until Bibi leaves." Israel's struggle to contain the coronavirus has stirred deep-seated resentment towards Prime Minister Benjamin Netanyahu and protests demanding his resignation are growing by the week.

Some demonstrators branded Netanyahu -- who has been indicted with bribery, fraud and breach of trust -- as corrupt, while others condemned a lack of coherence in the government's response to the pandemic

For Tamir Gay-Tsabary, who travels each day to the Jerusalem protests with his wife Tami from southern Israel, coronavirus was "a trigger" that brought renewed focus to Netanyahu's leadership faults.

The pandemic made people "understand that he doesn't care (about) Israel, he just cares for himself," the 56-year-old sales manager told AFP. Netanyahu won praise for his initial response to the virus.

His government's quick decisions in March to curb travel and impose a lockdown brought the daily case-count to a trickle by early May.

But an economic re-opening that began in late April has led to an explosion in transmission in the country of about 9 million people, with daily COVID-19 tallies ranging between 1,000 and 2,000 cases in recent weeks.

Anti-government protests that initially included a few hundred people in Tel Aviv, now regularly count several thousand there and in Jerusalem. Reflecting on the movement, Einav Schiff of the Yedioth Ahronoth newspaper said it began in response to "a premature victory celebration

for having defeated the coronavirus". That false victory "morphed into a healthcare and economic failure,

US sends envoy to press for peace talks in Afghanistan

Washington has dispatched a special envoy for Afghanistan to press for peace talks between the government and Taliban fighters, with the diplomat scheduled to visit Kabul on a trip with stops in five nations, the US State Department said on Saturday. US Special Representative for Afghanistan Zalmay Khalilzad departed on Friday to travel to Doha, Kabul, Islamabad, Oslo and Sofia, the department said in a statement. The United States is drawing down its troops in Afghanistan under an agreement struck in February with the Taliban. The agreement aimed to pave the way for formal peace talks between the insurgents and the Afghan government, and Khalilzad's task is to try and bring both sides to the table.

Hurricane Hanna lashes south Texas coast amid pandemic

Hurricane Hanna pummeled the south Texas coast on Saturday night with howling winds and a surging sea that threatened a broad area already contending with an intense spike in coronavirus deaths. Hanna is the first hurricane for the 2020 Atlantic storm season, which is expected to be unlike any other in recent memory. Authorities will have to contend with sheltering and evacuating

people while also maintaining social distancing protocols and other pandemic restrictions. The NHC forecast that Hanna would lose steam as it moved inland across Texas and northeastern Mexico overnight into Sunday. But the storm could dump upward of 18 inches of rain in the area through Monday.

Temperatures at Norway's Arctic

archipelago hit record high Temperatures at Norway's Svalbard

archipelago, about midway between the mainland and the North Pole, hit a record high of 21.7 degrees Celsius on Friday, Norway's

Meteorological Institute said. Home to more than 2,000 people, Longyearbyen, the main settlement in Svalbard, is about 1,300 kilometres (800 miles) from the North Pole. The Norwegian Centre for Climate Studies said last February average temperatures in Svalbard had leapt between three and five degrees Celsius (5.4-9.0 Fahrenheit) since the early 1970s and could rise by a total of 10C (18F) by 2100, if world greenhouse gas emissions keep climbing. The Arctic region is warming faster than the rest of the world, putting the entire ecosystem in danger.

UK to unveil anti-obesity plan AFP, London

British Prime Minister Boris Johnson is set to roll out a £10 million anti-obesity campaign, including junk food advert bans, following his own brush with death that he partly blamed on his weight.

Johnson will announce his "Better Health" campaign on Monday, which is expected to include encouraging doctors to issue "cycling prescriptions" for overweight patients, more segregated cycling lanes and a ban on junk food television ads before 9.00pm, according to British media reports.

"COVID-19 has given us all a wakeup call of the immediate and longterm risks of being overweight, and the Prime Minister is clear we must use this moment to get healthier, more active and eat better," said a government spokesman on Sunday.

"We will be urging the public to use this moment to take stock of how they live their lives, and to take simple steps to lose weight, live healthier lives, and reduce pressure on the NHS."

Restaurants will also have to publish the number of calories in the meals they serve, according to a report

in the Daily Mail. Johnson, who has fought his own battles to control his weight, required intensive care treatment in April after catching the virus.

The plan, which the Guardian estimated would cost £10 million (\$12.8 million,

11 million euros), marks a U-turn by the prime minister, who has long railed against the interventionist "nanny state".

A Public Health England (PHE) study published on Saturday found that obesity increased the risk of death from coronavirus by 40 percent.



The different intrigues and agendas tied to the Srebrenica Massacre

This year marked a quarter of a century since the Srebrenica Massacre of July 11, 1995, when around 8,000 Muslim men and boys were allegedly massacred by Bosnian Serbs—during the Bosnian War—in what has been described by some as the "worst war crime" to have taken place on European soil "since World War II". The killings were suspected to have been perpetrated by units of the Bosnian Serb Army of Republika Srpska (VRS) under the command of Ratko Mladic with the involvement of a paramilitary group from Serbia known as the Scorpions.

Of course, we here in Bangladesh are no strangers to genocide, having witnessed our share of it during the Liberation War of 1971. According to Bangladeshi authorities, as many as three million people were killed by the Pakistani Army. Unfortunately, as the country was busy rebuilding itself from the devastation left behind by the Pak Army in the immediate aftermath of the war, Bangladesh was unable to pursue the genocide case in the UN with much effort and hence, the genocide in Bangladesh, which was much worse than the one that was perpetrated in Srebrenica, never got the kind of attention at the UN that it deserved. Nevertheless, the Bosnian War lasted for a much longer time—raging

on from 1992 to 1995-and saw

Catholic Croats (17 percent)—passed a referendum for independence on February 29, 1992. Following the declaration of independence, Bosnian Serbs, led by Radovan Karadzic and supported by the Serbian government of Slobodan Milosevic and the Yugoslav People's Army (JNA), mobilised their forces inside Bosnia and Herzegovina in order to secure ethnic Serb territory. It was after this that the war started.

Throughout the first year of hostility, Srebrenica saw heavy fighting and the town at the centre of the municipality had to endure Serb military and artillery assaults. From late 1992 to January 1993, Bosniak forces under the command of Naser Oric launched military incursions into Serb villages around Srebrenica, resulting in the murder of Serb civilians and soldiers. Although the number of casualties have been subjects of controversy, these raids, according to some, is what motivated the massacre of Srebrenica. In April 1993 the United Nations had declared the enclave of Srebrenica which was under siege by the Serbs, a safe area under UN protection. However, the UN failed to both demilitarise the army of the Republic of Bosnia and Herzegovina within Srebrenica and force the withdrawal of the VRS surrounding Srebrenica.

September 1993, while he was a member of Srebrenica's delegation to his party's congress in Sarajevo, Izetbegovic had taken the delegation aside in confidence and said: "You know, I was offered by [US President Bill] Clinton in April 1993...that [if] the Chetnik forces enter Srebrenica, carry out a slaughter of 5,000 Muslims...there will be a [NATO-US] military intervention" ("5,000 Muslim Lives for Military Intervention", Dani, June 22, 1998). According to Meholjic, the Srebrenica delegates had turned down the offer. But in the grand scheme of things, the Srebrenica massacre played a significant role in letting NATO break out of its post-war "collective defence" area of operations (limited to the defence of the territories of its member nations) to become a globally

many terrible atrocities which is the hallmark of nearly all wars. By 2008, the International Criminal Tribunal for the former Yugoslavia (ICTY) had convicted 45 Serbs, 12 Croats and 4 Bosniaks of committing war crimes in connection with the war which resulted in the displacement of an estimated 2.2 million people and 100,000-200,000 deaths.

After Slovenia and Croatia seceded from the Socialist Federal Republic of Yugoslavia in 1991, the multi-ethnic Socialist Republic of Bosnia and Herzegovina—which was populated by mainly Muslim Bosniaks (44 percent), Orthodox Serbs (32.5 percent) and Srebrenica on July 11 and took peacekeepers hostage, about 25,000 Bosniaks fled to the UN base at Potocari on the city's outskirts. The United Nations Protection Force (UNPROFOR), represented on the ground by a 400-strong contingent of Dutch peacekeepers, could not prevent the town's capture by the VRS. And it was in its aftermath that the massacre is said to have taken place.

The ICTY spent years investigating the killings. And later declared that the Bosnian Serb forces had begun planning the genocide during the final stage of the three-year Bosnian War, in March 1995. court established by the UN to prosecute war crimes in the former Yugoslavia

(ICIY), nor anyone else, have been able to determine conclusively just how many people were actually killed in and around Srebrenica in July 1995—or even under what circumstances. However, many questions have been raised in recent years in regards to the alleged massacre, the role of different parties, as well as the agendas that drove and motivated their actions.

The number 8,000 originated from the International Committee of the Red Cross's (ICRC) estimate of 3,000 people being allegedly detained by Bosnian Serbs, along with another 5,000 it believed had attempted to "flee Srebrenica". Initially the ICRC said it was unable to verify what had happened to them. But in a later statement that is rarely mentioned, the Red Cross said that "some [of the 5,000] had already reached central Bosnia".

On the other hand, the ICRC's estimate that Bosnian Serbs had detained 3,000 people from Srebrenica was based on Angelo Gnaedinger's—the ICRC's head of operations for Western Europe visit to Pale and Belgrade in early September of 1995 and the gathering of information from witnesses. These witnesses were the United Nations Dutch Blue Helmet Protection Force stationed in Srebrenica, who earlier had told journalists a completely different figure after being evacuated from the area.

The *New York Times* for example reported: "Dutch peacekeeping troops evacuated from Srebrenica... say that Bosnian Serbian invaders... abducted between 150-300 men aged 16-60" (July 24, 1995). After the Red Cross's statement on 3,000 people being detained, the *New York Times* contradictorily stated: "About 8,000 Muslims are missing from Srebrenica... Among the missing were 3,000, mostly men, who were seen being arrested by Serbs...In addition to those arrested, about 5,000 'have simply disappeared."

The report never mentioned the Red Cross's statement that "some" of the 5,000 had already "reached central Bosnia". Nor that journalist Chris Hedges (who later won the Pulitzer Prize) had previously reported that: "Some 3,000 to 4,000 Bosnian Muslims who were considered by UN officials to be missing after the fall of Srebrenica have Bosnian government territory" (*New York Times*, July 18, 1995).

Similar to Hedges, the *Times of London* also reported that: "Thousands of the 'missing' Bosnian Muslim soldiers from Srebrenica who have been at the centre of reports of possible mass executions by the Serbs, are believed to be safe to the northeast of Tuzla" (August 2, 1995). And professor Milivoje Ivanisevic at the University of Belgrade, having compared the Red Cross' list with the Bosnian electoral lists for the 1996 fall elections, claims to have found 3,016 people named as "missing" by the Red Cross on the electoral lists ("Faux electeurs...ou faux cadavres", October 1996).

However, as far as summary executions were concerned, people like Lieutenant General Hans Couzy, the commander-in chief of Dutch ground forces, have documented how Bosnian Serbs had executed unarmed Muslim men by shooting them in the back of the head. And there is no doubt that many other war crimes were committed during the Bosnian War. But it is important to ask how many died during the evacuation of Srebrenica, how many managed to safely reach Bosnian Muslim territory, and when, according to former UN Military Observer Carlos Martino Branco—who was on the ground in Bosnia during the war and, in particular, during the fall of Srebrenica.

In his detailed account published in 1998, Major Branco wrote: "In mid 1995, the prolongation of the war had dampened public interest [in the west]...An incident of this importance would nonetheless provide hot news material...and incite new passions." The "western media exacerbated" the situation, which Bosnian politician Alija Izetbegovic "was quick to explore". Years later, French politician and Special Representative of the United Nations Secretary General in Kosovo (1999-2001), Bernard Kouchner, asked a dying Izetbegovic about the Bosnian Serb concentration camps, whereupon Izetbegovic answered that the claims had been inflated with the aim of getting NATO to bomb the Serbs (Les Guerriers de la Paix, 2004).

Former president of the (Muslim) Social Democratic Party in Srebrenica, Hakija Meholjic, during an interview with a Muslim journal, made another shocking revelation when he said that in

operating alliance—through NATO's bombing of Yugoslavia in 1999 during the Kosovo War based on "humanitarian reasons" (which was a precursor to the humanitarian wars in Iraq, Afghanistan, Libya, etc).

In September 1996, former UN official Cedric Thornberry wrote that he was warned at the UN headquarters back in the spring of 1993 to "take cover" because "the fix is on" ("Saving the War Crimes Tribunal; Bosnia Herzegovina," Foreign Policy). And also that, "prominently in parts of the international liberal media" the position is "that the Serbs were the only villains". As a result, Serb misbehaviour was routinely presented by the western media, who omitted similar atrocities when they were committed by other parties to the conflict—an example being the attention given to Bosnian Serb prison camps like Omarska, which the media focused on with indignation, even though the Muslims and Croats had very similar prison camps at Celebici, Tarcin, Livno, Bradina, Odzak, etc. (Fool's Crusade, Diana Johnstone).

Though this record of systematic omission does not disprove the truth of the standard narrative on the Srebrenica massacre, it does suggest the need for a closer look which the mainstream in the west has generally refused to provide. As well as remind us to be aware of the fact that even massacres are often tried to be spun by different factions to serve their own (geo)political agendas, and be suspicious of anyone willing to drop bombs for peace and start wars for humanitarianism.

Crossfire killings go on unabated

Belittles the rule of law and maligns the justice system

NCIDENTS of crossfire, regrettably, seems to be going on continually. So far this month, 35 people have been killed in so called-called crossfires. The accounts of the incidents have become rather predictable and hackneyed, and they hardly fit the definition of crossfire. Instead, it makes the law enforcers and the police appear to be the judge, jury and executioner, all in one, by taking, what a lawmaker termed, "instant action." It is surprising to hear the police briefings after the so-called crossfires, describing the antecedents of those killed, as if to justify the killings. Either they are drug dealers or persons with several criminal cases against him, or a suspected killer. As if an accused drug dealer automatically forfeits the right to his life.

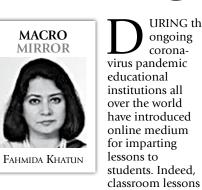
There is no doubt that these operations are a continuation of the government's anti-drug drive to rid the country of drugs? In fact, a police super's comment that the anti-drug operations would continue in the border areas of his district where drug smuggling is going on, confirms that. We would want the country to be free of drugs. But his statement to the effect that no drug dealer would be spared, betrays the ominous intention. We support the government's zero-tolerance against drugs, but take issue with the modus of ridding the country of drugs employed by the government. In fact, as per records 466 people were killed in 2018 after the government launched an anti-narcotics drive on May 4 that year. Last year, the figure was 391. In January of this year seven people-alleged drug dealers-were killed in one incident alone in Cox's Bazaar. This particular aspect of the current anti-drug strategy, we believe, is flawed. And it may be counterproductive in the long run.

No society that values justice and rule of law can condone extrajudicial killings, which the so called crossfire deaths are. It is also a gross violation of, and disregard for, the legal system. A suspect or an accused must be allowed to have his day in the court of law, and not the court of man through "instant action."

Children drowning and falling ill in flood-affected areas

Ensure shelter, pure drinking water and food supplies for children, families

HE increasing incidents of children drowning in the floodwaters and getting infected with waterborne diseases across the country is extremely worrying. Recently, a woman lost her three-year-old son in the Teesta as he slipped out of her lap and fell into the river while she was on a boat trying to go to a flood shelter, and a sevenyear-old girl in Lalmonirhat's Patgram upazila drowned in a deep hole in which stagnant floodwater had collected due to illegal lifting of stones. The girl drowned there when she was crossing knee-deep water to get to a road. Such incidents have become common in the flood-hit areas as families have been forced to take shelter on streets and embankments under the open sky, losing their homesteads and belongings to the flood. According to local health authorities, at least 24 children have drowned in floodwater in Jamalpur this month, while in Thakurgaon and Panchagarh, the number of children drowned in the last two months is 26. Although we do not have sufficient data on children drowning, it can be guessed that the situation could be the same in other flood-affected districts. Besides drowning, children are also vulnerable to various waterborne diseases. Reportedly, the number of child patients is rapidly increasing in the flood-hit areas as diarrhoea, skin disease and other waterborne diseases are spreading among them. Malnutrition, too, has become a major issue as children in the shelters do not have access to nutritious food and pure drinking water. The halted immunisation programmes in the affected areas is another reason for the high rate of illness among children. The Unicef has recently estimated that around 1.3 million children in Bangladesh would be affected by flooding this year. Under the circumstances, the government needs to scale up its flood response efforts and take particular measures to save our children from drowning and diseases. Families need to be evacuated to the flood shelters well ahead of time and those shelters need to be made safe for children. Children also need to have safe places in the shelters where they can play without facing any risk of drowning. The absence of shelters in the remote flood-affected areas has increased the vulnerability of children. So, the government needs to build flood shelters in the areas where it is needed the most. At the same time, awareness needs to be raised among parents about the risk of children drowning. Moreover, flood-affected families need to be provided with pure drinking water and food supplies. The government alone cannot ensure all this; non-government organisations and well-off people of society should also come forward to meet the immediate needs of affected children and their families



in many advanced countries had become technology dependent even before the pandemic. Now it is no longer a choice but a necessity if students are to be taught.

Several schools, colleges and universities in Bangladesh have also adopted this method so that students do not miss out on learning during the current situation. Various virtual platforms are being used for lessons and exams. Both private and public institutions have introduced this mechanism of teaching. Indeed, since the middle of March this year, the government has initiated distance learning through television. Various government ministries and departments such as the Ministry of Education, the Ministry of Primary and Mass Education, the Ministry of Information Technology and access to information of the ICT division of the government, have taken active measures to provide education to students during the corona crisis.

The importance of keeping students engaged in education throughout this period is a laudable task. However, how this system is functioning, who can access this facility, what quality of education are being provided and how this can be improved are issues that need to be looked at carefully.

The issue of infrastructure comes first. Online education is not accessible to all. Majority of the schools and colleges in the rural areas do not have facilities for technology-based education. Many students do not have laptops. Besides, internet connections and speed in rural areas are poor and slow. Even in the urban areas the quality of internet connection is not good.

Unfortunately, imposition of additional Value Added Tax (VAT) on internet use in the budget for fiscal year (FY) 2021 has been a contradictory measure taken by the government. Such VAT has been imposed on the bandwidth price both at the wholesale and retail levels. As a result, monthly internet payment for students will increase from Tk 1,000 to about Tk

1,400. This is a big jump for students from

URING the poor and low-income families during the coronavirus crisis. Parents will feel this is a burden and may think of withdrawing their children from education. As it is, economic hardship during this crisis will force poor families to send their children for income earning activities. One does not know whether and when they will be able to return to classrooms. Thus, the risk of child labour may increase. For girl children, the situation is even worse. Parents are marrying off their daughters who are below the age of marriage as they cannot bear daily expenses and feel girls are additional burden. This is also going to have impact on the health of these girls since they will now be having children at a very young age.

Shortcomings in several areas have to be removed. Higher resource availability and its use, quality education for all and improved governance in the education system are still unfinished agendas which may reverse the achievements made so far. Therefore, consolidation of the current initiatives, and ensuring consistency and alignment of education-related commitments with national priorities are essential to achieve the aspiration of building capable human resources for the future.

Making online education effective

Like many other sectors the achievement of the education sector made over the past decades is at risk of being reversed.

Indeed, like many other sectors the achievement of the education sector made over the past decades is at risk of being reversed. During the past decades, Bangladesh has achieved near-universal access to primary education. Gender gap in access to primary and secondary education has been reduced. About 14 percent of secondary level students is in the vocational track. Students' participation in education is being supported by expanding stipend scheme and free textbooks. Student-teacher ratio has improved, teachers' salaries have increased, student assessment reforms have been undertaken and school

facilities have improved. Thus, many deficiencies that characterised the education system of Bangladesh in the past decades have been

public education budget should be raised to at least 4 percent, and eventually to 6 percent of the gross domestic product (GDP), and at least to 20 percent of the national budget. Stagnation in public fund allocation for education in recent years is a worry. Actual expenditure on education as a share of GDP remained somewhat stagnant, hovering around the 2 percent mark. This is lower than what is targeted in the national Seventh Five-Year Plan (7FYP), and also below the standards set for Education 2030 Framework for Action of the United Nations Educational Scientific and Cultural Organization (UNESCO). The Education 2030 Framework for Action advises to allocate 4-6 percent of GDP and 15-20 percent of total public expenditure for the education sector. Though total allocation has been


increasing as the size of the budget is also increasing, the share of education expenditure compared to the total budget expenditure has not increased much over time. In the budget for FY2021, education budget as a share of total budget has decreased to 11.7 percent from 14 percent in FY2010. As a share of GDP, education budget has decreased to 2.09 percent in FY2021 compared 2.12 percent in the revised budget of FY2020. Even with such low allocation, the utilisation rate of the education budget, especially development expenditure, is low and has been decreasing over the years, except for certain years, such as FY2019.

Education objectives have to be aligned with national plans. There is no specific universalisation plan for education beyond grade five in Bangladesh. Measures are needed to reconcile global target of universal full secondary education by 2030, with national targets for grades eight, ten and twelve. The need for improved education governance has always been felt by education experts. A permanent statutory National Education Commission can be a mechanism for guiding the sector, exercising oversight, monitoring progress and assessing the impact of reforms in education governance and management.

The quality of teachers is another critical area for achieving the education objectives. The profession is yet to be looked at as a respected one. An overall transformation is needed for the teaching profession to make it prestigious and effective. A separate National Teaching Service Corps can be created with better remuneration package which will attract qualified and young graduates. The online lessons provided through digital platforms during the corona pandemic have also shown the ill-preparedness of teachers. Many are averse to technology and many have no experience.

The ongoing corona crisis underscores the need for change in the method of teaching at educational institutions. In order to adapt the new normal, the education sector has to be redesigned. Instead of following the path of providing certificates through traditional education system, the new realities have to be taken into consideration and contextualised within the plans and strategies of the education sector. This is essential for making quality education inclusive and equitable, particularly when it is becoming more technology dependent.

Stand beside the flood victims

Many of the flood-hit people are unable to return home from temporary shelters as their houses were badly damaged. And they are also facing a shortage of drinking water as most of the tube-wells in the area have gone under water.

Inadequate government relief has worsened their crises and compounded their woes. Apart from the government's aid, other affluent individuals and organisations must step forward immediately to stand beside the victims of flood.

value, somebody will tell you your value, and it'll be less than you're worth," stated Bernard Hopkins Jr, one of the most successful boxers of the past three decades. As the

world slowly comes to terms with the new norms following the global Covid-19 pandemic, is it time for the ready-made garment (RMG) industry of Bangladesh and the wider global apparel supply chain to reassess the value of the product that it produces and increase end-consumer awareness of the true costs of the fashion purchases that they make.

The RMG sector of Bangladesh has enjoyed rapid growth since its inception in the late 1970s and, until the devastating effects of the coronavirus hit home, had established the country as the second largest global supplier of apparel, with a 6.4 percent market share in clothing and with the RMG sector accounting for 83 percent of Bangladesh's exports, employing some 4.4 million people and contributing over USD 36 billion to the economy.

A few short months later and the entire fashion industry landscape has changed. Retailers and brands around the world have seen demand for their products shrink dramatically as their customers have been restricted by lockdown measures and, even as these measures are being relaxed, are reluctant to resume the purchasing habits they followed prior to the outbreak of the pandemic. The RMG industry has felt the consequences of this contraction in the fashion industry, with orders from customers being cancelled, delayed or, worse still, payments being withheld, leaving many companies in the

industry facing a bleak future. How could it have come to this in

such a short space of time? An industry that was the pride of the nation has been brought to its knees in a matter of weeks and this has raised some serious questions about how we recover and shape the sector for the future.

Lest we forget, the rapid rise in the fortunes of the Bangladesh RMG industry were largely based upon the supply of "value" product, with the industry able to rely on a ready workforce whose salary expectations were, until recently, very low. The current apparel industry in Bangladesh is heavily reliant on "basic" low ticket price production, although some 40 percent of exports in 2018 were

profit margins, often eroded through increasing taxes, rising charges for fuel and power and greater expenditure on transportation and wages.

Covid-19 has exposed the fragility of this reliance upon lower ticket price items manufactured by workers who depend on their salaries to support themselves and their dependents. For too long a culture of price pressure from our customers has

what has been achieved. Now is the time to engage with our customers and ensure that they understand our needs and the true value of the product we produce rather than continually chase orders for the lowest purchase price.

I appreciate that this approach will be alien to many involved in the Bangladesh RMG sector, but recent events have proven that we cannot let things carry on as

instilled a situation whereby, in general, the lower the cost paid for any apparel item, the lower the salary of the workforce that produce it.

But have we been missing a trick here? Has the RMG industry, over the years, lost sight of the true value of the product that it produces? I am not for a moment suggesting a wholesale increase in the purchase price of apparel products produced in Bangladesh but what I think needs to be realised is that the prices being paid for the product we produce are being kept artificially and, as has been proven, unsustainably low. In a post-Covid world we need to readdress this imbalance and, together with our business partners establish a fair pricing system for apparel produced in the country.

We should not forget the advances and investments that have been made in the RMG industry in the aftermath of the Rana Plaza disaster in 2013. We have been rightly proud of improvements in ethical,

normal. In fact it would be foolhardy to assume that things will return to normal once the ravages of the pandemic subside.

Now is the time, through engagement with our customers, to ensure that the true costs of any apparel item, whether produced in Bangladesh or in other sourcing hubs, are clearly communicated to the end consumer. There is an emerging groundswell of consumers in our key markets of the UK, Europe and the USA that want to be assured that the product that they purchase is produced in the most ethical, environmentally sound manner possible. The Covid-19 pandemic offers the opportunity to inform those consumers and, together with our business partners, we can champion the virtues of the apparel product that we produce as a nation.

The Bangladesh RMG industry can no longer rely on the level of business that we enjoyed before the pandemic broke and we will need to adapt. There is much talk about the "survival of the fittest"

the strongest, fastest, or smartest. By that definition, then, survival of the fittest might not be the best way to describe natural selection as it applies to evolution. Darwin did not mean it in those terms when he used it in his republished book. He intended "fittest" to mean the members of the species best suited, or able to adapt to the immediate environment, and it is this process of adaption that will ensure that the Bangladesh apparel industry can survive going forward.

Through engagement with our business partners, the championing of the advances the RMG sector has made and the establishment of meaningful partnerships based on a fair pricing strategy, the industry will continue, albeit in a different format to what we all knew before the Covid-19 crisis took hold.

Some questions on DU's research budget



newspaper published a report recently on University of Dhaka's (DU) Tk 869.56 crore budget for the current fiscal year, the

local

largest ever, to support the work of the iconic institution poised to celebrate its 100th year since its establishment in 1921. Recognised in the past as "The Oxford of the East", people ask, what happened to that illustrious veneer?

A prime reason the lustre has vanished, among several others, is the quality and quantity of research originating from its hallowed halls. In fact, the budget allocated to research is shown as merely 1.09 percent or roughly Tk 9.5 crores for the entire university. The rest is allocated as follows: 30.71 percent for salary, 24.81 percent for allowances, 22.74 percent for supply and services, 14.38 percent for pensions, and a tiny amount for grants and capital grants. One might look at the miniscule allocation for research and ask: how or why would faculty pursue research?

Teachers are actually compensated for three major activities: teaching, research, and service. They are aided by an administration whose budget is covered as institutional support. The entire budget is, therefore, for "faculty activities" and "administrative support." The "faculty activity" budget is largely for teaching and research, which is why faculty are compensated.

If we look at MIT's (USA) operating expenditure budget (2019), it is shown under three major heads: sponsored

research 47 percent; instruction and unsponsored research 32 percent, and general and administrative 21 percent. How then are salaries, allowances, and supply/services accounted for? Are the faculty not paid? The fact is that faculty compensation (salaries, etc.) is included in the operating expenditure as instruction and research (mainly) which accounts for 79 percent of the budget. Similarly, the University of Hong Kong's 2019 expenditures are listed under "two" heads: i) Teaching, Learning, and Research and ii) Institutional Support. The first head accounts for roughly 70 percent of the expenditures that covers faculty compensation and benefits.

For the DU budget, the faculty portion of compensation/allowances/ supply/services is surely for research and teaching. Then why is there a separate category of 1.09 percent for research? Say (as an example only) that faculty are expected to allocate 50 percent of their time for research: shouldn't the research allocation be shown not as Tk 9 crores but actually 50 percent of the budget or roughly Tk 434 crores (minus administrative costs)? The rest is for teaching (and services)

The amount "actually" allocated for research at DU, therefore, is substantially higher than claimed. The 1.09 percent for research is a misrepresentation which would allow faculty to complain and give them an excuse not to produce good researchor any research at all. With the more realistic view of the research budget that I present, the question would then arise: "For last year's budget expenditures of Tk 810 crores, what proportion of compensation was for research? And what outcome was thus generated? What record or evidence

would the university administration show?"

Another key point: If one takes a look at the revenue side of MIT's budget, tuition accounts for only 10 percent of the revenue stream. The lion's share of revenue comes from the Lincoln Lab (27 percent), research revenues (19 percent) and investment returns (likely from surplus money that research generates, 22 percent). MIT

"UCLA has averaged USD 1 billion in research funding with over 350 research labs, centres, and institutes...and over 1,800 inventions have come from this research powerhouse." If good research can be done by the DU faculty, under visionary leadership, that garners the confidence of the government, industry and international bodies, there should be no dearth of research funds!

DU's situation is context-bound

faculty members thus bring in, from research, roughly 68 percent of its total revenue of 3.932 billion dollars! Then there are endowments, grants, gifts, bequests, etc. In other words, faculty members bring in a good part of their own compensation through research grants and the like. Is this a model we can emulate?

I have also written elsewhere that

and should not be equated with that of MIT and other vaunted universities. The compensation that faculty earn also require serious discussion. I bring the matter of research budgets to the forefront to generate a conversation on what is the purpose of our universities, what outcomes should be expected from our faculty members, especially in terms of research, and how can the

budget guide the expected activities. Absence of a vision and a lack of desire to give prominence to research already shows dismal results (especially our rankings) that are not surprising.

I will concede that "if" research is not a priority, then DU (and other universities) ought to state clearly its priority and the activities for which the expenditure of Tk 869 crores is budgeted. This would establish accountability. Also, if teaching is the institution's priority, one might ask, why are so many DU graduates unemployed?

Universities build their reputations on research. When it makes impact and garners attention, not only do universities rise in stature, even the nation attains a stellar reputation. This is perhaps why many Asian universities have begun to focus on establishing a research pedigree. China, Japan, S Korea, Hong Kong, Singapore and Malaysia have already surged ahead. To build such a vibrant research culture, will Bangladesh follow?

With 38 public and 105 private universities in the higher education system, the question that must be posed is: What is the broad vision and expectation from these universities. To be in the ranks of the globally recognised universities, at least some of Bangladesh's universities must assume the role of flagship universities with a clear research agenda that drives their activities and outputs. Otherwise, they'll continue to churn out certificates for aspiring students who, at the end of their academic journey, will be destined, unfortunately, to join the ranks of the despondent and the unemployed.

Covid-19: Social stigma, discrimination and deprivation

ORE than half of the world's population lived in Covid-19 induced lockdown until recently, which highly disrupted lives and livelihoods throughout societies. In particular women, people with disabilities, the poor, ethnic minorities and the disadvantaged section of the society, mostly in the developing world, have been adversely affected. Income inequality, deprivation, discrimination on the basis of colour, creed, ethnicity, social status, etc. have worsened the situation. The pandemic outbreak has provoked social stigma and discriminatory behaviour against

with increased equality. The Gini coefficient has increased from 0.388 in 1992 to 0.482 in 2016, meaning that inequality has increased. GDP growth without proper job creation has resulted in slow progress in poverty reduction. Existing inequality of access to healthcare for the poor has aggravated during the pandemic. Economic recovery packages like bailouts, incentives, loan rescheduling, subsidies, etc. are benefitting mainly the rich businesses. Our average household consumption fell from 1.8 percent

etc. which makes on more vulnerable to Covid-19. The US Gini coefficient was 0.59 in 2016 which represents high inequality. Implicit racism and discrimination through attitudes, process, behaviour, prejudice, ignorance and thoughtlessness have been reported in the UK also, 8.5 million non-whites in Britain face disparity in education, employment, medical treatment, etc. Proportion of coronavirus infection is disproportionately higher (34 percent) among the UK's ethnic minority population (14 percent).

GDP from (-) 3 percent in April to (-) 4.9 percent in June 2020. Effective Covid-19 treatments and vaccines are still far off. Equitable and lasting solutions to the pandemic are urgently required on the basis of social justice, global cooperation, good governance and sustainable development. The core challenges to be addressed by the global community include suppressing the pandemic rapidly; meet the pressing needs of vulnerable groups (poor, elderly, minorities); prevent public health emergencies from turning into fulminant financial crises and improve healthcare systems.

Multilateral institutions like IMF, WHO, FAO, WFP, etc. which are

used to express solidarity with Covid-19 patients. Spread of social stigma can be stopped by calling out hateful online rhetoric which may be reported to the hosting platforms. Youths as active agents of change can use the digital platforms to create awareness about the pandemic and reduce social stigma against patients and front-line workers. The root causes of poverty and inequality should be addressed to encourage economic growth with equality.

people of certain ethnic or also social backgrounds. Anyone perceived to have been in contact with people affected by the virus has been discriminated against in certain cases.

Covid-19 patients in many cases have been neglected by caregivers, family, friends and the community. Stigma has undermined social cohesion and prompted social isolation of patients. Bodies of people who died from Covid-19 were found to have been abandoned in forests or on the streets in certain places of Bangladesh. Communities in a few areas even refused burial of such bodies. After being identified as a corona patient, a number of aged men/women could not even enter their own houses or get any treatment anywhere. And Covid-19 patients, their family members and frontline workers like medical professionals and law enforcers have been harassed in many places.

Economic disparity has led to deprivation, discriminatory behaviour and denial of proper treatment of economically poor corona patients in Bangladesh and elsewhere. The richpoor gap has increased significantly in Bangladesh in recent years. The massive GDP growth has not been accompanied

in 2010 to 1.4 percent in 2016. Lowincome communities are more likely to be exposed to the coronavirus and will be more affected due to long-standing segregation, high-cost of medicine, etc. Higher mortality rate has been observed among marginal groups in the US-21 percent of black Americans and 18 percent of Hispanic people live below the poverty line, compared to 8 percent of white Americans. Low income is associated with diabetes, heart-disease,

In the absence of effective testing and contact tracing system, the pandemic now confronts the world with unsolved and urgent challenges. Lockdown, business closure, job cuts, etc. have resulted in huge disruptive impacts on individuals and society. Even countries that have suppressed the pandemic are experiencing adverse economic spill-over effects from the rest of the world. The IMF has downgraded the decline in global

coordinating global responses to CovidD-19 seem to be caught up in the middle of big-power geopolitics. Strengthening the efficacy of these critical institutions is essential for sustainable economic recovery. Specific dimensions of the pandemic that need to be urgently addressed include: i) strengthened public health systems for surveillance, testing, tracing and isolating Covid-19 cases; ii) prevention of zoonotic diseases; ii) development and distribution of medicines and vaccines; iv) protection of vulnerable groups; and v) efficient and equitable financing of pandemic control. The global Lancet Covid-19 Commission headed by Jeffrey D Sachs aims to control the pandemic decisively through equitable, innovative and globally cooperative strategies with firm commitment to leaving no one behind.

Discriminating against Covid-19 patients violates their fundamental human rights. The poor and vulnerable patients must be given access to proper medical treatment and care. Accurate information about the pandemic should be shared, fear and rumours must not be spread. Infected persons must not be referred to as the "victims" of coronavirus. Social media may be

Direct payments should also include child benefits, disability benefits, social security and sickness benefits, etc. The use of enhanced budgetary allocations to the health sector in our budget this year, along with the special financial packages declared by the prime minister for the poor and jobless people, should be used transparently and with accountability. Social safety net should be widened.

Cottage, micro, small and medium enterprises in Bangladesh should be offered adequate financing through banks and MFIs to get the rural economy moving. Structural changes must be undertaken to ensure sustainable and equitable economic growth and reduce deprivation and exclusion. Universal non-contributory pension may be introduced for Bangladeshis above 70-years-old on a pilot basis. Covid-19 treatment facilities should be enhanced and some facilities should be kept reserved for the elderly and disadvantaged patients. Above all, patients of the disease must be treated with dignity and must not be stigmatised.

Many of the 700,000-plus Rohingya Muslims who fled a military crackdown in Myanmar three years ago have attempted to leave overcrowded refugee camps in Cox's Bazar on boats headed for Malaysia and neighbouring Indonesia.

Zawawi said two coastguard aircraft and two boats have been deployed to search the suspected area.

Malaysia has stepped up maritime patrols since the outbreak of the coronavirus epidemic in a bid to stop Rohingya boats from landing.

Although some have made it ashore many boats have been turned back, sparking anger from rights groups.

France opens probe into Rwandan genocide suspect

France has opened a probe into alleged crimes against humanity by a top former Rwandan military official, Aloys Ntiwiragabo, during the country's 1994 genocide which claimed 800,000 lives.

Anti-terrorism prosecutors told AFP Saturday that a preliminary investigation was opened after Ntiwiragabo was found hiding in the suburbs of the city of Orleans, about 100 kilometres south-west of Paris.

French investigative news site Mediapart tracked down the former Rwandan spy chief, who was identified by the International Criminal Tribunal for Rwanda (ICTR) as one of the architects of the genocide.

Neither the ICTR, Interpol, France nor Rwanda were actively seeking him now and had dropped arrest warrants years ago.

The revelation of his whereabouts comes barely two months after another suspected genocide architect, Felicien Kabuga, was arrested on the fringes of Paris.

Kabuga, who evaded police in several countries for 25 years, is accused of financing the genocide.

Finland-born Bangladesh defender Tariq Raihan Kazi has been drafted into Bangladesh's 36-member preliminary squad for four matches of the Joint Qualifiers for the World Cup and Asian Cup in October and November.

Tariq is one of few expatriate footballers in the preliminary squad. The 20-yearold, like Jamal Bhuiyan, enrolled in Bangladesh's domestic league. Denmarkbased Jamal made his way into the national team in 2012 and is now captain of the national side.

Tariq represented Finland's age-group teams in the U-17 and U-19 levels and last played for Bashundhara Kings in the 2019-20 season. He was selected in the starting eleven twice as a centre-back and came off the bench four times. However, Tariq's preferred position is at right-back.

Apart from Tariq, there were three more new faces in the squad with holding midfielder Nazmul Islam Rasel and winger SM Bablu of Bangladesh Police and Sumon Reza of Uttar Baridhara Club also named in the squad, which will start a conditioning camp from August 5 at Sarah Resorts in Gazipur.

Midfielders Masuk Mia Jonny, Mohammad Abdullah and Atiqur Rahman Fahad, alongside striker Nabib Newaj Jibon, also returned to the squad after recovering from injuries.

Sushanta Tripura, Tutul Hossain Badsha, Pappu Hossain, Yeasin Arafat and Manjurur Rahman Manik also returned

after being excluded for the Bangabandhu Gold Cup.

"We are really pleased to add some new players to the squad and are so excited by them. We have a good mixture of experience and youth. So we are looking forward to working with them and hopefully it will be a good camp ahead of the games in October and November," head coach Jamie Day said in a video message released by the Bangladesh Football Federation (BFF).

Bangladesh will host Afghanistan on October 7 in Sylhet before travelling to Qatar to play against the Asian champions on October 13. The men in red and green will host India and Oman in November and complete the qualifiers.

Jamie informed that players will initially start training under local coach Masud Parvez Kaiser before foreign staff join in mid-August.

About the picking up 36 players, BFF vice president and National Teams Committee deputy chairman Tabith M Awal said: "Bangladesh will play four official matches and have the possibility to play two practice matches. So keeping in mind injury problems and illness due to the coronavirus pandemic, we have selected more players to keep as backups.

Awal informed that they would start the camp from August 5 and that head coach Jamie would trim the squad to 25 within a month and announce a final 23-member squad before the match against Afghanistan.



'No doubt that Messi will stay'

Barcelona president Josep Maria Bartomeu repeated on Sunday that he had "no doubt" that • Lionel Messi would sign a new contract adding that he can only see Neymar returning in a player LaLiga exchange due to the club's financial constraints. "Messi has said many times that he wants

to retire here and I have no doubt that he will re-sign," Bartomeu said in an interview with Mundo Deportivo. Messi's contract expires in June 2021 and local radio station Cadena Ser reported that the Argentine had broken off talks.

Messi has had regular disagreements with the club's board. He reacted publicly when sporting director Eric Abidal appeared to blame the players for the sacking of coach Ernesto Valverde in January. He also led the fightback from the Barcelona players over a dispute with the board in March regarding pay cuts during the coronavirus pandemic.

In discussing plans for next season and financial constraints on the club, Bartomeu addressed another longrunning issue: the possibility that Neymar would return.

"Now we are making decisions and the players, if they do not come as part of a player exchange players, it is very difficult for them to come," Bartomeu said.

Bartomeu said another priority was persuading German goalkeeper Marc-Andre ter Stegen, whose contract expires in 2022, to sign a new deal "not only for his quality as a goalkeeper but for his personality" and added that talks with Inter Milan over Argentinian striker Lautaro Martinez were "at a standstill".



Eight other first-division games on Sunday were expected to go ahead as scheduled. The J-League returned to action behind closed doors in June and began allowing fans into stadiums earlier this month.

Hope for faster trade arrives

First container carrying train from India reaches Benapole

Bangladesh and India formally started operating commercial container trains yesterday more than two years after the trial run of the service, aiming to boost crossborder trade and business.

The first train, which started from Container Corporation of India Ltd (CONCOR) terminal in Kolkata's Majerhat, carrying 50 containers, reached Benapole Railway Station at 12:25pm, Bangladesh Railway (BR) officials said.

The goods, which include garment fabrics and toiletries, were unloaded at Benapole land port, they said, adding that necessary custom procedures would be followed before transporting them inside the country.

Three railway officials, including the divisional railway manager (Pakshy), were present when the train arrived at Benapole Railway Station, they added.

"We are hopeful that the service will continue," Shafiqur Rahman, director (traffic) of BR, told The Daily Star yesterday.

The development came days after the first parcel train came to Bangladesh carrying 384 tonnes of dry chillies from Guntur district of Andhra Pradesh in the second week of this month.

Besides, the first ship under the trial run of transhipment of Indian goods to its north-eastern states through Bangladesh reached Tripura last week.

Rohingya Migrants 24 feared drowned off Malaysia

A Rohingya migrant is feared to be the only survivor from a boat carrying at least two dozen asylum seekers that is believed to have run into difficulty off the Malaysian coast near Thailand, a coastguard official said yesterday.

Mohamad Zawawi Abdullah, coastguard chief for the northern states of Kedah and Perlis, said the 27-year-old named Nor Hossain was detained by police after he swam to shore on the resort island of Langkawi.

UK quarantines travellers from Spain after surge in infections; N Korea reports first suspected case Agencies

Australia has suffered its deadliest day from the coronavirus since the pandemic began, with authorities reporting ten fatalities yesterday and a rise in new infections despite an intensive lockdown effort.

The country's Covid-19 death toll rose to 155 and the southeastern state of Victoria reported more than 450 new infections in the last 24 hours.

A clearly concerned Victoria Premier Daniel Andrews said ten people aged between their 40s and 80s had died, of which seven deaths were linked to outbreaks in aged care facilities.

It is the worst loss of life from the virus in Australia since the disease first emerged, according to a tally compiled by AFP.

Australia has dodged the worst ravages of the pandemic so far, logging just 14,000 cases in total -- fewer than many harder-hit countries see in one day.

But a second wave of infections is testing the nation's much-lauded response to the contagion.

The number of new cases has remained stubbornly high in recent days despite five million people in greater Melbourne spending the last two weeks in lockdown.

Still, 459 fresh cases were reported in Victoria yesterday -- up from 357 on Saturday. Around a dozen more were recorded in other parts of Australia.
