Human trials of Covid vaccine set to begin in Indonesia

Human trials on a potential coronavirus vaccine are due to start in Indonesia next week as part of a collaboration between state-owned pharmaceutical company Bio Farma and China's Sinovac Biotech Ltd, a senior researcher said.

The launch of the vaccine trial comes as Indonesia has struggled to contain the spread of the novel coronavirus, with a consistently escalating number of cases.

The phase 3 clinical trial is set to begin on Aug. 11 and will involve

"On behalf of the people and the government of Bangladesh and on my own behalf, I express our deepest condolences, for the loss of innocent lives due to the explosion that took place in Beirut on Tuesday night," Hasina said in a message to her Lebanese counterpart Hassan Diab, reports BSS.

The Bangladesh premier also conveyed her sincere sympathy to the pereaved family members of the victims.

"It is my firm conviction that the government of Lebanon, under your able leadership, will be able to bring the situation under control," she said, adding that Bangladesh would stand beside the people and the government of Lebanon in such a crisis.

Speaking of the Bangladeshi nationals who lost their lives and were injured, she said the government would look after them. She prayed for the salvation of the departed souls and also for the quick recovery of the injured.

Foreign Minister AK Abdul Momen also called his Lebanese counterpart Charbel Wehbe on Wednesday and conveyed his condolences for the deaths, injuries and other damages.

"In need, Bangladesh stands ready to provide any emergency assistance to Lebanon," he told the Lebanese

thanked Wehbe Momen for providing medical treatment to Bangladeshis injured in the explosion in Lebanon, home to some 150,000 Bangladeshis.

Beirut's governor estimated that up to 300,000 people have been left temporarily homeless by the destruction, which he said would cost the debt-ridden country in excess of three billion dollars, reports AFP.

On July 7, a Rab mobile court raided Regent Hospital's Uttara branch and sealed it off. The court said it found proof that the hospital issued several thousand fake Covid-19 test reports, which prompted the rift.

The branch was sealed off in connection with issuing fake Covid-19 test certificates and collecting money from patients. Later, the DGHS shut down the hospital's branches in Uttara and Mirpur.

A day after the resignation of Prof Azad from DGHS, the ACC sued Shahed for misappropriating about Tk 1.51 crore of NRB Bank.

No decision yet on major exams

On August 4, 2015, when Pradeep was the OC of Bayezid Bostami Police Station, a police team seized a tanker lorry laden with 9,000 litres of fuel from an oil refinery.

A case was filed against 10 highups of the oil company, including its chairman and managing director, under the Special Powers Act for transporting "illegal fuel".

The company denied the allegation and lodged a complaint with the police headquarters. It also said the OC had demanded bribes.

policemen misused their powers and filed the case to harass the company officials. Pradeep and two sub-inspectors were

suspended. When Pradeep was the OC in reports published by this daily. Maheshkhali Police Station, there were

Teknaf Model Police Station on October According to The Daily Star reports, at least 84 people were shot dead by

Teknaf police since he took office. Citing media reports, Transparency International Bangladesh in a statement said as of July 30, 287 people died in "gunfights" with law enforcers in Cox's Bazar since an anti-narcotic drive began

in 2018. None of the families of the 84 people killed by Teknaf police, have prosecuted the police.

In fact, there have been rare occurrences of families of people shot dead by law enforcers filing cases against officers. This is the first time law enforcers were taken into custody for socalled gunfights.

Ex-Major Sinha, 36, had been making travel documentaries for a YouTube channel called "Just Go". On July 31, he was returning to Cox's Bazar from Teknaf. His car was stopped at Shaplapur on Marine Drive road. The police claimed that they tried to

this end, an ISPR press release said. Noting that the killing of Sinha was 'an isolated incident', the Army Chief and the IGP hoped that fair investigation into the killing and ensuring exemplary punishment to those involved in the killing will make the existing mutual trust between the two forces deepened

and strengthened more. As per the directives of Prime Minister Sheikh Hasina, a high-level joint probe committee was constituted, which started its probe on August 4. On Wednesday, the Chief of Army Staff and the Police IGP visited the spot and exchanged views with the local officers of their respective forces and gave necessary instructions to this end.

The Army Chief and the IGP said the responsible forces will not take the responsibility of the individuals involved in the incident and it would not affect the long-standing good relations of the two forces.

N Korea on flood alert as heavy rain kills 16 in South

Days of heavy rain could cause flooding or landslides across North Korea, officials warned, as the South said yesterday 16 people had died in

the downpours lashing the peninsula. North Korea is particularly vulnerable to sustained heavy rain as many mountains and hills have long been stripped of vegetation, allowing water to flow downhill unchecked.

But the South has also suffered, with authorities saying at least 16 people had been killed in the past few days by floods in the central region.

Another 11 were missing, while 1,600 people had been displaced from their homes, authorities said.

The North's official KCNA news agency said areas hardest-hit by the downpour include Hwanghae province, a major agricultural region. "It is important to take necessary

measures for the regions which are in danger," said Dokgo Hyok Chol, an official at the State Hydrometeorological Administration. KCNA did not mention any

casualties or damage caused by the At least 138 North Koreans died after torrential rain triggered major floods in 2016, the United Nations

said at the time. More than 160 people were killed by a massive rainstorm in the summer

Dozens feared dead after migrant boat sinks off Mauritania

AFP, Nouakchott About 40 people are feared dead after a migrant vessel sank off the coast of Mauritania, the UN said yesterday, in a fresh tragedy along the Atlantic

In a tweet, the UN refugee agency's special envoy for the central Mediterranean, Vincent Cochetel, said one person from the West African state of Guinea had survived.

The boat sank off the northern city of Nouadhibou, Mauritania's second argest, according to Cochetel. 'New shipwreck off the coast of Nouadhibou #Mauritania of approximately 40 persons on board, there is one survivor (from

Guinea)" Cochetel said on Twitter, without specifying when the incident happened Other details about the event

remained unclear and some accounts were conflicting. A Mauritanian security official, who declined to be named, told AFP that the sinking did not take place in Mauritanian waters, but "far from our

No more work

As part of safety precautions against Covid-19, the government on June 1 had asked ministries and departments not to have more than 25 percent of their officials and employees at the offices. There was, however, no official

The government enforced a 66-day shutdown from March 26 across the country to curb the spread of the novel coronavirus. It lifted the shutdown and reopened all government offices with reduced capacity and resumed public transport services under similar guidelines.
